Examples of DEs

$$
\begin{array}{ll}
\frac{d y}{d x}-5 y & =1 \\
(y-x) d x+4 x d y & =0 \\
\frac{d^{2} y}{d x^{2}}+5\left(\frac{d y}{d x}\right)^{3}-4 y & =e^{x} \\
\frac{\partial u}{\partial y}+\frac{\partial v}{\partial x} & =0 \\
x \frac{\partial u}{\partial x}+y \frac{\partial v}{\partial y} & =u \\
\frac{\partial^{2} u}{\partial x^{2}}-\frac{\partial^{2} u}{\partial t^{2}}+2 \frac{\partial u}{\partial t} & =0
\end{array}
$$

Specific Examples of ODE’s


■ The order of an equation:

- The order of the highest derivative appearing in the equation

$$
\begin{array}{ll}
\frac{d^{2} y}{d x^{2}}+5\left(\frac{d y}{d x}\right)^{3}-4 y & =e^{x} \\
a^{2} \frac{\partial^{4} y}{\partial x^{4}}+\frac{\partial^{2} u}{\partial x^{2}} & =0
\end{array}
$$

Ordinary Differential Equation

If an equation contains only ordinary derivatives of one or more dependent variables, w.r.t a single variable, then it is said to be an Ordinary Differential Equation (ODE). For example the differential equation

$$
\frac{d^{2} y}{d x^{2}}+5\left(\frac{d y}{d x}\right)^{3}-4 y=e^{x}
$$

is an ordinary differential equation.
Partial Differential Equation

Similarly an equation that involves partial derivatives of one or more dependent variables w.r.t two or more independent variables is called a Partial Differential Equation (PDE). For example the equation

$$
a^{2} \frac{\partial^{4} u}{\partial x^{4}}+\frac{\partial^{2} u}{\partial x^{2}} \quad=0
$$

is a partial differential equation.

## Results from ODE data

- The solution of a general differential equation:
- $f\left(t, y, y^{\prime}, \ldots, y(n)\right)=0$
- is defined over some interval $I$ having the following properties:

■ $y(t)$ and its first $n$ derivatives exist for all $t$ in $I$ so that $y(t)$ and its first $n-1$ derivates must be continuous in $I$
■ $y(t)$ satisfies the differential equation for all t in $I$

- General Solution - all solutions to the differential equation can be represented in this form for all constants
■ Particular Solution - contains no arbitrary constants
- Initial Condition

■ Boundary Condition
■ Initial Value Problem (IVP)

- Boundary Value Problem (BVP)

IVP Examples

- The Logistic Equation
- $p^{\prime}=a p-b p 2$
- with initial condition $p(t 0)=p 0$; for $p 0=10$ the solution is:
- $p(t)=10 a /(10 b+(a-10 b) e-a(t-t 0))$

■ The mass-spring system equation

- $x^{\prime \prime}+(a / m) x^{\prime}+(k / m) x=g+(\mathrm{F}(t) / m)$

BVP Examples

- Differential equations
$y^{\prime \prime}+9 y=\sin (t)$
- with initial conditions $y(0)=1, y^{\prime}(2 \mathrm{p})=-1$
- $y(t)=(1 / 8) \sin (t)+\cos (3 t)+\sin (3 t)$

■ $y^{\prime \prime}+\mathrm{p} 2 y=0$

- with initial conditions $y(0)=2, y(1)=-2$
- $y(t)=2 \cos (\mathrm{p} t)+(c) \sin (\mathrm{p} t)$

Properties of ODE's

- Linear - if the nth-order differential equation can be written:
- $a n(t) y(n)+a n-1(t) y(n-1)+\ldots+a 1 y^{\prime}+a 0(t) y=h(t)$

■ Nonlinear - not linear

$$
x 3\left(y^{\prime \prime},\right) 3-x 2 y\left(y^{\prime \prime}\right) 2+3 x y^{\prime}+5 y=e x
$$

Superposition

- Superposition - allows us to decompose a problem into smaller, simpler parts and then combine them to find a solution to the original problem.

Explicit Solution
A solution of a differential equation

$$
F\left(x, y, \frac{d y}{d x}, \frac{d^{2} y}{d x^{2}}, \cdots, \frac{d^{2} y}{d x^{2}}\right)=0
$$

that can be written as $y=f(x)$ is known as an explicit solution .
Example: The solution $\boldsymbol{y}=\boldsymbol{x e x}$ is an explicit solution of the differential equation

$$
\frac{d^{2} y}{d x^{2}}-2 \frac{d y}{d x}+y=0
$$

Implicit Solution
A relation $\boldsymbol{G}(\boldsymbol{x}, \boldsymbol{y})$ is known as an implicit solution of a differential equation, if it defines one or more explicit solution on I.

Example: The solution $x 2+y 2-4=0$ is an implicit solution of the equation $y^{\prime}=-x / y$ as it defines two explicit solutions $y= \pm(4-x 2) 1 / 2$

## Separable Equations

The differential equation of the form

$$
\frac{d y}{d x}=f(x, y)
$$

is called separable if it can be written in the form

$$
\frac{d y}{d x}=h(x) g(y)
$$

To solve a separable equation, we perform the following steps:

1. We solve the equation $g(y)=0$ to find the constant solutions of the equation.
2. For non-constant solutions we write the equation in the form.

$$
\frac{d y}{g(y)}=h(x) d x
$$

Then integrate

$$
\int \frac{1}{g(y)} d y=\int h(x) d x
$$

to obtain a solution of the form

$$
G(y)=H(x)+C
$$

3. We list the entire constant and the non-constant solutions to avoid repetition..
4. If you are given an IVP, use the initial condition to find the particular solution.

## Note that:

(a) No need to use two constants of integration because $C_{1}-C_{2}=C$.
(b) The constants of integration may be relabeled in a convenient way.
(c) Since a particular solution may coincide with a constant solution, step 3 is

## important.

## Example 1:

Find the particular solution of

$$
\frac{d y}{d x}=\frac{y^{2}-1}{x}, \quad y(1)=2
$$

## Solution:

1. By solving the equation

$$
y^{2}-1=0
$$

We obtain the constant solutions

$$
y= \pm 1
$$

2. Rewrite the equation as

$$
\frac{d y}{y^{2}-1}=\frac{d x}{x}
$$

Resolving into partial fractions and integrating, we obtain

$$
\frac{1}{2} \int\left[\frac{1}{y-1}-\frac{1}{y+1}\right] d y=\int \frac{1}{x} d x
$$

Integration of rational functions, we get

$$
\frac{1}{2} \ln \frac{|y-1|}{|y+1|}=\ln |x|+C
$$

3. The solutions to the given differential equation are

$$
\left\{\begin{aligned}
\frac{1}{2} \ln \frac{|y-1|}{|y+1|} & =\ln |x|+C \\
y & = \pm 1
\end{aligned}\right.
$$

4. Since the constant solutions do not satisfy the initial condition, we plug in the condition
$y=2$ When $x=1$ in the solution found in step 2 to find the value of $C$.

$$
\frac{1}{2} \ln \left(\frac{1}{3}\right)=C
$$

The above implicit solution can be rewritten in an explicit form as:

$$
y=\frac{3+x^{2}}{3-x^{2}}
$$

## Example 2:

Solve the differential equation

$$
\frac{d y}{d t}=1+\frac{1}{y^{2}}
$$

## Solution:

1. We find roots of the equation to find constant solutions

$$
1+\frac{1}{y^{2}}=0
$$

No constant solutions exist because the equation has no real roots.
2. For non-constant solutions, we separate the variables and integrate

$$
\int \frac{d y}{1+1 / y^{2}}=\int d t
$$

Since

$$
\frac{1}{1+1 / y^{2}}=\frac{y^{2}}{y^{2}+1}=1-\frac{1}{y^{2}+1}
$$

Thus

$$
\int \frac{d y}{1+1 / y^{2}}=y-\tan ^{-1}(y)
$$

So that

$$
y-\tan ^{-1}(y)=t+C
$$

It is not easy to find the solution in an explicit form i.e. $y$ as a function of $t$.
3. Since $\exists$ no constant solutions, all solutions are given by the implicit equation found in step 2.

## Example 3:

Solve the initial value problem

$$
\frac{d y}{d t}=1+t^{2}+y^{2}+t^{2} y^{2}, \quad y(0)=1
$$

## Solution:

1. Since $\quad 1+t^{2}+y^{2}+t^{2} y^{2}=\left(1+t^{2}\right)\left(1+y^{2}\right)$

The equation is separable $\&$ has no constant solutions because $\exists$ no real roots of

$$
1+y^{2}=0
$$

2. For non-constant solutions we separate the variables and integrate.

$$
\begin{aligned}
& \frac{d y}{1+y^{2}}=\left(1+t^{2}\right) d t \\
& \int \frac{d y}{1+y^{2}}=\int\left(1+t^{2}\right) d t \\
& \tan ^{-1}(y)=t+\frac{t^{3}}{3}+C
\end{aligned}
$$

Which can be written as

$$
y=\tan \left(t+\frac{t^{3}}{3}+C\right)
$$

3. Since $\exists$ no constant solutions, all solutions are given by the implicit or explicit equation.
4. The initial condition $y(0)=1$ gives

$$
C=\tan ^{-1}(1)=\frac{\pi}{4}
$$

The particular solution to the initial value problem is

$$
\begin{aligned}
& \qquad \tan ^{-1}(y)=t+\frac{t^{3}}{3}+\frac{\pi}{4} \\
& \text { or in the explicit form } \quad y=\tan \left(t+\frac{t^{3}}{3}+\frac{\pi}{4}\right)
\end{aligned}
$$

## Example 4:

Solve

$$
(1+x) d y-y d x=0
$$

## Solution:

Dividing with $(1+x) y$, we can write the given equation as

$$
\frac{d y}{d x}=\frac{y}{(1+x)}
$$

1. The only constant solution is $y=0$
2. For non-constant solution we separate the variables

$$
\frac{d y}{y}=\frac{d x}{1+x}
$$

Integrating both sides, we have

$$
\begin{gathered}
\int \frac{d y}{y}=\int \frac{d x}{1+x} \\
\ln |y|=\ln |1+x|+c_{1} \\
\text { or } \quad=e^{\ln |1+x|+C_{1}}=e^{\ln |1+x|} \cdot e^{c_{1}} \\
y=|1+x| e^{C_{1}}== \pm e^{C_{1}}(1+x) \\
y=C(1+x), \quad C= \pm e^{C}
\end{gathered}
$$

If we use $\ln |c|$ instead of $C_{1}$ then the solution can be written as

$$
\ln |y|=\ln |1+x|+\ln |c|
$$

or

$$
\ln |y|=\ln |c(1+x)|
$$

So that

$$
y=c(1+x)
$$

3. The solutions to the given equation are

$$
\begin{aligned}
& y=c(1+x) \\
& y=0
\end{aligned}
$$

## Example 5

## Solve

$$
x y^{4} d x+\left(y^{2}+2\right) e^{-3 x} d y=0
$$

## Solution:

The differential equation can be written as

$$
\frac{d y}{d x}=\left(-x e^{3 x}\right)\left(\frac{y^{4}}{y^{2}+2}\right)
$$

1. Since $\frac{y^{4}}{y^{2}+2} \Rightarrow y=0$. Therefore, the only constant solution is $y=0$.
2. We separate the variables

$$
x e^{3 x} d x+\frac{y^{2}+2}{y^{4}} d y=0 \text { or } x e^{3 x} d x+\left(y^{-2}+2 y^{-4}\right) d y=0
$$

Integrating, with use integration by parts by parts on the first term, yields

$$
\begin{aligned}
& \frac{1}{3} x e^{3 x}-\frac{1}{9} e^{3 x}-y^{-1}-\frac{2}{3} y^{-3}=c_{1} \\
& e^{3 x}(3 x-1)=\frac{9}{y}+\frac{6}{y^{3}}+c \text { where } 9 \mathrm{c}_{1}=c
\end{aligned}
$$

3. All the solutions are

$$
\begin{aligned}
e^{3 x}(3 x-1) & =\frac{9}{y}+\frac{6}{y^{3}}+c \\
& =0
\end{aligned}
$$

## Example 6:

## Solve the initial value problems

(a) $\frac{d y}{d x}=(y-1)^{2}, \quad y(0)=1$
(b) $\frac{d y}{d x}=(y-1)^{2}, \quad y(0)=1.01$
and compare the solutions.

## Solutions:

1. Since $(y-1)^{2}=0 \Rightarrow y=1$. Therefore, the only constant solution is $y=0$.
2. We separate the variables

$$
\frac{d y}{(y-1)^{2}}=d x \quad \text { or }(y-1)^{-2} d y=d x
$$

Integrating both sides we have

$$
\begin{aligned}
& \int(y-1)^{-2} d y=\int d x \\
& \frac{(y-1)^{-2+1}}{-2+1}=x+c
\end{aligned}
$$

$$
\text { or } \quad-\frac{1}{y-1}=x+c
$$

3. All the solutions of the equation are

$$
\begin{aligned}
-\frac{1}{y-1} & =x+c \\
y & =1
\end{aligned}
$$

4. We plug in the conditions to find particular solutions of both the problems
(a) $y(0)=1 \Rightarrow y=1$ when $x=0$. So we have

$$
-\frac{1}{1-1}=0+c \Rightarrow c=-\frac{1}{0} \Rightarrow c=-\infty
$$

The particular solution is

$$
-\frac{1}{y-1}=-\infty \Rightarrow y-1=0
$$

So that the solution is $y=1$, which is same as constant solution.
(b) $y(0)=1.01 \Rightarrow y=1.01$ when $x=0$. So we have

$$
-\frac{1}{1.01-1}=0+c \Rightarrow c=-100
$$

So that solution of the problem is

$$
-\frac{1}{y-1}=x-100 \Rightarrow y=1+\frac{1}{100-x}
$$

5. Comparison: A radical change in the solutions of the differential equation has Occurred corresponding to a very small change in the condition!!

## Example 7:

Solve the initial value problems
(a) $\frac{d y}{d x}=(y-1)^{2}+0.01, \quad y(0)=1$
(b) $\frac{d y}{d x}=(y-1)^{2}-0.01, \quad y(0)=1$.

## Solution:

(a) First consider the problem

$$
\frac{d y}{d x}=(y-1)^{2}+0.01, \quad y(0)=1
$$

We separate the variables to find the non-constant solutions

$$
\frac{d y}{(\sqrt{0.01})^{2}+(y-1)^{2}}=d x
$$

Integrate both sides

$$
\int \frac{d(y-1)}{(\sqrt{0.01})^{2}+(y-1)^{2}}=\int d x
$$

So that

$$
\begin{aligned}
& \frac{1}{\sqrt{0.01}} \tan ^{-1} \frac{y-1}{\sqrt{0.01}}=x+c \\
& \tan ^{-1}\left(\frac{y-1}{\sqrt{0.01}}\right)=\sqrt{0.01}(x+c) \\
& \frac{y-1}{\sqrt{0.01}}=\tan [\sqrt{0.01}(x+c)]
\end{aligned}
$$

or $\quad y=1+\sqrt{0.01} \tan \lfloor\sqrt{0.01}(x+c)\rfloor$
Applying $\quad y(0)=1 \Rightarrow y=1$ when $x=0$, we have

$$
\tan ^{-1}(0)=\sqrt{0.01}(0+c) \Rightarrow 0=c
$$

Thus the solution of the problem is

$$
y=1+\sqrt{0.01} \tan (\sqrt{0.01} x)
$$

(b) Now consider the problem

$$
\frac{d y}{d x}=(y-1)^{2}-0.01, \quad y(0)=1
$$

We separate the variables to find the non-constant solutions

$$
\begin{aligned}
& \frac{d y}{(y-1)^{2}-(\sqrt{0.01})^{2}}=d x \\
& \int \frac{d(y-1)}{(y-1)^{2}-(\sqrt{0.01})^{2}}=\int d x \\
& \frac{1}{2 \sqrt{0.01}} \ln \left|\frac{y-1-\sqrt{0.01}}{y-1+\sqrt{0.01}}\right|=x+c
\end{aligned}
$$

Applying the condition $y(0)=1 \Rightarrow y=1$ when $x=0$

$$
\begin{aligned}
\frac{1}{2 \sqrt{0.01}} \ln \left|\frac{-\sqrt{0.01}}{\sqrt{0.01}}\right| & =c \Rightarrow c=0 \\
\ln \left|\frac{y-1-\sqrt{0.01}}{y-1+\sqrt{0.01}}\right| & =2 \sqrt{0.01} x \\
\frac{y-1-\sqrt{0.01}}{y-1+\sqrt{0.01}} & =\frac{e^{2 \sqrt{0.01} x}}{1}
\end{aligned}
$$

## Simplification:

By using the property $\quad \frac{a}{b}=\frac{c}{d} \Rightarrow \frac{a+b}{a-b}=\frac{c+d}{c-d}$

$$
\begin{gathered}
\frac{y-1-\sqrt{0.01}+y-1+\sqrt{0.01}}{y-1-\sqrt{0.01}-y+1-\sqrt{0.01}}=\frac{e^{2 \sqrt{0.01} x}+1}{e^{2 \sqrt{0.01} x}-1} \\
\frac{2 y-2}{-2 \sqrt{0.01}}=\frac{e^{2 \sqrt{0.01}}+1}{e^{2 \sqrt{0.01}}-1} \\
\frac{y-1}{-\sqrt{0.01}}=\frac{e^{2 \sqrt{0.01}}+1}{e^{2 \sqrt{0.01}}-1} \\
y-1=-\sqrt{0.01}\left(\frac{e^{2 \sqrt{0.01}}+1}{e^{2 \sqrt{0.01}}-1}\right) \\
y=1-\sqrt{0.01}\left(\frac{e^{2 \sqrt{0.01}}+1}{e^{2 \sqrt{0.01}}-1}\right)
\end{gathered}
$$

## Comparison:

The solutions of both the problems are
(a) $y=\quad 1+\sqrt{0.01} \tan (\sqrt{0.01} x)$
(b) $y=1-\sqrt{0.01}\left(\frac{e^{2 \sqrt{0.01}}+1}{e^{2 \sqrt{0.01}}-1}\right)$

Again a radical change has occurred corresponding to a very small in the differential equation!

## Exercise:

Solve the given differential equation by separation of variables.

1. $\frac{d y}{d x}=\left(\frac{2 y+3}{4 x+5}\right)^{2}$

## Lecture 4

## Homogeneous Differential Equations

A differential equation of the form

$$
\frac{d y}{d x}=f(x, y)
$$

Is said to be homogeneous if the function $f(x, y)$ is homogeneous, which means

$$
f(t x, t y)=t^{n} f(x, y) \text { For some real number n, for any number } t
$$

## Example 1

Determine whether the following functions are homogeneous

$$
\left\{\begin{array}{l}
f(x, y)=\frac{x y}{x^{2}+y^{2}} \\
g(x, y)=\ln \left(-3 x^{2} y /\left(x^{3}+4 x y^{2}\right)\right)
\end{array}\right.
$$

## Solution:

The functions $f(x, y)$ is homogeneous because

$$
f(t x, t y)=\frac{t^{2} x y}{t^{2}\left(x^{2}+y^{2}\right)}=\frac{x y}{x^{2}+y^{2}}=f(x, y)
$$

Similarly, for the function $g(x, y)$ we see that

$$
g(t x, t y)=\ln \left(\frac{-3 t^{3} x^{2} y}{t^{3}\left(x^{3}+4 x y^{2}\right)}\right)=\ln \left(\frac{-3 x^{2} y}{x^{3}+4 x y^{2}}\right)=g(x, y)
$$

Therefore, the second function is also homogeneous.
Hence the differential equations

$$
\left\{\begin{array}{l}
\frac{d y}{d x}=f(x, y) \\
\frac{d y}{d x}=g(x, y)
\end{array}\right.
$$

Are homogeneous differential equations

## Method of Solution:

To solve the homogeneous differential equation

$$
\frac{d y}{d x}=f(x, y)
$$

We use the substitution

$$
v=\frac{y}{x}
$$

If $f(x, y)$ is homogeneous of degree zero, then we have

$$
f(x, y)=f(1, v)=F(v)
$$

Since $y^{\prime}=x v^{\prime}+v$, the differential equation becomes

$$
x \frac{d v}{d x}+v=f(1, v)
$$

This is a separable equation. We solve and go back to old variable $y$ through $y=x V$.

## Summary:

1. Identify the equation as homogeneous by checking $f(t x, t y)=t^{n} f(x, y)$;
2. Write out the substitution $v=\frac{y}{x}$;
3. Through easy differentiation, find the new equation satisfied by the new function $v$;

$$
x \frac{d v}{d x}+v=f(1, v)
$$

4. Solve the new equation (which is always separable) to find $V$;
5. Go back to the old function $y$ through the substitution $y=v x$;
6. If we have an IVP, we need to use the initial condition to find the constant of integration.

## Caution:

- Since we have to solve a separable equation, we must be careful about the constant solutions.
- If the substitution $y=v x$ does not reduce the equation to separable form then the equation is not homogeneous or something is wrong along the way.


## Illustration:

Example 2 Solve the differential equation

$$
\frac{d y}{d x}=\frac{-2 x+5 y}{2 x+y}
$$

## Solution:

Step 1. It is easy to check that the function

$$
f(x, y)=\frac{-2 x+5 y}{2 x+y}
$$

is a homogeneous function.
Step 2. To solve the differential equation we substitute

$$
v=\frac{y}{x}
$$

Step 3. Differentiating w.r.t $X$, we obtain

$$
x v^{\prime}+v=\frac{-2 x+5 x v}{2 x+x v}=\frac{-2+5 v}{2+v}
$$

which gives

$$
\frac{d v}{d x}=\frac{1}{x}\left(\frac{-2+5 v}{2+v}-v\right)
$$

This is a separable. At this stage please refer to the Caution!
Step 4. Solving by separation of variables all solutions are implicitly given by

$$
-4 \ln (|v-2|)+3 \ln |v-1|=\ln (|x|)+C
$$

Step 5. Going back to the function $y$ through the substitution $y=v x$, we get

$$
-4 \ln |y-2 x|+3 \ln |y-x|=C
$$

$$
\begin{aligned}
& -4 \ln \left|\frac{y-2 x}{x}\right|+3 \ln \left|\frac{y-x}{x}\right|=\ln |x|+c \\
& \ln \left|\frac{y-2 x}{x}\right|^{-4}+\ln \left|\frac{y-x}{x}\right|^{3}=\ln x+\ln c_{1}, c=\ln c_{1} \\
& x^{-4} \\
& \left.\ln |+\ln | \frac{(y-x)^{3}}{x^{3}} \right\rvert\,=\ln c_{1} x \\
& x^{-4} \\
& \left.\frac{(y-2 x)^{-4}}{x^{-4}} \cdot \frac{(y-x)^{3}}{x^{3}} \right\rvert\,=\ln c_{1} x \\
& x(y-2 x)^{3} \\
& x^{3}(y-x)^{3}=c_{1} x \\
& (y-2 x)^{-4}(y-x)^{3}=c_{1}
\end{aligned}
$$

Note that the implicit equation can be rewritten as

$$
(y-x)^{3}=C_{1}(y-2 x)^{4}
$$

## Equations reducible to homogenous form

The differential equation

$$
\frac{d y}{d x}=\frac{a_{1} x+b_{1} y+c_{1}}{a_{2} x+b_{2} y+c_{2}}
$$

is not homogenous. However, it can be reduced to a homogenous form as detailed below

Case 1: $\frac{a_{1}}{a_{2}}=\frac{b_{1}}{b_{2}}$
We use the substitution $Z=a_{1} x+b_{1} y$ which reduces the equation to a separable equation in the variables $X$ and $Z$. Solving the resulting separable equation and replacing $z$ with $a_{1} x+b_{1} y$, we obtain the solution of the given differential equation.

Case 2: $\frac{a_{1}}{a_{2}} \neq \frac{b_{1}}{b_{2}}$
In this case we substitute

$$
x=X+h, \quad y=Y+k
$$

Where $h$ and $k$ are constants to be determined. Then the equation becomes

$$
\frac{d Y}{d X}=\frac{a_{1} X+b_{1} Y+a_{1} h+b_{1} k+c_{1}}{a_{2} X+b_{2} Y+a_{2} h+b_{2} k+c_{2}}
$$

We choose $h$ and $k$ such that

$$
\left.\begin{array}{l}
a_{1} h+b_{1} k+c_{1}=0 \\
a_{2} h+b_{2} k+c_{2}=0
\end{array}\right\}
$$

This reduces the equation to

$$
\frac{d Y}{d X}=\frac{a_{1} X+b_{1} Y}{a_{2} X+b_{2} Y}
$$

Which is homogenous differential equation in $X$ and $Y$, and can be solved accordingly. After having solved the last equation we come back to the old variables $x$ and $y$.

## Example 3

Solve the differential equation

$$
\frac{d y}{d x}=-\frac{2 x+3 y-1}{2 x+3 y+2}
$$

## Solution:

Since $\frac{a_{1}}{a_{2}}=1=\frac{b_{1}}{b_{2}}$, we substitute $z=2 x+3 y$, so that

$$
\frac{d y}{d x}=\frac{1}{3}\left(\frac{d z}{d x}-2\right)
$$

Thus the equation becomes

$$
\frac{1}{3}\left(\frac{d z}{d x}-2\right)=-\frac{z-1}{z+2}
$$

i.e.

$$
\frac{d z}{d x}=\frac{-z+7}{z+2}
$$

This is a variable separable form, and can be written as

$$
\left(\frac{z+2}{-z+7}\right) d z=d x
$$

Integrating both sides we get

$$
-z-9 \ln (z-7)=x+A
$$

Simplifying and replacing $z$ with $2 x+3 y$, we obtain
or

$$
-\ln (2 x+3 y-7)^{9}=3 x+3 y+A
$$

$$
(2 x+3 y-7)^{-9}=c e^{3(x+y)}, \quad c=e^{A}
$$

## Example 4

Solve the differential equation

$$
\frac{d y}{d x}=\frac{(x+2 y-4)}{2 x+y-5}
$$

## Solution:

By substitution

$$
x=X+h, \quad y=Y+k
$$

The given differential equation reduces to

$$
\frac{d Y}{d X}=\frac{(X+2 Y)+(h+2 k-4)}{(2 X+Y)+(2 h+k-5)}
$$

We choose $h$ and $k$ such that

$$
h+2 k-4=0, \quad 2 h+k-5=0
$$

Solving these equations we have $h=2, k=1$. Therefore, we have

$$
\frac{d Y}{d X}=\frac{X+2 Y}{2 X+Y}
$$

This is a homogenous equation. We substitute $Y=V X$ to obtain

$$
X \frac{d V}{d X}=\frac{1-V^{2}}{2+V} \text { or }\left[\frac{2+V}{1-V^{2}}\right] d V=\frac{d X}{X}
$$

Resolving into partial fractions and integrating both sides we obtain

$$
\int\left[\frac{3}{2(1-V)}+\frac{1}{2(1+V)}\right] d V=\int \frac{d X}{X}
$$

or

$$
-\frac{3}{2} \ln (1-V)+\frac{1}{2} \ln (1+V)=\ln X+\ln A
$$

Simplifying and removing (ln ) from both sides, we get

$$
(1-V)^{3} /(1+V)=C X^{-2}, C=A^{-2}
$$

$$
\begin{aligned}
& -\frac{3}{2} \ln (1-V)+\frac{1}{2} \ln (1+V)=\ln X+\ln \\
& \ln (1-V)^{-3 / 2}+\ln (1+V)^{1 / 2}=\ln X A \\
& \ln (1-V)^{-3 / 2}(1+V)^{1 / 2}=\ln X A \\
& (1-V)^{-3 / 2}(1+V)^{1 / 2}=X A \\
& \text { taking power }-2 \text { "on both sides } \\
& (1-V)^{3}(1+V)^{-1}=X^{-2} A^{-2} \\
& \text { put } V=\frac{Y}{X} \\
& \left(1-\frac{Y}{X}\right)^{3}\left(1+\frac{Y}{X}\right)^{-1}=X^{-2} A^{-2} \\
& \left(\frac{X-Y}{X}\right)^{3}\left(\frac{X+Y}{X}\right)^{-1}=X^{-2} A^{-2} \\
& \frac{(X-Y)^{3}}{X+Y} X^{-3+1}=X^{-2} A^{-2} \\
& \text { Say, } c=A^{-2} \\
& (X-Y)^{3} \\
& X+Y=c \\
& \text { put } X=x-2, Y=y-1 \\
& (x+y-1)^{3} / x+y-3=c
\end{aligned}
$$

Now substituting $V=\frac{Y}{X}, X=x-2, Y=y-1$ and simplifying, we obtain $(x-y-1)^{3} /(x+y-3)=C$

This is solution of the given differential equation, an implicit one.

## Solve the following Differential Equations

1. $\left(x^{4}+y^{4}\right) d x-2 x^{3} y d y=0$
2. $\frac{d y}{d x}=\frac{y}{x}+\frac{x^{2}}{y^{2}}+1$
3. $\left(x^{2} e^{\frac{-y}{x}}+y^{2}\right) d x=x y d y$
4. $y d x+\left(y \cos \frac{x}{y}-x\right) d y=0$
5. $\left(x^{3}+y^{2} \sqrt{x^{2}+y^{2}}\right) d x-x y \sqrt{x^{2}+y^{2}} d y=0$

Solve the initial value problems

## Lecture 5

Exact Differential Equations
Let us first rewrite the given differential equation

$$
\frac{d y}{d x}=f(x, y)
$$

into the alternative form

$$
M(x, y) d x+N(x, y) d y=0 \quad \text { where } f(x, y)=-\frac{M(x, y)}{N(x, y)}
$$

This equation is an exact differential equation if the following condition is satisfied

$$
\frac{\partial M}{\partial y}=\frac{\partial N}{\partial x}
$$

This condition of exactness insures the existence of a function $F(x, y)$ such that

$$
\frac{\partial F}{\partial x}=M(x, y), \frac{\partial F}{\partial y}=N(x, y)
$$

## Method of Solution:

If the given equation is exact then the solution procedure consists of the following steps:
Step 1. Check that the equation is exact by verifying the condition $\frac{\partial M}{\partial y}=\frac{\partial N}{\partial x}$
Step 2. Write down the system $\frac{\partial F}{\partial x}=M(x, y), \frac{\partial F}{\partial y}=N(x, y)$
Step 3. Integrate either the $1^{\text {st }}$ equation w. r. to $\boldsymbol{x}$ or $2^{\text {nd }} w . r$. to $\boldsymbol{y}$. If we choose the $1^{\text {st }}$ equation then

$$
F(x, y)=\int M(x, y) d x+\theta(y)
$$

The function $\theta(y)$ is an arbitrary function of $y$, integration w.r.to $x ; y$ being constant.
Step 4. Use second equation in step 2 and the equation in step 3 to find $\theta^{\prime}(y)$.

$$
\begin{aligned}
& \frac{\partial F}{\partial y}=\frac{\partial}{\partial y}\left(\int M(x, y) d x\right)+\theta^{\prime}(y)=N(x, y) \\
& \theta^{\prime}(y)=N(x, y)-\frac{\partial}{\partial y} \int M(x, y) d x
\end{aligned}
$$

Step 5. Integrate to find $\theta(y)$ and write down the function $F(x, y)$,
Step 6. All the solutions are given by the implicit equation

$$
F(x, y)=C
$$

Step 7. If you are given an IVP, plug in the initial condition to find the constant $C$.

Caution: $X$ should disappear from $\theta^{\prime}(y)$. Otherwise something is wrong!

## Example 1

Solve

$$
\left(3 x^{2} y+2\right) d x+\left(x^{3}+y\right) d y=0
$$

Solution: Here $M=3 x^{2} y+2$ and $N=x^{3}+y$

$$
\frac{\partial M}{\partial y}=3 x^{2}, \frac{\partial N}{\partial x}=3 x^{2}
$$

i.e. $\frac{\partial M}{\partial y}=\frac{\partial N}{\partial x}$

Hence the equation is exact. The LHS of the equation must be an exact differential i.e. $\exists$ a function $f(x, y)$ such that

$$
\begin{aligned}
& \frac{\partial f}{\partial x}=3 x^{2} y+2=M \\
& \frac{\partial f}{\partial y}=x^{3}+y=N
\end{aligned}
$$

Integrating $1^{\text {st }}$ of these equations w. r. t. $x$, have

$$
f(x, y)=x^{3} y+2 x+h(y)
$$

where $h(y)$ is the constant of integration. Differentiating the above equation w. r. t. $y$ and using 2nd, we obtain

$$
\frac{\partial f}{\partial y}=x^{3}+h^{\prime}(y)=x^{3}+y=N
$$

Comparing $\quad h^{\prime}(y)=y \quad$ is independent of $x$.
or.
Integrating, we have

$$
h(y)=\frac{y^{2}}{2}
$$

Thus

$$
f(x, y)=x^{3} y+2 x+\frac{y^{2}}{2}
$$

Hence the general solution of the given equation is given by

$$
f(x, y)=c
$$

i.e.

$$
x^{3} y+2 x+\frac{y^{2}}{2}=c
$$

Note that we could start with the $2^{\text {nd }}$ equation

$$
\frac{\partial f}{\partial y}=x^{3}+y=N
$$

to reach on the above solution of the given equation!

## Example 2

Solve the initial value problem

$$
\begin{gathered}
\left(2 y \sin x \cos x+y^{2} \sin x\right) d x+\left(\sin ^{2} x-2 y \cos x\right) d y=0 \\
y(0)=3
\end{gathered}
$$

Solution: Here

$$
M=2 y \sin x \cos x+y^{2} \sin x
$$

and

$$
\begin{aligned}
& N=\sin ^{2} x-2 y \cos x \\
& \frac{\partial M}{\partial y}=2 \sin x \cos x+2 y \sin x
\end{aligned}
$$

$$
\frac{\partial N}{\partial x}=2 \sin x \cos x+2 y \sin x \text {, }
$$

This implies

$$
\frac{\partial M}{\partial y}=\frac{\partial N}{\partial x}
$$

Thus given equation is exact.
Hence there exists a function $f(x, y)$ such that

$$
\frac{\partial f}{\partial x}=2 y \sin x \cos x+y^{2} \sin x=M
$$

$$
\frac{\partial f}{\partial y}=\sin ^{2} x-2 y \cos x=N
$$

Integrating $1^{\text {st }}$ of these w. r. t. $x$, we have

$$
f(x, y)=y \sin ^{2} x-y^{2} \cos x+h(y)
$$

Differentiating this equation w. r. t. $y$ substituting in $\frac{\partial f}{\partial y}=N$

$$
\begin{aligned}
& \sin ^{2} x-2 y \cos x+h^{\prime}(y)=\sin ^{2} x-2 y \cos x \\
& h^{\prime}(y)=0 \text { or } h(y)=c_{1}
\end{aligned}
$$

Hence the general solution of the given equation is

$$
f(x, y)=c_{2}
$$

i.e. $\quad y \sin ^{2} x-y^{2} \cos x=C$, where $C=c_{1}-c_{2}$

Applying the initial condition that when $x=0, y=3$, we have

$$
-9=c
$$

since

$$
y^{2} \cos x-y \sin ^{2} x=9
$$

is the required solution.

## Example 3:

Solve the DE

$$
\left(e^{2 y}-y \cos x y\right) d x+\left(2 x e^{2 y}-x \cos x y+2 y\right) d y=0
$$

## Solution:

The equation is neither separable nor homogenous.

Since,

$$
\begin{aligned}
& M(x, y)=e^{2 y}-y \cos x y \\
& N(x, y)=2 x e^{2 y}-x \cos x y+2 y
\end{aligned}
$$

and

$$
\frac{\partial M}{\partial y}=2 e^{2 y}+x y \sin x y-\cos x y=\frac{\partial N}{\partial x}
$$

Hence the given equation is exact and a function $f(x, y)$ exist for which

$$
M(x, y)=\frac{\partial f}{\partial x} \text { and } N(x, y)=\frac{\partial f}{\partial y}
$$

which means that

$$
\frac{\partial f}{\partial x}=e^{2 y}-y \cos x y \text { and } \frac{\partial f}{\partial y}=2 x e^{2 y}-x \cos x y+2 y
$$

Let us start with the second equation i.e.

$$
\frac{\partial f}{\partial y}=2 x e^{2 y}-x \cos x y+2 y
$$

Integrating both sides w.r.to $y$, we obtain

$$
f(x, y)=2 x \int e^{2 y} d y-x \int \cos x y d y+2 \int y d y
$$

Note that while integrating w.r.to $y, x$ is treated as constant. Therefore

$$
f(x, y)=x e^{2 y}-\sin x y+y^{2}+h(x)
$$

$h$ is an arbitrary function of $x$. From this equation we obtain $\frac{\partial f}{\partial x}$ and equate it to $M$

So that

$$
\begin{gathered}
\frac{\partial f}{\partial x}=e^{2 y}-y \cos x y+h^{\prime}(x)=e^{2 y}-y \cos x y \\
h^{\prime}(x)=0 \Rightarrow h(x)=C
\end{gathered}
$$

Hence a one-parameter family of solution is given by

$$
x e^{2 y}-\sin x y+y^{2}+c=0
$$

## Example 4

Solve

$$
2 x y d x+\left(x^{2}-1\right) d y=0
$$

## Solution:

Clearly $M(x, y)=2 x y \quad$ and $\quad N(x, y)=x^{2}-1$

Therefore

$$
\frac{\partial M}{\partial y}=2 x=\frac{\partial N}{\partial x}
$$

The equation is exact and $\exists$ a function $f(x, y)$ such that

$$
\frac{\partial f}{\partial x}=2 x y \text { and } \frac{\partial f}{\partial y}=x^{2}-1
$$

We integrate first of these equations to obtain.

$$
f(x, y)=x^{2} y+g(y)
$$

Here $g(y)$ is an arbitrary function $y$. We find $\frac{\partial f}{\partial y}$ and equate it to $N(x, y)$

$$
\frac{\partial f}{\partial y}=x^{2}+g^{\prime}(y)=x^{2}-1
$$

$$
g^{\prime}(y)=-1 \Rightarrow g(y)=-y
$$

Constant of integration need not to be included as the solution is given by

$$
f(x, y)=c
$$

Hence a one-parameter family of solutions is given by

$$
x^{2} y-y=c
$$

## Example 5

Solve the initial value problem

$$
\left(\cos x \sin x-x y^{2}\right) d x+y\left(1-x^{2}\right) d y=0, y(0)=2
$$

## Solution:

Since

$$
\left\{\begin{array}{l}
M(x, y)=\cos x \cdot \sin x-x y^{2} \\
N(x, y)=y\left(1-x^{2}\right)
\end{array}\right.
$$

and

$$
\frac{\partial M}{\partial y}=-2 x y=\frac{\partial N}{\partial x}
$$

Therefore the equation is exact and $\exists$ a function $f(x, y)$ such that

$$
\frac{\partial f}{\partial x}=\cos x \cdot \sin x-x y^{2} \text { and } \frac{\partial f}{\partial y}=y\left(1-x^{2}\right)
$$

Now integrating $2{ }^{\text {nd }}$ of these equations w.r.t. ' $y$ ' keeping ' $x$ 'constant, we obtain

$$
f(x, y)=\frac{y^{2}}{2}\left(1-x^{2}\right)+h(x)
$$

Differentiate w.r.t. ' $X$ ' and equate the result to $M(x, y)$

$$
\frac{\partial f}{\partial x}=-x y^{2}+h^{\prime}(x)=\cos x \sin x-x y^{2}
$$

The last equation implies that.

$$
h^{\prime}(x)=\cos x \sin x
$$

Integrating w.r.to $X$, we obtain

$$
h(x)=-\int(\cos x)(-\sin x) d x=-\frac{1}{2} \cos ^{2} x
$$

Thus a one parameter family solutions of the given differential equation is

$$
\frac{y^{2}}{2}\left(1-x^{2}\right)-\frac{1}{2} \cos ^{2} x=c_{1}
$$

or

$$
y^{2}\left(1-x^{2}\right)-\cos ^{2} x=c
$$

where $2 c_{1}$ has been replaced by $C$. The initial condition $y=2$ when $x=0$ demand, that $4(1)-\cos ^{2}(0)=c$ so that $c=3$. Thus the solution of the initial value problem is

$$
y^{2}\left(1-x^{2}\right)-\cos ^{2} x=3
$$

1. $(\sin y-y \sin x) d x+(\cos x+x \cos y) d y=0$
2. $\left(1+\ln x+\frac{y}{x}\right) d x=(1-\ln x) d y$

## Lecture - 6

## Integrating Factor Technique

If the equation

$$
M(x, y) d x+N(x, y) d y=0
$$

is not exact, then we must have

$$
\frac{\partial M}{\partial y} \neq \frac{\partial N}{\partial x}
$$

Therefore, we look for a function $\boldsymbol{u}(x, y)$ such that the equation

$$
u(x, y) M(x, y) d x+u(x, y) N(x, y) d y=0
$$

becomes exact. The function $\mathbf{u}(\boldsymbol{x}, \boldsymbol{y})$ (if it exists) is called the integrating factor (IF) and it satisfies the equation due to the condition of exactness.

$$
\frac{\partial M}{\partial y} u+\frac{\partial u}{\partial y} M=\frac{\partial N}{\partial x} u+\frac{\partial u}{\partial x} N
$$

This is a partial differential equation and is very difficult to solve. Consequently, the determination of the integrating factor is extremely difficult except for some special cases:

## Example

Show that $1 /\left(x^{2}+y^{2}\right)$ is an integrating factor for the equation $\left(x^{2}+y^{2}-x\right) d x-y d y=0$, and then solve the equation.

Solution: Since

$$
M=x^{2}+y^{2}-x, \quad \mathrm{~N}=-y
$$

Therefore

$$
\frac{\partial M}{\partial y}=2 y, \quad \frac{\partial N}{\partial x}=0
$$

So that

$$
\frac{\partial M}{\partial y} \neq \frac{\partial N}{\partial x}
$$

and the equation is not exact. However, if the equation is multiplied by $1 /\left(x^{2}+y^{2}\right)$ then the equation becomes

$$
\left(1-\frac{x}{x^{2}+y^{2}}\right) d x-\frac{y}{x^{2}+y^{2}} d y=0
$$

Now

$$
M=1-\frac{x}{x^{2}+y^{2}} \quad \text { and } \quad N=-\frac{y}{x^{2}+y^{2}}
$$

Therefore

$$
\frac{\partial M}{\partial y}=\frac{2 x y}{\left(x^{2}+y^{2}\right)^{2}}=\frac{\partial N}{\partial x}
$$

So that this new equation is exact. The equation can be solved. However, it is simpler to observe that the given equation can also written

$$
\begin{gathered}
d x-\frac{x d x+y d y}{x^{2}+y^{2}}=0 \quad \text { or } \quad d x-\frac{1}{2} d\left[\ln \left(x^{2}+y^{2}\right)\right]=0 \\
d\left[x-\frac{\ln \left(x^{2}+y^{2}\right)}{2}\right]=0
\end{gathered}
$$

Hence, by integration, we have

$$
x-\ln \sqrt{x^{2}+y^{2}}=k
$$

## Case 1:

When $\exists$ an integrating factor $u(x)$, a function of $x$ only. This happens if the expression

$$
\frac{\frac{\partial M}{\partial y}-\frac{\partial N}{\partial x}}{N}
$$

is a function of $x$ only.
Then the integrating factor $u(x, y)$ is given by

$$
u=\exp \left(\int \frac{\frac{\partial M}{\partial y}-\frac{\partial N}{\partial x}}{N} d x\right)
$$

## Case 2:

When $\exists$ an integrating factor $u(y)$, a function of $y$ only. This happens if the expression
$\frac{\frac{\partial N}{\partial x}-\frac{\partial M}{\partial y}}{M}$
is a function of $y$ only. Then $\operatorname{IF} u(x, y)$ is given by

$$
u=\exp \left(\int \frac{\frac{\partial N}{\partial x}-\frac{\partial M}{\partial y}}{M} d y\right)
$$

## Case 3:

If the given equation is homogeneous and

Then

$$
\begin{aligned}
& x M+y N \neq 0 \\
& u=\frac{1}{x M+y N}
\end{aligned}
$$

## Case 4:

If the given equation is of the form
and
Then

$$
\begin{aligned}
& y f(x y) d x+x g(x y) d y=0 \\
& x M-y N \neq 0 \\
& u=\frac{1}{x M-y N}
\end{aligned}
$$

Once the IF is found, we multiply the old equation by $u$ to get a new one, which is exact. Solve the exact equation and write the solution.

Advice: If possible, we should check whether or not the new equation is exact?

## Summary:

Step 1. Write the given equation in the form

$$
M(x, y) d x+N(x, y) d y=0
$$

provided the equation is not already in this form and determine $M$ and $N$.
Step 2. Check for exactness of the equation by finding whether or not

$$
\frac{\partial M}{\partial y}=\frac{\partial N}{\partial x}
$$

Step 3. (a) If the equation is not exact, then evaluate

$$
\frac{\frac{\partial M}{\partial y}-\frac{\partial N}{\partial x}}{N}
$$

If this expression is a function of $X$ only, then

$$
u(x)=\exp \left(\int \frac{\frac{\partial M}{\partial y}-\frac{\partial N}{\partial x}}{N} d x\right.
$$

Otherwise, evaluate

$$
\frac{\frac{\partial N}{\partial x}-\frac{\partial M}{\partial y}}{M}
$$

If this expression is a function of $y$ only, then

$$
u(y)=\exp \left(\int \frac{\frac{\partial N}{\partial x}-\frac{\partial M}{\partial y}}{M} d y\right)
$$

In the absence of these 2 possibilities, better use some other technique. However, we could also try cases 3 and 4 in step 4 and 5
Step 4. Test whether the equation is homogeneous and

If yes then

$$
u=\frac{1}{x M+y N}
$$

Step 5. Test whether the equation is of the form

$$
y f(x y) d x+x g(x y) d y=0
$$

and whether

$$
x M-y N \neq 0
$$

If yes then

$$
u=\frac{1}{x M-y N}
$$

Step 6. Multiply old equation by $u$. if possible, check whether or not the new equation is exact?
Step 7. Solve the new equation using steps described in the previous section.

## Illustration:

## Example 1

Solve the differential equation

$$
\frac{d y}{d x}=-\frac{3 x y+y^{2}}{x^{2}+x y}
$$

## Solution:

1. The given differential equation can be written in form

$$
\left(3 x y+y^{2}\right) d x+\left(x^{2}+x y\right) d y=0
$$

Therefore

$$
M(x, y)=3 x y+y^{2}
$$

$$
N(x, y)=x^{2}+x y
$$

2. Now

$$
\begin{aligned}
& \frac{\partial M}{\partial y}=3 x+2 y, \frac{\partial N}{\partial x}=2 x+y \\
& \therefore \quad \frac{\partial M}{\partial y} \neq \frac{\partial N}{\partial x}
\end{aligned}
$$

3. To find an IF we evaluate

$$
\frac{\frac{\partial M}{\partial y}-\frac{\partial N}{\partial x}}{N}=\frac{1}{x}
$$

which is a function of $x$ only.
4.Therefore, an IF $u(x)$ exists and is given by

$$
u(x)=e^{\int \frac{1}{x} d x}=e^{\ln (x)}=x^{x}
$$

5. Multiplying the given equation with the IF, we obtain

$$
\left(3 x^{2} y+x y^{2}\right) d x+\left(x^{3}+x^{2} y\right) d y=0
$$

which is exact. (Please check!)
6. This step consists of solving this last exact differential equation.

## Solution of new exact equation:

1. Since $\frac{\partial M}{\partial y}=3 x^{2}+2 x y=\frac{\partial N}{\partial x}$, the equation is exact.
2. We find $F(x, y)$ by solving the system

$$
\left\{\begin{array}{l}
\frac{\partial F}{\partial x}=3 x^{2} y+x y^{2} \\
\frac{\partial F}{\partial y}=x^{3}+x^{2} y
\end{array}\right.
$$

3. We integrate the first equation to get

$$
F(x, y)=x^{3} y+\frac{x^{2}}{2} y^{2}+\theta(y)
$$

4. We differentiate $F$ w.r. t. ' $\mathbf{y}$ ' and use the second equation of the system in step 2 to obtain

$$
\begin{aligned}
& \frac{\partial F}{\partial y}=x^{3}+x^{2} y+\theta^{\prime}(y)=x^{3}+x^{2} y \\
& \Rightarrow \theta^{\prime}=0, \text { No dependence on } x
\end{aligned}
$$

5. Integrating the last equation to obtain $\theta=C$. Therefore, the function $F(x, y)$ is

$$
F(x, y)=x^{3} y+\frac{x^{2}}{2} y^{2}
$$

We don't have to keep the constant $C$, see next step.
6. All the solutions are given by the implicit equation $F(x, y)=C$ i.e.

$$
x^{3} y+\frac{x^{2} y^{2}}{2}=C
$$

Note that it can be verified that the function

$$
u(x, y)=\frac{1}{2 x y(2 x+y)}
$$

is another integrating factor for the same equation as the new equation

$$
\frac{1}{2 x y(2 x+y)}\left(3 x y+y^{2}\right) d x+\frac{1}{2 x y(2 x+y)}\left(x^{2}+x y\right) d y=0
$$

is exact. This means that we may not have uniqueness of the integrating factor.

## Example 2. Solve

$$
\left(x^{2}-2 x+2 y^{2}\right) d x+2 x y d y=0
$$

## Solution:

$$
\begin{aligned}
& M=x^{2}-2 x+2 y^{2} \\
& N=2 x y \\
& \frac{\partial M}{\partial y}=4 y, \frac{\partial N}{\partial x}=2 y \\
& \therefore \frac{\partial M}{\partial y} \neq \frac{\partial N}{\partial x}
\end{aligned}
$$

The equation is not exact.

Here

$$
\frac{M_{y}-N_{x}}{N}=\frac{4 y-2 y}{2 x y}=\frac{1}{x}
$$

Therefore, I.F. is given by

$$
\begin{aligned}
& u=\exp \left(\int \frac{1}{x} d x\right) \\
& u=x
\end{aligned}
$$

$\therefore$ I.F is $x$.
Multiplying the equation by $x$, we have

$$
\left(x^{3}-2 x^{2}+2 x y^{2}\right) d x+2 x^{2} y d y=0
$$

This equation is exact. The required Solution is

$$
\begin{aligned}
& \frac{x^{4}}{4}-\frac{2 x^{3}}{3}+x^{2} y^{2}=c_{0} \\
& 3 x^{4}-8 x^{3}+12 x^{2} y^{2}=c
\end{aligned}
$$

## Example 3

Solve $d x+\left(\frac{x}{y}-\sin y\right) d y=0$
Solution: Here

$$
\begin{aligned}
& M=1, \quad N=\frac{x}{y}-\sin y \\
& \frac{\partial M}{\partial y}=0, \quad \frac{\partial N}{\partial x}=\frac{1}{y} \\
& \therefore \frac{\partial M}{\partial y} \neq \frac{\partial N}{\partial x}
\end{aligned}
$$

The equation is not exact.
Now

$$
\frac{N_{x}-M_{y}}{M}=\frac{\frac{1}{y}-0}{1}=\frac{1}{y}
$$

Therefore, the IF is

$$
u(y)=\exp \int \frac{d y}{y}=y
$$

Multiplying the equation by $y$, we have

$$
y d x+(x-y \sin y) d y=0
$$

or $\quad y d x+x d y-y \sin y d y=0$
or

$$
d(x y)-y \sin y d y=0
$$

Integrating, we have

$$
x y+y \cos y-\sin y=c
$$

Which is the required solution.

## Example 4

Solve

$$
\left(x^{2} y-2 x y^{2}\right) d x-\left(x^{3}-3 x^{2} y\right) d y=0
$$

Solution: Comparing with

$$
M d x+N d y=0
$$

we see that

$$
M=x^{2} y-2 x y^{2} \quad \text { and } \quad \mathrm{N}=-\left(x^{3}-3 x^{2} y\right)
$$

Since both $M$ and $N$ are homogeneous. Therefore, the given equation is homogeneous. Now

$$
x M+y N=x^{3} y-2 x^{2} y^{2}-x^{3} y+3 x^{2} y^{2}=x^{2} y^{2} \neq 0
$$

Hence, the factor $u$ is given by

$$
u=\frac{1}{x^{2} y^{2}} \quad \because u=\frac{1}{x M+y N}
$$

Multiplying the given equation with the integrating factor $u$, we obtain.

$$
\left(\frac{1}{y}-\frac{2}{x}\right) d x-\left(\frac{x}{y^{2}}-\frac{3}{y}\right) d y=0
$$

Now

$$
M=\frac{1}{y}-\frac{2}{x} \quad \text { and } \quad \mathrm{N}=\frac{-x}{y^{2}}+\frac{3}{y}
$$

and therefore

$$
\frac{\partial M}{\partial y}=-\frac{1}{y^{2}}=\frac{\partial N}{\partial x}
$$

Therefore, the new equation is exact and solution of this new equation is given by

$$
\frac{x}{y}-2 \ln |x|+3 \ln |y|=C
$$

## Example 5

Solve

$$
y\left(x y+2 x^{2} y^{2}\right) d x+x\left(x y-x^{2} y^{2}\right) d y=0
$$

## Solution:

The given equation is of the form

$$
y f(x y) d x+x g(x y) d y=0
$$

Now comparing with

$$
M d x+N d y=0
$$

We see that

$$
M=y\left(x y+2 x^{2} y^{2}\right) \text { and } \mathrm{N}=x\left(x y-x^{2} y^{2}\right)
$$

Further

$$
\begin{aligned}
x M-y N & =x^{2} y^{2}+2 x^{3} y^{3}-x^{2} y^{2}+x^{3} y^{3} \\
& =3 x^{3} y^{3} \neq 0
\end{aligned}
$$

Therefore, the integrating factor $u$ is

$$
u=\frac{1}{3 x^{3} y^{3}}, \quad \because u=\frac{1}{x M-y N}
$$

Now multiplying the given equation by the integrating factor, we obtain

$$
\frac{1}{3}\left(\frac{1}{x^{2} y}+\frac{2}{x}\right) d x+\frac{1}{3}\left(\frac{1}{x y^{2}}-\frac{1}{y}\right) d y=0
$$

Therefore, solutions of the given differential equation are given by

$$
-\frac{1}{x y}+2 \ln |x|-\ln |y|=C
$$

where $3 \mathrm{C}_{0}=\mathrm{C}$

## Lecture 7

## First Order Linear Equations

The differential equation of the form:

$$
a(x) \frac{d y}{d x}+b(x) y=c(x)
$$

is a linear differential equation of first order. The equation can be rewritten in the following famous form.

$$
\frac{d y}{d x}+p(x) y=q(x)
$$

where $p(x)$ and $q(x)$ are continuous functions.

## Method of solution:

The general solution of the first order linear differential equation is given by

$$
\begin{aligned}
& y=\frac{\int u(x) q(x) d x+C}{u(x)} \\
& \text { Where } u(x)=\exp \left(\int p(x) d x\right)
\end{aligned}
$$

The function $u(x)$ is called the integrating factor. If it is an IVP then use it to find the constant $C$.

## Summary:

1. Identify that the equation is $1^{\text {st }}$ order linear equation. Rewrite it in the form

$$
\frac{d y}{d x}+p(x) y=q(x)
$$

if the equation is not already in this form.
2. Find the integrating factor

$$
u(x)=e^{\int p(x) d x}
$$

3. Write down the general solution

$$
y=\frac{\int u(x) q(x) d x+C}{u(x)}
$$

4. If you are given an IVP, use the initial condition to find the constant $C$.
5. Plug in the calculated value to write the particular solution of the problem.

## Example 1:

Solve the initial value problem

$$
y^{\prime}+\tan (x) y=\cos ^{2}(x), \quad y(0)=2
$$

## Solution:

1.The equation is already in the standard form

$$
\frac{d y}{d x}+p(x) y=q(x)
$$

with

$$
\left\{\begin{array}{l}
p(x)=\tan x \\
q(x)=\cos ^{2} x
\end{array}\right.
$$

2. Since

$$
\int \tan x d x=-\ln \cos x=\ln \sec x
$$

Therefore, the integrating factor is given by

$$
u(x)=e^{\int \tan x d x}=\sec x
$$

3. Further, because

$$
\int \sec x \cos ^{2} x d x=\int \cos x d x=\sin x
$$

So that the general solution is given by

$$
y=\frac{\sin x+C}{\sec x}=(\sin x+C) \cos x
$$

4. We use the initial condition $y(0)=2$ to find the value of the constant $C$

$$
y(0)=C=2
$$

5. Therefore the solution of the initial value problem is

$$
y=(\sin x+2) \cos x
$$

Example 2: Solve the IVP

$$
\frac{d y}{d t}-\frac{2 t}{1+t^{2}} y=\frac{2}{1+t^{2}}, \quad y(0)=0.4
$$

## Solution:

1.The given equation is a $1^{\text {st }}$ order linear and is already in the requisite form

$$
\frac{d y}{d x}+p(x) y=q(x)
$$

$$
\left\{\begin{array}{l}
p(t)=-\frac{2 t}{1+t^{2}} \\
q(t)=\frac{2}{1+t^{2}}
\end{array}\right.
$$

2. Since
with

$$
\left.\int\left(-\frac{2 t}{1+t^{2}}\right) d t=-\ln \right\rvert\, 1+t^{2}
$$

Therefore, the integrating factor is given by

$$
u(t)=e^{\int-\frac{2 t}{1+t^{2}} d t}=\left(1+t^{2}\right)^{-1}
$$

3. Hence, the general solution is given by

Now

$$
\begin{aligned}
& y=\frac{\int u(t) q(t) d t+C}{u(t)}, \int u(t) q(t) d t=\int \frac{2}{\left(1+t^{2}\right)^{2}} d t \\
& \int \frac{2}{\left(1+t^{2}\right)^{2}} d t=2 \int \frac{1+t^{2}-t^{2}}{\left(1+t^{2}\right)^{2}} d t=2 \int\left(\frac{1}{1+t^{2}}-\frac{t^{2}}{\left(1+t^{2}\right)^{2}}\right) d t
\end{aligned}
$$

The first integral is clearly $\tan ^{-1} t$. For the $2^{\text {nd }}$ we will use integration by parts with $t$ as first function and $2 t /\left(1+t^{2}\right)^{2}$ as $2^{\text {nd }}$ function.

$$
\begin{aligned}
& \int \frac{2 t^{2}}{\left(1+t^{2}\right)^{2}} d t=t\left(-\frac{1}{1+t^{2}}\right)+\int \frac{1}{1+t^{2}} d t=-\frac{t}{1+t^{2}}+\tan ^{-1}(t) \\
& \int \frac{2}{\left(1+t^{2}\right)^{2}} d t=2 \tan ^{-1}(t)+\frac{t}{1+t^{2}}-\tan ^{-1}(t)=\tan ^{-1}(t)+\frac{t}{1+t^{2}}
\end{aligned}
$$

The general solution is: $y=\left(1+t^{2}\right)\left(\tan ^{-1}(t)+\frac{t}{1+t^{2}}+C\right)$
4. The condition $y(0)=0.4$ gives $C=0.4$
5. Therefore, solution to the initial value problem can be written as:

$$
y=t+\left(1+t^{2}\right) \tan ^{-1}(t)+0.4\left(1+t^{2}\right)
$$

## Example 3:

Find the solution to the problem

$$
\cos ^{2} t \sin t \cdot y^{\prime}=-\cos ^{3} t \cdot y+1, y\left(\frac{\pi}{4}\right)=0
$$

## Solution:

1. The equation is $1^{\text {st }}$ order linear and is not in the standard form

$$
\frac{d y}{d x}+p(x) y=q(x)
$$

Therefore we rewrite the equation as

$$
y^{\prime}+\frac{\cos t}{\sin t} y=\frac{1}{\cos ^{2} t \sin t}
$$

2. Hence, the integrating factor is given by

$$
u(t)=e^{\int \frac{\cos t}{\sin t} d t}=e^{\ln |\sin t|}=\sin t
$$

3. Therefore, the general solution is given by

$$
y=\frac{\int \sin t \frac{1}{\cos ^{2} t \sin t} d t+C}{\sin t}
$$

Since

$$
\int \sin t \frac{1}{\cos ^{2} t \sin t} d t=\int \frac{1}{\cos ^{2} t} d t=\tan t
$$

Therefore

$$
y=\frac{\tan t+C}{\sin t}=\frac{1}{\cos t}+\frac{C}{\sin t}=\sec t+C \csc t
$$

(1) The initial condition $y(\pi / 4)=0$ implies

$$
\sqrt{2}+C \sqrt{2}=0
$$

which gives $C=-1$.
(2) Therefore, the particular solution to the initial value problem is

$$
y=\sec t-\csc t
$$

## Example 4

Solve

$$
\left(x+2 y^{3}\right) \frac{d y}{d x}=y
$$

## Solution:

We have

$$
\frac{d y}{d x}=\frac{y}{x+2 y^{3}}
$$

This equation is not linear in $y$. Let us regard $x$ as dependent variable and $y$ as independent variable. The equation may be written as
or

$$
\frac{\frac{d x}{d y}=\frac{x+2 y^{3}}{y}}{\frac{d x}{d y}-\frac{1}{y} x=2 y^{2}}
$$

Which is linear in x

$$
I F=\exp \left[\int\left(-\frac{1}{y}\right) d y\right]=\exp \left[\ln \frac{1}{y}\right]=\frac{1}{y}
$$

Multiplying with the $I F=\frac{1}{y}$, we get

$$
\begin{gathered}
\frac{1}{y} \frac{d x}{d y}-\frac{1}{y^{2}} x=2 y \\
\frac{d}{d y}\left(\frac{x}{y}\right)=2 y
\end{gathered}
$$

Integrating, we have

$$
\begin{aligned}
& \frac{x}{y}=y^{2}+c \\
& x=y\left(y^{2}+c\right)
\end{aligned}
$$

is the required solution.

## Example 5

Solve

$$
(x-1)^{3} \frac{d y}{d x}+4(x-1)^{2} y=x+1
$$

## Solution:

The equation can be rewritten as

Here

$$
\begin{aligned}
& \frac{d y}{d x}+\frac{4}{x-1} y=\frac{x+1}{(x-1)^{3}} \\
& P(x)=\frac{4}{x-1}
\end{aligned}
$$

Therefore, an integrating factor of the given equation is

$$
I F=\exp \left[\int \frac{4 d x}{x-1}\right]=\exp \left[\ln (x-1)^{4}\right]=(x-1)^{4}
$$

Multiplying the given equation by the IF, we get
or

$$
\begin{aligned}
& (x-1)^{4} \frac{d y}{d x}+4(x-1)^{3} y=x^{2}-1 \\
& \frac{d}{d x}\left[y(x-1)^{4}\right]=x^{2}-1
\end{aligned}
$$

Integrating both sides, we obtain

$$
y(x-1)^{4}=\frac{x^{3}}{3}-x+c
$$

which is the required solution.

## Exercise

Solve the following differential equations

1. $\frac{d y}{d x}+\left(\frac{2 x+1}{x}\right) y=e^{-2 x}$
2. $\frac{d y}{d x}+3 y=3 x^{2} e^{-3 x}$
3. $x \frac{d y}{d x}+(1+x \cot x) y=x$
4. $(x+1) \frac{d y}{d x}-n y=e^{x}(x+1)^{n+1}$
5. $\left(1+x^{2}\right) \frac{d y}{d x}+4 x y=\frac{1}{\left(1+x^{2}\right)^{2}}$
6. $\frac{d r}{d \theta}+r \sec \theta=\cos \theta$

## Lecture 8

## Bernoulli Equations

A differential equation that can be written in the form

$$
\frac{d y}{d x}+p(x) y=q(x) y^{n}
$$

is called Bernoulli equation.

## Method of solution:

For $n=0,1$ the equation reduces to $1^{\text {st }}$ order linear DE and can be solved accordingly.
For $n \neq 0,1$ we divide the equation with $y^{n}$ to write it in the form

$$
y^{-n} \frac{d y}{d x}+p(x) y^{1-n}=q(x)
$$

and then put

$$
v=y^{1-n}
$$

Differentiating w.r.t. ' $x$ ', we obtain

$$
v^{\prime}=(1-n) y^{-n} y^{\prime}
$$

Therefore the equation becomes

$$
\frac{d v}{d x}+(1-n) p(x) v=(1-n) q(x)
$$

This is a linear equation satisfied by $V$. Once it is solved, you will obtain the function

$$
y=v^{\frac{1}{(1-n)}}
$$

If $n>1$, then we add the solution $y=0$ to the solutions found the above technique.

## Summary:

1.Identify the equation

$$
\frac{d y}{d x}+p(x) y=q(x) y^{n}
$$

as Bernoulli equation.
Find $\boldsymbol{n}$. If $n \neq 0,1$ divide by $y^{n}$ and substitute;

$$
v=y^{1-n}
$$

2. Through easy differentiation, find the new equation

$$
\frac{d v}{d x}+(1-n) p(x) v=(1-n) q(x)
$$

3. This is a linear equation. Solve the linear equation to find $\boldsymbol{v}$.
4. Go back to the old function $y$ through the substitution $y=v^{1 /(1-n)}$.
5. If $n>1$, then include $y=0$ to in the solution.
6. If you have an IVP, use the initial condition to find the particular solution.

Example 1: Solve the equation $\frac{d y}{d x}=y+y^{3}$

## Solution:

1. The given differential can be written as

$$
\frac{d y}{d x}-y=y^{3}
$$

which is a Bernoulli equation with

$$
p(x)=-1, q(x)=1, \boldsymbol{n}=\mathbf{3}
$$

Dividing with $y^{3}$ we get

$$
y^{-3} \frac{d y}{d x}-y^{-2}=1
$$

Therefore we substitute

$$
v=y^{1-3}=y^{-2}
$$

2. Differentiating w.r.t. ' $x$ ' we have

$$
y^{-3} \frac{d y}{d x}=-\frac{1}{2}\left(\frac{d v}{d x}\right)
$$

So that the equation reduces to

$$
\frac{d v}{d x}+2 v=-2
$$

3. This is a linear equation. To solve this we find the integrating factor $u(x)$

$$
u(x)=e^{\int 2 d x}=e^{2 x}
$$

The solution of the linear equation is given by

Since

$$
v=\frac{\int u(x) q(x) d x+c}{u(x)}=\frac{\int e^{2 x}(-2) d x+c}{e^{2 x}}
$$

Therefore, the solution for $V$ is given by

$$
v=\frac{-e^{2 x}+C}{e^{2 x}}=C e^{-2 x}-1
$$

4. To go back to $y$ we substitute $v=y^{-2}$. Therefore the general solution of the given DE is

$$
y= \pm\left(C e^{-2 x}-1\right)^{-\frac{1}{2}}
$$

5. Since $n>1$, we include the $y=0$ in the solutions. Hence, all solutions are

$$
y=0, \quad y= \pm\left(C e^{-2 x}-1\right)^{-1 / 2}
$$

## Example 2:

Solve

$$
\frac{d y}{d x}+\frac{1}{x} y=x y^{2}
$$

Solution: In the given equation we identify $P(x)=\frac{1}{x}, q(x)=x$ and $n=2$.
Thus the substitution $w=y^{-1}$ gives

$$
\frac{d w}{d x}-\frac{1}{x} w=-x
$$

The integrating factor for this linear equation is

$$
e^{-\int \frac{d x}{x}}=e^{-\ln |x|}=e^{\ln |x|^{-1}}=x^{-1}
$$

Hence

$$
\frac{d}{d x}\left[x^{-1} w\right]=-1
$$

Integrating this latter form, we get

$$
x^{-1} w=-x+c \text { or } w=-x^{2}+c x
$$

Since $w=y^{-1}$, we obtain $y=\frac{1}{w}$ or

$$
y=\frac{1}{-x^{2}+c x}
$$

For $n>0$ the trivial solution $y=0$ is a solution of the given equation. In this example, $y=0$ is a singular solution of the given equation.

## Example 3:

Solve:

$$
\begin{equation*}
\frac{d y}{d x}+\frac{x y}{1-x^{2}}=x y^{\frac{1}{2}} \tag{1}
\end{equation*}
$$

Solution: Dividing (1) by $y^{\frac{1}{2}}$, the given equation becomes

Put

& y^{\frac{-1}{2}} \frac{d y}{d x}+\frac{x}{1-x^{2}} y^{\frac{1}{2}}=x^{\frac{1}{2}}=v \text { or. } \frac{1}{2} y^{-\frac{1}{2}} \frac{d y}{d x}=\frac{d v}{d x} \tag{2}
\end{align*}
$$

Then (2) reduces to

$$
\begin{equation*}
\frac{d v}{d x}+\frac{x}{2\left(1-x^{2}\right)} v=\frac{x}{2} \tag{3}
\end{equation*}
$$

This is linear in $v$.
I.F $=\exp \left[\int \frac{x}{2\left(1-x^{2}\right)} d x\right]=\exp \left[\frac{-1}{4} \ln \left(1-x^{2}\right)\right]=\left(1-x^{2}\right)^{\frac{-1}{4}}$

Multiplying (3) by $\left(1-x^{2}\right)^{\frac{-1}{4}}$, we get

$$
\begin{aligned}
& \left(1-x^{2}\right)^{\frac{-1}{4}} \frac{d v}{d x}+\frac{x}{2\left(1-x^{2}\right)^{5 / 4}} v=\frac{x}{2\left(1-x^{2}\right)^{1 / 4}} \\
& \frac{d}{d x}\left[\left(1-x^{2}\right)^{\frac{-1}{4}} v\right]=\frac{-1}{4}\left[-2 x\left(1-x^{2}\right)^{\frac{-1}{4}}\right]
\end{aligned}
$$

Integrating, we have
or

Or

$$
\begin{aligned}
& v\left(1-x^{2}\right)^{\frac{-1}{4}}=\frac{-1}{4} \frac{\left(1-x^{2}\right)^{\frac{3}{4}}}{3 / 4}+c \\
& v=c\left(1-x^{2}\right)^{1 / 4}-\frac{1-x^{2}}{3} \\
& y^{\frac{1}{2}}=c\left(1-x^{2}\right)^{1 / 4}-\frac{1-x^{2}}{3}
\end{aligned}
$$

is the required solution.

## SUBSTITUTIONS

- Sometimes a differential equation can be transformed by means of a substitution into a form that could then be solved by one of the standard methods i.e. Methods used to solve separable, homogeneous, exact, linear, and Bernoulli's differential equation.
- An equation may look different from any of those that we have studied in the previous lectures, but through a sensible change of variables perhaps an apparently difficult problem may be readily solved.
- Although no firm rules can be given on the basis of which these substitution could be selected, a working axiom might be: Try something! It sometimes pays to be clever.


## Example 1

The differential equation

$$
y(1+2 x y) d x+x(1-2 x y) d y=0
$$

is not separable, not homogeneous, not exact, not linear, and not Bernoulli.
However, if we stare at the equation long enough, we might be prompted to try the substitution

Since

$$
\begin{aligned}
& u=2 x y \quad \text { or } \quad y=\frac{u}{2 x} \\
& d y=\frac{x d u-u d x}{2 x^{2}}
\end{aligned}
$$

The equation becomes, after we simplify
we obtain

$$
2 u^{2} d x+(1-u) x d u=0
$$

$$
2 \ln |x|-u^{-1}-\ln |u|=c
$$

$$
\begin{aligned}
& \left.\ln \frac{x}{2 y} \right\rvert\,=c+\frac{1}{2 x y} \\
& \frac{x}{2 y}=c_{1} e^{1 / 2 x y} \\
& x=2 c_{1} y e^{1 / 2 x y}
\end{aligned}
$$

where $e^{c}$ was replaced by $C_{1}$. We can also replace $2 c_{1}$ by $C_{2}$ if desired

## Note that

The differential equation in the example possesses the trivial solution $y=0$, but then this function is not included in the one-parameter family of solution.

## Example 2

Solve

$$
2 x y \frac{d y}{d x}+2 y^{2}=3 x-6
$$

## Solution:

The presence of the term $2 y \frac{d y}{d x}$ prompts us to try $u=y^{2}$
Since

$$
\frac{d u}{d x}=2 y \frac{d y}{d x}
$$

Therefore, the equation becomes
Now

$$
x \frac{d u}{d x}+2 u=3 x-6
$$

or

$$
\frac{d u}{d x}+\frac{2}{x} u=3-\frac{6}{x}
$$

This equation has the form of $1^{\text {st }}$ order linear differential equation

$$
\frac{d y}{d x}+P(x) y=Q(x)
$$

with

$$
P(x)=\frac{2}{x} \text { and } Q(x)=3-\frac{6}{x}
$$

Therefore, the integrating factor of the equation is given by

$$
\mathrm{I}=e^{\int \frac{2}{x} d x}=e^{\ln x^{2}}=x^{2}
$$

Multiplying with the IF gives

$$
\frac{d}{d x}\left[x^{2} u\right]=3 x^{2}-6 x
$$

Integrating both sides, we obtain
or

$$
\begin{aligned}
& x^{2} u=x^{3}-3 x^{2}+c \\
& x^{2} y^{2}=x^{3}-3 x^{2}+c
\end{aligned}
$$

## Example 3

Solve

$$
x \frac{d y}{d x}-y=\frac{x^{3}}{y} e^{y / x}
$$

## Solution:

If we let

$$
u=\frac{y}{x}
$$

Then the given differential equation can be simplified to

$$
u e^{-u} d u=d x
$$

Integrating both sides, we have

$$
\int u e^{-u} d u=\int d x
$$

Using the integration by parts on LHS, we have

$$
-u e^{-u}-e^{-u}=x+c
$$

or

$$
u+1=\left(c_{1}-x\right) e^{u} \text { Where } c_{1}=-\mathbf{c}
$$

We then re-substitute

$$
u=\frac{y}{x}
$$

and simplify to obtain

$$
y+x=x\left(c_{1}-x\right) e^{y / x}
$$

## Example 4

Solve

$$
\frac{d^{2} y}{d x^{2}}=2 x\left(\frac{d y}{d x}\right)^{2}
$$

## Solution:

If we let

$$
u=y^{\prime}
$$

Then

$$
d u / d x=y^{\prime \prime}
$$

Then, the equation reduces to

$$
\frac{d u}{d x}=2 x u^{2}
$$

Which is separable form. Separating the variables, we obtain

$$
\frac{d u}{u^{2}}=2 x d x
$$

Integrating both sides yields

$$
\int u^{-2} d u=\int 2 x d x
$$

or

$$
-u^{-1}=x^{2}+c_{1}^{2}
$$

The constant is written as $c_{1}^{2}$ for convenience.
Since

$$
u^{-1}=1 / y^{\prime}
$$

Therefore
or

$$
\begin{aligned}
& \frac{d y}{d x}=-\frac{1}{x^{2}+c_{1}^{2}} \\
& d y=-\frac{d x}{x^{2}+c_{1}^{2}} \\
& d y=-\int \frac{d x}{x^{2}+c_{1}^{2}}
\end{aligned}
$$

$$
y+c_{2}=-\frac{1}{c_{1}} \tan ^{-1} \frac{x}{c_{1}}
$$

& e^{u}=-\cos x+c \\
& u=\ln |-\cos x+c| \\
& x+y=\ln |-\cos x+c|

## Applications of First Order Differential Equations

In order to translate a physical phenomenon in terms of mathematics, we strive for a set of equations that describe the system adequately. This set of equations is called a Model for the phenomenon. The basic steps in building such a model consist of the following steps:

Step 1: We clearly state the assumptions on which the model will be based. These assumptions should describe the relationships among the quantities to be studied.

Step 2. Completely describe the parameters and variables to be used in the model.

Step 3: Use the assumptions (from Step 1) to derive mathematical equations relating the parameters and variables (from Step 2).

The mathematical models for physical phenomenon often lead to a differential equation or a set of differential equations. The applications of the differential equations we will discuss in next two lectures include:

## Orthogonal Trajectories

- We know that that the solutions of a $1^{\text {st }}$ order differential equation, e.g. separable equations, may be given by an implicit equation

$$
F(x, y, C)=0
$$

with 1 parameter $C$, which represents a family of curves. Member curves can be obtained by fixing the parameter $C$. Similarly an $n^{\text {th }}$ order DE will yields an n-parameter family of curves/solutions.

$$
F\left(x, y, C_{1}, C_{1}, \cdots, C_{n}\right)=0
$$

- The question arises that whether or not we can turn the problem around: Starting with an n-parameter family of curves, can we find an associated $\mathrm{n}^{\text {th }}$ order differential equation free of parameters and representing the family. The answer in most cases is yes.
- Let us try to see, with reference to a 1-parameter family of curves, how to proceed if the answer to the question is yes.

1. Differentiate with respect to $x$, and get an equation-involving $x, y, \frac{d y}{d x}$ and $C$.
2. Using the original equation, we may be able to eliminate the parameter $C$ from the new equation.
3. The next step is doing some algebra to rewrite this equation in an explicit form

$$
\frac{d y}{d x}=f(x, y)
$$

- For illustration we consider an example:


## Illustration

## Example

Find the differential equation satisfied by the family

$$
x^{2}+y^{2}=C x
$$

## Solution:

1. We differentiate the equation with respect to $x$, to get

$$
2 x+2 y \frac{d y}{d x}=C
$$

2. Since we have from the original equation that

$$
C=\frac{x^{2}+y^{2}}{x}
$$

then we get

$$
2 x+2 y \frac{d y}{d x}=\frac{x^{2}+y^{2}}{x}
$$

3. The explicit form of the above differential equation is

$$
\frac{d y}{d x}=\frac{y^{2}-x^{2}}{2 x y}
$$

This last equation is the desired DE free of parameters representing the given family.

## Example.

Let us consider the example of the following two families of curves

$$
\begin{cases}y & =m x \\ x^{2}+y^{2} & =C^{2}\end{cases}
$$

The first family describes all the straight lines passing through the origin while the second family describes all the circles centered at the origin

If we draw the two families together on the same graph we get


Clearly whenever one line intersects one circle, the tangent line to the circle (at the point of intersection) and the line are perpendicular i.e. orthogonal to each other. We say that the two families of curves are orthogonal at the point of intersection.

## Orthogonal curves:

Any two curves $C_{1}$ and $C_{2}$ are said to be orthogonal if their tangent lines $T_{1}$ and $T_{2}$ at their point of intersection are perpendicular. This means that slopes are negative reciprocals of each other, except when $T_{1}$ and $T_{2}$ are parallel to the coordinate axes.

## Orthogonal Trajectories (OT):

When all curves of a family $\Im_{1}: G\left(x, y, c_{1}\right)=0$ orthogonally intersect all curves of another family $\mathfrak{J}_{2}: H\left(x, y, c_{2}\right)=0$ then each curve of the families is said to be orthogonal trajectory of the other.

## Example

As we can see from the previous figure that the family of straight lines $y=m x$ and the family of circles $x^{2}+y^{2}=C^{2}$ are orthogonal trajectories.
Orthogonal trajectories occur naturally in many areas of physics, fluid dynamics, in the study of electricity and magnetism etc. For example the lines of force are perpendicular to the equipotential curves i.e. curves of constant potential.
Method of finding Orthogonal Trajectory:
Consider a family of curves $\mathfrak{J}$. Assume that an associated DE may be found, which is given by:

$$
\frac{d y}{d x}=f(x, y)
$$

Since $\frac{d y}{d x}$ gives slope of the tangent to a curve of the family $\mathfrak{I}$ through $(x, y)$.
Therefore, the slope of the line orthogonal to this tangent is $-\frac{1}{f(x, y)}$ So that the slope of the line that is tangent to the orthogonal curve through $(x, y)$ is given by $-\frac{1}{f(x, y)}$. In other words, the family of orthogonal curves are solutions to the differential equation

$$
\frac{d y}{d x}=-\frac{1}{f(x, y)}
$$

The steps can be summarized as follows:

## Summary:

In order to find Orthogonal Trajectories of a family of curves $\mathfrak{J}_{\text {we perform the }}$ following steps:
Step 1. Consider a family of curves $\mathfrak{J}$ and find the associated differential equation.
Step 2. Rewrite this differential equation in the explicit form

$$
\frac{d y}{d x}=f(x, y)
$$

Step 3. Write down the differential equation associated to the orthogonal family

$$
\frac{d y}{d x}=-\frac{1}{f(x, y)}
$$

Step 4. Solve the new equation. The solutions are exactly the family of orthogonal curves.

Step 5 A specific curve from the orthogonal family may be required, something like an IVP.

## Example 1

Find the orthogonal Trajectory to the family of circles

$$
x^{2}+y^{2}=C^{2}
$$

## Solution:

The given equation represents a family of concentric circles centered at the origin.
Step 1. We differentiate w.r.t. ' $X$ ' to find the DE satisfied by the circles.

$$
2 y \frac{d y}{d x}+2 x=0
$$

Step 2. We rewrite this equation in the explicit form

$$
\frac{d y}{d x}=-\frac{x}{y}
$$

Step 3. Next we write down the DE for the orthogonal family

$$
\frac{d y}{d x}=-\frac{1}{-(x / y)}=\frac{y}{x}
$$

Step 4.This is a linear as well as a separable DE. Using the technique of linear equation, we find the integrating factor

$$
u(x)=e^{-\int \frac{1}{x} d x}=\frac{1}{x}
$$

which gives the solution

$$
y \cdot u(x)=m
$$

or

$$
y=\frac{m}{u(x)}=m x
$$

Which represent a family of straight lines through origin. Hence the family of straight lines $y=m x$ and the family of circles $x^{2}+y^{2}=C^{2}$ are Orthogonal Trajectories.

Step 5. A geometrical view of these Orthogonal Trajectories is:


## Example 2

Find the Orthogonal Trajectory to the family of circles

$$
x^{2}+y^{2}=2 C x
$$

## Solution:

1. We differentiate the given equation to find the DE satisfied by the circles.

$$
y \frac{d y}{d x}+x=C, \quad C=\frac{x^{2}+y^{2}}{2 x}
$$

2. The explicit differential equation associated to the family of circles is

$$
\frac{d y}{d x}=\frac{y^{2}-x^{2}}{2 x y}
$$

3. Hence the differential equation for the orthogonal family is

$$
\frac{d y}{d x}=\frac{2 x y}{x^{2}-y^{2}}
$$

4. This DE is a homogeneous, to solve this equation we substitute $v=y / x$ or equivalently $y=V \boldsymbol{X}$. Then we have

$$
\frac{d y}{d x}=x \frac{d v}{d x}+v \text { and } \frac{2 x y}{x^{2}-y^{2}}=\frac{2 v}{1-v^{2}}
$$

Therefore the homogeneous differential equation in step 3 becomes

$$
x \frac{d v}{d x}+v=\frac{2 v}{1-v^{2}}
$$

Algebraic manipulations reduce this equation to the separable form:

$$
\frac{d v}{d x}=\frac{1}{x}\left\{\frac{v+v^{3}}{1-v^{2}}\right\}
$$

The constant solutions are given by

$$
v+v^{3}=0 \Rightarrow v\left(1+v^{2}\right)=0
$$

The only constant solution is $v=0$.
To find the non-constant solutions we separate the variables

$$
\frac{1-v^{2}}{v+v^{3}} d v=\frac{1}{x} d x
$$

Integrate

$$
\int \frac{1-v^{2}}{v+v^{3}} d v=\int \frac{1}{x} d x
$$

Resolving into partial fractions the integrand on LHS, we obtain

$$
\frac{1-v^{2}}{v+v^{3}}=\frac{1-v^{2}}{v\left(1+v^{2}\right)}=\frac{1}{v}-\frac{2 v}{1+v^{2}}
$$

Hence we have

$$
\int \frac{1-v^{2}}{v+v^{3}} d v=\int\left\{\frac{1}{v}-\frac{2 v}{1+v^{2}}\right\} d v=\ln |v|-\ln \left[v^{2}+1\right]
$$

Hence the solution of the separable equation becomes

$$
\ln |v|-\ln \left[v^{2}+1\right]=\ln |x|+\ln C
$$

which is equivalent to

$$
\frac{v}{v^{2}+1}=C x
$$

where $C \neq 0$. Hence all the solutions are

$$
\left\{\begin{array}{c}
v=0 \\
\frac{v}{v^{2}+1}=C x
\end{array}\right.
$$

We go back to $y$ to get $y=0$ and $\frac{y}{y^{2}+x^{2}}=C$ which is equivalent to

$$
\begin{cases}y & =0 \\ x^{2}+y^{2} & =m y\end{cases}
$$

5. Which is $x$-axis and a family of circles centered on $y$-axis. A geometrical view of both the families is shown in the next slide.


## Population Dynamics

Some natural questions related to population problems are the following:

- What will the population of a certain country after e.g. ten years?
- How are we protecting the resources from extinction?

The easiest population dynamics model is the exponential model. This model is based on the assumption:

The rate of change of the population is proportional to the existing population.

If $P(t)$ measures the population of a species at any time $t$ then because of the above mentioned assumption we can write

$$
\frac{d P}{d t}=k P
$$

where the rate $k$ is constant of proportionality. Clearly the above equation is linear as well as separable. To solve this equation we multiply the equation with the integrating factor $e^{-k t}$ to obtain

$$
\frac{d}{d t}\left[P e^{-k t}\right]=0
$$

Integrating both sides we obtain

$$
P e^{-k t}=C \quad \text { or } \quad P=C e^{k t}
$$

If $P_{0}$ is the initial population then $P(0)=P_{0}$. So that $C=P_{0}$ and obtain

$$
P(t)=P_{0} e^{k t}
$$

Clearly, we must have $k>0$ for growth and $k<0$ for the decay

## Illustration

## Example:

The population of a certain community is known to increase at a rate proportional to the number of people present at any time. The population has doubled in 5 years, how long would it take to triple? If it is known that the population of the community is 10,000 after 3 years. What was the initial population? What will be the population in 30 years?

## Solution:

Suppose that $P_{0}$ is initial population of the community and $P(t)$ the population at any time $t$ then the population growth is governed by the differential equation

$$
\frac{d P}{d t}=k P
$$

As we know solution of the differential equation is given by

$$
P(t)=P_{0} e^{k t}
$$

Since $P(5)=2 P_{0}$. Therefore, from the last equation we have

$$
2 P_{0}=P_{0} e^{5 k} \Rightarrow e^{5 k}=2
$$

This means that

$$
5 k=\ln 2=0.69315 \quad \text { or } \quad k=\frac{0.69315}{5}=0.13863
$$

Therefore, the solution of the equation becomes

$$
P(t)=P_{0} e^{0.13863 t}
$$

If $t_{1}$ is the time taken for the population to triple then

$$
\begin{aligned}
& 3 P_{0}=P_{0} e^{0.1386 t_{1}} \Rightarrow e^{0.1386 t_{1}}=3 \\
& t_{1}=\frac{\ln 3}{0.1386}=7.9265 \approx 8 \text { years }
\end{aligned}
$$

Now using the information $P(3)=10,000$, we obtain from the solution that

$$
10,000=P_{0} e^{(0.13863)(3)} \Rightarrow P_{0}=\frac{10,000}{e^{0.41589}}
$$

Therefore, the initial population of the community was

$$
P_{0} \approx 6598
$$

Hence solution of the model is

$$
P(t)=6598 e^{0.13863 t}
$$

So that the population in 30 years is given by
or
or

$$
\begin{aligned}
& P(30)=6598 e^{(30)(0.13863)}=6598 e^{4.1589} \\
& P(30)=(6598)(64.0011) \\
& P(30) \approx 422279
\end{aligned}
$$

## Radioactive Decay

In physics a radioactive substance disintegrates or transmutes into the atoms of another element. Many radioactive materials disintegrate at a rate proportional to the amount present. Therefore, if $A(t)$ is the amount of a radioactive substance present at time $t$, then the rate of change of $A(t)$ with respect to time $t$ is given by

$$
\frac{d A}{d t}=k A
$$

where $k$ is a constant of proportionality. Let the initial amount of the material be $A_{0}$ then $A(0)=A_{0}$. As discussed in the population growth model the solution of the differential equation is

$$
A(t)=A_{0} e^{k t}
$$

The constant $k$ can be determined using half-life of the radioactive material.
The half-life of a radioactive substance is the time it takes for one-half of the atoms in an initial amount $A_{0}$ to disintegrate or transmute into atoms of another element. The halflife measures stability of a radioactive substance. The longer the half-life of a substance, the more stable it is. If $T$ denotes the half-life then

$$
A(T)=\frac{A_{0}}{2}
$$

Therefore, using this condition and the solution of the model we obtain

So that

$$
\frac{\frac{A_{0}}{2}=A_{0} e^{k t}}{-\ln 2}
$$

Therefore, if we know $T$, we can get $k$ and vice-versa. The half-life of some important radioactive materials is given in many textbooks of Physics and Chemistry. For example the half-life of $C-14$ is $5568 \pm 30$ years.

## Example 1:

A radioactive isotope has a half-life of 16 days. We have 30 g at the end of 30 days.
How much radioisotope was initially present?
Solution: Let $A(t)$ be the amount present at time $t$ and $A_{0}$ the initial amount of the isotope. Then we have to solve the initial value problem.

$$
\frac{d A}{d t}=k A, \quad A(30)=30
$$

We know that the solution of the IVP is given by

$$
A(t)=A_{0} e^{k t}
$$

If $T$ the half-life then the constant is given $k$ by

$$
k T=-\ln 2 \quad \text { or } \quad k=-\frac{\ln 2}{T}=-\frac{\ln 2}{16}
$$

Now using the condition $A(30)=30$, we have

$$
30=A_{0} e^{30 k}
$$

So that the initial amount is given by

$$
A_{0}=30 e^{-30 k}=30 e^{\frac{30 \ln 2}{16}}=110.04 \mathrm{~g}
$$

## Example 2:

A breeder reactor converts the relatively stable uranium 238 into the isotope plutonium 239. After 15 years it is determined that $0.043 \%$ of the initial amount $A_{0}$ of the plutonium has disintegrated. Find the half-life of this isotope if the rate of disintegration is proportional to the amount remaining.

## Solution:

Let $A(t)$ denotes the amount remaining at any time $t$, then we need to find solution to the initial value problem

$$
\frac{d A}{d t}=k A, \quad A(0)=A_{0}
$$

which we know is given by

$$
A(t)=A_{0} e^{k t}
$$

If $0.043 \%$ disintegration of the atoms of $A_{0}$ means that $99.957 \%$ of the substance remains. Further $99.957 \%$ of $A_{0}$ equals $(0.99957) A_{0}$. So that

$$
A(15)=(0.99957) A_{0}
$$

So that

$$
A_{0} \mathrm{e}^{15 \mathrm{k}}=(0.99957) A_{0}
$$

Or

Hence

$$
k=\frac{15 k=\ln (0.99957)}{15}=-0.00002867
$$

$$
\text { If } T \text { denotes the half-life then } A(T)=\frac{A_{0}}{2} \text { Thus }
$$

$$
\begin{gathered}
\frac{A_{0}}{2}=A_{0} e^{-0.00002867 T} \text { or } \frac{1}{2}=e^{-0.00002867} T \\
-0.00002867 \mathrm{~T}=\ln \left(\frac{1}{2}\right)=-\ln 2 \\
T=\frac{\ln 2}{0.00002867} \approx 24,180 \text { years }
\end{gathered}
$$

## Newton's Law of Cooling

From experimental observations it is known that the temperature $\boldsymbol{T}$ ( $t$ ) of an object changes at a rate proportional to the difference between the temperature in the body and the temperature $\boldsymbol{T}_{\boldsymbol{m}}$ of the surrounding environment. This is what is known as Newton's law of cooling.
If initial temperature of the cooling body is $T_{0}$ then we obtain the initial value problem

$$
\frac{d T}{d t}=k\left(T-T_{m}\right), \quad T(0)=T_{0}
$$

where $k$ is constant of proportionality. The differential equation in the problem in linear as well as separable.
Separating the variables and integrating we obtain

$$
\int \frac{d T}{T-T_{m}}=\int k d t
$$

This means that

$$
\begin{aligned}
& \frac{\ln \left|T-T_{m}\right|=k t+C}{T-T_{m}=e^{k t+C}} \\
& T(t)=T_{m}+C_{1} e^{k t} \quad \text { where } C_{1}=e^{C}
\end{aligned}
$$

Now applying the initial condition $T(0)=T_{0}$, we see that $C_{1}=T_{0}-T_{m}$. Thus the solution of the initial value problem is given by

$$
T(t)=T_{m}+\left(T_{0}-T_{m}\right) e^{k t}
$$

Hence, If temperatures at times $t_{1}$ and $t_{2}$ are known then we have

$$
T\left(t_{1}\right)-T_{m}=\left(T_{0}-T_{m}\right) e^{k t_{1}}, T\left(t_{2}\right)-T_{m}=\left(T_{0}-T_{m}\right) e^{k t_{2}}
$$

So that we can write

$$
\frac{T\left(t_{1}\right)-T_{m}}{T\left(t_{2}\right)-T_{m}}=e^{k\left(t_{1}-t_{2}\right)}
$$

This equation provides the value of $k$ if the interval of time ' $t_{1}-t_{2}$ ' is known and viceversa.

## Example 3:

Suppose that a dead body was discovered at midnight in a room when its temperature was $80^{\circ} \mathrm{F}$. The temperature of the room is kept constant at $60^{\circ} \mathrm{F}$. Two hours later the temperature of the body dropped to $75^{\circ} \mathrm{F}$. Find the time of death.
Solution:
Assume that the dead person was not sick, then

$$
T(0)=98.6^{\circ} \mathrm{F}=\mathrm{T}_{0} \text { and } T_{m}=60^{\circ} \mathrm{F}
$$

Therefore, we have to solve the initial value problem

$$
\frac{d T}{d t}=k(T-60), \quad T(0)=98.6
$$

We know that the solution of the initial value problem is

$$
T(t)=T_{m}+\left(T_{0}-T_{m}\right) e^{k t}
$$

$$
\text { So that } \quad \frac{T\left(t_{1}\right)-T_{m}}{T\left(t_{2}\right)-T_{m}}=e^{k\left(t_{1}-t_{2}\right)}
$$

The observed temperatures of the cooling object, i.e. the dead body, are

$$
T\left(t_{1}\right)=80^{\circ} \mathrm{F} \quad \text { and } \quad T\left(t_{2}\right)=75^{\circ} \mathrm{F}
$$

Substituting these values we obtain

So

$$
\frac{80-60}{75-60}=e^{2 k} \text { as } t_{1}-t_{2}=2 \text { hours }
$$

Now suppose that $t_{1}$ and $t_{2}$ denote the times of death and discovery of the dead body then

$$
T\left(t_{1}\right)=T(0)=98.6^{\circ} \mathrm{F} \text { and } T\left(t_{2}\right)=80^{\circ} \mathrm{F}
$$

For the time of death, we need to determine the interval $t_{1}-t_{2}=t_{d}$. Now

$$
\begin{aligned}
& \frac{T\left(t_{1}\right)-T_{m}}{T\left(t_{2}\right)-T_{m}}=e^{k\left(t_{1}-t_{2}\right)} \Rightarrow \frac{98.6-60}{80-60}=e^{k t_{d}} \\
& \text { or }
\end{aligned}
$$

Hence the time of death is 7:42 PM.

## Carbon Dating

- The isotope $C-14$ is produced in the atmosphere by the action of cosmic radiation on nitrogen.
- The ratio of C-14 to ordinary carbon in the atmosphere appears to be constant.
- The proportionate amount of the isotope in all living organisms is same as that in the atmosphere.
- When an organism dies, the absorption of $C-14$ by breathing or eating ceases.
- Thus comparison of the proportionate amount of $C-14$ present, say, in a fossil with constant ratio found in the atmosphere provides a reasonable estimate of its age.
- The method has been used to date wooden furniture in Egyptian tombs.
- Since the method is based on the knowledge of half-life of the radio active C-14 (5600 years approximately), the initial value problem discussed in the radioactivity model governs this analysis.


## Example:

A fossilized bone is found to contain $1 / 1000$ of the original amount of $C-14$. Determine the age of the fissile.

## Solution:

Let $A(t)$ be the amount present at any time $t$ and $\boldsymbol{A}_{0}$ the original amount of C-14. Therefore, the process is governed by the initial value problem.

$$
\frac{d A}{d t}=k A, \quad A(0)=A_{0}
$$

We know that the solution of the problem is

$$
A(t)=A_{0} e^{k t}
$$

Since the half life of the carbon isotope is 5600 years. Therefore,

$$
A(5600)=\frac{A_{0}}{2}
$$

So that $\frac{A_{0}}{2}=A_{0} e^{5600 k}$ or $5600 k=-\ln 2$
Hence

$$
A(t)=A_{0} e^{-(0.00012378) t}
$$

If $t$ denotes the time when fossilized bone was found then $A(t)=\frac{A_{0}}{1000}$

$$
\frac{A_{0}}{1000}=A_{0} e^{-(0.00012378) t} \Rightarrow-0.00012378 t=-\ln 1000
$$

Therefore

$$
t=\frac{\ln 1000}{0.00012378}=55,800 \text { years }
$$

## Applications of Non linear Equations

As we know that the solution of the exponential model for the population growth is

$$
P(t)=P_{0} e^{k t}
$$

$P_{0}$ being the initial population. From this solution we conclude that
(a) If $k>0$ the population grows and expand to infinity i.e. $\lim P(t)=+\infty$
(b) If $k<0$ the population will shrink to approach 0 , which means extinction.

## Note that:

(1) The prediction in the first case $(k>0)$ differs substantially from what is actually observed, population growth is eventually limited by some factor!
(2) Detrimental effects on the environment such as pollution and excessive and competitive demands for food and fuel etc. can have inhibitive effects on the population growth.

## Logistic equation:

Another model was proposed to remedy this flaw in the exponential model. This is called the logistic model (also called Verhulst-Pearl model).

Suppose that $a>0$ is constant average rate of birth and that the death rate is proportional to the population $P(t)$ at any time $t$. Thus if $\frac{1}{P} \frac{d P}{d t}$ is the rate of growth per individual then

$$
\frac{1}{P} \frac{d P}{d t}=a-b P \quad \text { or } \quad \frac{d P}{d t}=P(a-b P)
$$

where $b$ is constant of proportionality. The term $-b P^{2}, b>0$ can be interpreted as inhibition term. When $b=0$, the equation reduces to the one in exponential model.
Solution to the logistic equation is also very important in ecological, sociological and even in managerial sciences.

## Solution of the Logistic equation:

The logistic equation

$$
\frac{d P}{d t}=P(a-b P)
$$

can be easily identified as a nonlinear equation that is separable. The constant solutions of the equation are given by

$$
P(a-b P)=0
$$

$$
\Rightarrow \mathrm{P}=0 \text { and } P=\frac{a}{b}
$$

For non-constant solutions we separate the variables

$$
\frac{d P}{P(a-b P)}=d t
$$

Resolving into partial fractions we have

$$
\left[\frac{1 / a}{P}+\frac{b / a}{a-b P}\right] d P=d t
$$

Integrating

$$
\frac{1}{a} \ln |P|-\frac{1}{a} \ln |a-b P|=t+C
$$

$$
\frac{P}{a-b P}=C_{1} e^{a t} \text { where } C_{1}=e^{a C}
$$

Easy algebraic manipulations give

$$
P(t)=\frac{a C_{1} e^{a t}}{1+b C_{1} e^{a t}}=\frac{a C_{1}}{b C_{1}+e^{-a t}}
$$

Here $C_{1}$ is an arbitrary constant. If we are given the initial condition $P(0)=P_{0}, P_{0} \neq \frac{a}{b}$ we obtain $C_{1}=\frac{P_{0}}{a-b P_{0}}$. Substituting this value in the last equation and simplifying, we obtain

Clearly

$$
P(t)=\frac{a P_{0}}{b P_{0}+\left(a-b P_{0}\right) e^{-a t}}
$$

Note that $P=\frac{a}{b}$ is a singular solution of the logistic equation.

## Special Cases of Logistic Equation: 1. Epidemic Spread

Suppose that one person infected from a contagious disease is introduced in a fixed population of $n$ people.

The natural assumption is that the rate $\frac{d x}{d t}$ of spread of disease is proportional to the number $x(t)$ of the infected people and number $y(t)$ of people not infected people. Then

Since

$$
\frac{d x}{d t}=k x y
$$

Therefore, we have the following initial value problem

$$
\frac{d x}{d t}=k x(n+1-x), \quad x(0)=1
$$

The last equation a special case of the logistic equation and has also been used for the spread of information and the impact of advertising in centers of population.

## 2. A Modification of LE:

A modification of the nonlinear logistic differential equation is the following

$$
\frac{d P}{d t}=P(a-b \ln P)
$$

has been used in the studies of solid tumors, in actuarial predictions, and in growth of revenue from the sale of a commercial product in addition to growth or decline of population.

## Example:

Suppose a student carrying a flu virus returns to an isolated college campus of 1000 students. If it is assumed that the rate at which the virus spreads is proportional not only to the number $X$ of infected students but also to the number of students not infected, determine the number of infected students after 6 days if is further observed that after 4 days $x(4)=50$

## Solution

Assume that no one leaves the campus throughout the duration of the disease. We must solve the initial-value problem

$$
\frac{d x}{d t}=k x(1000-x), \quad x(0)=1
$$

We identify

$$
a=1000 k \text { and } \mathrm{b}=\mathrm{k}
$$

Since the solution of logistic equation is

$$
P(t)=\frac{a P_{0}}{b P_{0}+\left(a-b P_{0}\right) e^{-a t}}
$$

Therefore we have

$$
x(t)=\frac{1000 k}{k+999 k e^{-1000 k t}}=\frac{1000}{1+999 e^{-1000 k t}}
$$

Now, using $x(4)=50$, we determine $k$

We find

$$
\begin{aligned}
& 50=\frac{1000}{1+999 e^{-4000 k}} \\
& k=\frac{-1}{4000} \ln \frac{19}{999}=0.0009906
\end{aligned}
$$

Thus

$$
x(t)=\frac{1000}{1+999 e^{-0.9906 t}}
$$

Finally

$$
x(6)=\frac{1000}{1+999 e^{-5.9436}}=276 \text { students }
$$

## Chemical reactions:

In a first order chemical reaction, the molecules of a substance $A$ decompose into smaller molecules. This decomposition takes place at a rate proportional to the amount of the first substance that has not undergone conversion. The disintegration of a radioactive substance is an example of the first order reaction. If $X$ is the remaining amount of the substance $A$ at any time $t$ then

$$
\frac{d X}{d t}=k X
$$

$k<0$ because $X$ is decreasing.
In a $2^{\text {nd }}$ order reaction two chemicals $A$ and $B$ react to form another chemical $C$ at a rate proportional to the product of the remaining concentrations of the two chemicals.

If $X$ denotes the amount of the chemical $C$ that has formed at time $t$. Then the instantaneous amounts of the first two chemicals $A$ and $B$ not converted to the chemical $C$ are $\alpha-X$ and $\beta-X$, respectively. Hence the rate of formation of chemical $C$ is given by

$$
\frac{d X}{d t}=k(\alpha-\mathrm{X})(\beta-X)
$$

where $k$ is constant of proportionality.

## Example:

A compound $C$ is formed when two chemicals $A$ and $B$ are combined. The resulting reaction between the two chemicals is such that for each gram of $A, 4$ grams of $B$ are used. It is observed that 30 grams of the compound $C$ are formed in 10 minutes. Determine the amount of $C$ at any time if the rate of reaction is proportional to the amounts of $A$ and $B$ remaining and if initially there are 50 grams of $A$ and 32 grams of $B$. How much of the compound $C$ is present at 15 minutes? Interpret the solution as $t \rightarrow \infty$

## Solution:

If $X(t)$ denote the number of grams of chemical $C$ present at any time $t$. Then

$$
X(0)=0 \text { and } X(10)=30
$$

Suppose that there are 2 grams of the compound $\boldsymbol{C}$ and we have used $\boldsymbol{A}$ and $b$ grams of $B$ then

$$
a+b=2 \quad \text { and } \quad b=4 a
$$

Solving the two equations we have

$$
a=\frac{2}{5}=2(1 / 5) \quad \text { and } \quad b=\frac{8}{5}=2(4 / 5)
$$

In general, if there were for $X$ grams of $C$ then we must have

$$
a=\frac{X}{5} \quad \text { and } \quad b=\frac{4}{5} X
$$

Therefore the amounts of $A$ and $B$ remaining at any time $t$ are then

$$
50-\frac{X}{5} \text { and } 32-\frac{4}{5} X
$$

respectively .

Therefore, the rate at which chemical $C$ is formed satisfies the differential equation

$$
\frac{d X}{d t}=\lambda\left(50-\frac{X}{5}\right)\left(32-\frac{4}{5} X\right)
$$

or

$$
\frac{d X}{d t}=k(250-X)(40-X), \quad k=4 \lambda / 25
$$

We now solve this differential equation.
By separation of variables and partial fraction, we can write

$$
\begin{aligned}
& \frac{d X}{(250-X)(40-X)}=k d t \\
& -\frac{1 / 210}{250-X} d X+\frac{1 / 210}{40-X} d X=k d t \\
& \ln \left|\frac{\mid 250-X}{40-X}\right|=210 k t+c_{1} \\
& \left\lvert\, \frac{250-X}{40-X}=c_{2} e^{210 k t}\right. \text { Where } c_{2}=e^{c_{1}}
\end{aligned}
$$

When $t=0, X=0$, so it follows at this point that $c_{2}=25 / 4$. Using $X=30$ at $t=10$, we find

$$
210 k=\frac{1}{10} \ln \frac{88}{25}=0.1258
$$

With this information we solve for $X$ :

$$
X(t)=1000\left(\frac{1-e^{-0.1258 t}}{25-4 e^{-0.1258 t}}\right)
$$

It is clear that as $e^{-0.1258 t} \rightarrow 0$ as $t \rightarrow \infty$. Therefore $X \rightarrow 40$ as $t \rightarrow \infty$. This fact can also be verified from the following table that $X \rightarrow 40$ as $t \rightarrow \infty$.

| $\boldsymbol{t}$ | 10 | 15 | 20 | 25 | 30 | 35 |
| :---: | :--- | :--- | :--- | :--- | :--- | :--- |
| $\boldsymbol{X}$ | 30 | 34.78 | 37.25 | 38.54 | 39.22 | 39.59 |

This means that there are 40 grams of compound $C$ formed, leaving
and
$50-\frac{1}{5}(40)=42$ grams of chemical $A$ $32-\frac{4}{5}(40)=0 \quad$ grams of chemical $B$

## Miscellaneous Applications

- The velocity $V$ of a falling mass $m$, subjected to air resistance proportional to instantaneous velocity, is given by the differential equation

$$
m \frac{d v}{d x}=m g-k v
$$

Here $k>0$ is constant of proportionality.

- The rate at which a drug disseminates into bloodstream is governed by the differential equation

$$
\frac{d x}{d t}=A-B x
$$

Here $A, B$ are positive constants and $x(t)$ describes the concentration of drug in the bloodstream at any time $t$.

- The rate of memorization of a subject is given by

$$
\frac{d A}{d t}=k_{1}(M-A)-k_{2} A
$$

Here $k_{1}>0, k_{2}>0$ and $A(t)$ is the amount of material memorized in time $t$, $M$ is the total amount to be memorized and $M-A$ is the amount remaining to be memorized.

## Lecture 13

## Higher Order Linear Differential Equations

## Preliminary theory

- A differential equation of the form

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

or $\quad a_{n}(x) y^{(n)}+a_{n-1}(x) y^{(n-1)}+\cdots+a_{1}(x) y^{\prime}+a_{0}(x) y=g(x)$
where $a_{0}(x), a_{1}(x), \ldots, a_{n}(x), g(x)$ are functions of $x$ and $a_{n}(x) \neq 0$, is called a linear differential equation with variable coefficients.

- However, we shall first study the differential equations with constant coefficients i.e. equations of the type

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=g(x)
$$

where $a_{0}, a_{1}, \ldots, a_{n}$ are real constants. This equation is non-homogeneous differential equation and

- If $g(x)=0$ then the differential equation becomes

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=0
$$

which is known as the associated homogeneous differential equation.

## Initial -Value Problem

For a linear nth-order differential equation, the problem:
Solve: $\quad a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)$
Subject to: $\quad y\left(x_{0}\right)=y_{0}, \quad y^{\prime}\left(x_{0}\right)=y_{0}^{\prime}, \ldots y^{n-1}\left(x_{0}\right)=y_{0}^{n-1}$
$y_{0}, y_{0}{ }^{\prime}, \ldots, y_{0}^{n-1}$ being arbitrary constants, is called an initial-value problem (IVP).
The specified values $y\left(x_{0}\right)=y_{0}, y^{\prime}\left(x_{0}\right)=y_{0}^{\prime}, \ldots, y^{n-1}\left(x_{0}\right)=y_{0}{ }^{n-1}$ are called initialconditions.
For $n=2$ the initial-value problem reduces to
Solve:

$$
a_{2}(x) \frac{d^{2} y}{d x^{2}}+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

Subject to: $\quad y\left(x_{0}\right)=y_{0}, \ldots, \quad y^{\prime}\left(x_{0}\right)=y_{0}^{\prime}$

## Solution of IVP

A function satisfying the differential equation on $I$ whose graph passes through ( $x_{0}, y_{0}$ ) such that the slope of the curve at the point is the number $y_{0}^{\prime}$ is called solution of the initial value problem.

## Theorem: Existence and Uniqueness of Solutions

Let $a_{n}(x), a_{n-1}(x), \ldots, a_{1}(x), a_{0}(x)$ and $g(x)$ be continuous on an interval $I$ and let $a_{n}(x) \neq 0, \forall x \in I$. If $x=x_{0} \in I$, then a solution $y(x)$ of the initial-value problem exist on $I$ and is unique.

## Example 1

Consider the function $\quad y=3 e^{2 x}+e^{-2 x}-3 x$
This is a solution to the following initial value problem

$$
y^{\prime \prime}-4 y=12 x, \quad y(0)=4, y^{\prime}(0)=1
$$

Since

$$
\frac{d^{2} y}{d x^{2}}=12 e^{2 x}+4 e^{-2 x}
$$

and

$$
\frac{d^{2} y}{d x^{2}}-4 y=12 e^{2 x}+4 e^{-2 x}-12 e^{2 x}-4 e^{-2 x}+12 x=12 x
$$

Further

$$
y(0)=3+1-0=4 \text { and } \quad y^{\prime}(0)=6-2-3=1
$$

Hence

$$
y=3 e^{2 x}+e^{-2 x}-3 x
$$

is a solution of the initial value problem.
We observe that

- The equation is linear differential equation.
- The coefficients being constant are continuous.
- The function $g(x)=12 x$ being polynomial is continuous.
- The leading coefficient $a_{2}(x)=1 \neq 0$ for all values of $x$.

Hence the function $y=3 e^{2 x}+e^{-2 x}-3 x$ is the unique solution.

## Example 2

Consider the initial-value problem

$$
\begin{aligned}
& 3 y^{\prime \prime \prime}+5 y^{\prime \prime}-y^{\prime}+7 y=0 \\
& y(1)=0, \quad y^{\prime}(1)=0, \quad y^{\prime \prime}(1)=0
\end{aligned}
$$

Clearly the problem possesses the trivial solution $y=0$.
Since

- The equation is homogeneous linear differential equation.
- The coefficients of the equation are constants.
- Being constant the coefficient are continuous.
- The leading coefficient $a_{3}=3 \neq 0$.

Hence $y=0$ is the only solution of the initial value problem.

Note: If $a_{n}=0$ ?
If $a_{n}(x)=0$ in the differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

for some $x \in I$ then

- Solution of initial-value problem may not be unique.
- Solution of initial-value problem may not even exist.


## Example 4

Consider the function

$$
y=c x^{2}+x+3
$$

and the initial-value problem

Then

$$
\begin{aligned}
& x^{2} y^{\prime \prime}-2 x y^{\prime}+2 y=6 \\
& y(0)=3, \quad y^{\prime}(0)=1
\end{aligned}
$$

Therefore

$$
\begin{aligned}
x^{2} y^{\prime \prime}-2 x y^{\prime}+2 y & =x^{2}(2 c)-2 x(2 c x+1)+2\left(c x^{2}+x+3\right) \\
& =2 c x^{2}-4 c x^{2}-2 x+2 c x^{2}+2 x+6 \\
& =6 .
\end{aligned}
$$

Also

$$
y(0)=3 \Rightarrow c(0)+0+3=3
$$

and

$$
y^{\prime}(0)=1 \Rightarrow 2 c(0)+1=1
$$

So that for any choice of $c$, the function' $y$ ' satisfies the differential equation and the initial conditions. Hence the solution of the initial value problem is not unique.

## Note that

- The equation is linear differential equation.
- The coefficients being polynomials are continuous everywhere.
- The function $g(x)$ being constant is constant everywhere.
- The leading coefficient $a_{2}(x)=x^{2}=0$ at $x=0 \in(-\infty, \infty)$.

Hence $a_{2}(x)=0$ brought non-uniqueness in the solution

## Boundary-value problem (BVP)

For a $2^{\text {nd }}$ order linear differential equation, the problem
Solve: $\quad a_{2}(x) \frac{d^{2} y}{d x^{2}}+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)$
Subject to: $\quad y(a)=y_{0}, \quad y(b)=y_{1}$
is called a boundary-value problem. The specified values $y(a)=y_{0}$, and $y(b)=y_{1}$ are called boundary conditions.

## Solution of BVP

A solution of the boundary value problem is a function satisfying the differential equation on some interval $I$, containing $a$ and $b$, whose graph passes through two points ( $a, y_{0}$ ) and ( $b, y_{1}$ ).

## Example 5

Consider the function

$$
y=3 x^{2}-6 x+3
$$

We can prove that this function is a solution of the boundary-value problem

$$
\begin{aligned}
& x^{2} y^{\prime \prime}-2 x y^{\prime}+2 y=6, \\
& y(1)=0, \quad y(2)=3
\end{aligned}
$$

Since

$$
\frac{d y}{d x}=6 x-6, \frac{d^{2} y}{d x^{2}}=6
$$

Therefore

$$
x^{2} \frac{d^{2} y}{d x^{2}}-2 x \frac{d y}{d x}+2 y=6 x^{2}-12 x^{2}+12 x+6 x^{2}-12 x+6=6
$$

Also

$$
y(1)=3-6+3=0, \quad y(2)=12-12+3=3
$$

Therefore, the function ' $y$ ' satisfies both the differential equation and the boundary conditions. Hence $y$ is a solution of the boundary value problem.

## Possible Boundary Conditions

For a $2^{\text {nd }}$ order linear non-homogeneous differential equation

$$
a_{2}(x) \frac{d^{2} y}{d x^{2}}+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

all the possible pairs of boundary conditions are

$$
\begin{array}{ll}
y(a)=y_{0}, & y(b)=y_{1}, \\
y^{\prime}(a)=y_{0}^{\prime}, & y(b)=y_{1}, \\
y(a)=y_{0}, & y^{\prime}(b)=y^{\prime} 1, \\
y^{\prime}(a)=y_{0}^{\prime}, & y^{\prime}(b)=y_{1}^{\prime}
\end{array}
$$

where $y_{0}, y_{0}^{\prime}, y_{1}$ and $y_{1}^{\prime}$ denote the arbitrary constants.

## In General

All the four pairs of conditions mentioned above are just special cases of the general boundary conditions
where

$$
\begin{aligned}
& \alpha_{1} y(a)+\beta_{1} y^{\prime}(a)=\gamma_{1} \\
& \alpha_{2} y(b)+\beta_{2} y^{\prime}(b)=\gamma_{2}
\end{aligned}
$$

Note that
A boundary value problem may have

- Several solutions.
- A unique solution, or
- No solution at all.


## Example 1

Consider the function

$$
y=c_{1} \cos 4 x+c_{2} \sin 4 x
$$

and the boundary value problem

$$
y^{\prime \prime}+16 y=0, \quad y(0)=0, \quad y(\pi / 2)=0
$$

Then

$$
\begin{aligned}
& y^{\prime}=-4 c_{1} \sin 4 x+4 c_{2} \cos 4 x \\
& y^{\prime \prime}=-16\left(c_{1} \cos 4 x+c_{2} \sin 4 x\right) \\
& y^{\prime \prime}=-16 y \\
& y^{\prime \prime}+16 y=0
\end{aligned}
$$

Therefore, the function

$$
y=c_{1} \cos 4 x+c_{2} \sin 4 x
$$

satisfies the differential equation

$$
y^{\prime \prime}+16 y=0 .
$$

Now apply the boundary conditions
Applying

$$
y(0)=0
$$

We obtain

$$
\begin{aligned}
& 0=c_{1} \cos 0+c_{2} \sin 0 \\
& \Rightarrow c_{1}=0
\end{aligned}
$$

So that

$$
y=c_{2} \sin 4 x
$$

But when we apply the $2^{\text {nd }}$ condition $y(\pi / 2)=0$, we have

$$
0=c_{2} \sin 2 \pi
$$

Since $\sin 2 \pi=0$, the condition is satisfied for any choice of $c_{2}$, solution of the problem is the one-parameter family of functions

$$
y=c_{2} \sin 4 x
$$

Hence, there are an infinite number of solutions of the boundary value problem.

## Example 2

Solve the boundary value problem

$$
\begin{aligned}
& y^{\prime \prime}+16 y=0 \\
& y(0)=0, \quad y\left(\frac{\pi}{8}\right)=0
\end{aligned}
$$

## Solution:

As verified in the previous example that the function

$$
y=c_{1} \cos 4 x+c_{2} \sin 4 x
$$

satisfies the differential equation

$$
y^{\prime \prime}+16 y=0
$$

We now apply the boundary conditions

$$
\begin{aligned}
& y(0)=0 \Rightarrow 0=c_{1}+0 \\
& y(\pi / 8)=0 \Rightarrow 0=0+c_{2}
\end{aligned}
$$

and
So that

$$
c_{1}=0=c_{2}
$$

Hence

$$
y=0
$$

is the only solution of the boundary-value problem.

## Example 3

Solve the differential equation

$$
y^{\prime \prime}+16 y=0
$$

subject to the boundary conditions

$$
y(0)=0, \quad y(\pi / 2)=1
$$

## Solution:

As verified in an earlier example that the function

$$
y=c_{1} \cos 4 x+c_{2} \sin 4 x
$$

satisfies the differential equation

$$
y^{\prime \prime}+16 y=0
$$

We now apply the boundary conditions

$$
y(0)=0 \Rightarrow 0=c_{1}+0
$$

Therefore $\quad c_{1}=0$
So that $\quad y=c_{2} \sin 4 x$
However $\quad y(\pi / 2)=1 \Rightarrow c_{2} \sin 2 \pi=1$
or $\quad 1=c_{2} .0 \Rightarrow 1=0$
This is a clear contradiction. Therefore, the boundary value problem has no solution.

Definition: Linear Dependence
A set of functions

$$
\left\{f_{1}(x), f_{2}(x), \ldots, f_{n}(x)\right\}
$$

is said to be linearly dependent on an interval $I$ if $\exists$ constants $c_{1}, c_{2}, \ldots, c_{n}$ not all zero, such that

$$
c_{1} f_{1}(x)+c_{2} f_{2}(x)+\cdots+c_{n} f_{n}(x)=0, \quad \forall x \in I
$$

Definition: Linear Independence

A set of functions

$$
\left\{f_{1}(x), f_{2}(x), \ldots, f_{n}(x)\right\}
$$

is said to be linearly independent on an interval $I$ if

$$
c_{1} f_{1}(x)+c_{2} f_{2}(x)+\cdots+c_{n} f_{n}(x)=0, \quad \forall x \in I,
$$

only when

$$
c_{1}=c_{2}=\cdots=c_{n}=0
$$

## Case of two functions:

If $n=2$ then the set of functions becomes

$$
\left\{f_{1}(x), f_{2}(x)\right\}
$$

If we suppose that

$$
c_{1} f_{1}(x)+c_{2} f_{2}(x)=0
$$

Also that the functions are linearly dependent on an interval $I$ then either $c_{1} \neq 0$ or $c_{2} \neq 0$.

Let us assume that $c_{1} \neq 0$, then

$$
f_{1}(x)=-\frac{c_{2}}{c_{1}} f_{2}(x) ;
$$

Hence $f_{1}(x)$ is the constant multiple of $f_{2}(x)$.
Conversely, if we suppose

$$
f_{1}(x)=c_{2} f_{2}(x)
$$

Then

$$
(-1) f_{1}(x)+c_{2} f_{2}(x)=0, \forall x \in I
$$

So that the functions are linearly dependent because $c_{1}=-1$.

## Hence, we conclude that:

- Any two functions $f_{1}(x)$ and $f_{2}(x)$ are linearly dependent on an interval $I$ if and only if one is the constant multiple of the other.
- Any two functions are linearly independent when neither is a constant multiple of the other on an interval $I$.
- In general a set of $n$ functions $\left\{f_{1}(x), f_{2}(x), \ldots, f_{n}(x)\right\}$ is linearly dependent if at least one of them can be expressed as a linear combination of the remaining.


## Example 1

The functions

$$
\begin{array}{ll}
f_{1}(x)=\sin 2 x, & \forall x \in(-\infty, \infty) \\
f_{2}(x)=\sin x \cos x, & \forall x \in(-\infty, \infty)
\end{array}
$$

If we choose $c_{1}=\frac{1}{2}$ and $c_{2}=-1$ then

$$
c_{1} \sin 2 x+c_{2} \sin x \cos x=\frac{1}{2}(2 \sin x \cos x)-\sin x \cos x=0
$$

Hence, the two functions $f_{1}(x)$ and $f_{2}(x)$ are linearly dependent.

## Example 3

Consider the functions

$$
\begin{array}{ll}
f_{1}(x)=\cos ^{2} x, & f_{2}(x)=\sin ^{2} x,
\end{array} \quad \forall x \in(-\pi / 2, \pi / 2), ~=\sec ^{2} x, f_{4}(x)=\tan ^{2} x, \quad \forall x \in(-\pi / 2, \pi / 2), ~ l
$$

If we choose $c_{1}=c_{2}=1, c_{3}=-1, c_{4}=1$, then

$$
\begin{aligned}
& c_{1} f_{1}(x)+c_{2} f_{2}(x)+c_{3} f_{3}(x)+c_{4} f_{4}(x) \\
= & c_{1} \cos ^{2} x+c_{2} \sin ^{2} x+c_{3} \sec ^{2} x+c_{4} \tan ^{2} x \\
= & \cos ^{2} x+\sin ^{2} x+-1-\tan ^{2} x+\tan ^{2} x \\
= & 1-1+0=0
\end{aligned}
$$

Therefore, the given functions are linearly dependent.

## Note that

The function $f_{3}(x)$ can be written as a linear combination of other three functions $f_{1}(x), f_{2}(x)$ and $f_{4}(x)$ because $\sec ^{2} x=\cos ^{2} x+\sin ^{2} x+\tan ^{2} x$.

## Example 3

Consider the functions

$$
\begin{array}{ll}
f_{1}(x)=1+x, & \forall x \in(-\infty, \infty) \\
f_{2}(x)=x, & \forall x \in(-\infty, \infty) \\
f_{3}(x)=x^{2}, & \forall x \in(-\infty, \infty)
\end{array}
$$

Then

$$
c_{1} f_{1}(x)+c_{2} f_{2}(x)+c_{3} f_{3}(x)=0
$$

means that

$$
\begin{array}{ll}
c_{1}(1+x)+c_{2} x+c_{3} x^{2} & =0 \\
\text { or } & c_{1}+\left(c_{1}+c_{2}\right) x+c_{3} x^{2}
\end{array}
$$

Equating coefficients of $x$ and $x^{2}$ constant terms we obtain

$$
\begin{array}{ll} 
& c_{1}=0=c_{3} \\
& c_{1}+c_{2}=0 \\
\text { Therefore } \quad & c_{1}=c_{2}=c_{3}=0
\end{array}
$$

Hence, the three functions $f_{1}(x), f_{2}(x)$ and $f_{3}(x)$ are linearly independent.

Definition: Wronskian
Suppose that the function $f_{1}(x), f_{2}(x), \ldots, f_{n}(x)$ possesses at least $n-1$ derivatives then the determinant

$$
\left|\begin{array}{cccc} 
& & & \\
f_{1} & f_{2} & \cdots \cdots \cdots & f_{n} \\
f_{1}^{\prime} & f_{2}^{\prime} & \cdots \cdots \cdots & f_{n}^{\prime} \\
\vdots & \vdots & & \vdots \\
f_{1}^{n-1} & f_{2}^{n-1} & \cdots \cdots \cdots & f_{n}^{n-1}
\end{array}\right|
$$

is called Wronskian of the functions $f_{1}(x), f_{2}(x), \ldots, f_{n}(x)$ and is denoted by $W\left(f_{1}(x), f_{1}(x), \ldots, f_{1}(x)\right)$.

Theorem: Criterion for Linearly Independent Functions
Suppose the functions $f_{1}(x), f_{2}(x), \ldots, f_{n}(x)$ possess at least $n-1$ derivatives on an interval I . If

$$
W\left(f_{1}(x), f_{2}(x), \ldots, f_{n}(x)\right) \neq 0
$$

for at least one point in $I$, then functions $f_{1}(x), f_{2}(x), \ldots, f_{n}(x)$ are linearly independent on the interval $I$.

## Note that

This is only a sufficient condition for linear independence of a set of functions.

## In other words

If $f_{1}(x), f_{2}(x), \ldots, f_{n}(x)$ possesses at least $n-1$ derivatives on an interval and are linearly dependent on $I$, then

$$
W\left(f_{1}(x), f_{2}(x), \ldots, f_{n}(x)\right)=0, \quad \forall x \in I
$$

However, the converse is not true. i.e. a Vanishing Wronskian does not guarantee linear dependence of functions.

## Example 1

The functions

$$
\begin{aligned}
& f_{1}(x)=\sin ^{2} x \\
& f_{2}(x)=1-\cos 2 x
\end{aligned}
$$

are linearly dependent because

$$
\sin ^{2} x=\frac{1}{2}(1-\cos 2 x)
$$

We observe that for all $x \in(-\infty, \infty)$

$$
\begin{aligned}
W\left(f_{1}(x), f_{2}(x)\right)= & \left|\begin{array}{cc}
\sin ^{2} x & 1-\cos 2 x \\
2 \sin x \cos x & 2 \sin 2 x
\end{array}\right| \\
= & 2 \sin ^{2} x \sin 2 x-2 \sin x \cos x \\
& +2 \sin x \cos x \cos 2 x \\
= & \sin 2 x\left[2 \sin ^{2} x-1+\cos 2 x\right] \\
= & \sin 2 x\left[2 \sin ^{2} x-1+\cos ^{2} x-\sin ^{2} x\right] \\
= & \sin 2 x\left[\sin ^{2} x+\cos ^{2} x-1\right] \\
= & 0
\end{aligned}
$$

## Example 2

Consider the functions

$$
f_{1}(x)=e^{m_{1} x}, f_{2}(x)=e^{m_{2} x}, \quad m_{1} \neq m_{2}
$$

The functions are linearly independent because

$$
c_{1} f_{1}(x)+c_{2} f_{2}(x)=0
$$

if and only if

$$
c_{1}=0=c_{2} \quad \text { as } \quad m_{1} \neq m_{2}
$$

Now for all $x \in R$

$$
\begin{aligned}
W\left(e^{m_{1} x}, e^{m_{2} x}\right) & =\left|\begin{array}{cc}
e^{m_{1} x} & e^{m_{2} x} \\
m_{1} e^{m_{1} x} & m_{2} e^{m_{2} x}
\end{array}\right| \\
& =\left(m_{2}-m_{1}\right) e^{\left(m_{1}+m_{2}\right) x} \\
& \neq 0
\end{aligned}
$$

Thus $f_{1}$ and $f_{2}$ are linearly independent of any interval on $x$-axis.

## Example 3

If $\alpha$ and $\beta$ are real numbers, $\beta \neq 0$, then the functions

$$
y_{1}=e^{\alpha x} \cos \beta x \text { and } y_{2}=e^{\alpha x} \sin \beta x
$$

are linearly independent on any interval of the $x$-axis because

$$
\begin{aligned}
& W\left(e^{\alpha x} \cos \beta x, e^{\alpha x} \sin \beta x\right) \\
& =\left|\begin{array}{cc}
e^{\alpha x} \cos \beta x & e^{\alpha x} \sin \beta x \\
-\beta e^{\alpha x} \sin \beta x+\alpha e^{\alpha x} \cos \beta x & \beta e^{\alpha x} \cos \beta x+\alpha e^{\alpha x} \sin \beta x
\end{array}\right| \\
& =\beta e^{2 \alpha x}\left(\cos ^{2} \beta x+\sin ^{2} \beta x\right)=\beta e^{2 \alpha x} \neq 0
\end{aligned}
$$

## Example 4

The functions

$$
f_{1}(x)=e^{x}, f_{2}(x)=x e^{x}, \text { and } f_{3}(x)=x^{2} e^{x}
$$

are linearly independent on any interval of the $x$-axis because for all $x \in R$, we have

$$
\begin{aligned}
W\left(e^{x}, x e^{x}, x^{2} e^{x}\right) & =\left|\begin{array}{ccc}
e^{x} & x e^{x} & x^{2} e^{x} \\
e^{x} & x e^{x}+e^{x} & x^{2} e^{x}+2 x e^{x} \\
e^{x} & x e^{x}+2 e^{x} & x^{2} e^{x}+4 x e^{x}+2 e^{x}
\end{array}\right| \\
& =2 e^{3 x} \neq 0
\end{aligned}
$$

## Exercise

1. Given that

$$
y=c_{1} e^{x}+c_{2} e^{-x}
$$

is a two-parameter family of solutions of the differential equation

$$
y^{\prime \prime}-y=0
$$

on $(-\infty, \infty)$, find a member of the family satisfying the boundary conditions

$$
y(0)=0, \quad y^{\prime}(1)=1
$$

2. Given that

$$
y=c_{1}+c_{2} \cos x+c_{3} \sin x
$$

is a three-parameter family of solutions of the differential equation

$$
y^{\prime \prime \prime}+y^{\prime}=0
$$

on the interval $(-\infty, \infty)$, find a member of the family satisfying the initial conditions $y(\pi)=0, y^{\prime}(\pi)=2, y^{\prime \prime}(\pi)=-1$.
3. Given that

$$
y=c_{1} x+c_{2} x \ln x
$$

is a two-parameter family of solutions of the differential equation $x^{2} y^{\prime \prime}-x y^{\prime}+y=0$ on $(-\infty, \infty)$. Find a member of the family satisfying the initial conditions

$$
y(1)=3, \quad y^{\prime}(1)=-1 .
$$

## Lecture 14

## Solutions of Higher Order Linear Equations

## Preliminary Theory

- In order to solve an $n$th order non-homogeneous linear differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

we first solve the associated homogeneous differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

- Therefore, we first concentrate upon the preliminary theory and the methods of solving the homogeneous linear differential equation.
- We recall that a function $y=f(x)$ that satisfies the associated homogeneous equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

is called solution of the differential equation.

## Superposition Principle

Suppose that $y_{1}, y_{2}, \ldots, y_{n}$ are solutions on an interval $I$ of the homogeneous linear differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

Then

$$
y=c_{1} y_{1}(x)+c_{2} y_{2}(x)+\cdots+c_{n} y_{n}(x)
$$

$c_{1}, c_{2}, \ldots, c_{n}$ being arbitrary constants is also a solution of the differential equation.

## Note that

- A constant multiple $y=c_{1} y_{1}(x)$ of a solution $y_{1}(x)$ of the homogeneous linear differential equation is also a solution of the equation.
- The homogeneous linear differential equations always possess the trivial solution $y=0$.
- The superposition principle is a property of linear differential equations and it does not hold in case of non-linear differential equations.


## Example 1

The functions

$$
y_{1}=e^{x}, y_{2}=c^{2 x}, \text { and } y_{3}=e^{3 x}
$$

all satisfy the homogeneous differential equation

$$
\frac{d^{3} y}{d x^{3}}-6 \frac{d^{2} y}{d x^{2}}+11 \frac{d y}{d x}-6 y=0
$$

on $(-\infty, \infty)$. Thus $y_{1}, y_{2}$ and $y_{3}$ are all solutions of the differential equation

Now suppose that

$$
y=c_{1} e^{x}+c_{2} e^{2 x}+c_{3} e^{3 x} .
$$

Then

$$
\begin{aligned}
& \frac{d y}{d x}=c_{1} e^{x}+2 c_{2} e^{2 x}+3 c_{3} e^{3 x} \\
& \frac{d^{2} y}{d x^{2}}=c_{1} e^{x}+4 c_{2} e^{2 x}+9 c_{3} e^{3 x} \\
& \frac{d^{3} y}{d x^{3}}=c_{1} e^{x}+8 c_{2} e^{2 x}+27 c_{3} e^{3 x}
\end{aligned}
$$

Therefore

$$
\begin{aligned}
& \frac{d^{3} y}{d x^{3}}-6 \frac{d^{2} y}{d x^{2}}+11 \frac{d y}{d x}-6 y \\
& =c_{1}\left(e^{x}-6 e^{x}+11 e^{x}-6 e^{x}\right)+c_{2}\left(8 e^{2 x}-24 e^{2 x}+22 e^{2 x}-6 e^{2 x}\right) \\
& +c_{3}\left(27 e^{3 x}-54 e^{3 x}+33 e^{3 x}-6 e^{3 x}\right) \\
& =c_{1}(12-12) e^{x}+c_{2}(30-30) e^{2 x}+c_{3}(60-60) e^{3 x} \\
& =0
\end{aligned}
$$

Thus

$$
y=c_{1} e^{x}+c_{2} e^{2 x}+c_{3} e^{3 x} .
$$

is also a solution of the differential equation.

## Example 2

The function

$$
y=x^{2}
$$

is a solution of the homogeneous linear equation

$$
x^{2} y^{\prime \prime}-3 x y^{\prime}+4 y=0
$$

on $(0, \infty)$.
Now consider

$$
y=c x^{2}
$$

Then

$$
y^{\prime}=2 c x \text { and } y^{\prime \prime}=2 c
$$

So that

$$
x^{2} y^{\prime \prime}-3 x y^{\prime}+4 y=2 c x^{2}-6 c x^{2}+4 c x^{2}=0
$$

Hence the function

$$
y=c x^{2}
$$

is also a solution of the given differential equation.

## The Wronskian

Suppose that $y_{1}, y_{2}$ are 2 solutions, on an interval $I$, of the second order homogeneous linear differential equation

$$
a_{2} \frac{d^{2} y}{d x^{2}}+a_{1} \frac{d y}{d x}+a_{0} y=0
$$

Then either

$$
W\left(y_{1}, y_{2}\right)=0, \quad \forall x \in I
$$

or

$$
W\left(y_{1}, y_{2}\right) \neq 0, \quad \forall x \in I
$$

To verify this we write the equation as

$$
\begin{aligned}
& \frac{d^{2} y}{d x^{2}}+\frac{P d y}{d x}+Q y=0 \\
& W\left(y_{1}, y_{2}\right)=\left|\begin{array}{ll}
y_{1} & y_{2} \\
y_{1}^{\prime} & y_{2}^{\prime}
\end{array}\right|=y_{1} y_{2}^{\prime}-y_{1}^{\prime} y_{2}
\end{aligned}
$$

Now

Differentiating w.r.to $x$, we have

$$
\frac{d W}{d x}=y_{1} y_{2}^{\prime \prime}-y_{1}^{\prime \prime} y_{2}
$$

Since $y_{1}$ and $y_{2}$ are solutions of the differential equation

$$
\frac{d^{2} y}{d x^{2}}+\frac{P d y}{d x}+Q y=0
$$

Therefore

$$
\begin{aligned}
& y_{1}^{\prime \prime}+P y_{1}^{\prime}+Q y_{1}=0 \\
& y_{2}^{\prime \prime}+P y_{2}^{\prime}+Q y_{2}=0
\end{aligned}
$$

Multiplying $1^{\text {st }}$ equation by $y_{2}$ and $2^{\text {nd }}$ by $y_{1}$ the have

$$
\begin{aligned}
& y_{1}^{\prime \prime} y_{2}+P y_{1}^{\prime} y_{2}+Q y_{1} y_{2}=0 \\
& y_{1} y_{2}^{\prime \prime}+P y_{1} y_{2}^{\prime}+Q y_{1} y_{2}=0
\end{aligned}
$$

Subtracting the two equations we have:

$$
\left(y_{1} y_{2}^{\prime \prime}-y_{2} y_{1}^{\prime \prime}\right)+P\left(y_{1} y_{2}^{\prime}-y_{1}^{\prime} y_{2}\right)=0
$$

or

$$
\frac{d W}{d x}+P W=0
$$

This is a linear $1^{\text {st }}$ order differential equation in $W$, whose solution is

$$
W=c e^{-\int P d x}
$$

Therefore

- If $c \neq 0$ then $W\left(y_{1}, y_{2}\right) \neq 0, \quad \forall x \in I$
- If $c=0$ then $W\left(y_{1}, y_{2}\right)=0, \quad \forall x \in I$

Hence Wronskian of $y_{1}$ and $y_{2}$ is either identically zero or is never zero on $I$.

## In general

If $y_{1}, y_{2}, \ldots, y_{n}$ are $n$ solutions, on an interval $I$, of the homogeneous $n$th order linear differential equation with constants coefficients

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=0
$$

Then
Either

$$
W\left(y_{1}, y_{2}, \ldots, y_{n}\right)=0, \quad \forall x \in I
$$

or

$$
W\left(y_{1}, y_{2}, \ldots, y_{n}\right) \neq 0, \quad \forall x \in I
$$

## Linear Independence of Solutions:

Suppose that

$$
y_{1}, y_{2}, \ldots, y_{n}
$$

are $n$ solutions, on an interval $I$, of the homogeneous linear $n$ th-order differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

Then the set of solutions is linearly independent on $I$ if and only if

$$
W\left(y_{1}, y_{2}, \ldots, y_{n}\right) \neq 0
$$

## In other words

The solutions

$$
y_{1}, y_{2}, \ldots, y_{n}
$$

are linearly dependent if and only if

$$
W\left(y_{1}, y_{2}, \ldots, y_{n}\right)=0, \quad \forall x \in I
$$

## Fundamental Set of Solutions

A set

$$
\left\{y_{1}, y_{2}, \ldots, y_{n}\right\}
$$

of $n$ linearly independent solutions, on interval $I$, of the homogeneous linear $n$ th-order differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

is said to be a fundamental set of solutions on the interval $I$.

## Existence of a Fundamental Set

There always exists a fundamental set of solutions for a linear $n$ th-order homogeneous differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

on an interval $I$.

## General Solution-Homogeneous Equations

Suppose that

$$
\left\{y_{1}, y_{2}, \ldots, y_{n}\right\}
$$

is a fundamental set of solutions, on an interval $I$, of the homogeneous linear $n$ th-order differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

Then the general solution of the equation on the interval $I$ is defined to be

$$
y=c_{1} y_{1}(x)+c_{2} y_{2}(x)+\cdots+c_{n} y_{n}(x)
$$

Here $c_{1}, c_{2}, \ldots, c_{n}$ are arbitrary constants.

## Example 1

The functions

$$
y_{1}=e^{3 x} \text { and } y_{2}=e^{-3 x}
$$

are solutions of the differential equation

$$
y^{\prime \prime}-9 y=0
$$

Since $\quad W\left(e^{3 x}, e^{-3 x}\right)=\left|\begin{array}{cc}e^{3 x} & e^{-3 x} \\ 3 e^{3 x} & -3 e^{-3 x}\end{array}\right|=-6 \neq 0, \quad \forall x \in I$
Therefore $y_{1}$ and $y_{2}$ from a fundamental set of solutions on $(-\infty, \infty)$. Hence general solution of the differential equation on the $(-\infty, \infty)$ is

$$
y=c_{1} e^{3 x}+c_{2} e^{-3 x}
$$

## Example 2

Consider the function $y=4 \sinh 3 x-5 e^{-3 x}$
Then

$$
y^{\prime}=12 \cosh 3 x+15 e^{-3 x}, \quad y^{\prime \prime}=36 \sinh 3 x-45 e^{-3 x}
$$

$\Rightarrow \quad y^{\prime \prime}=9\left(4 \sinh 3 x-5 e^{-3 x}\right) \quad$ or $\quad y^{\prime \prime}=9 y$,
Therefore $\quad y^{\prime \prime}-9 y=0$
Hence

$$
y=4 \sinh 3 x-5 e^{-3 x}
$$

is a particular solution of differential equation.

$$
y^{\prime \prime}-9 y=0
$$

The general solution of the differential equation is

$$
y=c_{1} e^{3 x}+c_{2} e^{-3 x}
$$

Choosing

$$
c_{1}=2, c_{2}=-7
$$

We obtain

$$
\begin{aligned}
& y=2 e^{3 x}-7 e^{-3 x} \\
& y=2 e^{3 x}-2 e^{-3 x}-5 e^{-3 x} \\
& y=4\left(\frac{e^{3 x}-e^{-3 x}}{2}\right)-5 e^{-3 x} \\
& y=4 \sinh 3 x-5 e^{-3 x}
\end{aligned}
$$

Hence, the particular solution has been obtained from the general solution.

## Example 3

Consider the differential equation

$$
\frac{d^{3} y}{d x^{3}}-6 \frac{d^{2} y}{d x^{2}}+11 \frac{d y}{d x}-6 y=0
$$

and suppose that

$$
y_{1}=e^{x}, y_{2}=e^{2 x} \text { and } y_{3}=e^{3 x}
$$

Then

$$
\frac{d y_{1}}{d x}=e^{x}=\frac{d^{2} y_{1}}{d x^{2}}=\frac{d^{3} y_{1}}{d x^{3}}
$$

Therefore

$$
\frac{d^{3} y_{1}}{d x^{3}}-6 \frac{d^{2} y_{1}}{d x^{2}}+11 \frac{d y_{1}}{d x}-6 y_{1}=e^{x}-6 e^{X}+11 e^{X}-6 e^{x}
$$

or

$$
\frac{d^{3} y_{1}}{d x^{3}}-6 \frac{d^{2} y_{1}}{d x^{2}}+11 \frac{d y_{1}}{d x}-6 y_{1}=12 e^{x}-12 e^{x}=0
$$

Thus the function $y_{1}$ is a solution of the differential equation. Similarly, we can verify that the other two functions i.e. $y_{2}$ and $y_{3}$ also satisfy the differential equation.
Now for all $x \in R$

$$
W\left(e^{x}, e^{2 x}, e^{3 x}\right)=\left|\begin{array}{ccc}
e^{x} & e^{2 x} & e^{3 x} \\
e^{x} & 2 e^{2 x} & 3 e^{3 x} \\
e^{x} & 4 e^{2 x} & 9 e^{3 x}
\end{array}\right|=2 e^{6 x} \neq 0 \quad \forall x \in I
$$

Therefore $y_{1}, y_{2}$, and $y_{3}$ form a fundamental solution of the differential equation on $(-\infty, \infty)$. We conclude that

$$
y=c_{1} e^{x}+c_{2} e^{2 x}+c_{3} e^{3 x}
$$

is the general solution of the differential equation on the interval $(-\infty, \infty)$.

## Non-Homogeneous Equations

A function $y_{p}$ that satisfies the non-homogeneous differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

and is free of parameters is called the particular solution of the differential equation

## Example 1

Suppose that

$$
y_{p}=3
$$

Then

$$
y_{p}^{\prime \prime}=0
$$

So that

$$
\begin{aligned}
y_{p}^{\prime \prime}+9 y_{p} & =0+9(3) \\
& =27
\end{aligned}
$$

Therefore

$$
y_{p}=3
$$

is a particular solution of the differential equation

$$
y_{p}^{\prime \prime}+9 y_{p}=27
$$

## Example 2

Suppose that

$$
y_{p}=x^{3}-x
$$

Then

$$
y_{p}^{\prime}=3 x^{2}-1, \quad y_{p}^{\prime \prime}=6 x
$$

Therefore

$$
\begin{gathered}
x^{2} y_{p}^{\prime \prime}+2 x y_{p}^{\prime}-8 y_{p}=x^{2}(6 x)+2 x\left(3 x^{2}-1\right)-8\left(x^{3}-x\right) \\
=4 x^{3}+6 x
\end{gathered}
$$

Therefore

$$
y_{p}=x^{3}-x
$$

is a particular solution of the differential equation

$$
x^{2} y^{\prime \prime}+2 x y^{\prime}-8 y=4 x^{3}+6 x
$$

## Complementary Function

The general solution

$$
y_{c}=c_{1} y_{1}+c_{2} y_{2}+\cdots+c_{n} y_{n}
$$

of the homogeneous linear differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

is known as the complementary function for the non-homogeneous linear differential equation.

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

## General Solution of Non-Homogeneous Equations

Suppose that

- The particular solution of the non-homogeneous equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

is $y_{p}$.

- The complementary function of the non-homogeneous differential equation

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

is

$$
y_{c}=c_{1} y_{1}+c_{2} y_{2}+\cdots+c_{n} y_{n} .
$$

- Then general solution of the non-homogeneous equation on the interval $I$ is given by

$$
y=y_{c}+y_{p}
$$

or

$$
y=c_{1} y_{1}(x)+c_{2} y_{2}(x)+\cdots+c_{n} y_{n}(x)+y_{p}(x)=y_{c}(x)+y_{p}(x)
$$

## Hence

General Solution = Complementary solution + any particular solution.

## Example

Suppose that

$$
y_{p}=-\frac{11}{12}-\frac{1}{2} x
$$

Then

$$
y_{p}^{\prime}=-\frac{1}{2}, y_{p}^{\prime \prime}=0=y_{p}^{\prime \prime \prime}
$$

$$
\therefore \quad \frac{d^{3} y_{p}}{d x^{3}}-6 \frac{d^{2} y_{p}}{d x^{2}}+11 \frac{d y_{p}}{d x}-6 y_{p}=0-0-\frac{11}{2}+\frac{11}{2}+3 x=3 x
$$

Hence

$$
y_{p}=-\frac{11}{12}-\frac{1}{2} x
$$

is a particular solution of the non-homogeneous equation

$$
\frac{d^{3} y}{d x^{3}}-6 \frac{d^{2} y}{d x^{2}}+11 \frac{d y}{d x}-6 y=3 x
$$

Now consider

$$
y_{C}=c_{1} e^{x}+c_{2} e^{2 x}+c_{3} e^{3 x}
$$

Then

$$
\begin{aligned}
& \frac{d y_{C}}{d x}=c_{1} e^{x}+2 c_{2} e^{2 x}+3 c_{3} e^{3 x} \\
& \frac{d^{2} y_{C}}{d x^{2}}=c_{1} e^{x}+4 c_{2} e^{2 x}+9 c_{3} e^{3 x} \\
& \frac{d^{3} y_{C}}{d x^{3}}=c_{1} e^{x}+8 c_{2} e^{2 x}+27 c_{3} e^{3 x}
\end{aligned}
$$

Since,

$$
\begin{aligned}
& \frac{d^{3} y_{C}}{d x^{3}}-6 \frac{d^{2} y_{C}}{d x^{2}}+11 \frac{d y_{C}}{d x}-6 y_{C} \\
& =c_{1} e^{x}+8 c_{2} e^{2 x}+27 c_{3} e^{3 x}-6\left(c_{1} e^{x}+4 c_{2} e^{2 x}+9 c_{3} e^{3 x}\right) \\
& +11\left(c_{1} e^{x}+2 c_{2} e^{2 x}+3 c_{3} e^{3 x}\right)-6\left(c_{1} e^{x}+c_{2} e^{2 x}+c_{3} e^{3 x}\right) \\
& =12 c_{1} e^{x}-12 c_{1} e^{x}+30 c_{2} e^{2 x}-30 c_{2} e^{2 x}+60 c_{3} e^{3 x}-60 c_{3} e^{3 x} \\
& =0
\end{aligned}
$$

Thus $y_{c}$ is general solution of associated homogeneous differential equation

$$
\frac{d^{3} y}{d x^{3}}-6 \frac{d^{2} y}{d x^{2}}+11 \frac{d y}{d x}-6 y=0
$$

Hence general solution of the non-homogeneous equation is

$$
y=y_{c}+y_{p}=c_{1} e^{x}+c_{2} e^{2 x}+c_{3} e^{3 x}-\frac{11}{12}-\frac{1}{2} x
$$

## Superposition Principle for Non-homogeneous Equations

Suppose that

$$
y_{p_{1}}, y_{p_{2}}, \ldots, y_{p_{k}}
$$

denote the particular solutions of the $k$ differential equation

$$
a_{n}(x) y^{(n)}+a_{n-1}(x) y^{(n-1)}+\cdots+a_{1}(x) y^{\prime}+a_{0}(x) y=g_{i}(x),
$$

$i=1,2, \ldots k$, on an interval $I$. Then

$$
y_{p}=y_{p_{1}}(x)+y_{p_{2}}(x)+\cdots+y_{p_{k}}(x)
$$

is a particular solution of

$$
a_{n}(x) y^{(n)}+a_{n-1}(x) y^{(n-1)}+\cdots+a_{1}(x) y^{\prime}+a_{0}(x) y=g_{1}(x)+g_{2}(x)+\cdots+g_{k}(x)
$$

## Example

Consider the differential equation

$$
y^{\prime \prime}-3 y^{\prime}+4 y=-16 x^{2}+24 x-8+2 e^{2 x}+2 x e^{x}-e^{x}
$$

Suppose that

$$
y_{p_{1}}=-4 x^{2}, \quad y_{p_{2}}=e^{2 x}, \quad y_{p_{3}}=x e^{x}
$$

Then

$$
y_{p_{1}}^{\prime \prime}-3 y_{p_{1}}^{\prime}+4 y_{p_{1}}=-8+24 x-16 x^{2}
$$

Therefore

$$
y_{p_{1}}=-4 x^{2}
$$

is a particular solution of the non-homogenous differential equation

$$
y^{\prime \prime}-3 y^{\prime}+4 y=-16 x^{2}+24 x-8
$$

Similarly, it can be verified that

$$
y_{p_{2}}=e^{2 x} \text { and } y_{p_{3}}=x e^{x}
$$

are particular solutions of the equations:
and

$$
y^{\prime \prime}-3 y^{\prime}+4 y=2 e^{2 x}
$$

respectively.

Hence $\quad y_{p}=y_{p_{1}}+y_{p_{2}}+y_{p_{3}}=-4 x^{2}+e^{2 x}+x e^{x}$
is a particular solution of the differential equation

$$
y^{\prime \prime}-3 y^{\prime}+4 y=-16 x^{2}+24 x-8+2 e^{2 x}+2 x e^{x}-e^{x}
$$

## Exercise

Verify that the given functions form a fundamental set of solutions of the differential equation on the indicated interval. Form the general solution.

## Construction of a Second Solution

## General Case

Consider the differential equation

$$
a_{2}(x) \frac{d^{2} y}{d x^{2}}+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=0
$$

We divide by $a_{2}(x)$ to put the above equation in the form

$$
y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=0
$$

Where $P(x)$ and $Q(x)$ are continuous on some interval $I$.
Suppose that $y_{1}(x) \neq 0, \forall x \in \mathrm{I}$ is a solution of the differential equation
Then

$$
y_{1}^{\prime \prime}+P y_{1}^{\prime}+Q y_{1}=0
$$

We define $y=u(x) y_{1}(x)$ then

$$
\begin{gathered}
y^{\prime}=u y_{1}^{\prime}+y_{1} u^{\prime}, \quad y^{\prime \prime}=u y_{1}^{\prime \prime}+2 y_{1}^{\prime} u_{1}^{\prime}+y_{1} u^{\prime \prime} \\
y^{\prime \prime}+P y^{\prime}+Q y=u[\underbrace{y_{1}^{\prime \prime}+P y_{1}^{\prime}+Q y_{1}}_{\text {zero }}]+y_{1} u^{\prime \prime}+\left(2 y_{1}^{\prime}+P y_{1}\right) u^{\prime}=0
\end{gathered}
$$

This implies that we must have

$$
y_{1} u^{\prime \prime}+\left(2 y_{1}^{\prime}+P y_{1}\right) u^{\prime}=0
$$

If we suppose $w=u^{\prime}$, then

$$
y_{1} w^{\prime}+\left(2 y_{1}^{\prime}+P y_{1}\right) w=0
$$

The equation is separable. Separating variables we have from the last equation

$$
\cdot \frac{d w}{w}+\left(2 \frac{y_{1}^{\prime}}{y_{1}}+P\right) d x=0
$$

Integrating

$$
\begin{aligned}
& \ln |w|+2 \ln \left|y_{1}\right|=-\int P d x+c \\
& \ln \left|w y_{1}^{2}\right|=-\int P d x+c \\
& w y_{1}^{2}=c_{1} e^{-\int P d x} \\
& w=\frac{c_{1} e^{-\int P d x} d x}{y_{1}^{2}}
\end{aligned}
$$

or

$$
u^{\prime}=\frac{c_{1} e^{-\int P d x}}{y_{1}^{2}}
$$

Integrating again, we obtain

$$
u=c_{1} \int \frac{e^{-\int P d x}}{y_{1}^{2}} d x+c_{2}
$$

Hence $\quad y=u(x) y_{1}(x)=c_{1} y_{1}(x) \int \frac{e^{-\int P d x}}{y_{1}{ }^{2}} d x+c_{2} y_{1}(x)$.
Choosing $c_{1}=1$ and $c_{2}=0$, we obtain a second solution of the differential equation

$$
y_{2}=y_{1}(x) \int \frac{e^{-\int P d x}}{y_{1}{ }^{2}} d x
$$

## The Woolskin

$$
\begin{aligned}
W\left(y_{1}(x), y_{2}(x)\right)= & \left|\begin{array}{cc}
y_{1} & y_{1} \int \frac{e^{-\int P d x}}{y_{1}^{2}} d x \\
y_{1}^{\prime} & \frac{e^{-\int P d x}}{y_{1}}+y_{1}^{\prime} \\
\frac{e^{-\int P d x}}{y_{1}^{2}} d x
\end{array}\right| \\
& =e^{-\int P d x} \neq 0, \forall x
\end{aligned}
$$

Therefore $y_{1}(x)$ and $y_{2}(x)$ are linear independent set of solutions. So that they form a fundamental set of solutions of the differential equation

$$
y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=0
$$

Hence the general solution of the differential equation is

$$
y(x)=c_{1} y_{1}(x)+c_{2} y_{2}(x)
$$

## Example 1

Given that

$$
y_{1}=x^{2}
$$

is a solution of

$$
x^{2} y^{\prime \prime}-3 x y^{\prime}+4 y=0
$$

Find general solution of the differential equation on the interval $(0, \infty)$.

## Solution:

The equation can be written as

$$
y^{\prime \prime}-\frac{3}{x} y^{\prime}+\frac{4}{x^{2}} y=0
$$

The $2^{\text {nd }}$ solution $y_{2}$ is given by

$$
\begin{aligned}
& y_{2}=y_{1}(x) \int \frac{e^{-\int P d x}}{y_{1}^{2}} d x \\
& y_{2}=x^{2} \int \frac{e^{3 \int d x / x}}{x^{4}} d x=x^{2} \int \frac{e^{\ln x^{3}}}{x^{4}} d x \\
& y_{2}=x^{2} \int \frac{1}{x} d x=x^{2} \ln x
\end{aligned}
$$

Hence the general solution of the differential equation on $(0, \infty)$ is given by
or

$$
y=c_{1} \mathrm{y}_{1}+\mathrm{c}_{2} y_{2}
$$

$$
y=c_{1} \mathrm{x}^{2}+\mathrm{c}_{2} x^{2} \ln x
$$

## Example 2

Verify that

$$
y_{1}=\frac{\sin x}{\sqrt{x}}
$$

is a solution of

$$
x^{2} y^{\prime \prime}+x y^{\prime}+\left(x^{2}-1 / 4\right) y=0
$$

on $(0, \pi)$. Find a second solution of the equation.

## Solution:

The differential equation can be written as

$$
y^{\prime \prime}+\frac{1}{x} y^{\prime}+\left(1-\frac{1}{4 x^{2}}\right) y=0
$$

The $2^{\text {nd }}$ solution is given by

$$
\begin{aligned}
y_{2} & =y_{1} \int \frac{e^{-\int P d x}}{y_{1}{ }^{2} d x} \\
y_{2} & =\frac{\sin x}{\sqrt{x}} \int \frac{e^{-\int \frac{d x}{x}}}{\left(\frac{\sin x}{\sqrt{x}}\right)^{2}} d x \\
& =\frac{-\sin x}{\sqrt{x}} \int \frac{x}{x \sin ^{2} x} d x \\
& =\frac{-\sin x}{\sqrt{x}} \int \csc ^{2} x d x \\
& =\frac{-\sin x}{\sqrt{x}}(-\cot x)=\frac{\cos x}{\sqrt{x}}
\end{aligned}
$$

Thus the second solution is

$$
y_{2}=\frac{\cos x}{\sqrt{x}}
$$

Hence, general solution of the differential equation is

$$
y=c_{1}\left(\frac{\sin x}{\sqrt{x}}\right)+c_{2}\left(\frac{\cos x}{\sqrt{x}}\right)
$$

## Order Reduction

## Example 3

Given that

$$
y_{1}=x^{3}
$$

is a solution of the differential equation

$$
x^{2} y^{\prime \prime}-6 y=0
$$

Find second solution of the equation

## Solution

We write the given equation as:

$$
\begin{aligned}
& y^{\prime \prime}-\frac{6}{x^{2}} y=0 \\
& P(x)=-\frac{6}{x^{2}}
\end{aligned}
$$

So that

Therefore

$$
\begin{aligned}
& y_{2}=y_{1} \int \frac{e^{-\int P d x}}{y_{1}{ }^{2}} d x \\
& y_{2}=x^{3} \int \frac{e^{-\int \frac{6}{x^{2}}}}{x^{6}} d x \\
& y_{2}=x^{3} \int \frac{e^{\frac{6}{x}}}{x^{6}} d x
\end{aligned}
$$

Therefore, using the formula

$$
y_{2}=y_{1} \int \frac{e^{-\int P d x}}{y_{1}^{2}} d x
$$

We encounter an integral that is difficult or impossible to evaluate.

Hence, we conclude sometimes use of the formula to find a second solution is not suitable. We need to try something else.
Alternatively, we can try the reduction of order to find $y_{2}$. For this purpose, we again define

$$
y(x)=u(x) y_{1}(x) \text { or } y=u(x) \cdot x^{3}
$$

then

$$
\begin{aligned}
& y^{\prime}=3 x^{2} u+x^{3} u^{\prime} \\
& y^{\prime \prime}=x^{3} u^{\prime \prime}+6 x^{2} u^{\prime}+6 x u
\end{aligned}
$$

Substituting the values of $y, y^{\prime \prime}$ in the given differential equation

$$
x^{2} y^{\prime \prime}-6 y=0
$$

we have

$$
x^{2}\left(x^{3} u^{\prime \prime}+6 x^{2} u^{\prime}+6 x u\right)-6 u x^{3}=0
$$

or

$$
x^{5} u^{\prime \prime}+6 x^{4} u^{\prime}=0
$$

or

$$
u^{\prime \prime}+\frac{6}{x} u^{\prime}=0,
$$

If we take $w=u^{\prime}$ then

$$
w^{\prime}+\frac{6}{x} w=0
$$

This is separable as well as linear first order differential equation in $w$. For using the latter, we find the integrating factor

$$
I . F=e^{6 \int \frac{1}{x} d x}=e^{6 \ln x}=x^{6}
$$

Multiplying with the $I F=x^{6}$, we obtain
or

$$
\begin{aligned}
& x^{6} w^{\prime}+6 x^{5} w=0 \\
& \frac{d}{d x}\left(x^{6} w\right)=0
\end{aligned}
$$

Integrating w.r.t. ' $x$ ', we have
or

$$
\begin{aligned}
& x^{6} w=c_{1} \\
& u^{\prime}=\frac{c_{1}}{x^{6}}
\end{aligned}
$$

Integrating once again, gives

Therefore

$$
u=-\frac{c_{1}}{5 x^{5}}+c_{2}
$$

$$
y=u x^{3}=\frac{-c_{1}}{5 x^{2}}+c_{2} x^{3}
$$

Choosing $c_{2}=0$ and $c_{1}=-5$, we obtain

$$
y_{2}=\frac{1}{x^{2}}
$$

Thus the second solution is given by

$$
y_{2}=\frac{1}{x^{2}}
$$

Hence, general solution of the given differential equation is

$$
y=c_{1} y_{1}+c_{2} y_{2}
$$

i.e. $\quad y=c_{1} x^{3}+c_{2}\left(1 / x^{2}\right)$

Where $c_{1}$ and $c_{2}$ are constants.

## Lecture 16

## Homogeneous Linear Equations with Constant Coefficients

We know that the linear first order differential equation

$$
\frac{d y}{d x}+m y=0
$$

$m$ being a constant, has the exponential solution on $(-\infty, \infty)$

$$
y=c_{1} e^{-m x}
$$

The question?

- The question is whether or not the exponential solutions of the higher-order differential equations

$$
a_{n} y^{(n)}+a_{n-1} y^{(n-1)}+\cdots+a_{2} y^{\prime \prime}+a_{1} y^{\prime}+a_{0} y=0,
$$

exist on $(-\infty, \infty)$.

- In fact all the solutions of this equation are exponential functions or constructed out of exponential functions.


## Recall

That the linear differential of order $n$ is an equation of the form

$$
a_{n}(x) \frac{d^{n} y}{d x^{n}}+a_{n-1}(x) \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1}(x) \frac{d y}{d x}+a_{0}(x) y=g(x)
$$

## Method of Solution

Taking $n=2$, the $n$ th-order differential equation becomes

$$
a_{2} \frac{d^{2} y}{d x^{2}}+a_{1} \frac{d y}{d x}+a_{0} y=0
$$

This equation can be written as

$$
a \frac{d^{2} y}{d x^{2}}+b \frac{d y}{d x}+c y=0
$$

We now try a solution of the exponential form

$$
y=e^{m x}
$$

Then

$$
y^{\prime}=m e^{m x} \text { and } y^{\prime \prime}=m^{2} e^{m x}
$$

Substituting in the differential equation, we have

Since

$$
\begin{aligned}
& e^{m x}\left(a m^{2}+b m+c\right)=0 \\
& e^{m x} \neq 0, \quad \forall x \in(-\infty, \infty) \\
& a m^{2}+b m+c=0
\end{aligned}
$$

Therefore

This algebraic equation is known as the Auxiliary equation (AE). The solution of the auxiliary equation determines the solutions of the differential equation.
Case 1: Distinct Real Roots
If the auxiliary equation has distinct real roots $m_{1}$ and $m_{2}$ then we have the following two solutions of the differential equation.

$$
y_{1}=e^{m_{1} x} \text { and } y_{2}=e^{m_{2} x}
$$

These solutions are linearly independent because

$$
W\left(y_{1}, y_{2}\right)=\left|\begin{array}{ll}
y_{1} & y_{2} \\
y_{1}^{\prime} & y_{2}^{\prime}
\end{array}\right|=\left(m_{2}-m_{1}\right) e^{\left(m_{1}+m_{2}\right) x}
$$

Since $m_{1} \neq m_{2}$ and $e^{\left(m_{1}+m_{2}\right) x} \neq 0$
Therefore

$$
W\left(y_{1}, y_{2}\right) \neq 0 \quad \forall x \in(-\infty, \infty)
$$

Hence

- $y_{1}$ and $y_{2}$ form a fundamental set of solutions of the differential equation.
- The general solution of the differential equation on $(-\infty, \infty)$ is

$$
y=c_{1} e^{m_{1} x}+c_{2} e^{m_{2} x}
$$

## Case 2. Repeated Roots

If the auxiliary equation has real and equal roots i.e

$$
m=m_{1}, m_{2} \quad \text { with } \quad m_{1}=m_{2}
$$

Then we obtain only one exponential solution

$$
y=c_{1} e^{m x}
$$

To construct a second solution we rewrite the equation in the form

$$
y^{\prime \prime}+\frac{b}{a} y^{\prime}+\frac{c}{a} y=0
$$

Comparing with

$$
y^{\prime \prime}+P y^{\prime}+Q y=0
$$

We make the identification

$$
P=\frac{b}{a}
$$

Thus a second solution is given by

$$
y_{2}=y_{1} \int \frac{e^{-\int P d x}}{y_{1}^{2}} d x=e^{m x} \int \frac{e^{-\frac{b}{a} x}}{e^{2 m x}} d x
$$

Since the auxiliary equation is a quadratic algebraic equation and has equal roots
Therefore,

$$
\text { Disc. }=b^{2}-4 a c=0
$$

We know from the quadratic formula

$$
m=\frac{-b \pm \sqrt{b^{2}-4 a c}}{2 a}
$$

we have

$$
2 m=-\frac{b}{a}
$$

Therefore

$$
y_{2}=e^{m x} \int \frac{e^{2 m x}}{e^{2 m x}} d x=x e^{m x}
$$

Hence the general solution is

$$
y=c_{1} e^{m x}+c_{2} x e^{m x}=\left(c_{1}+c_{2} x\right) e^{m x}
$$

## Case 3: Complex Roots

If the auxiliary equation has complex roots $\alpha \pm i \beta$ then, with

$$
m_{1}=\alpha+i \beta \text { and } m_{2}=\alpha-i \beta
$$

Where $\alpha>0$ and $\beta>0$ are real, the general solution of the differential equation is

$$
y=c_{1} e^{(\alpha+i \beta) x}+c_{2} e^{(\alpha-i \beta) x}
$$

First we choose the following two pairs of values of $c_{1}$ and $c_{2}$

$$
\begin{aligned}
& c_{1}=c_{2}=1 \\
& c_{1}=1, c_{2}=-1
\end{aligned}
$$

Then we have

$$
\begin{aligned}
& y_{1}=e^{(\alpha+i \beta) x}+e^{(\alpha-i \beta) x} \\
& y_{2}=e^{(\alpha+i \beta) x}-e^{(\alpha-i \beta) x}
\end{aligned}
$$

We know by the Euler's Formula that

$$
e^{i \theta}=\cos \theta+i \sin \theta, \quad \theta \in \mathrm{R}
$$

Using this formula, we can simplify the solutions $y_{1}$ and $y_{2}$ as

$$
\begin{aligned}
& y_{1}=e^{\alpha x}\left(e^{i \beta x}+e^{-i \beta x}\right)=2 e^{\alpha x} \cos \beta x \\
& y_{2}=e^{\alpha x}\left(e^{i \beta x}-e^{-i \beta x}\right)=2 i e^{\alpha x} \sin \beta x
\end{aligned}
$$

We can drop constant to write

$$
y_{1}=e^{\alpha x} \cos \beta x, \quad y_{2}=e^{\alpha x} \sin \beta x
$$

## The Wronskian

$$
W\left(e^{\alpha x} \cos \beta x, e^{\alpha x} \sin \beta x\right)=\beta e^{2 \alpha x} \neq 0 \quad \forall x
$$

Therefore,

$$
e^{\alpha x} \cos (\beta x), e^{\alpha x} \sin (\beta x)
$$

form a fundamental set of solutions of the differential equation on $(-\infty, \infty)$.
Hence general solution of the differential equation is
or

$$
\begin{aligned}
& y=c_{1} e^{\alpha x} \cos \beta x+c_{2} e^{\alpha x} \sin \beta x \\
& y=e^{\alpha x}\left(c_{1} \cos \beta x+c_{2} \sin \beta x\right)
\end{aligned}
$$

## Example:

Solve

$$
2 y^{\prime \prime}-5 y^{\prime}-3 y=0
$$

## Solution:

The given differential equation is

$$
2 y^{\prime \prime}-5 y^{\prime}-3 y=0
$$

Put

$$
y=e^{m x}
$$

Then

$$
y^{\prime}=m e^{m x}, \quad y^{\prime \prime}=m^{2} e^{m x}
$$

Substituting in the give differential equation, we have

$$
\left(2 m^{2}-5 m-3\right) e^{m x}=0
$$

Since $e^{m x} \neq 0 \forall x$, the auxiliary equation is

$$
\begin{aligned}
& 2 m^{2}-5 m-3=0 \quad \text { as } \quad e^{m x} \neq 0 \\
& (2 m+1)(m-3)=0 \Rightarrow m=-\frac{1}{2}, 3
\end{aligned}
$$

Therefore, the auxiliary equation has distinct real roots

$$
m_{1}=-\frac{1}{2} \text { and } m_{2}=3
$$

Hence the general solution of the differential equation is

$$
y=c_{1} e^{(-1 / 2) x}+c_{2} e^{3 x}
$$

## Example 2

Solve

$$
y^{\prime \prime}-10 y^{\prime}+25 y=0
$$

## Solution:

We put $\quad y=e^{m x}$
Then $\quad \mathrm{y}^{\prime}=m e^{m x}, y^{\prime \prime}=m^{2} e^{m x}$
Substituting in the given differential equation, we have

$$
\left(m^{2}-10 m+25\right) e^{m x}=0
$$

Since $e^{m x} \neq 0 \forall x$, the auxiliary equation is

$$
\begin{aligned}
& m^{2}-10 m+25=0 \\
& (m-5)^{2}=0 \Rightarrow m=5,5
\end{aligned}
$$

Thus the auxiliary equation has repeated real roots i.e

$$
m_{1}=5=m_{2}
$$

Hence general solution of the differential equation is
or

$$
y=c_{1} e^{5 x}+c_{2} x e^{5 x}
$$

$$
y=\left(c_{1}+c_{2} x\right) e^{5 x}
$$

## Example 3

Solve the initial value problem

$$
\begin{aligned}
& y^{\prime \prime}-4 y^{\prime}+13 y=0 \\
& y(0)=-1, \quad y^{\prime}(0)=2
\end{aligned}
$$

## Solution:

Given that the differential equation

$$
y^{\prime \prime}-4 y^{\prime}+13 y=0
$$

Put

$$
y=e^{m x}
$$

Then

$$
y^{\prime}=m e^{m x}, y^{\prime \prime}=m^{2} e^{m x}
$$

Substituting in the given differential equation, we have:

$$
\left(m^{2}-4 m+13\right) e^{m x}=0
$$

Since $e^{m x} \neq 0 \forall x$, the auxiliary equation is

$$
m^{2}-4 m+13=0
$$

By quadratic formula, the solution of the auxiliary equation is

$$
m=\frac{4 \pm \sqrt{16-52}}{2}=2 \pm 3 i
$$

Thus the auxiliary equation has complex roots

$$
m_{1}=2+3 i, \quad m_{2}=2-3 i
$$

Hence general solution of the differential equation is

$$
y=e^{2 x}\left(c_{1} \cos 3 x+c_{2} \sin 3 x\right)
$$

## Example 4

Solve the differential equations

$$
\begin{equation*}
y^{\prime \prime}+k^{2} y=0 \tag{a}
\end{equation*}
$$

(b)

$$
y^{\prime \prime}-k^{2} y=0
$$

## Solution

First consider the differential equation

Put

$$
y^{\prime \prime}+k^{2} y=0
$$

$$
y=e^{m x}
$$

Then

$$
y^{\prime}=m e^{m x} \text { and } y^{\prime \prime}=m^{2} e^{m x}
$$

Substituting in the given differential equation, we have:

$$
\left(m^{2}+k^{2}\right) e^{m x}=0
$$

Since $e^{m x} \neq 0 \forall x$, the auxiliary equation is
or

$$
\begin{aligned}
& m^{2}+k^{2}=0 \\
& m= \pm k i,
\end{aligned}
$$

Therefore, the auxiliary equation has complex roots

$$
m_{1}=0+k i, \quad m_{2}=0-k i
$$

Hence general solution of the differential equation is

$$
y=c_{1} \cos k x+c_{2} \sin k x
$$

Next consider the differential equation

$$
\frac{d^{2} y}{d x^{2}}-k^{2} y=0
$$

Substituting values $y$ and $y^{\prime \prime}$, we have.

$$
\left(m^{2}-k^{2}\right) e^{m x}=0
$$

Since $e^{m x} \neq 0$, the auxiliary equation is

$$
\begin{aligned}
& m^{2}-k^{2}=0 \\
\Rightarrow \quad & m= \pm k
\end{aligned}
$$

Thus the auxiliary equation has distinct real roots

$$
m_{1}=+k, m_{2}=-k
$$

Hence the general solution is

$$
y=c_{1} e^{k x}+c_{2} e^{-k x}
$$

## Higher Order Equations

If we consider $n t h$ order homogeneous linear differential equation

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\ldots+a_{1} \frac{d y}{d x}+a_{0} y=0
$$

Then, the auxiliary equation is an $n t h$ degree polynomial equation

$$
a_{n} m^{n}+a_{n-1} m^{n-1}+\ldots+a_{1} m+a_{0}=0
$$

Case 1: Real distinct roots
If the roots $m_{1}, m_{2}, \ldots, m_{n}$ of the auxiliary equation are all real and distinct, then the general solution of the equation is

$$
y=c_{1} e^{m_{1} x}+c_{2} e^{m_{2} x}+\ldots+c_{n} e^{m_{n} x}
$$

## Case 2: Real \& repeated roots

We suppose that $m_{1}$ is a root of multiplicity $n$ of the auxiliary equation, then it can be shown that

$$
e^{m_{1} x}, x e^{m_{1} x}, \ldots, x^{n-1} e^{m_{1} x}
$$

are $n$ linearly independent solutions of the differential equation. Hence general solution of the differential equation is

$$
y=c_{1} e^{m_{1} x}+c_{2} x e^{m_{1} x}+\ldots+c_{n} x^{n-1} e^{m_{1} x}
$$

Case 3: Complex roots
Suppose that coefficients of the auxiliary equation are real.

- We fix $n$ at 6, all roots of the auxiliary are complex, namely

$$
\alpha_{1} \pm i \beta_{1}, \quad \alpha_{2} \pm i \beta_{2}, \quad \alpha_{3} \pm i \beta_{3}
$$

- Then the general solution of the differential equation

$$
\begin{aligned}
y=e^{\alpha_{1} x}\left(c_{1} \cos \beta_{1} x\right. & \left.+c_{2} \sin \beta_{1} x\right)+e^{\alpha_{2} x}\left(c_{3} \cos \beta_{2} x+c_{4} \sin \beta_{2} x\right) \\
& +e^{\alpha_{3} x}\left(c_{5} \cos \beta_{3} x+c_{6} \sin \beta_{3} x\right)
\end{aligned}
$$

- If $n=6$, two roots of the auxiliary equation are real and equal and the remaining 4 are complex, namely $\quad \alpha_{1} \pm i \beta_{1}, \quad \alpha_{2} \pm i \beta_{2}$ Then the general solution is $y=e^{\alpha_{1} x}\left(c_{1} \cos \beta_{1} x+c_{2} \sin \beta_{1} x\right)+e^{\alpha_{2} x}\left(c_{3} \cos \beta_{2} x+c_{4} \sin \beta_{2} x\right)+c_{5} e^{m_{1} x}+c_{6} x e^{m_{1} x}$
- If $m_{1}=\alpha+i \beta$ is a complex root of multiplicity $k$ of the auxiliary equation. Then its conjugate $m_{2}=\alpha-i \beta$ is also a root of multiplicity $k$. Thus from Case 2 , the
differential equation has $2 k$ solutions

$$
\begin{aligned}
& e^{(\alpha+i \beta) x}, x e^{(\alpha+i \beta) x}, x^{2} e^{(\alpha+i \beta) x}, \ldots, x^{k-1} e^{(\alpha+i \beta) x} \\
& e^{(\alpha-i \beta) x}, x e^{(\alpha-i \beta) x}, x^{2} e^{(\alpha-i \beta) x}, \ldots, x^{k-1} e^{(\alpha-i \beta) x}
\end{aligned}
$$

- By using the Euler's formula, we conclude that the general solution of the differential equation is a linear combination of the linearly independent solutions

$$
\begin{aligned}
& e^{\alpha x} \cos \beta x, x e^{\alpha x} \cos \beta x, x^{2} e^{\alpha x} \cos \beta x, \ldots, x^{k-1} e^{\alpha x} \cos \beta x \\
& e^{\alpha x} \sin \beta x, x e^{\alpha x} \sin \beta x, x^{2} e^{\alpha x} \sin \beta x, \ldots, x^{k-1} e^{\alpha x} \sin \beta x
\end{aligned}
$$

- Thus if $k=3$ then

$$
y=e^{\alpha x}\left[\left(c_{1}+c_{2} x+c_{3} x^{2}\right) \cos \beta x+\left(d_{1}+d_{2} x+d_{3} x^{2}\right) \sin \beta x\right]
$$

## Solving the Auxiliary Equation

Recall that the auxiliary equation of $n t h$ degree differential equation is $n t h$ degree polynomial equation

- Solving the auxiliary equation could be difficult

$$
P_{n}(m)=0, \mathrm{n}>2
$$

- One way to solve this polynomial equation is to guess a root $m_{1}$. Then $m-m_{1}$ is a factor of the polynomial $P_{n}(m)$.
- Dividing with $m-m_{1}$ synthetically or otherwise, we find the factorization

$$
P_{n}(m)=\left(m-m_{1}\right) Q(m)
$$

- We then try to find roots of the quotient i.e. roots of the polynomial equation

$$
Q(m)=0
$$

- Note that if $m_{1}=\frac{p}{q}$ is a rational real root of the equation

$$
P_{n}(m)=0, \mathrm{n}>2
$$

then $p$ is a factor of $a_{0}$ and $q$ of $a_{n}$.

- By using this fact we can construct a list of all possible rational roots of the auxiliary equation and test each of them by synthetic division.


## Example 1

Solve the differential equation

$$
y^{\prime \prime \prime}+3 y^{\prime \prime}-4 y=0
$$

## Solution:

Given the differential equation

$$
y^{\prime \prime \prime}+3 y^{\prime \prime}-4 y=0
$$

Put $\quad y=e^{m x}$
Then

$$
\mathrm{y}^{\prime}=m e^{m x}, y^{\prime \prime}=m^{2} e^{m x} \text { and } y^{\prime \prime \prime}=m^{3} e^{m x}
$$

Substituting this in the given differential equation, we have

$$
\left(m^{3}+3 m^{2}-4\right) e^{m x}=0
$$

Since $\quad e^{m x} \neq 0$
Therefore $\quad m^{3}+3 m^{2}-4=0$
So that the auxiliary equation is

$$
m^{3}+3 m^{2}-4=0
$$

## Solution of the $A E$

If we take $m=1$ then we see that

$$
m^{3}+3 m^{2}-4=1+3-4=0
$$

Therefore $m=1$ satisfies the auxiliary equations so that $m-1$ is a factor of the polynomial

$$
m^{3}+3 m^{2}-4
$$

By synthetic division, we can write
or $\quad m^{3}+3 m^{2}-4=(m-1)(m+2)^{2}$
Therefore

$$
\begin{aligned}
& m^{3}+3 m^{2}-4=0 \\
& \Rightarrow(m-1)(m+2)^{2}=0
\end{aligned}
$$

or

$$
m=1,-2,-2
$$

Hence solution of the differential equation is

$$
y=c_{1} e^{x}+c_{2} e^{-2 x}+c_{3} x e^{-2 x}
$$

## Example 2

Solve

$$
3 y^{\prime \prime \prime}+5 y^{\prime \prime}+10 y^{\prime}-4 y=0
$$

## Solution:

Given the differential equation

$$
3 y^{\prime \prime \prime}+5 y^{\prime \prime}+10 y^{\prime}-4 y=0
$$

Put

$$
y=e^{m x}
$$

Then

$$
\mathrm{y}^{\prime}=m e^{m x}, y^{\prime \prime}=m^{2} e^{m x} \text { and } y^{\prime / \prime}=m^{3} e^{m x}
$$

Therefore the auxiliary equation is

$$
3 m^{3}+5 m^{2}+10 m-4=0
$$

## Solution of the auxiliary equation:

a) $a_{\circ}=-4$ and all its factors are:

$$
p: \quad \pm 1, \pm 2, \pm 4
$$

b) $a_{n}=3$ and all its factors are:

$$
q: \quad \pm 1, \pm 3
$$

c) List of possible rational roots of the auxiliary equation is

$$
\frac{p}{q}: \quad-1,1,-2,2,-4,4, \frac{-1}{3}, \frac{1}{3}, \frac{-2}{3}, \frac{2}{3}, \frac{-4}{3}, \frac{4}{3}
$$

d) Testing each of these successively by synthetic division we find

$$
\begin{aligned}
& \frac{1}{3}
\end{aligned} \begin{array}{rrrr}
3 & 5 & 10 & -4 \\
& 1 & 2 & 4 \\
\hline 3 & 6 & 12 & 10
\end{array}
$$

Consequently a root of the auxiliary equation is

$$
m=1 / 3
$$

The coefficients of the quotient are

$$
\begin{array}{lll}
3 & 6 & 12
\end{array}
$$

Thus we can write the auxiliary equation as:

$$
\begin{aligned}
& (m-1 / 3)\left(3 m^{2}+6 m+12\right)=0 \\
& m-\frac{1}{3}=0 \quad \text { or } \quad 3 m^{2}+6 m+12=0
\end{aligned}
$$

Therefore $\quad m=1 / 3$ or $m=-1 \pm i \sqrt{3}$
Hence solution of the given differential equation is

$$
y=c_{1} e^{(1 / 3) x}+e^{-x}\left(c_{2} \cos \sqrt{3} x+c_{3} \sin \sqrt{3} x\right)
$$

## Example 3

Solve the differential equation

$$
\frac{d^{4} y}{d x^{4}}+2 \frac{d^{2} y}{d x^{2}}+y=0
$$

## Solution:

Given the differential equation

$$
\frac{d^{4} y}{d x^{4}}+2 \frac{d^{2} y}{d x^{2}}+y=0
$$

Put

$$
y=e^{m x}
$$

Then

$$
y^{\prime}=m e^{m x}, y^{\prime \prime}=m^{2} e^{m x}
$$

Substituting in the differential equation, we obtain

$$
\left(m^{4}+2 m^{2}+1\right) e^{m x}=0
$$

Since $e^{m x} \neq 0$, the auxiliary equation is

$$
\begin{aligned}
& m^{4}+2 m^{2}+1=0 \\
& \left(m^{2}+1\right)^{2}=0 \\
& \Rightarrow m= \pm i, \pm i \\
& m_{1}=m_{3}=i \text { and } m_{2}=m_{4}=-i
\end{aligned}
$$

Thus $i$ is a root of the auxiliary equation of multiplicity 2 and so is $-i$.
Now

$$
\alpha=0 \text { and } \beta=1
$$

Hence the general solution of the differential equation is

$$
y=e^{0 x}\left[\left(c_{1}+c_{2} x\right) \cos x+\left(d_{1}+d_{2} x\right) \sin x\right]
$$

or $\quad y=c_{1} \cos x+d_{1} \sin x+c_{2} x \cos x+d_{2} x \sin x$

## Lecture 17

## Method of Undetermined Coefficients-Superposition Approach

## Recall

1. That a non-homogeneous linear differential equation of order $n$ is an equation of the form

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=g(x)
$$

The coefficients $a_{0}, a_{1}, \ldots, a_{n}$ can be functions of $x$. However, we will discuss equations with constant coefficients.
2. That to obtain the general solution of a non-homogeneous linear differential equation we must find:
a The complementary function $y_{c}$, which is general solution of the associated homogeneous differential equation.

- Any particular solution $y_{p}$ of the non-homogeneous differential equation.

3. That the general solution of the non-homogeneous linear differential equation is given by

General solution = Complementary function + Particular Integral

## Finding

Complementary function has been discussed in the previous lecture. In the next three lectures we will discuss methods for finding a particular integral for the nonhomogeneous equation, namely

- The method of undetermined coefficients-superposition approach
- The method undetermined coefficients-annihilator operator approach.
- The method of variation of parameters.


## The Method of Undetermined Coefficient

The method of undetermined coefficients developed here is limited to non-homogeneous linear differential equations

- That have constant coefficients, and
- Where the function $g(x)$ has a specific form.


## The form of $g(x)$

The input function $g(x)$ can have one of the following forms:

- A constant function $k$.
- A polynomial function
- An exponential function $\mathrm{e}^{\mathrm{x}}$
- The trigonometric functions $\sin (\beta x), \cos (\beta x)$
- Finite sums and products of these functions.

Otherwise, we cannot apply the method of undetermined coefficients.

## The method

Consist of performing the following steps.
Step 1 Determine the form of the input function $g(x)$.
Step 2 Assume the general form of $y_{p}$ according to the form of $g(x)$
Step 3 Substitute in the given non-homogeneous differential equation.
Step 4 Simplify and equate coefficients of like terms from both sides.
Step 5 Solve the resulting equations to find the unknown coefficients.
Step 6 Substitute the calculated values of coefficients in assumed $y_{p}$

## Restriction on $g$ ?

The input function $g$ is restricted to have one of the above stated forms because of the reason:

- The derivatives of sums and products of polynomials, exponentials etc are again sums and products of similar kind of functions.
- The expression $a y_{p}{ }^{\prime \prime}+b y_{p}{ }^{\prime}+c y_{p}$ has to be identically equal to the input function $g(x)$.
Therefore, to make an educated guess, $y_{p}$ is assured to have the same form as $g$.


## Caution!

- In addition to the form of the input function $g(x)$, the educated guess for $y_{p}$ must take into consideration the functions that make up the complementary function $y_{C}$.
- No function in the assumed $y_{p}$ must be a solution of the associated homogeneous differential equation. This means that the assumed $y_{p}$ should not contain terms that duplicate terms in $y_{C}$.
Taking for granted that no function in the assumed $y_{p}$ is duplicated by a function in $y_{c}$, some forms of $g$ and the corresponding forms of $y_{p}$ are given in the following table.


## Trial particular solutions

| Number | The input function $g(x)$ | The assumed particular solution $y_{p}$ |
| :--- | :--- | :--- |
| 1 | Any constant e.g. 1 | $A$ |
| 2 | $5 x+7$ | $A x+B$ |
| 3 | $3 x^{2}-2$ | $A x^{2}+B x+c$ |
| 4 | $x^{3}-x+1$ | $A x^{3}+B x^{2}+C x+D$ |
| 5 | $\sin 4 x$ | $A \cos 4 x+B \sin 4 x$ |
| 6 | $\cos 4 x$ | $A \cos 4 x+B \sin 4 x$ |
| 7 | $e^{5 x}$ | $A e^{5 x}$ |
| 8 | $(9 x-2) e^{5 x}$ | $(A x+B) e^{5 x}$ |
| 9 | $x^{2} e^{5 x}$ | $\left(A x^{2}+B x+C\right) e^{5 x}$ |

## If $g(x)$ equals a sum?

Suppose that

- The input function $g(x)$ consists of a sum of $m$ terms of the kind listed in the above table i.e.

$$
g(x)=g_{1}(x)+g_{2}(x)+\cdots+g_{m}(x) .
$$

- The trial forms corresponding to $g_{1}(x), g_{2}(x), \ldots, g_{m}(x)$ be $y_{p_{1}}, y_{p_{2}}, \ldots, y_{p_{m}}$.

Then the particular solution of the given non-homogeneous differential equation is

$$
y_{p}=y_{p_{1}}+y_{p_{2}}+\cdots+y_{p_{m}}
$$

In other words, the form of $y_{p}$ is a linear combination of all the linearly independent functions generated by repeated differentiation of the input function $g(x)$.

## Example 1

Solve

$$
y^{\prime \prime}+4 y^{\prime}-2 y=2 x^{2}-3 x+6
$$

## Solution:

## Complementary function

To find $y_{c}$, we first solve the associated homogeneous equation

$$
y^{\prime \prime}+4 y^{\prime}-2 y=0
$$

We put

$$
y=e^{m x}, \quad y^{\prime}=m e^{m x}, \quad y^{\prime \prime}=m^{2} e^{m x}
$$

Then the associated homogeneous equation gives

$$
\left(m^{2}+4 m-2\right) e^{m x}=0
$$

Therefore, the auxiliary equation is

$$
m^{2}+4 m-2=0 \quad \text { as } e^{m x} \neq 0, \quad \forall x
$$

Using the quadratic formula, roots of the auxiliary equation are

$$
m=-2 \pm \sqrt{6}
$$

Thus we have real and distinct roots of the auxiliary equation

$$
m_{1}=-2-\sqrt{6} \quad \text { and } \quad m_{2}=-2+\sqrt{6}
$$

Hence the complementary function is

$$
y_{C}=c_{1} e^{-(2+\sqrt{6}) x}+c_{2} e^{(-2+\sqrt{6}) x}
$$

Next we find a particular solution of the non-homogeneous differential equation.

## Particular Integral

Since the input function

$$
g(x)=2 x^{2}-3 x+6
$$

is a quadratic polynomial. Therefore, we assume that

$$
y_{p}=A x^{2}+B x+C
$$

Then

$$
y_{p}{ }^{\prime}=2 A x+B \text { and } y_{p}^{\prime \prime}=2 A
$$

Therefore

$$
y_{p}^{\prime \prime}+4 y_{p}^{\prime}-2 y_{p}=2 A+8 A x+4 B-2 A x^{2}-2 B x-2 C
$$

Substituting in the given equation, we have

$$
\begin{array}{cc} 
& 2 A+8 A x+4 B-2 A x^{2}-2 B x-2 C=2 x^{2}-3 x+6 \\
\text { or } \quad & -2 A x^{2}+(8 A-2 B) x+(2 A+4 B-2 C)=2 x^{2}-3 x+6
\end{array}
$$

Equating the coefficients of the like powers of $x$, we have

$$
-2 \mathrm{~A}=2, \quad 8 \mathrm{~A}-2 \mathrm{~B}=-3, \quad 2 \mathrm{~A}+4 \mathrm{~B}-2 \mathrm{C}=6
$$

Solving this system of equations leads to the values

$$
A=-1, \quad B=-5 / 2, \quad C=-9
$$

Thus a particular solution of the given equation is

$$
y_{p}=-x^{2}-\frac{5}{2} x-9
$$

Hence, the general solution of the given non-homogeneous differential equation is given by

$$
y=y_{C}+y_{p}
$$

or

$$
y=-x^{2}-\frac{5}{2} x-9+c_{1} e^{-(2+\sqrt{6}) x}+c_{2} e^{(-2+\sqrt{6}) x}
$$

## Example 2

Solve the differential equation

$$
y^{\prime \prime}-y^{\prime}+y=2 \sin 3 x
$$

## Solution:

## Complementary function

To find $y_{c}$, we solve the associated homogeneous differential equation

Put

$$
y^{\prime \prime}-y^{\prime}+y=0
$$

Substitute in the given differential equation to obtain the auxiliary equation

$$
m^{2}-m+1=0 \quad \text { or } \quad m=\frac{1 \pm i \sqrt{3}}{2}
$$

Hence, the auxiliary equation has complex roots. Hence the complementary function is

$$
y_{C}=e^{(1 / 2) x}\left(c_{1} \cos \frac{\sqrt{3}}{2} x+c_{2} \sin \frac{\sqrt{3}}{2} x\right)
$$

## Particular Integral

Since successive differentiation of

$$
g(x)=\sin 3 x
$$

produce $\sin 3 x$ and $\cos 3 x$
Therefore, we include both of these terms in the assumed particular solution, see table

Then

$$
y_{p}=A \cos 3 x+B \sin 3 x
$$

$$
y_{p}^{\prime}=-3 A \sin 3 x+3 B \cos 3 x
$$

$$
y_{p}^{\prime \prime}=-9 A \cos 3 x-9 B \sin 3 x
$$

Therefore

$$
y_{p}^{\prime \prime}-y_{p}^{\prime}+y_{p}=(-8 A-3 B) \cos 3 x+(3 A-8 B) \sin 3 x .
$$

Substituting in the given differential equation

$$
(-8 A-3 B) \cos 3 x+(3 A-8 B) \sin 3 x=0 \cos 3 x+2 \sin 3 x .
$$

From the resulting equations

$$
-8 A-3 B=0,3 A-8 B=2
$$

Solving these equations, we obtain

$$
A=6 / 73, B=-16 / 73
$$

A particular solution of the equation is

$$
y_{p}=\frac{6}{73} \cos 3 x-\frac{16}{73} \sin 3 x
$$

Hence the general solution of the given non-homogeneous differential equation is

$$
y=e^{(1 / 2) x}\left(c_{1} \cos \frac{\sqrt{3}}{2} x+c_{2} \sin \frac{\sqrt{3}}{2} x\right)+\frac{6}{73} \cos 3 x-\frac{16}{73} \sin 3 x
$$

## Example 3

Solve

$$
y^{\prime \prime}-2 y^{\prime}-3 y=4 x-5+6 x e^{2 x}
$$

## Solution:

Complementary function
To find $y_{c}$, we solve the associated homogeneous equation

$$
y^{\prime \prime}-2 y^{\prime}-3 y=0
$$

Put

$$
y=e^{m x}, \quad y^{\prime}=m e^{m x}, y^{\prime \prime}=m^{2} e^{m x}
$$

Substitute in the given differential equation to obtain the auxiliary equation

$$
\begin{aligned}
& m^{2}-2 m-3=0 \\
& \Rightarrow(m+1)(m-3)=0 \\
& m=-1,3
\end{aligned}
$$

Therefore, the auxiliary equation has real distinct root

$$
m_{1}=-1, m_{2}=3
$$

Thus the complementary function is

$$
y_{c}=c_{1} e^{-x}+c_{2} e^{3 x}
$$

Particular integral
Since

$$
g(x)=(4 x-5)+6 x e^{2 x}=g_{1}(x)+g_{2}(x)
$$

Corresponding to $g_{1}(x) \quad y_{p_{1}}=A x+B$
Corresponding to $g_{2}(x)$

$$
y_{p_{2}}=(C x+D) e^{2 x}
$$

The superposition principle suggests that we assume a particular solution
i.e.

$$
y_{p}=y_{p_{1}}+y_{p_{2}}
$$

$$
\begin{gathered}
y_{p}=A x+B+(C x+D) e^{2 x} \\
y_{p}^{\prime}=A+2(C x+D) e^{2 x}+C e^{2 x} \\
y_{p}^{\prime \prime}=4(C x+D) e^{2 x}+4 C e^{2 x}
\end{gathered}
$$

Then

Substituting in the given

$$
\begin{aligned}
y_{p}^{\prime \prime}-2 y_{p}^{\prime}-3 y_{p}= & 4 C x e^{2 x}+4 D e^{2 x}+4 C e^{2 x}-2 A-4 C x e^{2 x} \\
& -4 D e^{2 x}-2 C e^{2 x}-3 A x-3 B-3 C x e^{2 x}-3 D e^{2 x}
\end{aligned}
$$

Simplifying and grouping like terms

$$
y_{p}^{\prime \prime}-2 y_{p}^{\prime}-3 y_{p}=-3 A x-2 A-3 B-3 C x e^{2 x}+(2 C-3 D) e^{2 x}=4 x-5+6 x e^{2 x} .
$$

Substituting in the non-homogeneous differential equation, we have

$$
-3 A x-2 A-3 B-3 C x e^{2 x}+(2 C-3 D) e^{2 x}=4 x-5+6 x e^{2 x}+0 e^{2 x}
$$

Now equating constant terms and coefficients of $x, x e^{2 x}$ and $e^{2 x}$, we obtain

$$
\begin{array}{llrl}
-2 A-3 B & =-5, & -3 A & =4 \\
-3 C & =6, & & 2 C-3 D
\end{array}
$$

Solving these algebraic equations, we find

$$
\begin{array}{ll}
A=-4 / 3, & B=23 / 9 \\
C=-2, & D=-4 / 3
\end{array}
$$

Thus, a particular solution of the non-homogeneous equation is

$$
y_{p}=-(4 / 3) x+(23 / 9)-2 x e^{2 x}-(4 / 3) e^{2 x}
$$

The general solution of the equation is

$$
y=y_{c}+y_{p}=c_{1} e^{-x}+c_{2} e^{3 x}-(4 / 3) x+(23 / 9)-2 \mathrm{xe}^{2 \mathrm{x}}-(4 / 3) e^{2 x}
$$

## Duplication between $y_{p}$ and $y_{c}$ ?

- If a function in the assumed $y_{p}$ is also present in $y_{C}$ then this function is a solution of the associated homogeneous differential equation. In this case the obvious assumption for the form of $y_{p}$ is not correct.
- In this case we suppose that the input function is made up of terms of $n$ kinds i.e.

$$
g(x)=g_{1}(x)+g_{2}(x)+\cdots+g_{n}(x)
$$

and corresponding to this input function the assumed particular solution $y_{p}$ is

$$
y_{p}=y_{p_{1}}+y_{p_{2}}+\cdots+y_{p_{n}}
$$

- If a $y_{p_{i}}$ contain terms that duplicate terms in $y_{C}$, then that $y_{p_{i}}$ must be multiplied with $x^{n}, n$ being the least positive integer that eliminates the duplication.


## Example 4

Find a particular solution of the following non-homogeneous differential equation

$$
y^{\prime \prime}-5 y^{\prime}+4 y=8 e^{x}
$$

## Solution:

To find $y_{C}$, we solve the associated homogeneous differential equation

$$
y^{\prime \prime}-5 y^{\prime}+4 y=0
$$

We put $y=e^{m x}$ in the given equation, so that the auxiliary equation is

$$
m^{2}-5 m+4=0 \Rightarrow m=1,4
$$

Thus

$$
y_{c}=c_{1} e^{x}+c_{2} e^{4 x}
$$

Since $\quad g(x)=8 e^{x}$
Therefore,

$$
y_{p}=A e^{x}
$$

Substituting in the given non-homogeneous differential equation, we obtain

So $\quad 0=8 e^{x}$
Clearly we have made a wrong assumption for $y_{p}$, as we did not remove the duplication.

Since $A e^{x}$ is present in $y_{C}$. Therefore, it is a solution of the associated homogeneous differential equation

$$
y^{\prime \prime}-5 y^{\prime}+4 y=0
$$

To avoid this we find a particular solution of the form

$$
y_{p}=A x e^{x}
$$

We notice that there is no duplication between $y_{c}$ and this new assumption for $y_{p}$
Now

$$
y_{p}^{\prime}=A x e^{x}+A e^{x}, \quad y_{\mathrm{p}}^{\prime \prime}=A x e^{x}+2 A e^{x}
$$

Substituting in the given differential equation, we obtain
or

$$
A x e^{x}+2 A e^{x}-5 A x e^{x}-5 A e^{x}+4 A x e^{x}=8 e^{x} .
$$

$$
-3 A e^{x}=8 e^{x} \Rightarrow A=-8 / 3
$$

So that a particular solution of the given equation is given by

$$
y_{p}=-(8 / 3) e^{x}
$$

Hence, the general solution of the given equation is

$$
y=c_{1} e^{x}+c_{2} e^{4 x}-(8 / 3) x e^{x}
$$

## Example 5

Determine the form of the particular solution
(a) $\quad y^{\prime /}-8 y^{\prime}+25 y=5 x^{3} e^{-x}-7 e^{-x}$
(b) $y^{\prime \prime}+4 y=x \cos x$.

## Solution:

(a) To find $y_{C}$ we solve the associated homogeneous differential equation

Put

$$
y^{\prime \prime}-8 y^{\prime}+25 y=0
$$

Then the auxiliary equation is

$$
m^{2}-8 m+25=0 \Rightarrow m=4 \pm 3 i
$$

Roots of the auxiliary equation are complex

$$
y_{C}=e^{4 x}\left(c_{1} \cos 3 x+c_{2} \sin 3 x\right)
$$

The input function is

$$
g(x)=5 x^{3} e^{-x}-7 e^{-x}=\left(5 x^{3}-7\right) e^{-x}
$$

Therefore, we assume a particular solution of the form

$$
y_{p}=\left(A x^{3}+B x^{2}+C x+D\right) e^{-x}
$$

Notice that there is no duplication between the terms in $y_{p}$ and the terms in $y_{C}$. Therefore, while proceeding further we can easily calculate the value $A, B, C$ and $D$.
(b) Consider the associated homogeneous differential equation

$$
y^{\prime \prime}+4 y=0
$$

Since

$$
g(x)=x \cos x
$$

Therefore, we assume a particular solution of the form

$$
y_{p}=(A x+B) \cos x+(C x+D) \sin x
$$

Again observe that there is no duplication of terms between $y_{C}$ and $y_{p}$

## Example 6

Determine the form of a particular solution of

$$
y^{\prime \prime}-y^{\prime}+y=3 x^{2}-5 \sin 2 x+7 x e^{6 x}
$$

## Solution:

To find $y_{C}$, we solve the associated homogeneous differential equation

$$
y^{\prime /}-y^{\prime}+y=0
$$

Put

$$
y=e^{m x}
$$

Then the auxiliary equation is

Therefore

$$
m^{2}-m+1=0 \Rightarrow m=\frac{1 \pm i \sqrt{3}}{2}
$$

$$
y_{C}=e^{(1 / 2) x}\left(c_{1} \cos \frac{\sqrt{3}}{2} x+c_{2} \sin \frac{\sqrt{3}}{2} x\right)
$$

Since

$$
g(x)=3 x^{2}-5 \sin 2 x+7 x e^{6 x}=g_{1}(x)+g_{2}(x)+g_{3}(x)
$$

Corresponding to $g_{1}(x)=3 x^{2}: \quad y_{p_{1}}=A x^{2}+B x+C$
Corresponding to $g_{2}(x)=-5 \sin 2 x: \quad y_{p_{2}}=D \cos 2 x+E \sin 2 x$
Corresponding to $g_{3}(x)=7 x e^{6 x}: \quad y_{p_{3}}=(F x+G) \mathrm{e}^{6 \mathrm{x}}$
Hence, the assumption for the particular solution is

$$
y_{p}=y_{p_{1}}+y_{p_{2}}+y_{p_{3}}
$$

or

$$
y_{p}=A x^{2}+B x+C+D \cos 2 x+E \sin 2 x+(F x+G) e^{6 \mathrm{x}}
$$

No term in this assumption duplicate any term in the complementary function

$$
y_{c}=c_{1} e^{2 x}+c_{2} e^{7 x}
$$

## Example 7

Find a particular solution of

$$
y^{\prime \prime}-2 y^{\prime}+y=e^{x}
$$

## Solution:

Consider the associated homogeneous equation

$$
y^{\prime \prime}-2 y^{\prime}+y=0
$$

Put

$$
y=e^{m x}
$$

Then the auxiliary equation is

$$
\begin{aligned}
& m^{2}-2 m+1=(m-1)^{2}=0 \\
& \Rightarrow m \quad=1,1
\end{aligned}
$$

Roots of the auxiliary equation are real and equal. Therefore,

$$
y_{c}=c_{1} e^{x}+c_{2} x e^{x}
$$

Since

$$
g(x)=e^{x}
$$

Therefore, we assume that

$$
y_{p}=A e^{x}
$$

This assumption fails because of duplication between $y_{c}$ and $y_{p}$. We multiply with $x$
Therefore, we now assume

$$
y_{p}=A x e^{x}
$$

However, the duplication is still there. Therefore, we again multiply with $x$ and assume

$$
y_{p}=A x^{2} e^{x}
$$

Since there is no duplication, this is acceptable form of the trial $y_{p}$

$$
y_{p}=\frac{1}{2} x^{2} e^{x}
$$

## Example 8

Solve the initial value problem

$$
\begin{aligned}
& y^{\prime \prime}+y=4 x+10 \sin x \\
& \mathrm{y}(\pi)=0, \mathrm{y}^{\prime}(\pi)=2
\end{aligned}
$$

## Solution

Consider the associated homogeneous differential equation

Put

$$
y^{\prime \prime}+y=0
$$

$$
y=e^{m x}
$$

Then the auxiliary equation is

$$
m^{2}+1=0 \Rightarrow m= \pm i
$$

The roots of the auxiliary equation are complex. Therefore, the complementary function is

$$
y_{C}=c_{1} \cos x+c_{2} \sin x
$$

Since

$$
g(x)=4 x+10 \sin x=g_{1}(x)+g_{2}(x)
$$

Therefore, we assume that

$$
y_{p_{1}}=A x+B, \quad y_{p_{2}}=C \cos x+D \sin x
$$

So that $\quad \mathrm{y}_{\mathrm{p}}=A x+B+\mathrm{C} \cos x+D \sin x$
Clearly, there is duplication of the functions $\cos x$ and $\sin x$. To remove this duplication we multiply $y_{p_{2}}$ with $x$. Therefore, we assume that

$$
\begin{aligned}
& y_{p}=A x+B+C x \cos x+D x \sin x \\
& y_{p}^{\prime \prime}=-2 C \sin x-C x \cos x+2 D \cos x-D x \sin x
\end{aligned}
$$

So that $\quad \mathrm{y}_{\mathrm{p}}{ }^{\prime \prime}+\mathrm{y}_{\mathrm{p}}=A x+B-2 \mathrm{C} \sin x+2 D \mathrm{x} \cos x$
Substituting into the given non-homogeneous differential equation, we have

$$
A x+B-2 C \sin x+2 D x \cos x=4 x+10 \sin x
$$

Equating constant terms and coefficients of $x, \sin x, x \cos x$, we obtain

$$
\begin{array}{ll} 
& B=0, A=4,-2 C=10,2 D=0 \\
\text { So that } & A=4, B=0, C=-5, D=0 \\
\text { Thus } & y_{p}=4 x-5 x \cos x
\end{array}
$$

Hence the general solution of the differential equation is

$$
y=y_{c}+y_{p}=c_{1} \cos x+c_{2} \sin x+4 x-5 x \cos x
$$

We now apply the initial conditions to find $c_{1}$ and $c_{2}$.

$$
y(\pi)=0 \Rightarrow c_{1} \cos \pi+c_{2} \sin \pi+4 \pi-5 \pi \cos \pi=0
$$

Since $\quad \sin \pi=0, \cos \pi=-1$
Therefore

$$
c_{1}=9 \pi
$$

Now $\quad y^{\prime}=-9 \pi \sin x+c_{2} \cos x+4+5 x \sin x-5 \cos x$
Therefore

$$
y^{\prime}(\pi)=2 \Rightarrow-9 \pi \sin \pi+c_{2} \cos \pi+4+5 \pi \sin \pi-5 \cos \pi=2
$$

$\therefore$

$$
\mathrm{c}_{2}=7
$$

Hence the solution of the initial value problem is

$$
y=9 \pi \cos x+7 \sin x+4 x-5 x \cos x .
$$

## Example 9

Solve the differential equation

$$
y^{\prime \prime}-6 y^{\prime}+9 y=6 x^{2}+2-12 e^{3 x}
$$

## Solution:

The associated homogeneous differential equation is

$$
y^{\prime \prime}-6 y^{\prime}+9 y=0
$$

$$
\text { Put } y=e^{m x}
$$

Then the auxiliary equation is

$$
m^{2}-6 m+9=0 \Rightarrow m=3,3
$$

Thus the complementary function is

Since

$$
y_{c}=c_{1} e^{3 x}+c_{2} x e^{3 x}
$$

We assume that
Corresponding to $g_{1}(x)=x^{2}+2: \quad y_{p_{1}}=A x^{2}+B x+C$
Corresponding to $g_{2}(x)=-12 e^{3 x}: \quad y_{p_{2}}=D e^{3 x}$
Thus the assumed form of the particular solution is

$$
y_{p}=A x^{2}+B x+C+D e^{3 x}
$$

The function $e^{3 x}$ in $y_{p_{2}}$ is duplicated between $y_{c}$ and $y_{p}$. Multiplication with $x$ does not remove this duplication. However, if we multiply $y_{p_{2}}$ with $x^{2}$, this duplication is removed.
Thus the operative from of a particular solution is

$$
y_{p}=A x^{2}+B x+C+D x^{2} e^{3 x}
$$

Then

$$
y_{p}^{\prime}=2 A x+B+2 D x e^{3 x}+3 D x^{2} e^{3 x}
$$

and

$$
y_{p}^{\prime \prime}=2 A+2 D e^{3 x}+6 D x e^{3 x}+9 D x^{2} e^{3 x}
$$

Substituting into the given differential equation and collecting like term, we obtain

$$
\mathrm{y}_{p}{ }^{\prime \prime}-6 y_{p}^{\prime}+\mathrm{y}_{p}=9 A x^{2}+(-12 A+9 B) x+2 A-6 B+9 \mathrm{C}+2 D e^{3 x}=6 x^{2}+2-12 e^{3 x}
$$

Equating constant terms and coefficients of $x, x^{2}$ and $e^{3 x}$ yields

$$
\begin{array}{lc}
2 A-6 B+9 C=2, & -12 A+9 B=0 \\
9 A=6, & 2 D=-12
\end{array}
$$

Solving these equations, we have the values of the unknown coefficients

$$
A=2 / 3, B=8 / 9, C=2 / 3 \text { and } \mathrm{D}=-6
$$

Thus

$$
y_{p}=\frac{2}{3} x^{2}+\frac{8}{9} x+\frac{2}{3}-6 x^{2} e^{3 x}
$$

Hence the general solution

$$
y=y_{\mathrm{C}}+\mathrm{y}_{\mathrm{p}}=c_{1} e^{3 x}+c_{2} x e^{3 x}+\frac{2}{3} x^{2}+\frac{8}{9} x+\frac{2}{3}-6 x^{2} e^{3 x} .
$$

## Higher -Order Equation

The method of undetermined coefficients can also be used for higher order equations of the form

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\ldots+a_{1} \frac{d y}{d x}+a_{0} y=g(x)
$$

with constant coefficients. The only requirement is that $g(x)$ consists of the proper kinds of functions as discussed earlier.

## Example 10

Solve

$$
y^{\prime \prime \prime}+y^{\prime \prime}=e^{x} \cos x
$$

## Solution:

To find the complementary function we solve the associated homogeneous differential equation

Put

$$
y^{\prime \prime \prime}+y^{\prime \prime}=0
$$

Then the auxiliary equation is
or

$$
\begin{aligned}
& m^{3}+m^{2}=0 \\
& m^{2}(m+1)=0 \Rightarrow m=0,0,-1
\end{aligned}
$$

The auxiliary equation has equal and distinct real roots. Therefore, the complementary function is

Since

$$
\begin{gathered}
y_{c}=c_{1}+c_{2} x+c_{3} e^{-x} \\
g(x)=e^{x} \cos x
\end{gathered}
$$

Therefore, we assume that

$$
y_{p}=A e^{x} \cos x+B e^{x} \sin x
$$

Clearly, there is no duplication of terms between $y_{C}$ and $y_{p}$.

Substituting the derivatives of $y_{p}$ in the given differential equation and grouping the like terms, we have

$$
y_{p}^{\prime \prime \prime}+y_{p}^{\prime \prime}=(-2 A+4 B) e^{x} \cos x+(-4 A-2 B) e^{x} \sin x=e^{x} \cos x .
$$

Equating the coefficients, of $e^{x} \cos x$ and $e^{x} \sin x$, yields

$$
-2 A+4 B=1,-4 A-2 B=0
$$

Solving these equations, we obtain

$$
A=-1 / 10, B=1 / 5
$$

So that a particular solution is

$$
y_{p}=c_{1}+c_{2} x+c_{3} e^{-x}-(1 / 10) e^{x} \cos x+(1 / 5) e^{x} \sin x
$$

Hence the general solution of the given differential equation is

$$
y_{p}=c_{1}+c_{2} x+c_{3} e^{-x}-(1 / 10) e^{x} \cos x+(1 / 5) e^{x} \sin x
$$

## Example 12

Determine the form of a particular solution of the equation

$$
y^{\prime \prime \prime \prime}+y^{\prime \prime \prime}=1-e^{-x}
$$

## Solution:

Consider the associated homogeneous differential equation

$$
y^{\prime \prime \prime \prime}+y^{\prime \prime \prime}=0
$$

The auxiliary equation is

$$
m^{4}+m^{3}=0 \Rightarrow m=0,0,0,-1
$$

Therefore, the complementary function is

$$
y_{c}=c_{1}+c_{2} x+c_{3} x^{2}+c_{4} e^{-x}
$$

Since

$$
g(x)=1-e^{-x}=g_{1}(x)+g_{2}(x)
$$

Corresponding to $g_{1}(x)=1$ :
$y_{p_{1}=A}$
Corresponding to $g_{2}(x)=-e^{-x}$ :

$$
y_{p_{2}}=B e^{-x}
$$

Therefore, the normal assumption for the particular solution is

$$
y_{p}=A+B e^{-x}
$$

Clearly there is duplication of
(i) The constant function between $y_{C}$ and $y_{p_{1}}$.
(ii) The exponential function $e^{-x}$ between $y_{c}$ and $y_{p_{2}}$.

To remove this duplication, we multiply $y_{p_{1}}$ with $x^{3}$ and $y_{p_{2}}$ with $x$. This duplication can't be removed by multiplying with $x$ and $x^{2}$. Hence, the correct assumption for the particular solution $y_{p}$ is
$y_{p}=A x^{3}+B x e^{-x}$

## Exercise

Solve the following differential equations using the undetermined coefficients.

1. $\frac{1}{4} y^{\prime \prime}+y^{\prime}+y=x^{2}+2 x$
2. $y^{\prime \prime}-8 y^{\prime}+20 y=100 x^{2}-26 x e^{x}$
3. $y^{\prime \prime}+3 y=-48 x^{2} e^{3 x}$
4. $4 y^{\prime \prime}-4 y^{\prime}-3 y=\cos 2 x$
5. $y^{\prime \prime}+4 y=\left(x^{2}-3\right) \sin 2 x$
6. $y^{\prime \prime}-5 y^{\prime}=2 x^{3}-4 x^{2}-x+6$

## Lecture 18

## Undetermined Coefficient: Annihilator Operator Approach

## Recall

1. That a non-homogeneous linear differential equation of order $n$ is an equation of the form

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=g(x)
$$

The following differential equation is called the associated homogeneous equation

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=0
$$

The coefficients $a_{0}, a_{1}, \ldots, a_{n}$ can be functions of $x$. However, we will discuss equations with constant coefficients.
2. That to obtain the general solution of a non-homogeneous linear differential equation we must find:
a The complementary function $y_{c}$, which is general solution of the associated homogeneous differential equation.

- Any particular solution $y_{p}$ of the non-homogeneous differential equation.

3. That the general solution of the non-homogeneous linear differential equation is given by

$$
\text { General Solution }=\text { Complementary Function }+ \text { Particular Integral }
$$

- Finding the complementary function has been completely discussed in an earlier lecture
- In the previous lecture, we studied a method for finding particular integral of the non-homogeneous equations. This was the method of undetermined coefficients developed from the viewpoint of superposition principle.
- In the present lecture, we will learn to find particular integral of the nonhomogeneous equations by the same method utilizing the concept of differential annihilator operators.


## Differential Operators

- In calculus, the differential coefficient $d / d x$ is often denoted by the capital letter $D$. So that

$$
\frac{d y}{d x}=D y
$$

The symbol $D$ is known as differential operator.

- This operator transforms a differentiable function into another function, e.g.

$$
D\left(e^{4 x}\right)=4 e^{4 x}, D\left(5 x^{3}-6 x^{2}\right)=15 x^{2}-12 x, D(\cos 2 x)=-2 \sin 2 x
$$

- The differential operator $D$ possesses the property of linearity. This means that if $f, g$ are two differentiable functions, then

$$
D\{a f(x)+b g(x)\}=a D f(x)+b D g(x)
$$

Where $a$ and $b$ are constants. Because of this property, we say that $D$ is a linear differential operator.

- Higher order derivatives can be expressed in terms of the operator $D$ in a natural manner:

$$
\frac{d^{2} y}{d^{2} x}=\frac{d}{d x}\left(\frac{d y}{d x}\right)=D(D y)=D^{2} y
$$

Similarly

$$
\frac{d^{3} y}{d x^{3}}=D^{3} y, \ldots, \frac{d^{n} y}{d^{n} x}=D^{n} y
$$

- The following polynomial expression of degree $n$ involving the operator $D$

$$
a_{n} D^{n}+a_{n-1} D^{n-1}+\cdots+a_{1} D+a_{0}
$$

is also a linear differential operator.
For example, the following expressions are all linear differential operators

$$
D+3, D^{2}+3 D-4,5 D^{3}-6 D^{2}+4 D
$$

## Differential Equation in Terms of $D$

Any linear differential equation can be expressed in terms of the notation $D$. Consider a $2^{\text {nd }}$ order equation with constant coefficients

Since

$$
\begin{aligned}
& a y^{\prime \prime}+b y^{\prime}+c y=g(x) \\
& \frac{d y}{d x}=D y, \frac{d^{2} y}{d x^{2}}=D^{2} y
\end{aligned}
$$

Therefore the equation can be written as

$$
a D^{2} y+b D y+c y=g(x)
$$

or

$$
\left(a D^{2}+b D+c\right) y=g(x)
$$

Now, we define another differential operator $L$ as

$$
L=a D^{2}+b D+c
$$

Then the equation can be compactly written as

$$
L(y)=g(x)
$$

The operator $L$ is a second-order linear differential operator with constant coefficients.

## Example 1

Consider the differential equation
Since $\quad \begin{aligned} & y^{\prime \prime}+y^{\prime}+2 y=5 x-3 \\ & \frac{d y}{d x}=D y, \frac{d^{2} y}{d x^{2}}=D^{2} y\end{aligned}$
Therefore, the equation can be written as

$$
\left(D^{2}+D+2\right) y=5 x-3
$$

Now, we define the operator $L$ as

$$
L=D^{2}+D+2
$$

Then the given differential can be compactly written as

$$
L(y)=5 x-3
$$

## Factorization of a differential operator

- An nth-order linear differential operator

$$
L=a_{n} D^{n}+a_{n-1} D^{n-1}+\cdots+a_{1} D+a_{0}
$$

with constant coefficients can be factorized, whenever the characteristics polynomial equation

$$
L=a_{n} m^{n}+a_{n-1} m^{n-1}+\cdots+a_{1} m+a_{0}
$$

can be factorized.

- The factors of a linear differential operator with constant coefficients commute.


## Example 2

(a) Consider the following $2^{\text {nd }}$ order linear differential operator

$$
D^{2}+5 D+6
$$

If we treat $D$ as an algebraic quantity, then the operator can be factorized as

$$
D^{2}+5 D+6=(D+2)(D+3)
$$

(b) To illustrate the commutative property of the factors, we consider a twicedifferentiable function $y=f(x)$. Then we can write

$$
\left(D^{2}+5 D+6\right) y=(D+2)(D+3) y=(D+3)(D+2) y
$$

To verify this we let

$$
w=(D+3) y=y^{\prime}+3 y
$$

Then

$$
(D+2) w=D w+2 w
$$

or

$$
(D+2) w=\left(y^{\prime \prime}+3 y^{\prime}\right)+\left(2 y^{\prime}+6 y\right)
$$

or $\quad(D+2) w=y^{\prime \prime}+5 y^{\prime}+6 y$
or
$(D+2)(D+3) y=y^{\prime \prime}+5 y^{\prime}+6 y$
Similarly if we let

$$
w=(D+2) y=\left(y^{\prime}+2 y\right)
$$

Then

$$
(D+3) w=D w+3 w=\left(y^{\prime \prime}+2 y^{\prime}\right)+\left(3 y^{\prime}+6 y\right)
$$

or
$(D+3) w=y^{\prime \prime}+5 y^{\prime}+6 y$
or
$(D+3)(D+2) y=y^{\prime /}+5 y^{\prime}+6 y$
Therefore, we can write from the two expressions that

$$
\begin{aligned}
& (D+3)(D+2) y=(D+2)(D+3) y \\
& \text { Hence } \quad(D+3)(D+2) y=(D+2)(D+3) y
\end{aligned}
$$

## Example 3

(a) The operator $D^{2}-1$ can be factorized as

$$
\begin{aligned}
& D^{2}-1=(D+1)(D-1) \\
& D^{2}-1=(\mathrm{D}-1)(D+1)
\end{aligned}
$$

(b) The operator $D^{2}+D+2$ does not factor with real numbers.

## Example 4

The differential equation

$$
y^{\prime \prime}+4 y^{\prime}+4 y=0
$$

can be written as
or

$$
\left(D^{2}+4 D+4\right) y=0
$$

or $\quad(D+2)^{2} y=0$.

## Annihilator Operator

Suppose that

- $\boldsymbol{L}$ is a linear differential operator with constant coefficients.
- $y=f(x)$ defines a sufficiently differentiable function.
- The function $f$ is such that $L(y)=0$

Then the differential operator $L$ is said to be an annihilator operator of the function $f$.

## Example 5

Since

$$
D x=0, D^{2} x=0, D^{3} x^{2}=0, D^{4} x^{3}=0, \ldots
$$

Therefore, the differential operators

$$
D, D^{2}, D^{3}, D^{4}, \ldots
$$

are annihilator operators of the following functions

$$
k(\text { a constant }), x, x^{2}, x^{3}, \ldots
$$

In general, the differential operator $D^{n}$ annihilates each of the functions

$$
1, x, x^{2}, \ldots, x^{n-1}
$$

Hence, we conclude that the polynomial function

$$
c_{0}+c_{1} x+\cdots+c_{n-1} x^{n-1}
$$

can be annihilated by finding an operator that annihilates the highest power of $x$.

## Example 6

Find a differential operator that annihilates the polynomial function

$$
y=1-5 x^{2}+8 x^{3} .
$$

## Solution

Since

$$
D^{4} x^{3}=0
$$

Therefore

$$
D^{4} y=D^{4}\left(1-5 x^{2}+8 x^{3}\right)=0
$$

Hence, $D^{4}$ is the differential operator that annihilates the function $y$.
Note that the functions that are annihilated by an nth-order linear differential operator $L$ are simply those functions that can be obtained from the general solution of the homogeneous differential equation

$$
L(y)=0 .
$$

## Example 7

Consider the homogeneous linear differential equation of order $n$

$$
(D-\alpha)^{n} y=0
$$

The auxiliary equation of the differential equation is

$$
\begin{aligned}
& (m-\alpha)^{n}=0 \\
& m=\alpha, \alpha, \ldots, \alpha(n \text { times })
\end{aligned}
$$

Therefore, the auxiliary equation has a real root $\alpha$ of multiplicity $n$. So that the differential equation has the following linearly independent solutions:

$$
e^{\alpha x}, x e^{\alpha x}, x^{2} e^{\alpha x}, \ldots, x^{n-1} e^{\alpha x}
$$

Therefore, the general solution of the differential equation is

$$
y=c_{1} e^{\alpha x}+c_{2} x e^{\alpha x}+c_{3} x^{2} e^{\alpha x}+\cdots+c_{n} x^{n-1} e^{\alpha x}
$$

So that the differential operator

$$
(D-\alpha)^{n}
$$

annihilates each of the functions

$$
e^{\alpha x}, x e^{\alpha x}, x^{2} e^{\alpha x}, \ldots, x^{n-1} e^{\alpha x}
$$

Hence, as a consequence of the fact that the differentiation can be performed term by term, the differential operator

$$
(D-\alpha)^{n}
$$

annihilates the function

$$
y=c_{1} e^{\alpha x}+c_{2} x e^{\alpha x}+c_{3} x^{2} e^{\alpha x}+\cdots+c_{n} x^{n-1} e^{\alpha x}
$$

## Example 8

Find an annihilator operator for the functions
(a)

$$
f(x)=e^{5 x}
$$

$$
\begin{equation*}
g(x)=4 e^{2 x}-6 x e^{2 x} \tag{b}
\end{equation*}
$$

## Solution

(a) Since

$$
(D-5) e^{5 x}=5 e^{5 x}-5 e^{5 x}=0
$$

Therefore, the annihilator operator of function $f$ is given by

$$
L=D-5
$$

We notice that in this case $\alpha=5, n=1$.
(b) Similarly

$$
(D-2)^{2}\left(4 e^{2 x}-6 x e^{2 x}\right)=\left(D^{2}-4 D+4\right)\left(4 e^{2 x}\right)-\left(D^{2}-4 D+4\right)\left(6 x e^{2 x}\right)
$$

or $\quad(D-2)^{2}\left(4 e^{2 x}-6 x e^{2 x}\right)=32 e^{2 x}-32 e^{2 x}+48 x e^{2 x}-48 x e^{2 x}+24 e^{2 x}-24 e^{2 x}$
or $\quad(D-2)^{2}\left(4 e^{2 x}-6 x e^{2 x}\right)=0$
Therefore, the annihilator operator of the function $g$ is given by

$$
L=(D-2)^{2}
$$

We notice that in this case $\alpha=2=n$.

## Example 9

Consider the differential equation

$$
\left(D^{2}-2 \alpha D+\left(\alpha^{2}+\beta^{2}\right)\right)^{n} y=0
$$

The auxiliary equation is

$$
\Rightarrow \begin{array}{ll} 
& \left(m^{2}-2 \alpha m+\left(\alpha^{2}+\beta^{2}\right)\right)^{n}=0 \\
& m^{2}-2 \alpha m+\left(\alpha^{2}+\beta^{2}\right)=0
\end{array}
$$

Therefore, when $\alpha, \beta$ are real numbers, we have from the quadratic formula

$$
m=\frac{2 \alpha \pm \sqrt{4 \alpha^{2}-4\left(\alpha^{2}+\beta^{2}\right)}}{2}=\alpha \pm i \beta
$$

Therefore, the auxiliary equation has the following two complex roots of multiplicity $n$.

$$
m_{1}=\alpha+i \beta, \quad m_{2}=\alpha-i \beta
$$

Thus, the general solution of the differential equation is a linear combination of the following linearly independent solutions

$$
\begin{aligned}
& e^{\alpha x} \cos \beta x, x e^{\alpha x} \cos \beta x, x^{2} e^{\alpha x} \cos \beta x, \cdots, x^{n-1} e^{\alpha x} \cos \beta x \\
& e^{\alpha x} \sin \beta x, x e^{\alpha x} \sin \beta x, x^{2} e^{\alpha x} \sin \beta x, \cdots, x^{n-1} e^{\alpha x} \sin \beta x
\end{aligned}
$$

Hence, the differential operator

$$
\left(D^{2}-2 \alpha D+\left(\alpha^{2}+\beta^{2}\right)\right) n
$$

is the annihilator operator of the functions

$$
\begin{aligned}
& e^{\alpha x} \cos \beta x, x e^{\alpha x} \cos \beta x, x^{2} e^{\alpha x} \cos \beta x, \cdots, x^{n-1} e^{\alpha x} \cos \beta x \\
& e^{\alpha x} \sin \beta x, x e^{\alpha x} \sin \beta x, x^{2} e^{\alpha x} \sin \beta x, \cdots, x^{n-1} e^{\alpha x} \sin \beta x
\end{aligned}
$$

## Example 10

If we take

$$
\alpha=-1, \beta=2, n=1
$$

Then the differential operator

$$
\left(D^{2}-2 \alpha D+\left(\alpha^{2}+\beta^{2}\right)\right)^{n}
$$

becomes

$$
D^{2}+2 D+5
$$

Also, it can be verified that

$$
\begin{aligned}
& \left(D^{2}+2 D+5\right) e^{-x} \cos 2 x=0 \\
& \left(D^{2}+2 D+5\right) e^{-x} \sin 2 x=0
\end{aligned}
$$

Therefore, the linear differential operator

$$
D^{2}+2 D+5
$$

annihilates the functions

$$
\begin{aligned}
& y_{1}(x)=e^{-x} \cos 2 x \\
& y_{2}(x)=e^{-x} \sin 2 x
\end{aligned}
$$

Now, consider the differential equation

$$
\left(D^{2}+2 D+5\right) y=0
$$

The auxiliary equation is

$$
\begin{aligned}
& m^{2}+2 m+5=0 \\
& \Rightarrow m=-1 \pm 2 i
\end{aligned}
$$

Therefore, the functions

$$
\begin{aligned}
& y_{1}(x)=e^{-x} \cos 2 x \\
& y_{2}(x)=e^{-x} \sin 2 x
\end{aligned}
$$

are the two linearly independent solutions of the differential equation

$$
\left(D^{2}+2 D+5\right) y=0
$$

Therefore, the operator also annihilates a linear combination of $y_{1}$ and $y_{2}$, e.g.

$$
5 y_{1}-9 y_{2}=5 e^{-x} \cos 2 x-9 e^{-x} \sin 2 x
$$

## Example 11

If we take

$$
\alpha=0, \beta=1, n=2
$$

Then the differential operator

$$
\left(D^{2}-2 \alpha D+\left(\alpha^{2}+\beta^{2}\right)\right)^{n}
$$

becomes

$$
\left(D^{2}+1\right)^{2}=D^{4}+2 D^{2}+1
$$

Also, it can be verified that

$$
\begin{aligned}
& \left(D^{4}+2 D^{2}+1\right) \cos x=0 \\
& \left(D^{4}+2 D^{2}+1\right) \sin x=0
\end{aligned}
$$

and

$$
\begin{aligned}
& \left(D^{4}+2 D^{2}+1\right) x \cos x=0 \\
& \left(D^{4}+2 D^{2}+1\right) x \sin x=0
\end{aligned}
$$

Therefore, the linear differential operator

$$
D^{4}+2 D^{2}+1
$$

annihilates the functions

$$
\begin{array}{lr}
\cos x, & \sin x \\
x \cos x, & x \sin x
\end{array}
$$

## Example 12

Taking $\alpha=0, \mathrm{n}=1$, the operator

$$
\left(D^{2}-2 \alpha D+\left(\alpha^{2}+\beta^{2}\right)\right) n
$$

becomes

$$
D^{2}+\beta^{2}
$$

Since $\quad\left(D^{2}+\beta^{2}\right) \cos \beta x=-\beta^{2} \cos \beta x+\beta^{2} \cos \beta x=0$

$$
\left(D^{2}+\beta^{2}\right) \sin \beta x=-\beta^{2} \sin \beta x+\beta^{2} \sin \beta x=0
$$

Therefore, the differential operator annihilates the functions

$$
f(x)=\cos \beta x, \quad g(x)=\sin \beta x
$$

## Note that

- If a linear differential operator with constant coefficients is such that

$$
L\left(y_{1}\right)=0, \quad L\left(y_{2}\right)=0
$$

i.e. the operator $L$ annihilates the functions $y_{1}$ and $y_{2}$. Then the operator $L$ annihilates their linear combination.

$$
L\left[c_{1} y_{1}(x)+c_{2} y_{2}(x)\right]=0 .
$$

This result follows from the linearity property of the differential operator $L$.

- Suppose that $L_{1}$ and $L_{2}$ are linear operators with constant coefficients such that

$$
\begin{array}{ll}
L_{1}\left(y_{1}\right)=0, & L_{2}\left(y_{2}\right)=0 \\
L_{1}\left(y_{2}\right) \neq 0, & L_{2}\left(y_{1}\right) \neq 0
\end{array}
$$

then the product of these differential operators $L_{1} L_{2}$ annihilates the linear sum

$$
y_{1}(x)+y_{2}(x)
$$

So that $\quad L_{1} L_{2}\left[y_{1}(x)+y_{2}(x)\right]=0$
To demonstrate this fact we use the linearity property for writing

$$
L_{1} L_{2}\left(y_{1}+y_{2}\right)=L_{1} L_{2}\left(y_{1}\right)+L_{1} L_{2}\left(y_{2}\right)
$$

Since
therefore

$$
L_{1} L_{2}=L_{2} L_{1}
$$

or $\quad L_{1} L_{2}\left(y_{1}+y_{2}\right)=L_{2}\left[L_{1}\left(y_{1}\right)\right]+L_{1}\left[L_{2}\left(y_{2}\right)\right]$
But we know that $\quad L_{1}\left(y_{1}\right)=0, \quad L_{2}\left(y_{2}\right)=0$

Therefore

$$
L_{1} L_{2}\left(y_{1}+y_{2}\right)=L_{2}[0]+L_{1}[0]=0
$$

## Example 13

Find a differential operator that annihilates the function

$$
f(x)=7-x+6 \sin 3 x
$$

## Solution

Suppose that

$$
y_{1}(x)=7-x, \quad \mathrm{y}_{2}(x)=6 \sin 3 x
$$

Then

$$
\begin{aligned}
& D^{2} y_{1}(x)=D^{2}(7-x)=0 \\
& \left(D^{2}+9\right) y_{2}(x)=\left(D^{2}+9\right) \sin 3 x=0
\end{aligned}
$$

Therefore,

$$
D^{2}\left(D^{2}+9\right) \text { annihilates the function } f(x)
$$

## Example 14

Find a differential operator that annihilates the function

$$
f(x)=e^{-3 x}+x e^{x}
$$

## Solution

Suppose that

$$
y_{1}(x)=e^{-3 x}, \quad y_{2}(x)=x e^{x}
$$

Then

$$
\begin{aligned}
& (D+3) y_{1}=(D+3) e^{-3 x}=0 \\
& (D-1)^{2} y_{2}=(D-1)^{2} x e^{x}=0
\end{aligned}
$$

Therefore, the product of two operators

$$
(D+3)(D-1)^{2}
$$

annihilates the given function $f(x)=e^{-3 x}+x e^{x}$

## Note that

- The differential operator that annihilates a function is not unique. For example,

$$
\begin{aligned}
& (D-5) e^{5 x}=0 \\
& (D-5)(D+1) e^{5 x}=0 \\
& (D-5) D^{2} e^{5 x}=0
\end{aligned}
$$

Therefore, there are 3 annihilator operators of the functions, namely

$$
(D-5),(D-5)(D+1),(D-5) D^{2}
$$

- When we seek a differential annihilator for a function, we want the operator of lowest possible order that does the job.

## Lecture 19

## Undetermined Coefficients: Annihilator Operator Approach

The method of undetermined coefficients that utilizes the concept of annihilator operator approach is also limited to non-homogeneous linear differential equations

- That have constant coefficients, and
- Where the function $g(x)$ has a specific form.

The form of $g(x)$ :The input function $g(x)$ has to have one of the following forms:

- A constant function $k$.
- A polynomial function
- An exponential function $e^{X}$
- The trigonometric functions $\sin (\beta x), \cos (\beta x)$
- Finite sums and products of these functions.

Otherwise, we cannot apply the method of undetermined coefficients.

## The Method

Consider the following non-homogeneous linear differential equation with constant coefficients of order $n$

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=g(x)
$$

If $L$ denotes the following differential operator

$$
L=a_{n} D^{n}+a_{n-1} D^{n-1}+\cdots+a_{1} D+a_{0}
$$

Then the non-homogeneous linear differential equation of order $n$ can be written as

$$
L(y)=g(x)
$$

The function $g(x)$ should consist of finite sums and products of the proper kind of functions as already explained.

The method of undetermined coefficients, annihilator operator approach, for finding a particular integral of the non-homogeneous equation consists of the following steps:

Step 1 Write the given non-homogeneous linear differential equation in the form

$$
L(y)=g(x)
$$

Step 2 Find the complementary solution $y_{c}$ by finding the general solution of the associated homogeneous differential equation:

$$
L(y)=0
$$

Step 3 Operate on both sides of the non-homogeneous equation with a differential operator $L_{1}$ that annihilates the function $\mathrm{g}(\mathrm{x})$.
Step 4 Find the general solution of the higher-order homogeneous differential equation

$$
L_{1} L(y)=0
$$

Step 5 Delete all those terms from the solution in step 4 that are duplicated in the complementary solution $y_{C}$, found in step 2.

Step 6 Form a linear combination $y_{p}$ of the terms that remain. This is the form of a particular solution of the non-homogeneous differential equation

$$
L(y)=g(x)
$$

Step 7 Substitute $y_{p}$ found in step 6 into the given non-homogeneous linear differential equation

$$
L(y)=g(x)
$$

Match coefficients of various functions on each side of the equality and solve the resulting system of equations for the unknown coefficients in $y_{p}$.
Step 8 With the particular integral found in step 7, form the general solution of the given differential equation as:

$$
y=y_{c}+y_{p}
$$

## Example 1

Solve

$$
\frac{d^{2} y}{d x^{2}}+3 \frac{d y}{d x}+2 y=4 x^{2}
$$

## Solution:

Step 1 Since

$$
\frac{d y}{d x}=D y, \frac{d^{2} y}{d x^{2}}=D^{2} y
$$

Therefore, the given differential equation can be written as

$$
\left(D^{2}+3 D+2\right) y=4 x^{2}
$$

Step 2 To find the complementary function $y_{c}$, we consider the associated homogeneous differential equation

$$
\left(D^{2}+3 D+2\right) y=0
$$

The auxiliary equation is

$$
\begin{aligned}
m^{2}+3 m+2= & (m+1)(m+2)=0 \\
\Rightarrow m & =-1,-2
\end{aligned}
$$

Therefore, the auxiliary equation has two distinct real roots.

$$
m_{1}=-1, m_{2}=-2,
$$

Thus, the complementary function is given by

$$
y_{C}=c_{1} e^{-x}+c_{2} e^{-2 x}
$$

Step 3 In this case the input function is

$$
g(x)=4 x^{2}
$$

Further $\quad D^{3} g(x)=4 D^{3} x^{2}=0$

Therefore, the differential operator $D^{3}$ annihilates the function $g$. Operating on both sides of the equation in step 1 , we have

$$
\begin{aligned}
& D^{3}\left(D^{2}+3 D+2\right) y=4 D^{3} x^{2} \\
& D^{3}\left(D^{2}+3 D+2\right) y=0
\end{aligned}
$$

This is the homogeneous equation of order 5 . Next we solve this higher order equation.
Step 4 The auxiliary equation of the differential equation in step 3 is

$$
\begin{aligned}
& m^{3}\left(m^{2}+3 m+2\right)=0 \\
& m^{3}(m+1)(m+2)=0 \\
& m=0,0,0,-1,-2
\end{aligned}
$$

Thus its general solution of the differential equation must be

$$
y=c_{1}+c_{2} x+c_{3} x^{2}+c_{4} e^{-x}+c_{5} e^{-2 x}
$$

Step 5 The following terms constitute $y_{C}$

$$
c_{4} e^{-x}+c_{5} e^{-2 x}
$$

Therefore, we remove these terms and the remaining terms are

$$
c_{1}+c_{2} x+c_{3} x^{2}
$$

Step 6 This means that the basic structure of the particular solution $y_{p}$ is

$$
y_{p}=A+B x+C x^{2}
$$

Where the constants $c_{1}, c_{2}$ and $c_{3}$ have been replaced, with $A, B$, and $C$, respectively.
Step 7 Since

$$
\begin{aligned}
& y_{p}=A+B x+C x^{2} \\
& y_{p}^{\prime}=B+2 C x, \\
& y_{p}^{\prime \prime}=2 C
\end{aligned}
$$

Therefore

$$
y_{p}^{\prime \prime}+3 y_{p}^{\prime}+2 y_{p}=2 C+3 B+6 C x+2 A+2 B x+2 C x^{2}
$$

or

$$
y_{p}^{\prime \prime}+3 y_{p}^{\prime}+2 y_{p}=(2 C) x^{2}+(2 B+6 C) x+(2 A+3 B+2 C)
$$

Substituting into the given differential equation, we have

$$
(2 C) x^{2}+(2 B+6 C) x+(2 A+3 B+2 C)=4 x^{2}+0 x+0
$$

Equating the coefficients of $x^{2}, x$ and the constant terms, we have

$$
\begin{array}{ll}
2 C & =4 \\
2 B+6 C & =0 \\
2 A+3 B+2 C & =0
\end{array}
$$

Solving these equations, we obtain

$$
A=7, \quad B=-6, \quad \mathrm{C}=2
$$

Hence

$$
y_{p}=7-6 x+2 x^{2}
$$

Step 8 The general solution of the given non-homogeneous differential equation is

$$
\begin{aligned}
& y=y_{c}+y_{p} \\
& y=c_{1} e^{-x}+c_{2} e^{-2 x}+7-6 x+2 x^{2}
\end{aligned}
$$

## Example 2

Solve

$$
\frac{d^{2} y}{d x^{2}}-3 \frac{d y}{d x}=8 e^{3 x}+4 \sin x
$$

## Solution:

Step 1 Since

$$
\frac{d y}{d x}=D y, \frac{d^{2} y}{d x^{2}}=D^{2} y
$$

Therefore, the given differential equation can be written as

$$
\left(D^{2}-3 D\right) y=8 e^{3 x}+4 \sin x
$$

Step 2 We first consider the associated homogeneous differential equation to find $y_{C}$ The auxiliary equation is

$$
m(m-3)=0 \Rightarrow m=0,3
$$

Thus the auxiliary equation has real and distinct roots. So that we have

$$
y_{c}=c_{1}+c_{2} e^{3 x}
$$

Step 3 In this case the input function is given by

$$
g(x)=8 e^{3 x}+4 \sin x
$$

Since

$$
(D-3)\left(8 e^{3 x}\right)=0,\left(D^{2}+1\right)(4 \sin x)=0
$$

Therefore, the operators $D-3$ and $D^{2}+1$ annihilate $8 e^{3 x}$ and $4 \sin x$, respectively. So the operator $(D-3)\left(D^{2}+1\right)$ annihilates the input function $g(x)$. This means that

$$
(D-3)\left(D^{2}+1\right) g(x)=(D-3)\left(D^{2}+1\right)\left(8 e^{3 x}+\sin x\right)=0
$$

We apply $(D-3)\left(D^{2}+1\right)$ to both sides of the differential equation in step 1 to obtain

$$
(D-3)\left(D^{2}+1\right)\left(D^{2}-3 D\right) y=0 .
$$

This is homogeneous differential equation of order 5 .
Step 4 The auxiliary equation of the higher order equation found in step 3 is

$$
\begin{aligned}
& (m-3)\left(m^{2}+1\right)\left(m^{2}-3 m\right)=0 \\
& m(m-3)^{2}\left(m^{2}+1\right)=0 \\
& \Rightarrow m=0,3,3, \pm i
\end{aligned}
$$

Thus, the general solution of the differential equation

$$
y=c_{1}+c_{2} e^{3 x}+c_{3} x e^{3 x}+c_{4} \cos x+c_{5} \sin x
$$

Step 5 First two terms in this solution are already present in $y_{C}$

$$
c_{1}+c_{2} e^{3 x}
$$

Therefore, we eliminate these terms. The remaining terms are

$$
c_{3} x e^{3 x}+c_{4} \cos x+c_{5} \sin x
$$

Step 6 Therefore, the basic structure of the particular solution $y_{p}$ must be

$$
y_{p}=A x e^{3 x}+B \cos x+C \sin x
$$

The constants $c_{3}, c_{4}$ and $c_{5}$ have been replaced with the constants $A, B$ and $C$, respectively.

Step 7 Since

$$
y_{p}=A x e^{3 x}+B \cos x+C \sin x
$$

Therefore

$$
y_{p}^{\prime \prime}-3 y_{p}^{\prime}=3 A e^{3 x}+(-B-3 C) \cos x+(3 B-C) \sin x
$$

Substituting into the given differential equation, we have

$$
3 A e^{3 x}+(-B-3 C) \cos x+(3 B-C) \sin x=8 e^{3 x}+4 \sin x
$$

Equating coefficients of $e^{3 x}, \cos x$ and $\sin x$, we obtain

$$
3 A=8,-B-3 C=0,3 B-C=4
$$

Solving these equations we obtain

$$
\begin{aligned}
& A=8 / 3, \quad B=6 / 5, \quad C=-2 / 5 \\
& y_{p}=\frac{8}{3} x e^{3 x}+\frac{6}{5} \cos x-\frac{2}{5} \sin x .
\end{aligned}
$$

Step 8 The general solution of the differential equation is then

$$
y=c_{1}+c_{2} e^{3 x}+\frac{8}{3} x e^{3 x}+\frac{6}{5} \cos x-\frac{2}{5} \sin x
$$

## Example 3

Solve

$$
\frac{d^{2} y}{d x^{2}}+8 y=5 x+2 e^{-x}
$$

## Solution:

Step 1 The given differential equation can be written as

$$
\left(D^{2}+8\right) y=5 x+2 e^{-x}
$$

Step 2 The associated homogeneous differential equation is

$$
\left(D^{2}+8\right) y=0
$$

Roots of the auxiliary equation are complex

$$
m= \pm 2 \sqrt{2} i
$$

Therefore, the complementary function is

$$
y_{c}=c_{1} \cos 2 \sqrt{2} x+c_{2} \sin 2 \sqrt{2} x
$$

Step 3 Since

$$
D^{2} x=0, \quad(D+1) e^{-x}=0
$$

Therefore the operators $D^{2}$ and $D+1$ annihilate the functions $5 x$ and $2 e^{-x}$. We apply $D^{2}(D+1)$ to the non-homogeneous differential equation

$$
D^{2}(D+1)\left(D^{2}+8\right) y=0
$$

This is a homogeneous differential equation of order 5.
Step 4 The auxiliary equation of this differential equation is

$$
\begin{aligned}
& m^{2}(m+1)\left(m^{2}+8\right)=0 \\
& \Rightarrow m=0,0,-1, \pm 2 \sqrt{2} i
\end{aligned}
$$

Therefore, the general solution of this equation must be

$$
y=c_{1} \cos 2 \sqrt{2} x+c_{2} \sin 2 \sqrt{2} x+c_{3}+c_{4} x+c_{5} e^{-x}
$$

Step 5 Since the following terms are already present in $y_{C}$

$$
c_{1} \cos 2 \sqrt{2} x+c_{2} \sin 2 \sqrt{2} x
$$

Thus we remove these terms. The remaining ones are

$$
c_{3}+c_{4} x+c_{5} e^{-x}
$$

Step 6 The basic form of the particular solution of the equation is

$$
y_{p}=A+B x+C e^{-x}
$$

The constants $c_{3}, c_{4}$ and $c_{5}$ have been replaced with $A, B$ and $C$.

Step 7 Since

$$
y_{p}=A+B x+C e^{-x}
$$

Therefore

$$
y_{p}^{\prime \prime}+8 y_{p}=8 A+8 B x+9 C e^{-x}
$$

Substituting in the given differential equation, we have

$$
8 A+8 B x+9 C e^{-x}=5 x+2 e^{-x}
$$

Equating coefficients of $x, e^{-x}$ and the constant terms, we have

$$
A=0, B=5 / 8, C=2 / 9
$$

Thus

$$
y_{p}=\frac{5}{8} x+\frac{2}{9} e^{-x}
$$

Step 8 Hence, the general solution of the given differential equation is
or

$$
y=y_{C}+y_{p}
$$

$$
y=c_{1} \cos 2 \sqrt{2} x+c_{2} \sin 2 \sqrt{2} x+\frac{5}{8} x+\frac{2}{9} e^{-x}
$$

## Example 4

Solve

$$
\frac{d^{2} y}{d x^{2}}+y=x \cos x-\cos x
$$

## Solution:

Step 1 The given differential equation can be written as

$$
\left(D^{2}+1\right) y=x \cos x-\cos x
$$

Step 2 Consider the associated differential equation

$$
\left(D^{2}+1\right) y=0
$$

The auxiliary equation is

Therefore $\quad y_{c}=c_{1} \cos x+c_{2} \sin x$

$$
m^{2}+1=0 \Rightarrow m= \pm i
$$

Step 3 Since

$$
\begin{aligned}
& \left(D^{2}+1\right)^{2}(x \cos x)=0 \\
& \left(D^{2}+1\right)^{2} \cos x=0 ; \quad \because x \neq 0
\end{aligned}
$$

Therefore, the operator $\left(D^{2}+1\right)^{2}$ annihilates the input function

$$
x \cos x-\cos x
$$

Thus operating on both sides of the non-homogeneous equation with $\left(D^{2}+1\right)^{2}$, we have

$$
\left(D^{2}+1\right)^{2}\left(D^{2}+1\right) y=0
$$

or

$$
\left(D^{2}+1\right)^{3} y=0
$$

This is a homogeneous equation of order 6 .
Step 4 The auxiliary equation of this higher order differential equation is

$$
\left(m^{2}+1\right)^{3}=0 \Rightarrow m=i, i, i,-i,-i,-i
$$

Therefore, the auxiliary equation has complex roots $i$, and $-i$ both of multiplicity 3 . We conclude that

$$
y=c_{1} \cos x+c_{2} \sin x+c_{3} x \cos x+c_{4} x \sin x+c_{5} x^{2} \cos x+c_{6} x^{2} \sin x
$$

Step 5 Since first two terms in the above solution are already present in $y_{C}$

$$
c_{1} \cos x+c_{2} \sin x
$$

Therefore, we remove these terms.
Step 6 The basic form of the particular solution is

$$
y_{p}=A x \cos x+B x \sin x+C x^{2} \cos x+E x^{2} \sin x
$$

Step 7 Since

$$
y_{p}=A x \cos x+B x \sin x+C x^{2} \cos x+E x^{2} \sin x
$$

Therefore

$$
y_{p}^{\prime \prime}+y_{p}=4 E x \cos x-4 C x \sin x+(2 B+2 C) \cos x+(-2 A+2 E) \sin x
$$

Substituting in the given differential equation, we obtain

$$
4 E x \cos x-4 C x \sin x+(2 B+2 C) \cos x+(-2 A+2 E) \sin x=x \cos x-\cos x
$$

Equating coefficients of $x \cos x, x \sin x, \cos x$ and $\sin x$, we obtain

$$
\begin{aligned}
& 4 E=1,-4 C \quad=0 \\
& 2 B+2 C=-1,-2 A+2 E=0
\end{aligned}
$$

Solving these equations we obtain

$$
A=1 / 4, B=-1 / 2, C=0, E=1 / 4
$$

Thus

$$
y_{p}=\frac{1}{4} x \cos x-\frac{1}{2} x \sin x+\frac{1}{4} x^{2} \sin x
$$

Step 8 Hence the general solution of the differential equation is

$$
y=c_{1} \cos x+c_{2} \sin x+\frac{1}{4} x \cos x-\frac{1}{2} x \sin x+\frac{1}{4} x^{2} \sin x .
$$

## Example 5

Determine the form of a particular solution for

$$
\frac{d^{2} y}{d x^{2}}-2 \frac{d y}{d x}+y=10 e^{-2 x} \cos x
$$

## Solution

Step 1 The given differential equation can be written as

$$
\left(D^{2}-2 D+1\right) y=10 e^{-2 x} \cos x
$$

Step 2 To find the complementary function, we consider

$$
y^{\prime \prime}-2 y^{\prime}+y=0
$$

The auxiliary equation is

$$
m^{2}-2 m+1=0 \Rightarrow(m-1)^{2}=0 \Rightarrow m=1,1
$$

The complementary function for the given equation is

$$
y_{c}=c_{1} e^{x}+c_{2} x e^{x}
$$

Step 3 Since $\left(D^{2}+4 D+5\right) e^{-2 x} \cos x=0$
Applying the operator $\left(D^{2}+4 D+5\right)$ to both sides of the equation, we have

$$
\left(D^{2}+4 D+5\right)\left(D^{2}-2 D+1\right) y=0
$$

This is homogeneous differential equation of order 4.
Step 4 The auxiliary equation is

$$
\begin{aligned}
& \left(m^{2}+4 m+5\right)\left(m^{2}-2 m+1\right)=0 \\
& \Rightarrow m=-2 \pm i, 1,1
\end{aligned}
$$

Therefore, general solution of the $4^{\text {th }}$ order homogeneous equation is

$$
y=c_{1} e^{x}+c_{2} x e^{x}+c_{3} e^{-2 x} \cos x+c_{4} e^{-2 x} \sin x
$$

Step 5 Since the terms $c_{1} e^{x}+c_{2} x e^{x}$ are already present in $y_{c}$, therefore, we remove these and the remaining terms are $c_{3} e^{-2 x} \cos x+c_{4} e^{-2 x} \sin x$

Step 6 Therefore, the form of the particular solution of the non-homogeneous equation is

$$
\therefore \quad y_{p}=A e^{-2 x} \cos x+B e^{-2 x} \sin x
$$

Note that the steps 7 and 8 are not needed, as we don't have to solve the given differential equation.

## Example 6

Determine the form of a particular solution for

$$
\frac{d^{3} y}{d x^{3}}-4 \frac{d^{2} y}{d x^{2}}+4 \frac{d y}{d x}=5 x^{2}-6 x+4 x^{2} e^{2 x}+3 e^{5 x}
$$

## Solution:

Step 1 The given differential can be rewritten as

$$
\left(D^{3}-4 D^{2}+4 D\right) y=5 x^{2}-6 x+4 x^{2} e^{2 x}+3 e^{5 x}
$$

Step 2 To find the complementary function, we consider the equation

$$
\left(D^{3}-4 D^{2}+4 D\right) y=0
$$

The auxiliary equation is

$$
\begin{aligned}
& m^{3}-4 m^{2}+4 m=0 \\
& m\left(m^{2}-4 m+4\right)=0 \\
& m(m-2)^{2}=0 \Rightarrow m=0,2,2
\end{aligned}
$$

Thus the complementary function is

$$
y_{c}=c_{1}+c_{2} e^{2 x}+c_{3} x e^{2 x}
$$

Step 3 Since

$$
g(x)=5 x^{2}-6 x+4 x^{2} e^{2 x}+3 e^{5 x}
$$

Further

$$
\begin{aligned}
& D^{3}\left(5 x^{2}-6 x\right)=0 \\
& (D-2)^{3} x^{2} e^{2 x}=0 \\
& (D-5) e^{5 x}=0
\end{aligned}
$$

Therefore the following operator must annihilate the input function $g(x)$. Therefore, applying the operator $D^{3}(D-2)^{3}(D-5)$ to both sides of the non-homogeneous equation, we have

$$
D^{3}(D-2)^{3}(D-5)\left(D^{3}-D^{2}+4 D\right) y=0
$$

or

$$
D^{4}(D-2)^{5}(D-5) y=0
$$

This is homogeneous differential equation of order 10.

Step 4 The auxiliary equation for the $10^{\text {th }}$ order differential equation is

$$
\begin{aligned}
& m^{4}(m-2)^{5}(m-5)=0 \\
& \Rightarrow m=0,0,0,0,2,2,2,2,2,5
\end{aligned}
$$

Hence the general solution of the $10^{\text {th }}$ order equation is

$$
y=c_{1}+c_{2} x+c_{3} x^{2}+c_{4} x^{3}+c_{5} e^{2 x}+c_{6} x e^{2 x}+c_{7} x^{2} e^{2 x}+c_{8} x^{3} e^{2 x}+c_{9} x^{4} e^{2 x}+c_{10} e^{5 x}
$$

Step 5 Since the following terms constitute the complementary function $y_{c}$, we remove these

$$
c_{1}+c_{5} e^{2 x}+c_{6} x e^{2 x}
$$

Thus the remaining terms are

$$
c_{2} x+c_{3} x^{2}+c_{4} x^{3}+c_{7} x^{2} e^{2 x}+c_{8} x^{3} e^{2 x}+c_{9} x^{4} e^{2 x}+c_{10} e^{5 x}
$$

Hence, the form of the particular solution of the given equation is

$$
y_{p}=A x+B x^{2}+C x^{3}+E x^{2} e^{2 x}+F x^{3} e^{2 x}+G x^{4} e^{2 x}+H e^{5 x}
$$

8. $y^{\prime \prime}+y=8 \cos 2 x-4 \sin x, y(\pi / 2)=-1, y^{\prime}(\pi / 2)=0$
9. $y^{\prime \prime \prime}-2 y^{\prime \prime}+y^{\prime}=x e^{x}+5, \quad \mathrm{y}(0)=2, \quad y^{\prime}(0)=2, y^{\prime \prime}(0)=-1$
10. $y^{(4)}-y^{\prime \prime \prime}=x+e^{x}, \quad y(0)=0, y^{\prime}(0)=0, y^{\prime \prime}(0)=0, y^{\prime \prime \prime}(0)=0$

## Lecture 20

## Variation of Parameters

## Recall

- That a non-homogeneous linear differential equation with constant coefficients is an equation of the form

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=g(x)
$$

- The general solution of such an equation is given by
General Solution = Complementary Function + Particular Integral
- Finding the complementary function has already been completely discussed.
- In the last two lectures, we learnt how to find the particular integral of the nonhomogeneous equations by using the undetermined coefficients.
- That the general solution of a linear first order differential equation of the form

$$
\begin{aligned}
& \frac{d y}{d x}+P(x) y=f(x) \\
& y=e^{-\int P d x} \cdot \int e^{\int P d x} f(x) d x+c_{1} e^{-\int P d x}
\end{aligned}
$$

is given by

## Note that

- In this last equation, the $2^{\text {nd }}$ term

$$
y_{c}=c_{1} e^{-\int P d x}
$$

is solution of the associated homogeneous equation:

$$
\frac{d y}{d x}+P(x) y=0
$$

- Similarly, the $1^{\text {st }}$ term

$$
y_{p}=e^{-\int P d x} \cdot \int e^{\int P d x} \cdot f(x) d x
$$

is a particular solution of the first order non-homogeneous linear differential equation.

- Therefore, the solution of the first order linear differential equation can be written in the form

$$
y=y_{c}+y_{p}
$$

In this lecture, we will use the variation of parameters to find the particular integral of the non-homogeneous equation.

## The Variation of Parameters

## First order equation

The particular solution $y_{p}$ of the first order linear differential equation is given by

$$
y_{p}=e^{-\int P d x} \cdot \int e^{\int P d x} \cdot f(x) d x
$$

This formula can also be derived by another method, known as the variation of parameters. The basic procedure is same as discussed in the lecture on construction of a second solution

Since

$$
y_{1}=e^{-\int P d x}
$$

is the solution of the homogeneous differential equation

$$
\frac{d y}{d x}+P(x) y=0
$$

and the equation is linear. Therefore, the general solution of the equation is

$$
y=c_{1} y_{1}(x)
$$

The variation of parameters consists of finding a function $u_{1}(x)$ such that

$$
y_{p}=u_{1}(x) y_{1}(x)
$$

is a particular solution of the non-homogeneous differential equation

$$
\frac{d y}{d x}+P(x) y=f(x)
$$

Notice that the parameter $c_{1}$ has been replaced by the variable $u_{1}$. We substitute $y_{p}$ in the given equation to obtain

$$
u_{1}\left[\frac{d y_{1}}{d x}+P(x) y_{1}\right]+y_{1} \frac{d u_{1}}{d x}=f(x)
$$

Since $y_{1}$ is a solution of the non-homogeneous differential equation. Therefore we must have

$$
\frac{d y_{1}}{d x}+P(x) y_{1}=0
$$

So that we obtain

$$
\therefore \quad y_{1} \frac{d u_{1}}{d x}=f(x)
$$

This is a variable separable equation. By separating the variables, we have

$$
d u_{1}=\frac{f(x)}{y_{1}(x)} d x
$$

Integrating the last expression w.r.to $X$, we obtain

$$
u_{1}(x)=\int \frac{f(x)}{y_{1}} d x=\int e^{\int P d x} \cdot f(x) d x
$$

Therefore, the particular solution $y_{p}$ of the given first-order differential equation is .
or

$$
\begin{aligned}
& y=u_{1}(x) y_{1} \\
& y_{p}=e^{-\int P d x} \cdot \int e^{\int P d x} \cdot f(x) d x \\
& u_{1}=\int \frac{f(x)}{y_{1}(x)} d x
\end{aligned}
$$

## Second Order Equation

Consider the $2^{\text {nd }}$ order linear non-homogeneous differential equation

$$
a_{2}(x) y^{\prime \prime}+a_{1}(x) y^{\prime}+a_{0}(x) y=g(x)
$$

By dividing with $a_{2}(x)$, we can write this equation in the standard form

$$
y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=f(x)
$$

The functions $P(x), Q(x)$ and $f(x)$ are continuous on some interval $I$. For the complementary function we consider the associated homogeneous differential equation

$$
y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=0
$$

## Complementary function

Suppose that $y_{1}$ and $y_{2}$ are two linearly independent solutions of the homogeneous equation. Then $y_{1}$ and $y_{2}$ form a fundamental set of solutions of the homogeneous equation on the interval $I$. Thus the complementary function is

$$
y_{c}=c_{1} y_{1}(x)+c_{2} y_{2}(x)
$$

Since $y_{1}$ and $y_{2}$ are solutions of the homogeneous equation. Therefore, we have

$$
\begin{aligned}
& y_{1}^{\prime \prime}+P(x) y_{1}^{\prime}+Q(x) y_{1}=0 \\
& y_{2}^{\prime \prime}+P(x) y_{2}^{\prime}+Q(x) y_{2}=0
\end{aligned}
$$

## Particular Integral

For finding a particular solution $y_{p}$, we replace the parameters $c_{1}$ and $c_{2}$ in the complementary function with the unknown variables $u_{1}(x)$ and $u_{2}(x)$. So that the assumed particular integral is

$$
y_{p}=u_{1}(x) y_{1}(x)+u_{2}(x) y_{2}(x)
$$

Since we seek to determine two unknown functions $u_{1}$ and $u_{2}$, we need two equations involving these unknowns. One of these two equations results from substituting the
assumed $y_{p}$ in the given differential equation. We impose the other equation to simplify the first derivative and thereby the $2^{\text {nd }}$ derivative of $y_{p}$.

$$
y_{p}^{\prime}=u_{1} y_{1}^{\prime}+y_{1} u_{1}^{\prime}+u_{2} y_{2}^{\prime}+u_{2}^{\prime} y_{2}=u_{1} y_{1}^{\prime}+u_{2} y_{2}^{\prime}+u_{1}^{\prime} y_{1}+u_{2}^{\prime} y_{2}
$$

To avoid $2^{\text {nd }}$ derivatives of $u_{1}$ and $u_{2}$, we impose the condition

$$
u_{1}^{\prime} y_{1}+u_{2}^{\prime} y_{2}=0
$$

Then

$$
y_{p}^{\prime}=u_{1} y_{1}^{\prime}+u_{2} y_{2}^{\prime}
$$

So that

$$
y_{p}^{\prime \prime}=u_{1} y_{1}^{\prime \prime}+u_{1}^{\prime} y_{1}^{\prime}+u_{2} y_{2}^{\prime \prime}+u_{2}^{\prime} y_{2}^{\prime}
$$

Therefore

$$
\begin{aligned}
y_{p}^{\prime \prime}+P y_{p}^{\prime}+Q y_{p} & =u_{1} y_{1}^{\prime \prime}+u_{1}^{\prime} y_{1}^{\prime}+u_{2} y_{2}^{\prime \prime}+u_{2}^{\prime} y_{2}^{\prime} \\
& +P u_{1} y_{1}^{\prime}+P u_{2} y_{2}^{\prime}+Q u_{1} y_{1}+Q u_{2} y_{2}
\end{aligned}
$$

Substituting in the given non-homogeneous differential equation yields

$$
\begin{aligned}
& u_{1} y_{1}^{\prime \prime}+u_{1}^{\prime} y_{1}^{\prime}+u_{2} y_{2}^{\prime \prime}+u_{2}^{\prime} y_{2}^{\prime}+P u_{1} y_{1}^{\prime}+P u_{2} y_{2}^{\prime}+Q u_{1} y_{1}+Q u_{2} y_{2}=f(x) \\
& u_{1}\left[y_{1}^{\prime \prime}+P y_{1}^{\prime}+Q y_{1}\right]+u_{2}\left[y_{2}^{\prime \prime}+P y_{2}^{\prime}+Q y_{2}\right]+u_{1}^{\prime} y_{1}^{\prime}+u_{2}^{\prime} y_{2}^{\prime}=f(x)
\end{aligned}
$$

or

Now making use of the relations

$$
\begin{aligned}
& y_{1}^{\prime \prime}+P(x) y_{1}^{\prime}+Q(x) y_{1}=0 \\
& y_{2}^{\prime \prime}+P(x) y_{2}^{\prime}+Q(x) y_{2}=0
\end{aligned}
$$

we obtain

$$
u_{1}^{\prime} y_{1}^{\prime}+u_{2}^{\prime} y_{2}^{\prime}=f(x)
$$

Hence $u_{1}$ and $u_{2}$ must be functions that satisfy the equations

$$
\begin{aligned}
& u_{1}^{\prime} y_{1}+u_{2}^{\prime} y_{2}=0 \\
& u_{1}^{\prime} y_{1}^{\prime}+u_{2}^{\prime} y_{2}^{\prime}=f(x)
\end{aligned}
$$

By using the Cramer's rule, the solution of this set of equations is given by

$$
u_{1}^{\prime}=\frac{W_{1}}{W}, \quad u_{2}^{\prime}=\frac{W_{2}}{W}
$$

Where $W, W_{1}$ and $W_{2}$ denote the following determinants

$$
W=\left|\begin{array}{ll}
y_{1} & y_{2} \\
y_{1}^{\prime} & y_{2}^{\prime}
\end{array}\right|, \quad W_{1}=\left|\begin{array}{cc}
0 & y_{2} \\
f(x) & y_{2}^{\prime}
\end{array}\right|, \quad W_{2}=\left|\begin{array}{cc}
y_{1} & 0 \\
y_{1}^{\prime} & f(x)
\end{array}\right|
$$

The determinant $W$ can be identified as the Wronskian of the solutions $y_{1}$ and $y_{2}$. Since the solutions $y_{1}$ and $y_{2}$ are linearly independent on $I$. Therefore

$$
W\left(y_{1}(x), y_{2}(x)\right) \neq 0, \forall x \in I .
$$

Now integrating the expressions for $u_{1}^{\prime}$ and $u_{2}^{\prime}$, we obtain the values of $u_{1}$ and $u_{2}$, hence the particular solution of the non-homogeneous linear differential equation.

## Summary of the Method

To solve the $2^{\text {nd }}$ order non-homogeneous linear differential equation

$$
a_{2} y^{\prime \prime}+a_{1} y^{\prime}+a_{0} y=g(x)
$$

using the variation of parameters, we need to perform the following steps:

Step 1 We find the complementary function by solving the associated homogeneous differential equation

$$
a_{2} y^{\prime \prime}+a_{1} y^{\prime}+a_{0} y=0
$$

Step 2 If the complementary function of the equation is given by

$$
y_{C}=c_{1} y_{1}+c_{2} y_{2}
$$

then $y_{1}$ and $y_{2}$ are two linearly independent solutions of the homogeneous differential equation. Then compute the Wronskian of these solutions.

$$
W=\left|\begin{array}{ll}
y_{1} & y_{2} \\
y_{1}^{\prime} & y_{2}^{\prime}
\end{array}\right|
$$

Step 3 By dividing with $a_{2}$, we transform the given non-homogeneous equation into the standard form

$$
y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=f(x)
$$

and we identify the function $f(x)$.
Step 4 We now construct the determinants $W_{1}$ and $W_{2}$ given by

$$
W_{1}=\left|\begin{array}{cc}
0 & y_{2} \\
f(x) & y_{2}^{\prime}
\end{array}\right|, \quad W_{2}=\left|\begin{array}{cc}
y_{1} & 0 \\
y_{1}^{\prime} & f(x)
\end{array}\right|
$$

Step 5 Next we determine the derivatives of the unknown variables $u_{1}$ and $u_{2}$ through the relations

$$
u_{1}^{\prime}=\frac{W_{1}}{W}, \quad u_{2}^{\prime}=\frac{W_{2}}{W}
$$

Step 6 Integrate the derivatives $u_{1}^{\prime}$ and $u_{2}^{\prime}$ to find the unknown variables $u_{1}$ and $u_{2}$. So that

$$
u_{1}=\int \frac{W_{1}}{W} d x, \quad u_{2}=\int \frac{W_{2}}{W} d x
$$

Step 7 Write a particular solution of the given non-homogeneous equation as

$$
y_{p}=u_{1} y_{1}+u_{2} y_{2}
$$

Step 8 The general solution of the differential equation is then given by

$$
y=y_{c}+y_{p}=c_{1} y_{1}+c_{2} y_{2}+u_{1} y_{1}+u_{2} y_{2}
$$

## Constants of Integration

We don't need to introduce the constants of integration, when computing the indefinite integrals in step 6 to find the unknown functions of $u_{1}$ and $u_{2}$. For, if we do introduce these constants, then

$$
y_{p}=\left(u_{1}+a_{1}\right) y_{1}+\left(u_{2}+b_{1}\right) y_{2}
$$

So that the general solution of the given non-homogeneous differential equation is
or

$$
y=y_{c}+y_{p}=c_{1} y_{1}+c_{2} y_{2}+\left(u_{1}+a_{1}\right) y_{1}+\left(u_{2}+b_{1}\right) y_{2}
$$

If we replace $c_{1}+a_{1}$ with $C_{1}$ and $c_{2}+b_{1}$ with $C_{2}$, we obtain

$$
y=C_{1} y_{1}+C_{2} y_{2}+u_{1} y_{1}+u_{2} y_{2}
$$

This does not provide anything new and is similar to the general solution found in step 8, namely

$$
y=c_{1} y_{1}+c_{2} y_{2}+u_{1} y_{1}+u_{2} y_{2}
$$

## Example 1

Solve

$$
y^{\prime \prime}-4 y^{\prime}+4 y=(x+1) e^{2 x}
$$

## Solution:

Step 1 To find the complementary function

Put

$$
y^{\prime \prime}-4 y^{\prime}+4 y=0
$$

Then the auxiliary equation is

$$
\begin{aligned}
& m^{2}-4 m+4=0 \\
& (m-2)^{2}=0 \Rightarrow m=2,2
\end{aligned}
$$

Repeated real roots of the auxiliary equation

$$
y_{c}=c_{1} e^{2 x}+c_{2} x e^{2 x}
$$

Step 2 By the inspection of the complementary function $y_{C}$, we make the identification

Therefore

$$
y_{1}=e^{2 x} \text { and } y_{2}=x e^{2 x}
$$

$$
W\left(y_{1}, y_{2}\right)=W\left(e^{2 x}, x e^{2 x}\right)=\left|\begin{array}{cc}
e^{2 x} & x e^{2 x} \\
2 e^{2 x} & 2 x e^{2 x}+e^{2 x}
\end{array}\right|=e^{4 x} \neq 0, \forall x
$$

Step 3 The given differential equation is

$$
y^{\prime \prime}-4 y^{\prime}+4 y=(x+1) e^{2 x}
$$

Since this equation is already in the standard form

$$
y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=f(x)
$$

Therefore, we identify the function $f(x)$ as

$$
f(x)=(x+1) e^{2 x}
$$

Step 4 We now construct the determinants

$$
\begin{aligned}
& W_{1}=\left|\begin{array}{cc}
0 & x e^{2 x} \\
(x+1) e^{2 x} & 2 x e^{2 x}+e^{2 x}
\end{array}\right|=-(x+1) x e^{4 x} \\
& W_{2}=\left|\begin{array}{cc}
e^{2 x} & 0 \\
2 e^{2 x} & (x+1) e^{2 x}
\end{array}\right|=(x+1) e^{4 x}
\end{aligned}
$$

Step 5 We determine the derivatives of the functions $u_{1}$ and $u_{2}$ in this step

$$
\begin{aligned}
& u_{1}^{\prime}=\frac{W_{1}}{W}=-\frac{(x+1) x e^{4 x}}{e^{4 x}}=-x^{2}-x \\
& u_{2}^{\prime}=\frac{W_{2}}{W}=\frac{(x+1) e^{4 x}}{e^{4 x}}=x+1
\end{aligned}
$$

Step 6 Integrating the last two expressions, we obtain

$$
\begin{aligned}
& u_{1}=\int\left(-x^{2}-x\right) d x=-\frac{x^{3}}{3}-\frac{x^{2}}{2} \\
& u_{2}=\int(x+1) d x=\frac{x^{2}}{2}+x
\end{aligned}
$$

Remember! We don't have to add the constants of integration.
Step 7 Therefore, a particular solution of then given differential equation is

$$
y_{p}=\left(-\frac{x^{3}}{3}-\frac{x^{2}}{2}\right) e^{2 x}+\left(\frac{x^{2}}{2}+x\right) x e^{2 x}
$$

or

$$
y_{p}=\left(\frac{x^{3}}{6}+\frac{x^{2}}{2}\right) e^{2 x}
$$

Step 8 Hence, the general solution of the given differential equation is

$$
y=y_{c}+y_{p}=c_{1} e^{2 x}+c_{2} x e^{2 x}+\left(\frac{x^{3}}{6}+\frac{x^{2}}{2}\right) e^{2 x}
$$

## Example 2

Solve

$$
4 y^{\prime \prime}+36 y=\csc 3 x
$$

## Solution:

Step 1 To find the complementary function we solve the associated homogeneous differential equation

$$
4 y^{\prime \prime}+36 y=0 \Rightarrow y^{\prime \prime}+9 y=0
$$

The auxiliary equation is

$$
m^{2}+9=0 \Rightarrow m= \pm 3 i
$$

Roots of the auxiliary equation are complex. Therefore, the complementary function is

$$
y_{C}=c_{1} \cos 3 x+c_{2} \sin 3 x
$$

Step 2 From the complementary function, we identify

$$
y_{1}=\cos 3 x, y_{2}=\sin 3 x
$$

as two linearly independent solutions of the associated homogeneous equation. Therefore

$$
W(\cos 3 x, \sin 3 x)=\left|\begin{array}{cc}
\cos 3 x & \sin 3 x \\
-3 \sin 3 x & 3 \cos 3 x
\end{array}\right|=3
$$

Step 3 By dividing with 4, we put the given equation in the following standard form

$$
y^{\prime \prime}+9 y=\frac{1}{4} \csc 3 x
$$

So that we identify the function $f(x)$ as

$$
f(x)=\frac{1}{4} \csc 3 x
$$

Step 4 We now construct the determinants $W_{1}$ and $W_{2}$

$$
\begin{aligned}
& W_{1}=\left|\begin{array}{cc}
0 & \sin 3 x \\
\frac{1}{4} \csc 3 x & 3 \cos 3 x
\end{array}\right|=-\frac{1}{4} \csc 3 x \cdot \sin 3 x=-\frac{1}{4} \\
& W_{2}=\left|\begin{array}{cc}
\cos 3 x & 0 \\
-3 \sin 3 x & \frac{1}{4} \csc 3 x
\end{array}\right|=\frac{1}{4} \frac{\cos 3 x}{\sin 3 x}
\end{aligned}
$$

Step 5 Therefore, the derivatives $u_{1}^{\prime}$ and $u_{2}^{\prime}$ are given by

$$
u_{1}^{\prime}=\frac{W_{1}}{W}=-\frac{1}{12}, \quad u_{2}^{\prime}=\frac{W_{2}}{W}=\frac{1}{12} \frac{\cos 3 x}{\sin 3 x}
$$

Step 6 Integrating the last two equations w.r.to $x$, we obtain

$$
u_{1}=-\frac{1}{12} x \quad \text { and } \quad u_{2}=\frac{1}{36} \ln |\sin 3 x|
$$

Note that no constants of integration have been added.
Step 7 The particular solution of the non-homogeneous equation is

$$
y_{p}=-\frac{1}{12} x \cos 3 x+\frac{1}{36}(\sin 3 x) \ln |\sin 3 x|
$$

Step 8 Hence, the general solution of the given differential equation is

$$
y=y_{C}+y_{p}=c_{1} \cos 3 x+c_{2} \sin 3 x-\frac{1}{12} x \cos 3 x+\frac{1}{36}(\sin 3 x) \ln |\sin 3 x|
$$

## Example 3

Solve

$$
y^{\prime \prime}-y=\frac{1}{x}
$$

## Solution:

Step 1 For the complementary function consider the associated homogeneous equation

$$
y^{\prime \prime}-y=0
$$

To solve this equation we put

$$
y=e^{m x}, y^{\prime}=m e^{m x}, y^{\prime \prime}=m^{2} e^{m x}
$$

Then the auxiliary equation is:

$$
m^{2}-1=0 \Rightarrow m= \pm 1
$$

The roots of the auxiliary equation are real and distinct. Therefore, the complementary function is

$$
y_{c}=c_{1} e^{x}+c_{2} e^{-x}
$$

Step 2 From the complementary function we find

$$
y_{1}=e^{x}, \quad y_{2}=e^{-x}
$$

The functions $y_{1}$ and $y_{2}$ are two linearly independent solutions of the homogeneous equation. The Wronskian of these solutions is

$$
W\left(e^{x}, e^{-x}\right)=\left|\begin{array}{cc}
e^{x} & e^{-x} \\
e^{x} & -e^{-x}
\end{array}\right|=-2
$$

Step 3 The given equation is already in the standard form

$$
y^{\prime \prime}+p(x) y^{\prime}+Q(x) y=f(x)
$$

Here

$$
f(x)=\frac{1}{x}
$$

Step 4 We now form the determinants

$$
\begin{aligned}
& \mathrm{W}_{1}=\left|\begin{array}{cc}
0 & e^{-x} \\
1 / x & -e^{-x}
\end{array}\right|=-e^{-x}(1 / x) \\
& \mathrm{W}_{2}=\left|\begin{array}{cc}
e^{x} & 0 \\
e^{x} & 1 / x
\end{array}\right|=e^{x}(1 / x)
\end{aligned}
$$

Step 5 Therefore, the derivatives of the unknown functions $u_{1}$ and $u_{2}$ are given by

$$
\begin{aligned}
& u_{1}^{\prime}=\frac{W_{1}}{W}=-\frac{e^{-x}(1 / x)}{-2}=\frac{e^{-x}}{2 x} \\
& u_{2}^{\prime}=\frac{W_{2}}{W}=\frac{e^{x}(1 / x)}{-2}=-\frac{e^{x}}{2 x}
\end{aligned}
$$

Step 6 We integrate these two equations to find the unknown functions $u_{1}$ and $u_{2}$.

$$
u_{1}=\frac{1}{2} \int \frac{e^{-x}}{x} d x, \quad u_{2}=-\frac{1}{2} \int \frac{e^{x}}{x} d x
$$

The integrals defining $u_{1}$ and $u_{2}$ cannot be expressed in terms of the elementary functions and it is customary to write such integral as:

$$
u_{1}=\frac{1}{2} \int_{x_{0}}^{x} \frac{e^{-t}}{t} d t, \quad u_{2}=-\frac{1}{2} \int_{x_{0}}^{x} \frac{e^{t}}{t} d t
$$

Step 7 A particular solution of the non-homogeneous equations is

$$
y_{p}=\frac{1}{2} e^{x} \int_{x_{0}}^{x} \frac{e^{-t}}{t} d t-\frac{1}{2} e^{-x} \int_{x_{0}}^{x} \frac{e^{t}}{t} d t
$$

Step 8 Hence, the general solution of the given differential equation is

$$
y=y_{C}+y_{p}=c_{1} e^{x}+c_{2} e^{-x}+\frac{1}{2} e^{x} \int_{x_{\circ}}^{x} \frac{e^{-t}}{t} d t-\frac{1}{2} e^{-x} \int_{x_{\circ}}^{x} \frac{e^{t}}{t} d t
$$

## Lecture 21

## Variation of Parameters Method for Higher-Order Equations

The method of the variation of parameters just examined for second-order differential equations can be generalized for an nth-order equation of the type.

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=g(x)
$$

The application of the method to $n^{\text {th }}$ order differential equations consists of performing the following steps.
Step 1 To find the complementary function we solve the associated homogeneous equation

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=0
$$

Step 2 Suppose that the complementary function for the equation is

$$
y=c_{1} y_{1}+c_{2} y_{2}+\cdots+c_{n} y_{n}
$$

Then $y_{1}, y_{2}, \ldots, y_{n}$ are $n$ linearly independent solutions of the homogeneous equation. Therefore, we compute Wronskian of these solutions.

$$
W\left(y_{1}, y_{2}, y_{3}, \ldots, y_{n}\right)=\left|\begin{array}{cccc}
y_{1} & y_{2} & \ldots & y_{n} \\
y_{1}^{\prime} & y_{2}^{\prime} & \ldots & y_{n}^{\prime} \\
\ldots & \ldots & \ldots & \ldots \\
\ldots & \ldots & \ldots & \ldots \\
y_{1}^{(n-1)} & y_{2}^{(n-1)} & \ldots & y_{n}^{(n-1)}
\end{array}\right|
$$

Step 4 We write the differential equation in the form

$$
y^{(n)}+P_{n-1}(x) y^{(n-1)}+\cdots+P_{1}(x) y^{\prime}+P_{\circ}(x) y=f(x)
$$

and compute the determinants $W_{k} ; k=1,2, \ldots, n$; by replacing the $k$ th column of $W$ by
the column

Step 5 Next we find the derivatives $u_{1}^{\prime}, u_{2}^{\prime}, \ldots, u_{n}^{\prime}$ of the unknown functions $u_{1}, u_{2}, \ldots, u_{n}$ through the relations

$$
u_{k}^{\prime}=\frac{W_{k}}{W}, \quad k=1,2, \ldots, n
$$

Note that these derivatives can be found by solving the nequations


Step 6 Integrate the derivative functions computed in the step 5 to find the functions $u_{k}$

$$
u_{k}=\int \frac{W_{k}}{W} d x, \quad k=1,2, \ldots, n
$$

Step 7 We write a particular solution of the given non-homogeneous equation as

$$
y_{p}=u_{1}(x) y_{1}(x)+u_{2}(x) y_{2}(x)+\cdots+u_{n}(x) y_{n}(x)
$$

Step 8 Having found the complementary function $y_{c}$ and the particular integral $y_{p}$, we write the general solution by substitution in the expression

$$
y=y_{c}+y_{p}
$$

## Note that

- The first $n-1$ equations in step 5 are assumptions made to simplify the first $n-1$ derivatives of $y_{p}$. The last equation in the system results from substituting the particular integral $y_{p}$ and its derivatives into the given nth order linear differential equation and then simplifying.
- Depending upon how the integrals of the derivatives $u_{k}^{\prime}$ of the unknown functions are found, the answer for $y_{p}$ may be different for different attempts to find $y_{p}$ for the same equation.
- When asked to solve an initial value problem, we need to be sure to apply the initial conditions to the general solution and not to the complementary function alone, thinking that it is only $y_{C}$ that involves the arbitrary constants.


## Example 1

Solve the differential equation by variation of parameters.

$$
\frac{d^{3} y}{d x^{3}}+\frac{d y}{d x}=\csc x
$$

## Solution

Step 1: The associated homogeneous equation is

$$
\frac{d^{3} y}{d x^{3}}+\frac{d y}{d x}=0
$$

Auxiliary equation

$$
\begin{aligned}
& m^{3}+m=0 \Rightarrow m\left(m^{2}+1\right)=0 \\
& m=0, \quad m= \pm i
\end{aligned}
$$

Therefore the complementary function is

$$
y_{C}=c_{1}+c_{2} \cos x+c_{3} \sin x
$$

Step 2: Since

$$
y_{C}=c_{1}+c_{2} \cos x+c_{3} \sin x
$$

Therefore

$$
y_{1}=1, \quad y_{2}=\cos x, \quad y_{3}=\sin x
$$

So that the Wronskian of the solutions $y_{1}, y_{2}$ and $y_{3}$

$$
W\left(y_{1}, y_{2}, y_{3}\right)=\left|\begin{array}{ccc}
1 & \cos x & \sin x \\
0 & -\sin x & \cos x \\
0 & -\cos x & -\sin x
\end{array}\right|
$$

By the elementary row operation $R_{1}+R_{3}$, we have

$$
\begin{aligned}
& =\left|\begin{array}{ccc}
1 & 0 & 0 \\
0 & -\sin x & \cos x \\
0 & -\cos x & -\sin x
\end{array}\right| \\
& =\left(\sin ^{2} x+\cos ^{2} x\right)=1 \neq 0
\end{aligned}
$$

Step 3: The given differential equation is already in the required standard form

$$
y^{\prime \prime \prime}+0 y^{\prime \prime}+y^{\prime}+0 y=\csc x
$$

Step 4: Next we find the determinants $W_{1}, W_{2}$ and $W_{3}$ by respectively, replacing $1^{\text {st }}, 2^{\text {nd }}$ 0
and $3^{\text {rd }}$ column of $W$ by the column 0

$$
\csc x
$$

$$
\begin{aligned}
W_{1} & =\left|\begin{array}{ccc}
0 & \cos x & \sin x \\
0 & -\sin x & \cos x \\
\csc x & -\cos x & -\sin x
\end{array}\right| \\
& =\csc x\left(\sin ^{2} x+\cos ^{2} x\right)=\csc x
\end{aligned}
$$

$$
W_{2}=\left|\begin{array}{ccc}
1 & 0 & \sin x \\
0 & 0 & \cos x \\
0 & \csc x & -\sin x
\end{array}\right|
$$

$$
=\left|\begin{array}{cc}
0 & \cos x \\
\csc x & -\sin x
\end{array}\right|=-\cos x \csc x=-\cot x
$$

and

$$
W_{3}=\left|\begin{array}{ccc}
1 & \cos x & 0 \\
0 & -\sin x & 0 \\
0 & -\cos x & \csc x
\end{array}\right|=\left|\begin{array}{cc}
-\sin x & 0 \\
-\cos x & \csc x
\end{array}\right|=-\sin x \csc x=-1
$$

Step 5: We compute the derivatives of the functions $u_{1}, u_{2}$ and $u_{3}$ as:

$$
\begin{aligned}
& u_{1}^{\prime}=\frac{W_{1}}{W}=\csc x \\
& u_{2}^{\prime}=\frac{W_{2}}{W}=-\cot x \\
& u_{3}^{\prime}=\frac{W_{3}}{W}=-1
\end{aligned}
$$

Step 6: Integrate these derivatives to find $u_{1}, u_{2}$ and $u_{3}$

$$
u_{1}=\int \frac{W_{1}}{W} d x=\int \csc x d x=\ln |\csc x-\cot x|
$$

$$
\begin{aligned}
& u_{2}=\int \frac{W_{2}}{W} d x=\int-\cot x d x=\int \frac{-\cos x}{\sin x} d x=-\ln |\sin x| \\
& u_{3}=\int \frac{W_{3}}{W} d x=\int-1 d x=-x
\end{aligned}
$$

Step 7: A particular solution of the non-homogeneous equation is

$$
y_{p}=\ln |\csc x-\cot x|-\cos x \ln |\sin x|-x \sin x
$$

Step 8: The general solution of the given differential equation is:

$$
y=c_{1}+c_{2} \cos x+c_{3} \sin x+\ln |\csc x-\cot x|-\cos x \ln |\sin x|-x \sin x
$$

## Example 2

Solve the differential equation by variation of parameters.

$$
y^{\prime \prime \prime}+y^{\prime}=\tan x
$$

## Solution

Step 1: We find the complementary function by solving the associated homogeneous equation

$$
y^{\prime \prime \prime}+y^{\prime}=0
$$

Corresponding auxiliary equation is

$$
\begin{aligned}
& m^{3}+m=0 \Rightarrow m\left(m^{2}+1\right)=0 \\
& m=0, \quad m= \pm i
\end{aligned}
$$

Therefore the complementary function is

$$
y_{C}=c_{1}+c_{2} \cos x+c_{3} \sin x
$$

Step 2: Since

$$
y_{C}=c_{1}+c_{2} \cos x+c_{3} \sin x
$$

Therefore

$$
y_{1}=1, \quad y_{2}=\cos x, \quad y_{3}=\sin x
$$

Now we compute the Wronskian of $y_{1}, y_{2}$ and $y_{3}$

$$
W\left(y_{1}, y_{2}, y_{3}\right)=\left|\begin{array}{ccc}
1 & \cos x & \sin x \\
0 & -\sin x & \cos x \\
0 & -\cos x & -\sin x
\end{array}\right|
$$

By the elementary row operation $R_{1}+R_{3}$, we have

$$
\begin{aligned}
& =\left|\begin{array}{ccc}
1 & 0 & 0 \\
0 & -\sin x & \cos x \\
0 & -\cos x & -\sin x
\end{array}\right| \\
& =\left(\sin ^{2} x+\cos ^{2} x\right)=1 \neq 0
\end{aligned}
$$

Step 3: The given differential equation is already in the required standard form

$$
y^{\prime \prime \prime}+0 \cdot y^{\prime \prime}+y^{\prime}+0 \cdot y=\tan x
$$

Step 4: The determinants $W_{1}, W_{2}$ and $W_{3}$ are found by replacing the $1^{\text {st }}, 2^{\text {nd }}$ and $3^{\text {rd }}$ column of $W$ by the column

$$
\begin{gathered}
0 \\
0 \\
\tan x
\end{gathered}
$$

Therefore

$$
\begin{aligned}
& \qquad \begin{aligned}
W_{1} & =\left|\begin{array}{ccc}
0 & \cos x & \sin x \\
0 & -\sin x & \cos x \\
\tan x & -\cos x & -\sin x
\end{array}\right| \\
& =\tan x\left(\cos ^{2} x+\sin ^{2} x\right)=\tan x \\
\text { and } \quad W_{2} & =\left|\begin{array}{ccc}
1 & 0 & \sin x \\
0 & 0 & \cos x \\
0 & \tan x & -\sin x
\end{array}\right|=1(0-\cos x \tan x)=-\sin x \\
W_{3} & =\left|\begin{array}{ccc}
1 & \cos x & 0 \\
0 & -\sin x & 0 \\
0 & -\cos x & \tan x
\end{array}\right|=1(-\sin x \tan x)-0=-\sin x \tan x
\end{aligned}
\end{aligned}
$$

Step 5: We compute the derivatives of the functions $u_{1}, u_{2}$ and $u_{3}$.

$$
\begin{aligned}
& u_{1}^{\prime}=\frac{W_{1}}{W}=\tan x \\
& u_{2}^{\prime}=\frac{W_{2}}{W}=-\sin x \\
& u_{3}^{\prime}=\frac{W_{3}}{W}=-\sin x \tan x
\end{aligned}
$$

Step 6: We integrate these derivatives to find $u_{1}, u_{2}$ and $u_{3}$

$$
\begin{aligned}
u_{1} & =\int \frac{W_{1}}{W} d x=\int \tan x d x=-\int-\frac{\sin x}{\cos x} d x=-\ln |\cos x| \\
u_{2} & =\int \frac{W_{2}}{W} d x=\int-\sin x d x=\cos x \\
u_{3} & =\int \frac{W_{3}}{W} d x=\int-\sin x \tan x d x \\
& =\int-\sin x \frac{\sin x}{\cos x} d x=\int-\sin ^{2} x \sec d x \\
& =\int\left(\cos ^{2} x-1\right) \sec x d x=\int\left(\cos ^{2} x \sec x-\sec x\right) d x \\
& =\int(\cos x-\sec x) d x=\int \cos x d x-\int \sec x d x \\
& =\sin x-\ln |\sec x+\tan x|
\end{aligned}
$$

Step 7: Thus, a particular solution of the non-homogeneous equation

$$
\begin{aligned}
y_{p} & =-\ln |\cos x|+\cos x \cos x+(\sin x-\ln |\sec x+\tan x|)(\sin x) \\
& =-\ln |\cos x|+\cos ^{2} x+\sin ^{2} x-\sin x \ln |\sec x+\tan x| \\
& =-\ln |\cos x|+1-\sin x \ln |\sec x+\tan x|
\end{aligned}
$$

Step 8: Hence, the general solution of the given differential equation is:
or

$$
y=c_{1}+c_{2} \cos x+c_{3} \sin x-\ln |\cos x|+1-\sin x \ln |\sec x+\tan x|
$$

$$
y=\left(c_{1}+1\right)+c_{2} \cos x+c_{3} \sin x-\ln |\cos x|-\sin x \ln |\sec x+\tan x|
$$

or $\quad y=d_{1}+c_{2} \cos x+c_{3} \sin x-\ln |\cos x|-\sin x \ln |\sec x+\tan x|$
where $d_{1}$ represents $c_{1}+1$.

## Example 3

Solve the differential equation by variation of parameters.

$$
y^{\prime \prime \prime}-2 y^{\prime \prime}-y^{\prime}+2 y=e^{3 x}
$$

## Solution

Step 1: The associated homogeneous equation is

$$
y^{\prime \prime \prime}-2 y^{\prime \prime}-y^{\prime}+2 y=0
$$

The auxiliary equation of the homogeneous differential equation is

$$
\begin{aligned}
& m^{3}-2 m^{2}-m+2=0 \\
& \Rightarrow(m-2)\left(m^{2}-1\right)=0 \\
& \Rightarrow m=1,2,-1
\end{aligned}
$$

The roots of the auxiliary equation are real and distinct. Therefore $y_{c}$ is given by

$$
y_{c}=c_{1} e^{x}+c_{2} e^{2 x}+c_{3} e^{-x}
$$

Step 2: From $y_{C}$ we find that three linearly independent solutions of the homogeneous differential equation.

$$
y_{1}=e^{x}, y_{2}=e^{2 x}, y_{3}=e^{-x}
$$

Thus the Wronskian of the solutions $y_{1}, y_{2}$ and $y_{3}$ is given by

$$
W=\left|\begin{array}{ccc}
e^{x} & e^{2 x} & e^{-x} \\
e^{x} & 2 e^{2 x} & -e^{-x} \\
e^{x} & 4 e^{2 x} & e^{-x}
\end{array}\right|=e^{x} \cdot e^{2 x} \cdot e^{-x}\left|\begin{array}{ccc}
1 & 1 & 1 \\
1 & 2 & -1 \\
1 & 4 & 1
\end{array}\right|
$$

By applying the row operations $R_{2}-R_{1}, R_{3}-R_{1}$, we obtain

$$
W=e^{2 x}\left|\begin{array}{ccc}
1 & 1 & 1 \\
0 & 1 & -2 \\
0 & 3 & 0
\end{array}\right|=6 e^{2 x} \neq 0
$$

Step 3: The given differential equation is already in the required standard form

$$
y^{\prime \prime \prime}-2 y^{\prime \prime}-y^{\prime}+2 y=e^{3 x}
$$

Step 4: Next we find the determinants $W_{1}, W_{2}$ and $W_{3}$ by, respectively, replacing the $1^{\text {st }}$, $2^{\text {nd }}$ and $3^{\text {rd }}$ column of $W$ by the column

$$
\begin{gathered}
0 \\
0 \\
e^{3 x}
\end{gathered}
$$

Thus

$$
\begin{aligned}
& W_{1}=\left|\begin{array}{ccc}
0 & e^{2 x} & e^{-x} \\
0 & 2 e^{2 x} & -e^{-x} \\
e^{3 x} & 4 e^{2 x} & e^{-x}
\end{array}\right|=(-1)^{3+1}\left|\begin{array}{cc}
e^{2 x} & e^{-x} \\
2 e^{2 x} & -e^{-x}
\end{array}\right| e^{3 x} \\
&=e^{3 x}\left(-e^{x}-2 e^{x}\right)=-3 e^{4 x} \\
& \begin{aligned}
W_{2} & =\left|\begin{array}{ccc}
e^{x} & 0 & e^{-x} \\
e^{x} & 0 & -e^{-x} \\
e^{x} & e^{3 x} & e^{-x}
\end{array}\right|=(-1)^{3+2}\left|\begin{array}{cc}
e^{x} & e^{-x} \\
e^{x} & -e^{-x}
\end{array}\right| e^{3 x} \\
& =-\left(-e^{0}-e^{0}\right) e^{3 x}=2 e^{3 x}
\end{aligned}
\end{aligned}
$$

and

$$
\begin{aligned}
W_{3} & =\left|\begin{array}{ccc}
e^{x} & e^{2 x} & 0 \\
e^{x} & 2 e^{2 x} & 0 \\
e^{x} & 4 e^{2 x} & e^{3 x}
\end{array}\right|=e^{3 x}\left|\begin{array}{cc}
e^{x} & e^{2 x} \\
e^{x} & 2 e^{2 x}
\end{array}\right| \\
& =e^{3 x}\left(2 e^{3 x}-e^{3 x}\right)=e^{6 x}
\end{aligned}
$$

Step 5: Therefore, the derivatives of the unknown functions $u_{1}, u_{2}$ and $u_{3}$ are given by.

$$
\begin{aligned}
& u_{1}^{\prime}=\frac{W_{1}}{W}=\frac{-3 e^{4 x}}{6 e^{2 x}}=-\frac{1}{2} e^{2 x} \\
& u_{2}^{\prime}=\frac{W_{2}}{W}=\frac{2 e^{3 x}}{6 e^{2 x}}=\frac{1}{3} e^{x} \\
& u_{3}^{\prime}=\frac{W_{3}}{W}=\frac{e^{6 x}}{6 e^{2 x}}=\frac{1}{6} e^{4 x}
\end{aligned}
$$

Step 6: Integrate these derivatives to find $u_{1}, u_{2}$ and $u_{3}$

$$
\begin{aligned}
& u_{1}=\int \frac{W_{1}}{W} d x=\int-\frac{1}{2} e^{2 x} d x=-\frac{1}{2} \int e^{2 x} d x=-\frac{1}{4} e^{2 x} \\
& u_{2}=\int \frac{W_{2}}{W} d x=\int \frac{1}{3} e^{x} d x=\frac{1}{3} e^{x} \\
& u_{3}=\int \frac{W_{3}}{W} d x=\int \frac{1}{6} e^{4 x} d x=\frac{1}{24} e^{4 x}
\end{aligned}
$$

Step 7: A particular solution of the non-homogeneous equation is

$$
y_{p}=-\frac{1}{4} e^{3 x}+\frac{1}{3} e^{3 x}+\frac{1}{24} e^{3 x}
$$

Step 8: The general solution of the given differential equation is:

$$
y=c_{1} e^{x}+c_{2} e^{2 x}+c_{3} e^{-x}-\frac{1}{4} e^{3 x}+\frac{1}{3} e^{3 x}+\frac{1}{24} e^{3 x}
$$

## Applications of Second Order Differential Equation

- A single differential equation can serve as mathematical model for many different phenomena in science and engineering.
- Different forms of the $2^{\text {nd }}$ order linear differential equation

$$
a \frac{d^{2} y}{d x^{2}}+b \frac{d y}{d x}+c y=f(x)
$$

appear in the analysis of problems in physics, chemistry and biology.

- In the present and next lecture we shall focus on one application; the motion of a mass attached to a spring.
- We shall see, what the individual terms $a \frac{d^{2} y}{d x^{2}}, b \frac{d y}{d x}, c y$ and $f(x)$ means in the context of vibrational system.
- Except for the terminology and physical interpretation of the terms

$$
a \frac{d^{2} y}{d x^{2}}, \quad b \frac{d y}{d x}, c y, f(x)
$$

the mathematics of a series circuit is identical to that of a vibrating spring-mass system. Therefore we will discuss an $L R C$ circuit in lecture.

## Simple Harmonic Motion

When the Newton's $2^{\text {nd }}$ law is combined with the Hook's Law, we can derive a differential equation governing the motion of a mass attached to spring-the simple harmonic motion.

## Hook's Law

Suppose that

- A mass is attached to a flexible spring suspended from a rigid support, then
- The spring stretches by an amount ' $s$ '.
- The spring exerts a restoring $F$ opposite to the direction of elongation or stretch.

The Hook's law states that the force $F$ is proportional to the elongation $s$. i.e

$$
F=k s
$$

Where $k$ is constant of proportionality, and is called spring constant.

## Note That

- Different masses stretch a spring by different amount i.e $s$ is different for different $m$.
- The spring is characterized by the spring constant $k$.
- For example if $W=10 \mathrm{lbs}$ and $s=\frac{1}{2} \mathrm{f} t$

Then

$$
F=k s
$$

or

$$
10=\left(\frac{1}{2}\right) k
$$

or

$$
\text { If } W=8 \text { lbs then }
$$

$$
\begin{aligned}
& k=20 \mathrm{lbs} / \mathrm{ft} \\
& 8=20(s) \Rightarrow s=2 / 5 \mathrm{ft}
\end{aligned}
$$

## Newton's Second Law

When a force $F$ acts upon a body, the acceleration $a$ is produced in the direction of the force whose magnitude is proportional to the magnitude of force. i.e

$$
F=m a
$$

Where $m$ is constant of proportionality and it represents mass of the body.

## Weight

- The gravitational force exerted by the earth on a body of mass $m$ is called weight of the body, denoted by W
- In the absence of air resistance, the only force acting on a freely falling body is its weight. Thus from Newton's $2^{\text {nd }}$ law of motion

$$
\mathrm{W}=m g
$$

Where $m$ is measured in slugs, kilograms or grams and $g=32 \mathrm{ft} / \mathrm{s}^{2}, 9.8 \mathrm{~m} / \mathrm{s}^{2}$ or $980 \mathrm{~cm} / \mathrm{s}^{2}$.

## Differential Equation

- When a body of mass $m$ is attached to a spring
- The spring stretches by an amount $s$ and attains an equilibrium position.
- At the equilibrium position, the weight is balanced by the restoring force $k s$. Thus, the condition of equilibrium is

$$
m g=k s \Rightarrow m g-k s=0
$$

- If the mass is displaced by an amount $x$ from its equilibrium position and then released. The restoring force becomes $k(s+x)$. So that the resultant of weight and the restoring force acting on the body is given by

$$
\text { Resultant }=-k(s+x)+m g .
$$

By Newton's $2^{\text {nd }}$ Law of motion, we can written

$$
\begin{array}{ll} 
& m \frac{d^{2} x}{d t^{2}}=-k(s+x)+m g \\
\text { or } & m \frac{d^{2} x}{d t^{2}}=-k x-k s+m g \\
\text { Since } & m g-k s=0
\end{array}
$$

Therefore

$$
m \frac{d^{2} x}{d t^{2}}=-k x
$$

- The negative indicates that the restoring force of the spring acts opposite to the direction of motion.
- The displacements measured below the equilibrium position are positive.
- By dividing with $m$, the last equation can be written as:

$$
\frac{d^{2} x}{d t^{2}}+\frac{k}{m} x=0
$$

$$
\text { or } \quad \frac{d^{2} x}{d t^{2}}+\omega^{2} x=0
$$

Where $\omega^{2}=\frac{k}{m}$. This equation is known as the equation of simple harmonic motion or as the free un-damped motion.

## Initial Conditions

Associated with the differential equation

$$
\frac{d^{2} x}{d t^{2}}+\omega^{2} x=0
$$

are the obvious initial conditions

$$
x(0)=\alpha, \quad x^{\prime}(0)=\beta
$$

These initial conditions represent the initial displacement and the initial velocity. For example

- If $\alpha>0, \beta<0$ then the body starts from a point below the equilibrium position with an imparted upward velocity.
- If $\alpha<0, \beta=0$ then the body starts from rest $|\alpha|$ units above the equilibrium position.


## Solution and Equation of Motion

Consider the equation of simple harmonic motion

$$
\begin{aligned}
& \frac{d^{2} x}{d t^{2}}+\omega^{2} x=0 \\
& \text { Put } x=e^{m x}, \frac{d^{2} x}{d t^{2}}=m^{2} e^{m x}
\end{aligned}
$$

Then the auxiliary equation is

$$
m^{2}+\omega^{2}=0 \Rightarrow m= \pm i \omega
$$

Thus the auxiliary equation has complex roots.

$$
m_{1}=\omega i, \quad m_{2}=-\omega i
$$

Hence, the general solution of the equation of simple harmonic motion is

$$
x(t)=c_{1} \cos \omega t+c_{2} \sin \omega t
$$

## Alternative form of Solution

It is often convenient to write the above solution in a alternative simpler form. Consider

$$
x(t)=c_{1} \cos \omega t+c_{2} \sin \omega t
$$

and suppose that $A, \phi \in R$ such that

Then

$$
c_{1}=A \sin \phi, c_{2}=A \cos \phi
$$

$$
A=\sqrt{c_{1}^{2}+c_{2}^{2}}, \tan \phi=\frac{c_{1}}{c_{2}}
$$

So that
or

$$
\begin{aligned}
& x(t)=A \sin \omega t \cos \phi+B \cos \omega t \sin \phi \\
& x(t)=A \sin (\omega t+\phi)
\end{aligned}
$$

The number $\phi$ is called the phase angle;

## Note that

This form of the solution of the equation of simple harmonic motion is very useful because

- Amplitude of free vibrations becomes very obvious
- The times when the body crosses equilibrium position are given by $x=0 \Rightarrow \sin (\omega t+\phi)=0$
or $\quad \omega t+\phi=n \pi$
Where $n$ is a non-negative integer.


## The Nature of Simple Harmonic Motion

## Amplitude

- We know that the solution of the equation of simple harmonic motion can be written as

$$
x(t)=A \sin (\omega t+\phi)
$$

- Clearly, the maximum distance that the suspended body can travel on either side of the equilibrium position is $A$.
- This maximum distance called the amplitude of motion and is given by

$$
\text { Amplitude }=A=\sqrt{c_{1}^{2}+c_{2}^{2}}
$$

## A Vibration or a Cycle

In travelling from $x=A$ to $x=-A$ and then back to $A$, the vibrating body completes one vibration or one cycle.

## Period of Vibration

The simple harmonic motion of the suspended body is periodic and it repeats its position after a specific time period $T$. We know that the distance of the mass at any time $t$ is given by

Since

$$
\begin{aligned}
& x=A \sin (\omega t+\phi) \\
& A \sin \left[\omega\left(t+\frac{2 \pi}{\omega}\right)+\phi\right] \\
& =A \sin [(\omega t+\phi+2 \pi)] \\
& =A \sin [(\omega t+\phi)]
\end{aligned}
$$

Therefore, the distances of the suspended body from the equilibrium position at the times $t$ and $t+\frac{2 \pi}{\omega}$ are same

Further, velocity of the body at any time $t$ is given by

$$
\begin{aligned}
& \frac{d x}{d t}=A \omega \cos (\omega t+\phi) \\
& A \omega \cos \left(\omega\left(t+\frac{2 \pi}{\omega}\right)+\phi\right) \\
& =A \omega \cos [\omega t+\phi+2 \pi] \\
& =A \omega \cos (\omega t+\phi)
\end{aligned}
$$

Therefore the velocity of the body remains unaltered if $t$ is increased by $2 \pi / \omega$. Hence the time period of free vibrations described by the $2^{\text {nd }}$ order differential equation

$$
\frac{d^{2} x}{d t^{2}}+\omega^{2} x=0
$$

is given by

$$
T=\frac{2 \pi}{\omega}
$$

## Frequency

The number of vibration /cycle completed in a unit of time is known as frequency of the free vibrations, denoted by $f$. Since the cycles completed in time $T$ is 1 . Therefore, the number of cycles completed in a unit of time is $1 / T$
Hence

$$
f=\frac{1}{T}=\frac{\omega}{2 \pi}
$$

## Example 1

Solve and interpret the initial value problem

$$
\begin{aligned}
& \frac{d^{2} x}{d t^{2}}+16 x=0 \\
& x(0)=10, x^{\prime}(0)=0
\end{aligned}
$$

## Interpretation

Comparing the initial conditions

$$
x(0)=10, x^{\prime}(0)=0 .
$$

With

$$
x(0)=\alpha, \quad x^{\prime}(0)=\beta
$$

We see that

$$
\alpha=10, \beta=0
$$

Thus the problem is equivalent to

- Pulling the mass on a spring 10 units below the equilibrium position.
- Holding it there until time $t=0$ and then releasing the mass from rest.


## Solution

Consider the differential equation

$$
\begin{gathered}
\frac{d^{2} x}{d t^{2}}+16 x=0 \\
x=e^{m t}, \frac{d^{2} x}{d t^{2}}=m^{2} e^{m t}
\end{gathered}
$$

Then, the auxiliary equation is

$$
\begin{aligned}
& m^{2}+16=0 \\
\Rightarrow & m=0 \pm 4 i
\end{aligned}
$$

Therefore, the general solution is:

$$
x(t)=c_{1} \cos 4 t+c_{2} \sin 4 t
$$

Now we apply the initial conditions.

$$
x(0)=10 \Rightarrow c_{1} \cdot 1+c_{2} \cdot 0=10
$$

Thus

$$
c_{1}=10
$$

So that

$$
\begin{aligned}
& x(t)=10 \cos 4 t+c_{2} \sin 4 t \\
& \frac{d x}{d t}=-40 \sin 4 t+4 c_{2} \cos 4 t
\end{aligned}
$$

Therefore
Thus

$$
\begin{gathered}
x^{\prime}(0)=0 \Rightarrow-40(0)+4 c_{2} \cdot 1=0 \\
c_{2}=0
\end{gathered}
$$

Hence, the solution of the initial value problem is

$$
x(t)=10 \cos 4 t
$$

## Note that

- Clearly, the solution shows that once the system is set into motion, it stays in motion with mass bouncing back and forth with amplitude being 10 units.
- Since $\omega=4$. Therefore, the period of oscillation is

$$
T=\frac{2 \pi}{4}=\frac{\pi}{2} \text { seconds }
$$

## Example 2

A mass weighing 2lbs stretches a spring 6 inches. At $t=0$ the mass is released from a point 8 inches below the equilibrium position with an upward velocity of $\frac{4}{3} \mathrm{ft} / \mathrm{s}$. Determine the function $x(t)$ that describes the subsequent free motion.

## Solution

For consistency of units with the engineering system, we make the following conversions

$$
\begin{aligned}
& 6 \text { inches }=\frac{1}{2} \text { foot } \\
& 8 \text { inches }=\frac{2}{3} \text { foot } .
\end{aligned}
$$

Further weight of the body is given to be

$$
\mathrm{W}=2 \mathrm{lbs}
$$

But

$$
\mathrm{W}=m g
$$

Therefore

$$
m=\frac{\mathrm{W}}{g}=\frac{2}{32}
$$

or

$$
m=\frac{1}{16} \text { slugs. }
$$

Since

$$
\text { Stretch }=s=\frac{1}{2} \text { foot }
$$

Therefore by Hook's Law, we can write

$$
2=k\left(\frac{1}{2}\right) \Rightarrow k=4 \mathrm{lbs} / \mathrm{ft}
$$

Hence the equation of simple harmonic motion

$$
m \frac{d^{2} x}{d t^{2}}=-k x
$$

becomes
or

$$
\begin{aligned}
& \frac{1}{16} \frac{d^{2} x}{d t^{2}}=-4 x \\
& \frac{d^{2} x}{d t^{2}}+64 x=0 .
\end{aligned}
$$

Since the initial displacement is 8 inches $=\frac{2}{3} \mathrm{f} t$ and the initial velocity is $\frac{-4}{3} \mathrm{ft} / \mathrm{s}$, the initial conditions are:

$$
x(0)=\frac{2}{3}, \quad x^{\prime}(0)=-\frac{4}{3}
$$

The negative sign indicates that the initial velocity is given in the upward i.e negative direction. Thus, we need to solve the initial value problem.

Solve

$$
\frac{d^{2} x}{d t^{2}}+64 x=0
$$

Subject to

$$
x(0)=\frac{2}{3}, \quad x^{\prime}(0)=-\frac{4}{3}
$$

Putting $\quad x=e^{m t}, \frac{d^{2} x}{d t^{2}}=m^{2} e^{m t}$
We obtain the auxiliary equation
or

$$
\begin{aligned}
& m^{2}+64=0 \\
& m= \pm 8 i
\end{aligned}
$$

The general solution of the equation is

$$
x(t)=c_{1} \cos 8 t+c_{2} \sin 8 t
$$

Now, we apply the initial conditions.

$$
x(0)=\frac{2}{3} \Rightarrow c_{1} \cdot 1+c_{2} \cdot 0=\frac{2}{3}
$$

Thus

$$
c_{1}=\frac{2}{3}
$$

So that

$$
x(t)=\frac{2}{3} \cos 8 t+c_{2} \sin 8 t
$$

Since

$$
x^{\prime}(t)=-\frac{16}{3} \sin 8 t+8 c_{2} \cos 8 t
$$

Therefore

$$
x^{\prime}(0)=-\frac{4}{3} \Rightarrow-\frac{16}{3} \cdot 0+8 c_{2} \cdot 1=-\frac{4}{3}
$$

Thus

$$
c_{2}=-\frac{1}{6} .
$$

Hence, solution of the initial value problem is

$$
x(t)=\frac{2}{3} \cos 8 t-\frac{1}{6} \sin 8 t .
$$

## Example 3

Write the solution of the initial value problem discussed in the previous example in the form

$$
x(t)=A \sin (\omega t+\phi)
$$

## Solution

The initial value discussed in the previous example is:
Solve

$$
\frac{d^{2} x}{d t^{2}}+64 x=0
$$

Subject to

$$
x(0)=\frac{2}{3}, \quad x^{\prime}(0)=-\frac{4}{3}
$$

Solution of the problem is

$$
x(t)=\frac{2}{3} \cos 8 t-\frac{1}{6} \sin 8 t
$$

Thus amplitude of motion is given by

$$
A=\sqrt{\left(\frac{2}{3}\right)^{2}+\left(-\frac{1}{6}\right)^{2}}=\frac{\sqrt{17}}{6} \approx 0.69 \mathrm{ft}
$$

and the phase angle is defined by

$$
\begin{aligned}
& \sin \phi=\frac{2 / 3}{\sqrt{17} / 6}=\frac{4}{\sqrt{17}}>0 \\
& \cos \phi=\frac{-1 / 6}{\sqrt{17} / 6}=-\frac{1}{\sqrt{17}}<0
\end{aligned}
$$

Therefore
or

$$
\begin{aligned}
& \tan \phi=-4 \\
& \tan ^{-1}(-4)=-1.326 \text { radians }
\end{aligned}
$$

Since $\sin \phi>0, \cos \phi<0$, the phase angle $\phi$ must be in $2^{\text {nd }}$ quadrant.
Thus

$$
\phi=\pi-1.326=1.816 \text { radians }
$$

Hence the required form of the solution is

$$
x(t)=\frac{\sqrt{17}}{6} \sin (8 t+1.816)
$$

## Example 4

For the motion described by the initial value problem
Solve

$$
\frac{d^{2} x}{d t^{2}}+64 x=0
$$

Subject to

$$
x(0)=\frac{2}{3}, \quad x^{\prime}(0)=-\frac{4}{3}
$$

Find the first value of time for which the mass passes through the equilibrium position heading downward.

## Solution

We know that the solution of initial value problem is

$$
x(t)=\frac{2}{3} \cos 8 t-\frac{1}{6} \sin 8 t .
$$

This solution can be written in the form

$$
x(t)=\frac{\sqrt{17}}{6} \sin (8 t+1.816)
$$

The values of $t$ for which the mass passes through the equilibrium position i.e for which $x=0$ are given by

$$
w t+\phi=n \pi
$$

Where $n=1,2, \ldots$, therefore, we have
or

$$
8 t_{1}+1.816=\pi, \quad 8 t_{2}+1.816=2 \pi, \quad 8 t_{3}+1.816=3 \pi, \ldots
$$

$$
t_{1}=0.166, \quad t_{2}=0.558, \quad t_{3}=0.951, \ldots
$$

Hence, the mass passes through the equilibrium position

$$
x=0
$$

heading downward first time at $t_{2}=0.558$ seconds.

## Lecture 23

## Damped Motion

In the previous lecture, we discussed the free harmonic motion that assumes no retarding forces acting on the moving mass. However

- No retarding forces acting on the moving body is not realistic, because
- There always exists at least a resisting force due to surrounding medium.

For example a mass can be suspended in a viscous medium. Hence, the damping forces need to be included in a realistic analysis.

## Damping Force

In the study of mechanics, the damping forces acting on a body are considered to be proportional to a power of the instantaneous velocity $\frac{d x}{d t}$. In the hydro dynamical problems, the damping force is proportional to $(d x / d t)^{2}$. So that in these problems

$$
\text { Damping force }=-\beta\left(\frac{d x}{d t}\right)^{2}
$$

Where $\beta$ is a positive damping constant and negative sign indicates that the damping force acts in a direction opposite to the direction of motion.

In the present discussion, we shall assume that the damping force is proportional to the instantaneous velocity $\frac{d x}{d t}$. Thus for us

$$
\text { Damping force }=-\beta\left(\frac{d x}{d t}\right)
$$

## The Differential Equation

Suppose That

- A body of mass $m$ is attached to a spring.
- The spring stretches by an amount $s$ to attain the equilibrium position.
- The mass is further displaced by an amount $x$ and then released.
- No external forces are impressed on the system.

Therefore, there are three forces acting on the mass, namely:
a) Weight $m g$ of the body
b) Restoring force $-k(s+x)$
c) Damping force $-\beta\left(\frac{d x}{d t}\right)$

Therefore, total force acting on the mass $m$ is

$$
m g-k(s+x)-\beta\left(\frac{d x}{d t}\right)
$$

So that by Newton's second law of motion, we have

$$
m \frac{d^{2} x}{d t^{2}}=m g-k(s+x)-\beta\left(\frac{d x}{d t}\right)
$$

Since in the equilibrium position

$$
m g-k s=0
$$

Therefore

$$
m \frac{d^{2} x}{d t^{2}}=-k x-\beta\left(\frac{d x}{d t}\right)
$$

Dividing with $m$, we obtain the differential equation of free damped motion

$$
\frac{d^{2} x}{d t^{2}}+\frac{\beta}{m}\left(\frac{d x}{d t}\right)+\frac{k}{m} x=0
$$

For algebraic convenience, we suppose that

$$
2 \lambda=\frac{\beta}{m}, \quad \omega^{2}=\frac{k}{m}
$$

Then the equation becomes:

$$
\frac{d^{2} x}{d t^{2}}+2 \lambda \frac{d x}{d t}+\omega^{2} x=0
$$

## Solution of the Differential Equation

Consider the equation of the free damped motion

$$
\frac{d^{2} x}{d t^{2}}+2 \lambda \frac{d x}{d t}+\omega^{2} x=0
$$

Put

$$
x=e^{m t}, \frac{d x}{d t}=m e^{m t}, \frac{d^{2} x}{d t^{2}}=m^{2} e^{m t}
$$

Then the auxiliary equation is:

$$
m^{2}+2 \lambda m+\omega^{2}=0
$$

Solving by use of quadratic formula, we obtain

$$
m=-\lambda \pm \sqrt{\lambda^{2}-\omega^{2}}
$$

Thus the roots of the auxiliary equation are

$$
m_{1}=-\lambda+\sqrt{\lambda^{2}-\omega^{2}}, \quad m_{2}=-\lambda-\sqrt{\lambda^{2}-\omega^{2}}
$$

Depending upon the sign of the quantity $\lambda^{2}-\omega^{2}$, we can now distinguish three possible cases of the roots of the auxiliary equation.

## Case 1 Real and distinct roots

If $\lambda^{2}-\omega^{2}>0$ then $\beta>k$ and the system is said to be over-damped. The solution of the equation of free damped motion is
or

$$
\begin{aligned}
& x(t)=c_{1} e^{m_{1} t}+c_{2} e^{m_{2} t} \\
& x(t)=e^{-\lambda t}\left[c_{1} e^{\sqrt{\lambda^{2}-\omega^{2}} t}+c_{2} e^{-\sqrt{\lambda^{2}-\omega^{2}} t}\right]
\end{aligned}
$$

This equation represents smooth and non oscillatory motion.

## Case 2 Real and equal roots

If $\lambda^{2}-\omega^{2}=0$, then $\beta=k$ and the system is said to be critically damped, because any slight decrease in the damping force would result in oscillatory motion. The general solution of the differential equation of free damped force is
or

$$
\begin{aligned}
& x(t)=c_{1} e^{m_{1} t}+c_{2} t e^{m_{1} t} \\
& x(t)=e^{-\lambda t}\left(c_{1}+c_{2} t\right)
\end{aligned}
$$

Case 3 Complex roots
If $\lambda^{2}-w^{2}<0$, then $\beta<k$ and the system is said to be under-damped. We need to rewrite the roots of the auxiliary equation as:

$$
m_{1}=-\lambda+\sqrt{\omega^{2}-\lambda^{2}} i, \quad m_{2}=-\lambda-\sqrt{\omega^{2}-\lambda^{2}} i
$$

Thus, the general solution of the equation of free damped motion is

$$
x(t)=e^{-\lambda t}\left[c_{1} \cos \sqrt{\omega^{2}-\lambda^{2}} t+c_{2} \sin \sqrt{\omega^{2}-\lambda^{2}} t\right]
$$

This represents an oscillatory motion; but amplitude of vibration $\rightarrow 0$ as $t \rightarrow \infty$ because of the coefficient $e^{-\lambda t}$.

## Note that

Each of the three solutions contain the damping factor $e^{-\lambda t}, \lambda>0$, the displacements of the mass become negligible for larger times.

## Alternative form of the Solution

When $\lambda^{2}-\omega^{2}<0$, the solution of the differential equation of free damped motion
is

$$
\begin{gathered}
\frac{d^{2} x}{d t^{2}}+2 \lambda \frac{d x}{d t}+\omega^{2} x=0 \\
x(t)=e^{-\lambda t}\left[c_{1} \cos \sqrt{\omega^{2}-\lambda^{2}} t+c_{2} \sin \sqrt{\omega^{2}-\lambda^{2}} t\right]
\end{gathered}
$$

Suppose that $A$ and $\phi$ are two real numbers such that

$$
\sin \phi=\frac{c_{1}}{A}, \quad \cos \phi=\frac{c_{2}}{A}
$$

So that

$$
A=\sqrt{c_{1}^{2}+c_{2}^{2}}, \quad \tan \phi=\frac{c_{1}}{c_{2}}
$$

The number $\phi$ is known as the phase angle. Then the solution of the equation becomes:
or

$$
\begin{aligned}
& x(t)=A e^{-\lambda t}\left[\sin \sqrt{\omega^{2}-\lambda^{2}} t \cos \phi+\cos \sqrt{\omega^{2}-\lambda^{2}} t \sin \phi\right] \\
& x(t)=A e^{-\lambda t} \sin \left(\sqrt{\omega^{2}-\lambda^{2}} t+\phi\right)
\end{aligned}
$$

## Note that

- The coefficient $A e^{-\lambda t}$ is called the damped amplitude of vibrations.
- The time interval between two successive maxima of $x(t)$ is called quasi period, and is given by the number

$$
\frac{2 \pi}{\sqrt{\omega^{2}-\lambda^{2}}}
$$

- The following number is known as the quasi frequency.

$$
\frac{\sqrt{\omega^{2}-\lambda^{2}}}{2 \pi}
$$

- The graph of the solution

$$
x(t)=A e^{-\lambda t} \sin \left(\sqrt{\omega^{2}-\lambda^{2}} t+\phi\right)
$$

crosses positive $t$-axis, i.e the line $x=0$, at times that are given by

$$
\sqrt{\omega^{2}-\lambda^{2}} t+\phi=n \pi
$$

Where $n=1,2,3, \ldots$.
For example, if we have

$$
x(t)=e^{-0.5 t} \sin \left(2 t-\frac{\pi}{3}\right)
$$

Then

$$
2 t-\frac{\pi}{3}=n \pi
$$

or

$$
\begin{aligned}
& 2 t_{1}-\frac{\pi}{3}=0,2 t_{2}-\frac{\pi}{3}=\pi, 2 t_{3}-\frac{\pi}{3}=2 \pi, \ldots \\
& t_{1}=\frac{\pi}{6}, t_{2}=\frac{4 \pi}{6}, t_{3}=\frac{7 \pi}{6}, \ldots
\end{aligned}
$$

or
We notice that difference between two successive roots is

$$
t_{k}-t_{k-1}=\frac{\pi}{2}=\frac{1}{2} \text { quasi period }
$$

Since quasi period $=\frac{2 \pi}{2}=\pi$. Therefore

$$
t_{k}-t_{k-1}=\frac{\pi}{2}=\frac{1}{2} \text { quasi period }
$$

- Since $|x(t)| \leq A e^{-\lambda t}$ when $\left|\sin \sqrt{\omega^{2}-\lambda^{2}} t+\phi\right| \leq 1$, the graph of the solution

$$
x(t)=A e^{-\lambda t} \sin \left(\sqrt{\omega^{2}-\lambda^{2}} t+\phi\right)
$$

touches the graphs of the exponential functions

$$
\pm A e^{-\lambda t}
$$

at the values of $t$ for which

$$
\sin \left(\sqrt{\omega^{2}-\lambda^{2}} t+\phi\right)= \pm 1
$$

This means those values of $t$ for which
or

$$
\begin{aligned}
& \sqrt{\omega^{2}-\lambda^{2}} t+\phi=(2 n+1) \frac{\pi}{2} \\
& t=\frac{(2 n+1)(\pi / 2)-\phi}{\sqrt{\omega^{2}-\lambda^{2}}} \text { where } n=0,1,2,3, \ldots
\end{aligned}
$$

Again, if we consider

$$
x(t)=e^{-0.5 t} \sin \left(2 t-\frac{\pi}{3}\right)
$$

Then

$$
2 t_{1}^{*}-\frac{\pi}{3}=\frac{\pi}{2}, 2 t_{2}^{*}-\frac{\pi}{3}=\frac{3 \pi}{2}, 2 t_{3}^{*}-\frac{\pi}{3}=\frac{5 \pi}{2}, \ldots
$$

Or

$$
t_{1}^{*}=\frac{5 \pi}{12}, \quad t_{2}^{*}=\frac{11 \pi}{12}, \quad t_{3}^{*}=\frac{17 \pi}{12}, \ldots
$$

Again, we notice that the difference between successive values is

$$
t_{k}^{*}-t_{k-1}^{*}=\frac{\pi}{2}
$$

- The values of $t$ for which the graph of the solution

$$
x(t)=A e^{-\lambda t} \sin \left(\sqrt{\omega^{2}-\lambda^{2}} t+\phi\right)
$$

touches the exponential graph are not the values for which the function attains its relative extremum.

## Example 1

Interpret and solve the initial value problem

$$
\begin{aligned}
& \frac{d^{2} x}{d t^{2}}+5 \frac{d x}{d t}+4 x=0 \\
& x(0)=1, \quad x^{\prime}(0)=1
\end{aligned}
$$

Find extreme values of the solution and check whether the graph crosses the equilibrium position.

## Interpretation

Comparing the given differential equation

$$
\frac{d^{2} x}{d t^{2}}+5 \frac{d x}{d t}+4 x=0
$$

with the general equation of the free damped motion

$$
\frac{d^{2} x}{d t^{2}}+2 \lambda \frac{d x}{d t}+\omega^{2} x=0
$$

we see that

$$
\lambda=\frac{5}{2}, \quad \omega^{2}=4
$$

so that

$$
\lambda^{2}-\omega^{2}>0
$$

Therefore, the problem represents the over-damped motion of a mass on a spring.
Inspection of the boundary conditions

$$
x(0)=1, \quad x^{\prime}(0)=1
$$

reveals that the mass starts 1 unit below the equilibrium position with a downward velocity of $1 \mathrm{ft} / \mathrm{sec}$.

## Solution

To solve the differential equation

$$
\frac{d^{2} x}{d t^{2}}+5 \frac{d x}{d t}+4 x=0
$$

We put

$$
x=e^{m t}, \frac{d x}{d t}=m e^{m t}, \frac{d^{2} x}{d t^{2}}=m^{2} e^{m t}
$$

Then the auxiliary equation is

$$
\begin{aligned}
& m^{2}+5 m+4=0 \\
\Rightarrow & (m+4)(m+1)=0 \\
\Rightarrow & m=-1, \quad m=-4,
\end{aligned}
$$

Therefore, the auxiliary equation has distinct real roots

$$
m=-1, \quad m=-4
$$

Thus the solution of the differential equation is:

$$
x(t)=c_{1} e^{-t}+c_{2} e^{-4 t}
$$

So that

$$
x^{\prime}(t)=-c_{1} e^{-t}-4 c_{2} e^{-4 t}
$$

Now, we apply the boundary conditions

$$
\begin{aligned}
& x(0)=1 \Rightarrow c_{1} \cdot 1+c_{2} \cdot 1=1 \\
& x^{\prime}(0)=1 \Rightarrow-c_{1}-4 c_{2}=1
\end{aligned}
$$

Thus

$$
\begin{gathered}
c_{1}+c_{2}=1 \\
-c_{1}-4 c_{2}=1
\end{gathered}
$$

Solving these two equations, we have.

$$
c_{1}=\frac{5}{3}, \quad c_{2}=-\frac{2}{3}
$$

Therefore, solution of the initial value problem is

$$
x(t)=\frac{5}{3} e^{-t}-\frac{2}{3} e^{-4 t}
$$

## Extremum

Since

$$
x(t)=\frac{5}{3} e^{-t}-\frac{2}{3} e^{-4 t}
$$

Therefore

$$
\frac{d x}{d t}=-\frac{5}{3} e^{-t}+\frac{8}{3} e^{-4 t}
$$

So that

$$
x^{\prime}(t)=0 \Rightarrow-\frac{5}{3} e^{-t}+\frac{8}{3} e^{-4 t}=0
$$

or

$$
e^{3 t}=\frac{8}{5} \Rightarrow t=\frac{1}{3} \ln \frac{8}{5}
$$

or

$$
t=0.157
$$

Since

$$
\frac{d^{2} x}{d t^{2}}=\frac{5}{3} e^{-t}-\frac{32}{3} e^{-4 t}
$$

Therefore at $t=0.157$, we have

$$
\begin{aligned}
\frac{d^{2} x}{d t^{2}} & =\frac{5}{3} e^{-0.157}-\frac{32}{3} e^{-0.628} \\
& =1.425-5.692=-4.267<0
\end{aligned}
$$

So that the solution $x(t)$ has a maximum at $t=0.157$ and maximum value of $x$ is:

$$
x(0.157)=1.069
$$

Hence the mass attains an extreme displacement of 1.069 ft below the equilibrium position.

## Check

Suppose that the graph of $x(t)$ does cross the $t$-axis, that is, the mass passes through the equilibrium position. Then a value of $t$ exists for which

$$
\begin{array}{ll} 
& x(t)=0 \\
\text { i.e } & \frac{5}{3} e^{-t}-\frac{2}{3} e^{-4 t}=0 \\
\Rightarrow & e^{3 t}=\frac{2}{5} \\
\text { or } & t=\frac{1}{3} \ln \frac{2}{5}=-0.305
\end{array}
$$

This value of $t$ is physically irrelevant because time can never be negative. Hence, the mass never passes through the equilibrium position.

## Example 2

An 8-lb weight stretches a spring 2 ft . Assuming that a damping force numerically equals to two times the instantaneous velocity acts on the system. Determine the equation of motion if the weight is released from the equilibrium position with an upward velocity of $3 \mathrm{ft} / \mathrm{sec}$.

## Solution

Since

$$
\text { Weight }=8 \mathrm{lbs}, \quad \text { Stretch }=s=2 \mathrm{ft}
$$

Therefore, by Hook's law

$$
\begin{aligned}
8 & =2 k \\
\Rightarrow k & =4 \mathrm{lb} / \mathrm{ft}
\end{aligned}
$$

Since $\quad$ Damping force $=2\left(\frac{d x}{d t}\right)$
Therefore $\quad \beta=2$
Also $\quad$ mass $=\frac{\text { Weight }}{\mathrm{g}} \Rightarrow m=\frac{8}{32}=\frac{1}{4}$ slugs

Thus, the differential equation of motion of the free damped motion is given by

$$
\begin{aligned}
& m \frac{d^{2} x}{d t^{2}}=-k x-\beta\left(\frac{d x}{d t}\right) \\
& \frac{1}{4} \frac{d^{2} x}{d t^{2}}=-4 x-2\left(\frac{d x}{d t}\right) \\
& \frac{d^{2} x}{d t^{2}}+8 \frac{d x}{d t}+16 x=0
\end{aligned}
$$

Since the mass is released from equilibrium position with an upward velocity $3 \mathrm{ft} / \mathrm{s}$. Therefore the initial conditions are:

$$
x(0)=0, \quad x^{\prime}(0)=-3
$$

Thus we need to solve the initial value problem

Solve

$$
\frac{d^{2} x}{d t^{2}}+8 \frac{d x}{d t}+16 x=0
$$

Subject to

$$
x(0)=0, \quad x^{\prime}(0)=-3
$$

Put

$$
x=e^{m t}, \quad \frac{d x}{d t}=m e^{m t}, \quad \frac{d^{2} x}{d t^{2}}=m^{2} e^{m t}
$$

Thus the auxiliary equation is

$$
m^{2}+8 m+16=0
$$

or

$$
(m+4)^{2}=0 \Rightarrow m=-4,-4
$$

So that roots of the auxiliary equation are real and equal.

$$
m_{1}=-4=m_{2}
$$

Hence the system is critically damped and the solution of the governing differential equation is

$$
x(t)=c_{1} e^{-4 t}+c_{2} t e^{-4 t}
$$

Moreover, the system is critically damped.

We now apply the boundary conditions.

$$
\begin{aligned}
x(0)=0 & \Rightarrow c_{1} \cdot 1+c_{2} \cdot 0=0 \\
& \Rightarrow c_{1}=0
\end{aligned}
$$

Thus

$$
x(t)=c_{2} t e^{-4 t}
$$

$$
\Rightarrow \quad \frac{d x}{d t}=c_{2} e^{-4 t}-4 c_{2} t e^{-4 t}
$$

So that

$$
\begin{aligned}
x^{\prime}(0)=-3 & \Rightarrow c_{2} \cdot 1-0=-3 \\
& \Rightarrow c_{2}=-3
\end{aligned}
$$

Thus solution of the initial value problem is

$$
x(t)=-3 t e^{-4 t}
$$

## Extremum

Since

$$
x(t)=-3 t e^{-4 t}
$$

Therefore

$$
\begin{aligned}
& \frac{d x}{d t}=-3 e^{-4 t}+12 t e^{-4 t} \\
& =-3 e^{-4 t}(1-4 t) \\
& \frac{d x}{d t}=0 \Rightarrow t=\frac{1}{4}
\end{aligned}
$$

Thus
The corresponding extreme displacement is

$$
x\left(\frac{1}{4}\right)=-3\left(\frac{1}{4}\right) e^{-1}=-0.276 \mathrm{ft}
$$

Thus the weight reaches a maximum height of 0.276 ft above the equilibrium position.

## Example 3

A $16-\mathrm{lb}$ weight is attached to a $5-\mathrm{ft}$ long spring. At equilibrium the spring measures 8.2 ft .If the weight is pushed up and released from rest at a point $2-\mathrm{ft}$ above the equilibrium position. Find the displacement $x(t)$ if it is further known that the surrounding medium offers a resistance numerically equal to the instantaneous velocity.

## Solution

Length of un - stretched spring $=5 \mathrm{ft}$
Length of spring at equilibrium $=8.2 \mathrm{ft}$
Thus Elongation of spring $=s=3.2 \mathrm{ft}$
By Hook's law, we have

$$
16=k(3.2) \Rightarrow k=5 \mathrm{lb} / \mathrm{ft}
$$

Further

$$
\text { mass }=\frac{\text { Weight }}{\mathrm{g}} \Rightarrow m=\frac{16}{32}=\frac{1}{2} \text { slugs }
$$

Since

$$
\text { Damping force }=\frac{d x}{d t}
$$

Therefore

$$
\beta=1
$$

Thus the differential equation of the free damped motion is given by
or

$$
\begin{aligned}
& m \frac{d^{2} x}{d t^{2}}=-k x-\beta \frac{d x}{d t} \\
& \frac{1}{2} \frac{d^{2} x}{d t^{2}}=-5 x-\frac{d x}{d t} \\
& \frac{d^{2} x}{d t^{2}}+2 \frac{d x}{d t}+10 x=0
\end{aligned}
$$

Since the spring is released from rest at a point 2 ft above the equilibrium position.
The initial conditions are:

$$
x(0)=-2, \quad x^{\prime}(0)=0
$$

Hence we need to solve the initial value problem

$$
\begin{aligned}
& \frac{d^{2} x}{d t^{2}}+2 \frac{d x}{d t}+10 x=0 \\
& x(0)=-2, \quad x^{\prime}(0)=0
\end{aligned}
$$

To solve the differential equation, we put

$$
x=e^{m t}, \quad \frac{d x}{d t}=m e^{m t}, \quad \frac{d^{2} x}{d t^{2}}=m^{2} e^{m t}
$$

Then the auxiliary equation is
or

$$
\begin{aligned}
& m^{2}+2 m+10=0 \\
& m=-1 \pm 3 i
\end{aligned}
$$

So that the auxiliary equation has complex roots

$$
m_{1}=-1+3 i, \quad m_{2}=-1-3 i
$$

The system is under-damped and the solution of the differential equation is:

$$
x(t)=e^{-t}\left(c_{1} \cos 3 t+c_{2} \sin 3 t\right)
$$

Now we apply the boundary conditions

$$
\begin{aligned}
x(0)=-2 & \Rightarrow c_{1} \cdot 1+c_{2} \cdot 0=-2 \\
& \Rightarrow c_{1}=-2
\end{aligned}
$$

Thus

$$
\begin{aligned}
& x(t)=e^{-t}\left(-2 \cos 3 t+c_{2} \sin 3 t\right) \\
& \frac{d x}{d t}=e^{-t}\left(6 \sin 3 t+3 c_{2} \cos 3 t\right)-e^{-t}\left(-2 \cos 3 t+c_{2} \sin 3 t\right)
\end{aligned}
$$

Therefore

$$
\begin{gathered}
x^{\prime}(0)=0 \Rightarrow 3 c_{2}+2=0 \\
c_{2}=\frac{-2}{3}
\end{gathered}
$$

Hence, solution of the initial value problem is

$$
x(t)=e^{-t}\left(-2 \cos 3 t-\frac{2}{3} \sin 3 t\right)
$$

## Example 4

Write the solution of the initial value problem

$$
\begin{aligned}
& \frac{d^{2} x}{d t^{2}}+2 \frac{d x}{d t}+10 x=0 \\
& x(0)=-2, \quad x^{\prime}(0)=0
\end{aligned}
$$

in the alternative form

$$
x(t)=A e^{-t} \sin (3 t+\phi)
$$

## Solution

We know from previous example that the solution of the initial value problem is

$$
x(t)=e^{-t}\left(-2 \cos 3 t-\frac{2}{3} \sin 3 t\right)
$$

Suppose that $A$ and $\phi$ are real numbers such that

Then

$$
\begin{aligned}
& \sin \phi=-\frac{2}{A}, \quad \cos \phi=\frac{-2 / 3}{A} \\
& A=\sqrt{4+\frac{4}{9}}=\frac{2}{3} \sqrt{10}
\end{aligned}
$$

Also

$$
\tan \phi=\frac{-2}{-2 / 3}=3
$$

Therefore

$$
\tan ^{-1}(3)=1.249 \text { radian }
$$

Since $\sin \phi<0, \cos \phi<0$, the phase angle $\phi$ must be in $3^{\text {rd }}$ quadrant.
Therefore

$$
\phi=\pi+1.249=4.391 \text { radians }
$$

Hence

$$
x(t)=\frac{2}{3} \sqrt{10} e^{-t} \sin (3 t+4.391)
$$

The values of $t=t_{\gamma}$ where the graph of the solution crosses positive t - axis and the values $t=t_{\gamma}{ }^{*}$ where the graph of the solution touches the graphs of $\pm\left(\frac{2}{3}\right) \sqrt{10} e^{-t}$ are given in the following table.

| $\gamma$ | $t_{\gamma}$ | $t_{\gamma}^{*}$ | $x\left(t_{\gamma}^{*}\right)$ |
| :--- | :--- | :--- | :--- |
| 1 | .631 | 1.154 | 0.665 |
| 2 | 1.678 | 2.202 | -0.233 |
| 3 | 2.725 | 3.249 | 0.082 |
| 4 | 3.772 | 4.296 | -0.029 |

## Quasi Period

Since
Therefore

$$
\begin{gathered}
x(t)=\frac{2}{3} \sqrt{10} e^{-t} \sin (3 t+4.391) \\
\sqrt{\lambda^{2}-\omega^{2}}=3
\end{gathered}
$$

So that the quasi period is given by

$$
\frac{2 \pi}{\sqrt{\lambda^{2}-\omega^{2}}}=\frac{2 \pi}{3} \text { seconds }
$$

Hence, difference between the successive $t_{\gamma}$ and $t_{\gamma}^{*}$ is $\frac{\pi}{3}$ units.

## Exercise

Give a possible interpretation of the given initial value problems.

1. $\frac{1}{6} x^{\prime \prime}+2 x^{\prime}+x=0, \quad x(0)=0, x^{\prime}(0)=-1.5$
2. $\frac{16}{32} x^{\prime \prime}+x^{\prime}+2 x=0, \quad x(0)=-2, x^{\prime}(0)=1$
3. A 4-lb weight is attached to a spring whose constant is $2 \mathrm{lb} / \mathrm{ft}$. The medium offers a resistance to the motion of the weight numerically equal to the instantaneous velocity. If the weight is released from a point 1 ft above the equilibrium position with a downward velocity of $8 \mathrm{ft} / \mathrm{s}$, determine the time that the weight passes through the equilibrium position. ## Lecture 24

## Forced Motion

In this last lecture on the applications of second order linear differential equations, we consider

- A vibrational system consisting of a body of mass $m$ attached to a spring. The motion of the body is being driven by an external force $f(t)$ i.e. forced motion.
a Flow of current in an electrical circuit that consists of an inductor, resistor and a capacitor connected in series, because of its similarity with the forced motion.


## Forced motion with damping

Suppose that we now take into consideration an external force $f(t)$. Then, the forces acting on the system are:
a) Weight of the body $=m g$
b) The restoring force $=-k(s+x)$
c) The damping effect $=-\beta(d x / d t)$
d) The external force $=f(t)$.

Hence $x$ denotes the distance of the mass $m$ from the equilibrium position. Thus the total force acting on the mass $m$ is given by

$$
\text { Force }=m g-k(s+x)-\beta\left(\frac{d x}{d t}\right)+f(t)
$$

By the Newton's $2^{\text {nd }}$ law of motion, we have

Therefore

$$
\text { Force }=m a=m \frac{d^{2} x}{d t^{2}}
$$

$$
m \frac{d^{2} x}{d t^{2}}=m g-k s-k x-\beta\left(\frac{d x}{d t}\right)+f(t)
$$

But

$$
m g-k s=0
$$

So that

$$
\frac{d^{2} x}{d t^{2}}+\frac{\beta}{m}\left(\frac{d x}{d t}\right)+\frac{k}{m} x=\frac{f(t)}{m}
$$

or

$$
\frac{d^{2} x}{d t^{2}}+2 \lambda \frac{d x}{d t}+\omega^{2} x=F(t)
$$

where $F(t)=\frac{f(t)}{m}, \quad 2 \lambda=\frac{\beta}{m}$ and $\omega^{2}=\frac{k}{m}$.

## Note that

- The last equation is a non-homogeneous differential equation governing the forced motion with damping.
- To solve this equation, we use either the method of undetermined coefficients or the variation of parameters.


## Example 1

Interpret and solve the initial value problem

$$
\begin{aligned}
& \frac{1}{5} \frac{d^{2} x}{d t^{2}}+1.2 \frac{d x}{d t}+2 x=5 \cos 4 t \\
& x(0)=\frac{1}{2}, \quad x^{\prime}(0)=0
\end{aligned}
$$

## Interpretation

The problem represents a vibrational system consisting of

- A mass $m=\frac{1}{5}$ slugs or kilograms
- The mass is attached to a spring having spring constant $k=2 \mathrm{lb} / \mathrm{ft}$ or $\mathrm{N} / \mathrm{m}$
- The mass is released from rest $\frac{1}{2} \mathrm{ft}$ or meter below the equilibrium position
- The motion is damped with damping constant $\beta=1.2$.
- The motion is being driven by an external periodic force $f(t)=5 \cos 4 t$ that has period $T=\frac{\pi}{2}$.


## Solution

Given the differential equation
or

$$
\begin{aligned}
& \frac{1}{5} \frac{d^{2} x}{d t^{2}}+1.2 \frac{d x}{d t}+2 x=5 \cos 4 t \\
& \frac{d^{2} x}{d t^{2}}+6 \frac{d x}{d t}+10 x=25 \cos 4 t
\end{aligned}
$$

First consider the associated homogeneous differential equation.

$$
\begin{gathered}
\frac{d^{2} x}{d t^{2}}+6 \frac{d x}{d t}+10 x=0 \\
\text { Put } x=e^{m t}, \frac{d x}{d t}=m e^{m t}, \quad \frac{d^{2} x}{d t^{2}}=m^{2} e^{m t}
\end{gathered}
$$

Then the auxiliary equation is:

$$
\begin{array}{ll} 
& m^{2}+6 m+10=0 \\
\Rightarrow \quad & m=-3 \pm i
\end{array}
$$

Thus the auxiliary equation has complex roots

$$
m_{1}=-3+i, \quad m_{2}=-3-i
$$

So that the complementary function of the equation is

$$
x_{c}=e^{-3 t}\left(c_{1} \cos t+c_{2} \sin t\right)
$$

To find a particular integral of non-homogeneous differential equation we use the undetermined coefficients, we assume that

$$
x_{p}(t)=A \cos 4 t+B \sin 4 t
$$

Then

$$
\begin{aligned}
& x_{p}^{\prime}(t)=-4 A \sin 4 t+4 B \cos 4 t \\
& x_{p}^{\prime \prime}(t)=-16 A \cos 4 t-16 B \sin 4 t
\end{aligned}
$$

So that

$$
\begin{aligned}
x_{p}^{\prime \prime}+6 x_{p}^{\prime}+10 x_{p} & =-16 A \cos 4 t-16 B \sin 4 t-24 A \sin 4 t \\
& +24 B \cos 4 t+10 A \cos 4 t+10 B \sin 4 t \\
& =(-6 A+24 B) \cos 4 t+(-24 A-6 B) \sin 4 t
\end{aligned}
$$

Substituting in the given non-homogeneous differential equation, we obtain

$$
(-6 A+24 B) \cos 4 t+(-24 A-6 B) \sin 4 t=25 \cos 4 t
$$

Equating coefficients, we have

$$
\begin{gathered}
-6 A+24 B=25 \\
-24 A-6 B=0
\end{gathered}
$$

Solving these equations, we obtain

$$
A=-\frac{25}{102}, \quad B=\frac{50}{51}
$$

Thus

$$
x_{p}(t)=-\frac{25}{102} \cos 4 t+\frac{50}{51} \sin 4 t
$$

Hence the general solution of the differential equation is:

$$
\begin{gathered}
x(t)=e^{-3 t}\left[c_{1} \cos t+c_{2} \sin t\right]-\frac{25}{102} \cos 4 t+\frac{50}{51} \sin 4 t \\
x^{\prime}(t)=-3 e^{-3 t}\left[c_{1} \cos t+c_{2} \sin t\right]+e^{-3 t}\left(-c_{1} \sin t+c_{2} \cos t\right)+\frac{50}{51} \sin 4 t+\frac{200}{51} \cos 4 t
\end{gathered}
$$

Now

$$
\begin{aligned}
& x(0)=\frac{1}{2} \text { gives } \\
& c_{1} \cdot 1-\frac{25}{102}=\frac{1}{2} \\
& c_{1}=\frac{1}{2}+\frac{25}{102}=\frac{51+25}{102} \\
& c_{1}=\frac{38}{51}
\end{aligned}
$$

or
or
Also

$$
x^{\prime}(0)=0 \text { gives }
$$

$$
-3 c_{1}+c_{2}+\frac{200}{51}=0
$$

or

$$
c_{2}=-\frac{200}{51}+\frac{114}{51}=-\frac{86}{51}
$$

Hence the solution of the initial value problem is:

$$
x(t)=e^{-3 t}\left(\frac{38}{51} \cos t-\frac{86}{51} \sin t\right)-\frac{25}{102} \cos 4 t+\frac{50}{51} \sin 4 t
$$

## Transient and Steady-State Terms

Due to the presence of the factor $e^{-3 t}$ we notice that the complementary function

$$
x_{c}(t)=e^{-3 t}\left(\frac{38}{51} \cos t-\frac{86}{51} \sin t\right)
$$

possesses the property that

$$
\lim _{x \rightarrow \infty} x_{c}(t)=0
$$

Thus for large time, the displacements of the weight are closely approximated by the particular solution

$$
x_{p}(t)=-\frac{25}{102} \cos 4 t+\frac{50}{51} \sin 4 t
$$

Since $x_{c}(t) \rightarrow 0$ as $t \rightarrow \infty$, it is said to be transient term or transient solution. The particular solution $x_{p}(t)$ is called the steady-state solution
Hence, when $F$ is a periodic function, such as

$$
F(t)=F_{0} \sin \gamma t \quad \text { or } \quad F(t)=F_{0} \cos \gamma t
$$

The general solution of the equation

$$
\frac{d^{2} x}{d t^{2}}+2 \lambda \frac{d x}{d t}+\omega^{2} x=F(t)
$$

consists of

$$
x(t)=\text { Transient solution }+ \text { Steady State Solution }
$$

## Example 2

Solve the initial value problem

$$
\begin{aligned}
& \frac{d^{2} x}{d t^{2}}+2 \frac{d x}{d t}+2 x=4 \cos t+2 \sin t \\
& x(0)=0, \quad x^{\prime}(0)=3
\end{aligned}
$$

## Solution

First consider the associated homogeneous linear differential equation

$$
\frac{d^{2} x}{d t^{2}}+2 \frac{d x}{d t}+2 x=0
$$

Put

$$
x=e^{m x}, x^{\prime}=m e^{m x}, x^{\prime \prime}=m^{2} e^{m x}
$$

Then the auxiliary equation is
or

$$
\begin{aligned}
& m^{2}+2 m+2=0 \\
& m=\frac{-2 \pm \sqrt{4-8}}{2}=-1 \pm i
\end{aligned}
$$

Thus the complementary function is

$$
x_{c}=e^{-t}\left(c_{1} \cos t+c_{2} \sin t\right)
$$

For the particular integral we assume that

$$
\begin{aligned}
x_{p} & =A \cos t+B \sin t \\
x_{p}^{\prime} & =-A \sin t+B \cos t \\
x_{p}^{\prime \prime} & =-A \cos t-B \sin t
\end{aligned}
$$

So that

$$
\begin{aligned}
& \frac{d^{2} x_{p}}{d t^{2}}+2 \frac{d x_{p}}{d t}+2 x_{p}=-A \cos t-B \sin t-2 A \sin t+2 B \cos t+2 A \cos t+2 B \sin t \\
& \text { or } \quad \frac{d^{2} x_{p}}{d t^{2}}+2 \frac{d x_{p}}{d t}+2 x_{p}=(A+2 B) \cos t+(-2 A+B) \sin t
\end{aligned}
$$

Substituting in the given differential equation, we have

$$
(A+2 B) \cos t+(-2 A+B) \sin t=4 \cos t+2 \sin t
$$

Equating coefficients, we obtain

$$
\begin{array}{r}
A+2 B=4 \\
-2 A+B=2
\end{array}
$$

Solving these two equations, we have:

$$
A=0, \quad \mathrm{~B}=2
$$

Thus

$$
x_{p}=2 \sin t
$$

Hence general solution of the differential equation is
or

$$
x=x_{c}+x_{p}
$$

$$
x(t)=e^{-t}\left(c_{1} \cos t+c_{2} \sin t\right)+2 \sin t
$$

Thus

$$
x^{\prime}(t)=-e^{-t}\left(c_{1} \cos t+c_{2} \sin t\right)+e^{-t}\left(-c_{1} \sin t+c_{2} \cos t\right)+2 \cos t
$$

Now we apply the boundary conditions

$$
\begin{aligned}
x(0)=0 & \Rightarrow c_{1} \cdot 1+c_{2} \cdot 0+0=0 \\
& \Rightarrow c_{1}=0 \\
x^{\prime}(0)=3 & \Rightarrow-c_{1} \cdot 1+c_{2} \cdot 1+2=3 \\
& \Rightarrow c_{2}=1
\end{aligned}
$$

Thus solution of the initial value problem is

$$
x=e^{-t} \sin t+2 \sin t
$$

Since

$$
e^{-t} \sin t \rightarrow 0 \text { as } t \rightarrow 0
$$

Therefore

$$
e^{-t} \sin t=\text { Transient Term }, \quad 2 \sin t=\text { Steady State }
$$

Hence

$$
x=\underbrace{e^{-t} \sin t}_{\text {Transient }}+\underbrace{2 \sin t}_{\text {Steady-state }}
$$

We notice that the effect of the transient term becomes negligible for about

$$
t>2 \pi
$$

## Motion without Damping

If the system is impressed upon by a periodic force and there is no damping force then there is no transient term in the solution.

## Example 3

Solve the initial value problem

$$
\begin{aligned}
& \frac{d^{2} x}{d t^{2}}+\omega^{2} x=F_{o} \sin \gamma t \\
& x(0)=0, \quad x^{\prime}(0)=0
\end{aligned}
$$

Where $F_{o}$ is a constant

## Solution

For complementary function, consider the associated homogeneous differential equation

$$
\frac{d^{2} x}{d t^{2}}+\omega^{2} x=0
$$

Put

$$
x=e^{m t}, x^{\prime \prime}=m^{2} e^{m t}
$$

Then the auxiliary equation is

$$
m^{2}+\omega^{2}=0 \Rightarrow m= \pm \omega i
$$

Thus the complementary function is

$$
x_{c}(t)=c_{1} \cos \omega t+c_{2} \sin \omega t
$$

To find a particular solution, we assume that

Then

$$
\begin{aligned}
& x_{p}(t)=A \cos \gamma t+B \sin \gamma t \\
& x_{p}^{\prime}(t)=-A \gamma \sin \gamma t+B \gamma \cos \gamma t \\
& x_{p}^{\prime \prime}(t)=-A \gamma^{2} \cos \gamma t-B \gamma^{2} \sin \gamma t
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
& x_{p}^{\prime \prime}+\omega^{2} x_{p}=-A \gamma^{2} \cos \gamma t-B \gamma^{2} \sin \gamma t+A \omega^{2} \cos \gamma t+B \omega^{2} \sin \gamma t \\
& x_{p}^{\prime \prime}+\omega^{2} x_{p}=A\left(\omega^{2}-\gamma^{2}\right) \cos \gamma t+B\left(\omega^{2}-\gamma^{2}\right) \sin \gamma t
\end{aligned}
$$

Substituting in the given differential equation, we have

$$
A\left(\omega^{2}-\gamma^{2}\right) \cos \gamma t+B\left(\omega^{2}-\gamma^{2}\right) \sin \gamma t=F_{o} \sin \gamma t
$$

Equating coefficients, we have

$$
A\left(\omega^{2}-\gamma^{2}\right)=0, \quad B\left(\omega^{2}-\gamma^{2}\right)=F_{o}
$$

Solving these two equations, we obtain

$$
A=0, \quad B=\frac{F_{o}}{\omega^{2}-\gamma^{2}} \quad(\gamma \neq \omega)
$$

Therefore

$$
x_{p}(t)=\left(\frac{F_{o}}{\omega^{2}-\gamma^{2}}\right) \sin \gamma t
$$

Hence, the general solution of the differential equation is

$$
x(t)=c_{1} \cos \omega t+c_{2} \sin \omega t+\left(\frac{F_{o}}{\omega^{2}-\gamma^{2}}\right) \sin \gamma t
$$

Then

$$
x^{\prime}(t)=-c_{1} \omega \sin \omega t+c_{2} \omega \cos \omega t+\frac{F_{o} \gamma}{\omega^{2}-\gamma^{2}} \cos \gamma t
$$

Now we apply the boundary conditions

$$
\begin{aligned}
x(0)=0 & \Rightarrow c_{1} \cdot 1+c_{2} \cdot 0+0=0 \\
& \Rightarrow c_{1}=0 \\
x^{\prime}(0)=0 & \Rightarrow c_{1} \cdot 0+c_{2} \omega \cdot 1+\frac{F_{o} \gamma}{\omega^{2}-\gamma^{2}}=0 \\
& \Rightarrow c_{2}=\frac{-\gamma F_{o}}{\omega\left(\omega^{2}-\gamma^{2}\right)}
\end{aligned}
$$

Thus solution of the initial value problem is

$$
x(t)=\frac{F_{o}}{\omega\left(\omega^{2}-\gamma^{2}\right)}(-\gamma \sin \omega t+\omega \sin \gamma t), \quad(\gamma \neq \omega)
$$

Note that the solution is not defined for $\gamma=\omega$, However $\lim x(t)$ can be obtained using $\gamma \rightarrow \omega$
the L'Hôpital's rule

$$
\begin{aligned}
x(t) & =\lim _{\gamma \rightarrow \omega} F_{o} \frac{-\gamma \sin \omega t+\omega \sin \gamma t}{\omega\left(\omega^{2}-\gamma^{2}\right)} \\
& =F_{o} \lim _{\gamma \rightarrow \omega} \omega \frac{\frac{d}{d \gamma}(-\gamma \sin \omega t+\omega \sin \gamma t)}{\frac{d}{d \gamma} \omega\left(\omega^{2}-\gamma^{2}\right)} \\
& =F_{o} \lim _{\gamma \rightarrow \omega} \omega \frac{-\sin \omega t+\omega t \cos \gamma t}{-2 \omega \gamma} \\
& =F_{o}\left(\frac{-\sin \omega t+\omega t \cos \omega t}{-2 \omega^{2}}\right) \\
& =\frac{F_{o}}{2 \omega^{2}} \sin \omega t-\frac{F_{o}}{2 \omega} t \cos \omega t
\end{aligned}
$$

Clearly $|x(t)| \rightarrow \infty$ as $t \rightarrow \infty$. Therefore there is no transient term when there is no damping force in the presence of a periodic impressed force.

## Electric Circuits

Many different physical systems can be described by a second order linear differential equation similar to the differential equation of the forced motion:

$$
m \frac{d^{2} x}{d t^{2}}+\beta \frac{d x}{d t}+k x=f(t)
$$

One such analogous case is that of an $L R C$-Series circuit. Because of the similarity in mathematics that governs these two systems, it might be possible to use our intuitive understanding of one to help understand the other.

## The LRC Series Circuits

The LRC series circuit consist of an inductor, resistor and capacitor connected in series with a time varying source voltage $E(t)$,

## Resistor

A resistor is an electrical component that limits or regulates the flow of electrical current in an electrical circuit.

The measure of the extent to which a resistor impedes or resists with the flow of current through it is called resistance, denoted by $R$.
Clearly higher the resistance, lower the flow of current. Lower the resistance, higher the flow of current. Therefore, we conclude that the flow of current is inversely proportional to the resistance, i.e

$$
I=V \cdot \frac{1}{R} \Rightarrow V=I R
$$

Where $V$ is constant of proportionality and it represents the voltage. The above equation is mathematical statement of the well known as Ohm's Law.

## Inductor

An inductor is a passive electronic component that stores energy in the form of magnetic field. In its simplest form the conductor consists of a wire loop or coil wound on some suitable material.

Whenever current through an inductor changes, i.e increases or decreases, a counter emf is induced in it, which tends to oppose this change. This property of the coil due to which it opposes any change of current through it is called the inductance.
Suppose that $I$ denotes the current then the rate of change of current is given by

$$
\frac{d I}{d t}
$$

This produces a counter emf voltage $V$. Then $V$ is directly proportional to $\frac{d I}{d t}$

$$
V \alpha \frac{d I}{d t} \Rightarrow V=L \frac{d I}{d t}
$$

Where $L$ is constant of proportionality, which represents inductance of the inductor. The standard unit for measurement of inductance is Henry, denoted by $H$.

## Capacitor

A capacitor is a passive electronic component of an electronic circuit that has the ability to store charge and opposes any change of voltage in the circuit. The ability of a capacitor to store charge is called capacitance of the capacitor denoted by $C$. If $+q$ coulomb of a charge to the capacitor and the potential difference of $V$ volts is established between 2 plates of the capacitor then
or

$$
\begin{aligned}
& q \propto C \Rightarrow q=C V \\
& V=q / C
\end{aligned}
$$

Where $C$ is called constant of proportionality, which represent capacitance. The standard unit to measure capacitance is farad, denoted by $F$.

## Kirchhoff's Voltage Law

The Kirchhoff's $2^{\text {nd }}$ law states that the sum of the voltage drops around any closed loop equals the sum of the voltage rises around that loop. In other words the algebraic sum of voltages around the close loop is zero.
The Differential Equation
Now we consider the following circuit consisting of an inductor, a resistor and a capacitor in series with a time varying voltage source $E(t)$.


If $V_{L}, V_{R}$ and $V_{c}$ denote the voltage drop across the inductor, resistor and capacitor respectively. Then

$$
V_{L}=L \frac{d I}{d t}, V_{R}=R I, \quad V_{c}=\frac{q}{C}
$$

Now by Kirchhoff's law, the sum of $V_{L}, V_{R}$ and $V_{c}$ must equal the source voltage $E(t)$ i.e
or

$$
\begin{aligned}
& V_{L}+V_{R}+V_{c}=E(t) \\
& L \frac{d I}{d t}+R I+\frac{q}{C}=E(t)
\end{aligned}
$$

Since the electric current $I$ represents the rate of flow of charge $\frac{d q}{d t}$. Therefore, we can write

$$
I=\frac{d q}{d t}
$$

Substituting in the last equation, we have:

$$
L \frac{d^{2} q}{d t^{2}}+R \frac{d q}{d t}+\frac{q}{C}=E(t)
$$

## Note that

- We have seen this equation before! It is mathematically exactly the same as the equation for a driven, damped harmonic oscillator.
- If $E(t)=0, R \neq 0$ the electric vibration of the circuit are said to be free damped oscillation.
- If $E(t)=0, R=0$ then the electric vibration can be called free un-damped oscillations.


## Solution of the differential equation

The differential equation that governs the flow of charge in an LRC-Series circuit is

$$
L \frac{d^{2} q}{d t^{2}}+R \frac{d q}{d t}+\frac{q}{C}=E(t)
$$

This is a non-homogeneous linear differential equation of order-2. Therefore, the general solution of this equation consists of a complementary function and particular integral.
For the complementary function we find general solution of the associated homogeneous differential equation

$$
\begin{aligned}
& L \frac{d^{2} q}{d t^{2}}+R \frac{d q}{d t}+\frac{q}{C}=0 \\
& q=e^{m t}, \quad \frac{d q}{d t}=m e^{m t}, \quad \frac{d^{2} q}{d t^{2}}=m^{2} e^{m t}
\end{aligned}
$$

Then the auxiliary equation of the associated homogeneous differential equation is:

$$
L m^{2}+R m+\frac{1}{C}=0
$$

If $R \neq 0$ then, depending on the discriminant, the auxiliary equation may have

- Real and distinct roots
- Real and equal roots
- Complex roots


## Case 1 Real and distinct roots

If

$$
D i s c=R^{2}-\frac{4 L}{C}>0
$$

Then the auxiliary equation has real and distinct roots. In this case, the circuit is said to be over damped.

## Case 2 Real and equal

If

$$
D i s c=R^{2}-\frac{4 L}{c}=0
$$

Then the auxiliary equation has real and equal roots. In this case, the circuit is said to be critically damped.

## Case 3 Complex roots

If

$$
\text { Disc }=R^{2}-4 \frac{L}{c}<0
$$

Then the auxiliary equation has complex roots. In this case, the circuit is said to be under damped.

## Note that

- Since by the quadratic formula, we know that

$$
m=\frac{-R \pm \sqrt{R^{2}-4 L / c}}{2 L}
$$

In each of the above mentioned three cases, the general solution of the nonhomogeneous governing equation contains the factor $e^{-R t / 2 L}$. Therefore

$$
q(t) \rightarrow 0 \text { as } t \rightarrow \infty
$$

- In the under damped case when $q(0)=q_{o}$ the charge on the capacitor oscillates as it decays. This means that the capacitor is charging and discharging as $t \rightarrow \infty$
- In the under damped case, i.e. when $E(0)=0$, and $R=0$, the electrical vibration do not approach zero as $t \rightarrow \infty$. This means that the response of the circuit is Simple Harmonic.


## Lecture 25

Forced Motion - Examples

## Example 1

Consider an LC series circuit in which .

$$
E(t)=0
$$

Determine the charge $q(t)$ on the capacitor for $t>0$ if its initial charge is $q_{o}$ and if initially there is no current flowing in the circuit.

## Solution

Since in an LC series circuit, there is no resistor. Therefore,

$$
R \frac{d q}{d t}=0
$$

So that, the governing differential equation becomes

$$
L \frac{d^{2} q}{d t^{2}}+\frac{1}{c} q=0
$$

The initial conditions for the circuit are

$$
q(0)=q_{o}, \quad I(0)=0
$$

Since

$$
\frac{d q}{d t}=I(t)
$$

Therefore the initial conditions are equivalent to

$$
q(0)=q_{o}, \quad q^{\prime}(0)=0
$$

Thus, we have to solve the initial value problem.

$$
\begin{aligned}
& L \frac{d^{2} q}{d t^{2}}+\frac{1}{c} q=0 \\
& q(0)=q_{o}, \quad q^{\prime}(0)=0
\end{aligned}
$$

To solve the governing differential equation, we put

$$
q=e^{m t}, \quad \frac{d^{2} q}{d t^{2}}=m^{2} e^{m t}
$$

So that the auxiliary equation is:

$$
\begin{aligned}
& L m^{2}+\frac{1}{c}=0 \\
\Rightarrow & m^{2}=-\frac{1}{L c} \\
\Rightarrow \quad & m= \pm\left(\frac{1}{\sqrt{L c}}\right) i
\end{aligned}
$$

Therefore, the solution of the differential equation is :

$$
q(t)=c_{1} \cos \left(\frac{1}{\sqrt{L c}} t\right)+c_{2} \sin \left(\frac{1}{\sqrt{L c}} t\right)
$$

Now, we apply the boundary conditions

$$
\begin{aligned}
q(0)=q_{o} & \Rightarrow q_{o}=c_{1} \cdot 1+c_{2} \cdot 0 \\
& \Rightarrow c_{1}=q_{o}
\end{aligned}
$$

Thus

$$
q(t)=q_{o} \cos \left(\frac{1}{\sqrt{L c}} t\right)+c_{2} \sin \left(\frac{1}{\sqrt{L c}} t\right)
$$

Differentiating w.r to $t$, we have:

$$
\frac{d q}{d t}=-\frac{q_{o}}{\sqrt{L c}} \sin \left(\frac{1}{\sqrt{L c}} t\right)+\frac{c_{2}}{\sqrt{L c}} \cos \left(\frac{1}{\sqrt{L c}} t\right)
$$

Now

$$
\begin{aligned}
q^{\prime}(0)=0 & \Rightarrow 0+\frac{c_{2}}{\sqrt{L c}} \cdot 1=0 \\
& \Rightarrow c_{2}=0
\end{aligned}
$$

Hence

$$
q(t)=q_{o} \cos \frac{1}{\sqrt{L c}} t
$$

Since

$$
I(t)=\frac{d q}{d t}
$$

Therefore, current in the circuit is given by

$$
I(t)=-\frac{q_{o}}{\sqrt{L c}} \sin \left(\frac{1}{\sqrt{L C}} t\right)
$$

## Example 2

Find the charge $q(t)$ on the capacitor in an LRC series circuit when $\mathrm{L}=0.25$ Henry, $\mathrm{R}=10$ Ohms, C=0.001 farad, $E(t)=0, q(0)=q_{o}$ and $I(0)=0$.

## Solution

We know that for an LRC circuit, the governing differential equation is

$$
L \frac{d^{2} q}{d t^{2}}+R \frac{d q}{d t}+\frac{q}{c}=E(t)
$$

Since $L=0.25=\frac{1}{4}, R=10, C=0.001=\frac{1}{1000}$
Therefore, the equation becomes:
or

$$
\begin{aligned}
\frac{1}{4} \frac{d^{2} q}{d t^{2}}+10 \frac{d q}{d t}+1000 q & =0 \\
\frac{d^{2} q}{d t^{2}}+40 \frac{d q}{d t}+4000 q & =0
\end{aligned}
$$

The initial conditions are
or

$$
\begin{array}{ll}
q(0)=q_{o}, & I(0)=0 \\
q(0)=q_{o}, & q^{\prime}(0)=0
\end{array}
$$

To solve the differential equation, we put

$$
q=e^{m t}, \quad \frac{d q}{d t}=m e^{m t}, \quad \frac{d^{2} q}{d t^{2}}=m^{2} e^{m t}
$$

Therefore, the auxiliary equation is

$$
\begin{aligned}
& m^{2}+40 m+4000=0 \\
& \Rightarrow m=\frac{-40 \pm \sqrt{1600-16000}}{2} \\
& \Rightarrow m=-20 \pm 60 i
\end{aligned}
$$

Thus, the solution of the differential equation is

$$
q(t)=e^{-20 t}\left(c_{1} \cos 60 t+c_{2} \sin 60 t\right)
$$

Now, we apply the initial conditions

$$
\begin{aligned}
q(0)=q_{o} & \Rightarrow c_{1} \cdot 1+c_{2} \cdot 0=q_{o} \\
& \Rightarrow c_{1}=q_{o}
\end{aligned}
$$

Therefore

$$
q(t)=e^{-20 t}\left(q_{o} \cos 60 t+c_{2} \sin 60 t\right)
$$

Now $\quad q^{\prime}(t)=-20 e^{-20 t}\left(q_{o} \cos 60 t+c_{2} \cos 60 t\right)+e^{-20 t}\left(-60 q_{o} \sin 60 t+60 c_{2} \cos 60 t\right)$

Thus

$$
\begin{aligned}
q^{\prime}(0)=0 & \Rightarrow-20 q_{o}-20 c_{2}+60 c_{2} \cdot 1=0 \\
& \Rightarrow c_{2}=\frac{q_{o}}{2}
\end{aligned}
$$

Hence the solution of the initial value problem is

$$
q(t)=q_{o} e^{-20 t}\left(\cos 60 t+\frac{1}{2} \sin 60 t\right)
$$

As discussed in the previous lectures, a single sine function

$$
q(t)=\frac{q_{o} \sqrt{10}}{3} e^{-20 t} \sin (60 t+1.249)
$$

Since $R \neq 0$ and $\lim _{t \rightarrow \infty} q(t)=0$
Therefore the solution of the given differential equation is transient solution.
Note that
The electric vibrations in this case are free damped oscillations as there is no impressed voltage $E(t)$ on the circuit.

## Example 3

Find the steady state of solution $q_{p}(t)$ and the steady state current in an $L R C$ series circuit when the impressed voltage is

$$
E(t)=E_{o} \sin \gamma t
$$

## Solution

The steady state solution $q_{p}(t)$ is a particular solution of the differential equation

$$
L \frac{d^{2} q}{d t^{2}}+R \frac{d q}{d t}+\frac{1}{C} q=E_{o} \sin \gamma t
$$

We use the method of undetermined coefficients, for finding $q_{p}(t)$. Therefore, we assume

Then

$$
\begin{aligned}
& q(t)=A \sin \gamma t+B \cos \gamma t \\
& q^{\prime}(t)=A \gamma \cos \gamma t-B \gamma \sin \gamma t \\
& q^{\prime \prime}(t)=-A \gamma^{2} \sin \gamma t-B \gamma^{2} \cos \gamma t
\end{aligned}
$$

Therefore

$$
\begin{aligned}
L \frac{d^{2} q}{d t^{2}}+R \frac{d q}{d t}+\frac{1}{C} q & =-A L \gamma^{2} \sin \gamma t-B L \gamma^{2} \cos \gamma t+A R \gamma \cos \gamma t \\
& -B R \gamma \sin \gamma t+\frac{A}{C} \sin \gamma t+\frac{B}{C} \cos \gamma t \\
& =\left[\frac{A}{C}-A L \gamma^{2}-B R \gamma\right] \sin \gamma t+\left[\frac{B}{C}-B L \gamma^{2}+A R \gamma\right] \cos \gamma t
\end{aligned}
$$

Substituting in the given differential equation, we obtain

$$
\left[\frac{A}{C}-A L \gamma^{2}-B R \gamma\right] \sin \gamma t+\left[\frac{B}{C}-B L \gamma^{2}+A R \gamma\right] \cos \gamma t=E_{o} \sin \gamma t
$$

Equating coefficients of $\sin \gamma t$ and $\cos \gamma t$, we obtain
or

$$
\begin{aligned}
& \frac{A}{C}-A L \gamma^{2}-B R \gamma=E_{o} \\
& \frac{B}{C}-B L \gamma^{2}+A R \gamma=0 \\
& \left(\frac{1}{C}-L \gamma^{2}\right) A-B R \gamma=E_{o} \\
& A R \gamma+\left(\frac{1}{C}-L \gamma^{2}\right) B=0
\end{aligned}
$$

To solve these equations, we have from second equation

$$
B=\frac{-A R \gamma}{\frac{1}{C}-L \gamma^{2}}
$$

Substituting in the first equation and simplifying, we obtain

$$
A=\frac{E_{o}\left(L \gamma-\frac{1}{C \gamma}\right)}{-\gamma\left[L^{2} \gamma^{2}-\frac{2 L}{C}+\frac{1}{C^{2} \gamma^{2}}+R^{2}\right]}
$$

Using this value of $A$ and simplifying yields

$$
B=\frac{E_{o} R}{-\gamma\left[L^{2} \gamma^{2}-\frac{2 L}{C}+\frac{1}{C^{2} \gamma^{2}}+R^{2}\right]}
$$

If we use the notations

$$
\begin{aligned}
& X=L \gamma-\frac{1}{C \gamma} \text { then } X^{2}=L^{2} \gamma^{2}-\frac{2 L}{C}+\frac{1}{C^{2} \gamma^{2}} \\
& Z=\sqrt{X^{2}+R^{2}} \text { then } Z^{2}=L^{2} \gamma^{2}-\frac{2 L}{C}+\frac{1}{C^{2} \gamma^{2}}+R^{2} \\
& A=\frac{E_{o} X}{-\gamma Z^{2}}, \quad \mathrm{~B}=\frac{E_{o} R}{-\gamma Z^{2}}
\end{aligned}
$$

Therefore, the steady-state charge is given by

$$
q_{p}(t)=-\frac{E_{o} X}{\gamma Z^{2}} \sin \gamma t-\frac{E_{o} R}{\gamma Z^{2}} \cos \gamma t
$$

So that the steady-state current is given by

$$
I_{p}(t)=\frac{E_{o}}{Z}\left(\frac{R}{Z} \sin \gamma t-\frac{X}{Z} \cos \gamma t\right)
$$

## Note that

- The quantity $X=L \gamma-\frac{1}{C \gamma}$ is called the reactance of the circuit.
- The quantity $Z=\sqrt{X^{2}+R^{2}}$ is called impedance of the circuit.
- Both the reactance and the impedance are measured in ohms.


## Exercise

1. A 16 -lb weight stretches a spring $8 / 3 \mathrm{ft}$. Initially the weight starts from rest $2-\mathrm{ft}$ below the equilibrium position and the subsequent motion takes place in a medium that offers a damping force numerically equal to $1 / 2$ the instantaneous velocity. Find the equation of motion, if the weight is driven by an external force equal to $f(t)=10 \cos 3 t$.
2. A mass 1 -slug, when attached to a spring, stretches it 2 - ft and then comes to rest in the equilibrium position. Starting at $t=0$, an external force equal to $f(t)=8 \sin 4 t$ is applied to the system. Find the equation of motion if the surrounding medium offers a damping force numerically equal to 8 times the instantaneous velocity.
3. In problem 2 determine the equation of motion if the external force is $f(t)=e^{-t} \sin 4 t$. Analyze the displacements for $t \rightarrow \infty$.
4. When a mass of 2 kilograms is attached to a spring whose constant is $32 \mathrm{~N} / \mathrm{m}$, it comes to rest in the equilibrium position. Starting at $t=0$, a force equal to $f(t)=68 e^{-2 t} \cos 4 t$ is applied to the system. Find the equation of motion in the absence of damping.
5. In problem 4 write the equation of motion in the form

$$
x(t)=A \sin (\omega t+\varphi)+B e^{-2 t} \sin (4 t+\theta) .

6. Find the charge on the capacitor and the current in an $L C$ series circuit. Where $L=1$ Henry, $C=\frac{1}{16}$ farad, $E(t)=60$ volts . Assuming that $q(0)=0$ and $i(0)=0$.
7. Determine whether an $L R C$ series circuit, where $L=3$ Henrys, $R=10$ ohms, $C=0.1$ farad is over-damped, critically damped or under-damped.

## Lecture 26

## Differential Equations with Variable Coefficients

So far we have been solving Linear Differential Equations with constant coefficients.
We will now discuss the Differential Equations with non-constant (variable) coefficients.

These equations normally arise in applications such as temperature or potential $\boldsymbol{U}$ in the region bounded between two concentric spheres. Then under some circumstances we have to solve the differential equation:

$$
r \frac{d^{2} u}{d r^{2}}+2 \frac{d u}{d r}=0
$$

where the variable $r>0$ represents the radial distance measured outward from the center of the spheres.

Differential equations with variable coefficients such as

$$
\begin{aligned}
& x^{2} y^{\prime \prime}+x y^{\prime}+\left(x^{2}-v^{2}\right) y=0 \\
& \left(1-x^{2}\right) y^{\prime \prime}-2 x y^{\prime}+n(n+1) y=0
\end{aligned}
$$

and $\quad y^{\prime \prime}-2 x y^{\prime}+2 n y=0$
occur in applications ranging from potential problems, temperature distributions and vibration phenomena to quantum mechanics.

The differential equations with variable coefficients cannot be solved so easily.

## Cauchy- Euler Equation:

Any linear differential equation of the form

$$
a_{n} x^{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} x^{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} x \frac{d y}{d x}+a_{0} y=g(x)
$$

where $a_{n}, a_{n-1}, \cdots, a_{0}$ are constants, is said to be a Cauchy-Euler equation or equidimensional equation. The degree of each monomial coefficient matches the order of differentiation i.e $x^{n}$ is the coefficient of nth derivative of $y, x^{n-1}$ of ( $n-1$ )th derivative of y , etc.

For convenience we consider a homogeneous second-order differential equation

$$
a x^{2} \frac{d^{2} y}{d x^{2}}+b x \frac{d y}{d x}+c y=0, \quad x \neq 0
$$

The solution of higher-order equations follows analogously.

Also, we can solve the non-homogeneous equation

$$
a x^{2} \frac{d^{2} y}{d x^{2}}+b x \frac{d y}{d x}+c y=g(x), \quad x \neq 0
$$

by variation of parameters after finding the complementary function $y_{c}(x)$.
We find the general solution on the interval $(0, \infty)$ and the solution on $(0,-\infty)$ can be obtained by substituting $t=-x$ in the differential equation.

## Method of Solution:

We try a solution of the form $y=x^{m}$, where $m$ is to be determined. The first and second derivatives are, respectively,

$$
\frac{d y}{d x}=m x^{m-1} \quad \text { and } \quad \frac{d^{2} y}{d x^{2}}=m(m-1) x^{m-2}
$$

Consequently the differential equation becomes

$$
\begin{aligned}
a x^{2} \frac{d^{2} y}{d x^{2}}+b x \frac{d y}{d x}+c y & =a x^{2} \cdot m(m-1) x^{m-2}+b x \cdot m x^{m-1}+c x^{m} \\
& =a m(m-1) x^{m}+b m x^{m}+c x^{m} \\
& =x^{m}(a m(m-1)+b m+c)
\end{aligned}
$$

Thus $y=x^{m}$ is a solution of the differential equation whenever $m$ is a solution of the auxiliary equation

$$
(a m(m-1)+b m+c)=0 \text { or } a m^{2}+(b-a) m+c=0
$$

The solution of the differential equation depends on the roots of the AE.

## Case-I: Distinct Real Roots

Let $m_{1}$ and $m_{2}$ denote the real roots of the auxiliary equation such that $m_{1} \neq m_{2}$. Then

$$
y=x^{m_{1}} \text { and } y=x^{m_{2}} \text { form a fundamental set of solutions. }
$$

Hence the general solution is

$$
y=c_{1} x^{m_{1}}+c_{2} x^{m_{2}} .
$$

## Example 1

$$
\text { Solve } \quad x^{2} \frac{d^{2} y}{d x^{2}}-2 x \frac{d y}{d x}-4 y=0
$$

## Solution:

Suppose that $y=x^{m}$, then

$$
\frac{d y}{d x}=m x^{m-1} \quad, \quad \frac{d^{2} y}{d x^{2}}=m(m-1) x^{m-2}
$$

Now substituting in the differential equation, we get:

$$
\begin{gathered}
x^{2} \frac{d^{2} y}{d x^{2}}-2 x \frac{d y}{d x}-4 y=x^{2} \cdot m(m-1) x^{m-2}-2 x \cdot m x^{m-1}-4 x^{m} \\
=x^{m}(m(m-1)-2 m-4) \\
x^{m}\left(m^{2}-3 m-4\right)=0 \quad \text { if } m^{2}-3 m-4=0
\end{gathered}
$$

This implies $m_{1}=-1, m_{2}=4$; roots are real and distinct.
So the solution is $\quad y=c_{1} x^{-1}+c_{2} x^{4}$.

## Case II: Repeated Real Roots

If the roots of the auxiliary equation are repeated, that is, then we obtain only one solution $y=x^{m_{1}}$.

To construct a second solution $y_{2}$, we first write the Cauchy-Euler equation in the form

$$
\frac{d^{2} y}{d x^{2}}+\frac{b}{a x} \frac{d y}{d x}+\frac{c}{a x^{2}} y=0
$$

Comparing with

$$
\frac{d^{2} y}{d x^{2}}+P(x) \frac{d y}{d x}+Q(x) y=0
$$

We make the identification $P(x)=\frac{b}{a x}$. Thus

$$
\begin{aligned}
y_{2} & =x^{m_{1}} \int \frac{e^{\int \frac{b}{a x} d x}}{\left(x^{m_{1}}\right)^{2}} d x \\
& =x^{m_{1}} \int \frac{e^{-\left(\frac{b}{a}\right) \ln x}}{x^{2 m_{1}}} d x \\
& =x^{m_{1}} \int x^{-\frac{b}{a}} \cdot x^{-2 m_{1}} d x
\end{aligned}
$$

Since roots of the AE $a m^{2}+(b-a) m+c=0$ are equal, therefore discriminant is zero

$$
\text { i.e } \begin{aligned}
m_{1} & =-\frac{(b-a)}{2 a} \text { or }-2 m_{1}=+\frac{(b-a)}{a} \\
y_{2} & =x^{m_{1}} \int x^{\frac{-b}{a}} \cdot x^{\frac{b-a}{a}} d x \\
y_{2} & =x^{m_{1}} \int \frac{d x}{x}=x^{m_{1}} \ln x .
\end{aligned}
$$

The general solution is then

$$
y=c_{1} x^{m_{1}}+c_{2} x^{m_{1}} \ln x
$$

## Example 2

Solve

$$
4 x^{2} \frac{d^{2} y}{d x^{2}}+8 x \frac{d y}{d x}+y=0
$$

## Solution:

Suppose that $y=x^{m}$, then

$$
\frac{d y}{d x}=m x^{m-1} \quad, \quad \frac{d^{2} y}{d x^{2}}=m(m-1) x^{m-2}
$$

Substituting in the differential equation, we get:

$$
\begin{aligned}
& 4 x^{2} \frac{d^{2} y}{d x^{2}}+8 x \frac{d y}{d x}+y=x^{m}(4 m(m-1)+8 m+1)=x^{m}\left(4 m^{2}+4 m+1\right)=0 \\
& \text { if } 4 m^{2}+4 m+1=0 \text { or }(2 m+1)^{2}=0
\end{aligned}
$$

Since $m_{1}=-\frac{1}{2}$, the general solution is

$$
y=c_{1} x^{-\frac{1}{2}}+c_{2} x^{-\frac{1}{2}} \ln x
$$

For higher order equations, if $m_{1}$ is a root of multiplicity $k$, then it can be shown that: $x^{m_{1}}, x^{m_{1}} \ln x, x^{m_{1}}(\ln x)^{2}, \cdots, x^{m_{1}}(\ln x)^{k-1}$ are k linearly independent solutions.

Correspondingly, the general solution of the differential equation must then contain a linear combination of these k solutions.

## Case III Conjugate Complex Roots

If the roots of the auxiliary equation are the conjugate pair

$$
m_{1}=\alpha+i \beta, \quad m_{2}=\alpha-i \beta
$$

where $\alpha$ and $\beta>0$ are real, then the solution is

$$
y=c_{1} x^{\alpha+i \beta}+c_{2} x^{\alpha-i \beta}
$$

But, as in the case of equations with constant coefficients, when the roots of the auxiliary equation are complex, we wish to write the solution in terms of real functions only. We note the identity

$$
x^{i \beta}=\left(e^{\ln x}\right)^{i \beta}=e^{i \beta \ln x}
$$

which, by Euler's formula, is the same as

$$
x^{i \beta}=\cos (\beta \ln x)+i \sin (\beta \ln x)
$$

Similarly we have

$$
x^{-i \beta}=\cos (\beta \ln x)-i \sin (\beta \ln x)
$$

Adding and subtracting last two results yields, respectively,

$$
\begin{aligned}
& x^{i \beta}+x^{-i \beta}=2 \cos (\beta \ln x) \\
& x^{i \beta}-x^{-i \beta}=2 i \sin (\beta \ln x)
\end{aligned}
$$

and

From the fact that $y=c_{1} x^{\alpha+i \beta}+c_{2} x^{\alpha-i \beta}$ is the solution of $a x^{2} y^{\prime \prime}+b x y^{\prime}+c y=0$, for any values of constants $c_{1}$ and $c_{2}$, we see that

$$
\begin{array}{ll} 
& y_{1}=x^{\alpha}\left(x^{i \beta}+x^{-i \beta}\right), \quad\left(c_{1}=c_{2}=1\right) \\
y_{2}=x^{\alpha}\left(x^{i \beta}-x^{-i \beta}\right), \quad\left(c_{1}=1, c_{2}=-1\right) \\
\text { or } \quad & y_{1}=2 x^{\alpha}(\cos (\beta \ln x)) \\
y_{2}=2 x^{\alpha}(\sin (\beta \ln x)) \quad \text { are also solutions. }
\end{array}
$$

Since $W\left(x^{\alpha} \cos (\beta \ln x), x^{\alpha} \sin (\beta \ln x)\right)=\beta x^{2 \alpha-1} \neq 0 ; \beta>0$, on the interval $(0, \infty)$, we conclude that

$$
y_{1}=x^{\alpha} \cos (\beta \ln x) \text { and } y_{2}=x^{\alpha} \sin (\beta \ln x)
$$

constitute a fundamental set of real solutions of the differential equation.
Hence the general solution is

$$
y_{1}=x^{\alpha}\left[c_{1} \cos (\beta \ln x)+c_{2} \sin (\beta \ln x)\right]
$$

## Example 3

Solve the initial value problem

$$
x^{2} \frac{d^{2} y}{d x^{2}}+3 x \frac{d y}{d x}+3 y=0, \quad y(1)=1, y^{\prime}(1)=-5
$$

## Solution:

Let us suppose that: $\quad y=x^{m}$, then $\frac{d y}{d x}=m x^{m-1}$ and $\frac{d^{2} y}{d x^{2}}=m(m-1) x^{m-2}$.

$$
x^{2} \frac{d^{2} y}{d x^{2}}+3 x \frac{d y}{d x}+3 y=x^{m}(m(m-1)+3 m+3)=x^{m}\left(m^{2}+2 m+3\right)=0
$$

$$
\text { if } \quad m^{2}+2 m+3=0
$$

From the quadratic formula we find that $m_{1}=-1+\sqrt{2} i$ and $m_{1}=-1-\sqrt{2} i$. If we make the identifications $\alpha=-1$ and $\beta=\sqrt{2}$, so the general solution of the differential equation is

$$
y_{1}=x^{-1}\left[c_{1} \cos (\sqrt{2} \ln x)+c_{2} \sin (\sqrt{2} \ln x)\right] .
$$

By applying the conditions $y(1)=1, y^{\prime}(1)=-5$, we find that

$$
c_{1}=1 \quad \text { and } c_{2}=-2 \sqrt{2} .
$$

Thus the solution to the initial value problem is

$$
y_{1}=x^{-1}[\cos (\sqrt{2} \ln x)-2 \sqrt{2} \sin (\sqrt{2} \ln x)]
$$

## Example 4

Solve the third-order Cauchy-Euler differential equation

$$
x^{3} \frac{d^{3} y}{d x^{3}}+5 x^{2} \frac{d^{2} y}{d x^{2}}+7 x \frac{d y}{d x}+8 y=0
$$

## Solution

The first three derivative of $y=x^{m}$ are

$$
\frac{d y}{d x}=m x^{m-1}, \frac{d^{2} y}{d x^{2}}=m(m-1) x^{m-2}, \frac{d^{3} y}{d x^{3}}=m(m-1)(m-2) x^{m-3},
$$

so the given differential equation becomes

$$
\begin{aligned}
x^{3} \frac{d^{3} y}{d x^{3}}+5 x^{2} \frac{d^{2} y}{d x^{2}}+7 x \frac{d y}{d x}+8 y & =x^{3} m(m-1)(m-2) x^{m-3}+5 x^{2} m(m-1) x^{m-2}+7 x m x^{m-1}+8 x^{m} \\
& =x^{m}(m(m-1)(m-2)+5 m(m-1)+7 m+8) \\
& =x^{m}\left(m^{3}+2 m^{2}+4 m+8\right)
\end{aligned}
$$

In this case we see that $y=x^{m}$ is a solution of the differential equation, provided $m$ is a root of the cubic equation

$$
\begin{aligned}
& m^{3}+2 m^{2}+4 m+8=0 \\
& \text { or }(m+2)\left(m^{2}+4\right)=0
\end{aligned}
$$

The roots are: $m_{1}=-2, m_{2}=2 i, m_{3}=-2 i$.
Hence the general solution is

$$
y_{1}=c_{1} x^{-2}+c_{2} \cos (2 \ln x)+c_{3} \sin (2 \ln x)
$$

## Example 5

Solve the non-homogeneous equation

$$
x^{2} y^{\prime \prime}-3 x y^{\prime}+3 y=2 x^{4} e^{x}
$$

## Solution

Put $y=x^{m}$

$$
\frac{d y}{d x}=m x^{m-1}, \frac{d^{2} y}{d x^{2}}=m(m-1) x^{m-2}
$$

Therefore we get the auxiliary equation,

$$
m(m-1)-3 m+3=0 \text { or }(m-1)(m-3)=0 \text { or } m=1,3
$$

Thus $y_{c}=c_{1} x+c_{2} x^{3}$
Before using variation of parameters to find the particular solution $y_{p}=u_{1} y_{1}+u_{2} y_{2}$,
recall that the formulas $u_{1}^{\prime}=\frac{W_{1}}{W}$ and $u_{2}^{\prime}=\frac{W_{2}}{W}$, where $W_{1}=\left|\begin{array}{cc}0 & y_{2} \\ f(x) & y_{2}^{\prime}\end{array}\right|, W_{2}=\left|\begin{array}{cc}y_{1} & 0 \\ y_{1}^{\prime} & f(x)\end{array}\right|$,
and W is the Wronskian of $y_{1}$ and $y_{2}$, were derived under the assumption that the differential equation has been put into special form $. y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=f(x)$
Therefore we divide the given equation by $x^{2}$, and form $y^{\prime \prime}-\frac{3}{x} y^{\prime}+\frac{3}{x^{2}} y=2 x^{2} e^{x}$ we make the identification $f(x)=2 x^{2} e^{x}$. Now with $y_{1}=x, y_{2}=x^{2}$, and

$$
W=\left|\begin{array}{cc}
x & x^{3} \\
1 & 3 x^{2}
\end{array}\right|=2 x^{3}, \quad W_{1}=\left|\begin{array}{cc}
0 & x^{3} \\
2 x^{2} e^{x} & 3 x^{2}
\end{array}\right|=-2 x^{5} e^{x}, \quad W_{2}=\left|\begin{array}{cc}
x & x \\
1 & 2 x^{2} e^{x}
\end{array}\right|=2 x^{3} e^{x}
$$

we find

$$
\begin{aligned}
& u_{1}^{\prime}=\frac{2 x^{5} e^{x}}{2 x^{3}}=-x^{2} e^{x} \text { and } \quad u_{2}^{\prime}=\frac{2 x^{3} e^{x}}{2 x^{3}}=e^{x} \\
& u_{1}=-x^{2} e^{x}+2 x e^{x}-2 e^{x} \text { and } u_{2}=e^{x} .
\end{aligned}
$$

Hence

$$
\begin{aligned}
y_{p} & =u_{1} y_{1}+u_{2} y_{2} \\
& =\left(-x^{2} e^{x}+2 x e^{x}-2 e^{x}\right) x+e^{x} x^{3}=2 x^{2} e^{x}-2 x e^{x}
\end{aligned}
$$

Finally we have $y=y_{c}+y_{p}=c_{1} x+c_{2} x^{3}+2 x^{2} e^{x}-2 x e^{x}$

## Lecture 27

## Cauchy-Euler Equation: Alternative Method of Solution

We reduce any Cauchy-Euler differential equation to a differential equation with constant coefficients through the substitution

$$
\begin{aligned}
& x=e^{t} \text { or } t=\ln x \\
& \therefore \frac{d y}{d x}=\frac{d y}{d t} \cdot \frac{d t}{d x}=\frac{1}{x} \cdot \frac{d y}{d t} \\
& \frac{d^{2} y}{d x^{2}}=\frac{d}{d x}\left(\frac{1}{x} \cdot \frac{d y}{d t}\right)=\frac{1}{x} \cdot \frac{d}{d x}\left(\frac{d y}{d t}\right)-\frac{1}{x^{2}} \cdot \frac{d y}{d t} \\
& \text { or } \quad \frac{d^{2} y}{d x^{2}}=\frac{1}{x} \cdot \frac{d}{d t}\left(\frac{d y}{d t}\right) \frac{d t}{d x}-\frac{1}{x^{2}} \cdot \frac{d y}{d t} \\
& \text { or } \quad \frac{d^{2} y}{d x^{2}}=\frac{1}{x^{2}} \cdot \frac{d^{2} y}{d t^{2}}-\frac{1}{x^{2}} \cdot \frac{d y}{d t}
\end{aligned}
$$

Therefore

$$
x \frac{d y}{d x}=\frac{d y}{d t}, x^{2} \frac{d^{2} y}{d x^{2}}=\frac{d^{2} y}{d t^{2}}-\frac{d y}{d t}
$$

Now introduce the notation

$$
D=\frac{d}{d x}, D^{2}=\frac{d^{2}}{d x^{2}}, \text { etc. }
$$

and

$$
\Delta=\frac{d}{d t}, \Delta^{2}=\frac{d^{2}}{d t^{2}}, \quad \text { etc. }
$$

Therefore, we have

$$
\begin{aligned}
& x D=\Delta \\
& x^{2} D^{2}=\Delta^{2}-\Delta=\Delta(\Delta-1)
\end{aligned}
$$

Similarly

$$
\begin{aligned}
& x^{3} D^{3}=\Delta(\Delta-1)(\Delta-2) \\
& x^{4} D^{4}=\Delta(\Delta-1)(\Delta-2)(\Delta-3) \text { so on so forth. }
\end{aligned}
$$

This substitution in a given Cauchy-Euler differential equation will reduce it into a differential equation with constant coefficients.

At this stage we suppose $y=e^{m t}$ to obtain an auxiliary equation and write the solution in terms of y and t . We then go back to $x$ through $x=e^{t}$.

## Example 1

Solve $x^{2} \frac{d^{2} y}{d x^{2}}-2 x \frac{d y}{d x}-4 y=0$

## Solution

The given differential equation can be written as

$$
\left(x^{2} D^{2}-2 x D-4\right) y=0
$$

With the substitution $x=e^{t}$ or $t=\ln x$, we obtain

$$
x D=\Delta, \quad x^{2} D^{2}=\Delta(\Delta-1)
$$

Therefore the equation becomes:

$$
[\Delta(\Delta-1)-2 \Delta-4] y=0
$$

or $\quad\left(\Delta^{2}-3 \Delta-4\right) y=0$
or $\frac{d^{2} y}{d t^{2}}-3 \frac{d y}{d t}-4 y=0$
Now substitute: $y=e^{m t}$ then $\frac{d y}{d t}=m e^{m t}, \frac{d^{2} y}{d t^{2}}=m^{2} e^{m t}$
Thus $\left(m^{2}-3 m-4\right) e^{m t}=0$ or $m^{2}-3 m-4=0$, which is the auxiliary equation.

$$
(m+1)(m-4)=0 \quad m=-1,4
$$

The roots of the auxiliary equation are distinct and real, so the solution is

$$
y=c_{1} e^{-t}+c_{2} e^{4 t}
$$

But $x=e^{t}$, therefore the answer will be

$$
y=c_{1} x^{-1}+c_{2} x^{4}
$$

## Example 2

Solve $4 x^{2} \frac{d^{2} y}{d x^{2}}+8 x \frac{d y}{d x}+y=0$

## Solution

The differential equation can be written as:

$$
\left(4 x^{2} D^{2}+8 x D+1\right) y=0
$$

Where $D=\frac{d}{d x}, D^{2}=\frac{d^{2}}{d x^{2}}$
Now with the substitution $x=e^{t}$ or $t=\ln x, x D=\Delta, x^{2} D^{2}=\Delta(\Delta-1)$ where $\Delta=\frac{d}{d t}$
The equation becomes:

$$
\begin{aligned}
& (4 \Delta(\Delta-1)+8 \Delta+1) y=0 \quad \text { or }\left(4 \Delta^{2}+4 \Delta+1\right) y=0 \\
& 4 \frac{d^{2} y}{d t^{2}}+4 \frac{d y}{d t}+y=0
\end{aligned}
$$

Now substituting $y=e^{m t}$ then $\frac{d y}{d t}=m e^{m t}, \frac{d^{2} y}{d t^{2}}=m^{2} e^{m t}$, we get

$$
\left(4 m^{2}+4 m+1\right) e^{m t}=0
$$

$$
\text { or } 4 m^{2}+4 m+1=0 \text { or }(2 m+1)^{2}=0
$$

or $m=-\frac{1}{2},-\frac{1}{2}$; the roots are real but repeated.
Therefore the solution is

$$
\begin{aligned}
& y=\left(c_{1}+c_{2} t\right) e^{-\frac{1}{2} t} \\
& \text { or } y=\left(c_{1}+c_{2} \ln x\right) x^{-\frac{1}{2}} \\
& \text { i-e } y=c_{1} x^{-\frac{1}{2}}+c_{2} x^{-\frac{1}{2}} \ln x
\end{aligned}
$$

## Example 3

Solve the initial value problem

$$
x^{2} \frac{d^{2} y}{d x^{2}}+3 x \frac{d y}{d x}+3 y=0, y(1)=1, y^{\prime}(1)=-5
$$

## Solution

The given differential can be written as:

$$
\left(x^{2} D^{2}+3 x D+3\right) y=0
$$

Now with the substitution $x=e^{t}$ or $t=\ln x$ we have:

$$
x D=\Delta, x^{2} D^{2}=\Delta(\Delta-1)
$$

Thus the equation becomes:

$$
\begin{aligned}
& (\Delta(\Delta-1)+3 \Delta+3) y=0 \text { or }\left(\Delta^{2}+2 \Delta+3\right) y=0 \\
& \frac{d^{2} y}{d t^{2}}+2 \frac{d y}{d t}+3 y=0
\end{aligned}
$$

Put $y=e^{m t}$ then the A.E. equation is:

$$
\begin{aligned}
& \text { or } m^{2}+2 m+3=0 \\
& \text { or } m=\frac{-2 \pm \sqrt{4-12}}{2}=-1 \pm i \sqrt{2}
\end{aligned}
$$

So that solution is:

$$
\begin{aligned}
& y=e^{-t}\left(c_{1} \cos \sqrt{2} t+c_{2} \sin \sqrt{2} t\right) \\
& \text { or } y=x^{-1}\left(c_{1} \cos \sqrt{2} \ln x+c_{2} \sin \sqrt{2} \ln x\right)
\end{aligned}
$$

Now $y(1)=1$ gives, $1=\left(c_{1} \cos 0+c_{2} \sin 0\right) \Rightarrow c_{1}=1$
$y^{\prime}=-x^{-2}\left(c_{1} \cos \sqrt{2} \ln x+c_{2} \sin \sqrt{2} \ln x\right)+x^{-2}\left(-\sqrt{2} c_{1} \sin \sqrt{2} \ln x+\sqrt{2} c_{2} \cos \sqrt{2} \ln x\right)$
$\therefore y^{\prime}(1)=-5$ gives: $-5=-\left[c_{1}+0\right]+\left[\sqrt{2} c_{2}\right]$ or $\sqrt{2} c_{2}=c_{1}-5=-4, c_{2}=\frac{-4}{\sqrt{2}}=-2 \sqrt{2}$
Hence solution of the IVP is:

$$
y=x^{-1}[\cos (\sqrt{2} \ln x)-2 \sqrt{2} \sin (\sqrt{2} \ln x)] .
$$

## Example 4

Solve $x^{3} \frac{d^{3} y}{d x^{3}}+5 x^{2} \frac{d^{2} y}{d x^{2}}+7 x \frac{d y}{d x}+8 y=0$

## Solution

The given differential equation can be written as:

$$
\left(x^{3} D^{3}+5 x^{2} D^{2}+7 x D+8\right) y=0
$$

Now with the substitution $x=e^{t}$ or $t=\ln x$ we have:

$$
x D=\Delta, x^{2} D^{2}=\Delta(\Delta-1), x^{3} D^{3}=\Delta(\Delta-1)(\Delta-2)
$$

So the equation becomes:

$$
\begin{aligned}
& (\Delta(\Delta-1)(\Delta-2)+5 \Delta(\Delta-1)+7 \Delta+8) y=0 \\
& \text { or }\left(\Delta^{3}-3 \Delta^{2}+2 \Delta+5 \Delta^{2}-5 \Delta+7 \Delta+8\right) y=0 \\
& \text { or }\left(\Delta^{3}+2 \Delta^{2}+4 \Delta+8\right) y=0 \\
& \text { or } \frac{d^{3} y}{d t^{3}}+2 \frac{d^{2} y}{d t^{2}}+4 \frac{d y}{d t}+8 y=0
\end{aligned}
$$

Put $y=e^{m t}$, then the auxiliary equation is:

$$
\begin{gathered}
m^{3}+2 m^{2}+4 m+8=0 \\
\text { or }\left(m^{2}+4\right)(m+2)=0 \\
m=-2, \text { or } \pm 2 i
\end{gathered}
$$

So the solution is:

$$
y=c_{1} e^{-2 t}+c_{2} \cos 2 t+c_{3} \sin 2 t
$$

or

$$
y=c_{1} x^{-2}+c_{2} \cos (2 \ln x)+c_{3} \sin (2 \ln x)
$$

## Example 5

Solve the non-homogeneous differential equation

$$
x^{2} y^{\prime \prime}-3 x y^{\prime}+3 y=2 x^{4} e^{x}
$$

## Solution

First consider the associated homogeneous differential equation.

$$
x^{2} y^{\prime \prime}-3 x y^{\prime}+3 y=0
$$

With the notation $\frac{d}{d x}=D, \frac{d^{2}}{d x^{2}}=D^{2}$, the differential equation becomes:

$$
\left(x^{2} D^{2}-3 x D+3\right) y=0
$$

With the substitution $x=e^{t}$ or $t=\ln x$, we have:

$$
x D=\Delta, \quad x^{2} D^{2}=\Delta(\Delta-1)
$$

So the homogeneous differential equation becomes:

$$
\begin{aligned}
& {[\Delta(\Delta-1)-3 \Delta+3] y=0} \\
& \\
& \left(\Delta^{2}-4 \Delta+3\right) y=0 \\
& \text { or } \quad \frac{d^{2} y}{d t^{2}}-4 \frac{d y}{d t}+3 y=0
\end{aligned}
$$

Put $y=e^{m t}$ then the AE is:

$$
\begin{aligned}
& m^{2}-4 m+3=0 \text { or }(m-3)(m-1)=0, \text { or } \quad m=1,3 \\
& \therefore y_{C}=c_{1} e^{t}+c_{2} e^{3 t}, \text { as } x=e^{t} \\
& \quad y_{C}=c_{1} x+c_{2} x^{3}
\end{aligned}
$$

For $y_{p}$ we write the differential equation as:

$$
\begin{aligned}
& y^{\prime \prime}-\frac{3}{x} y^{\prime}+\frac{3}{x^{2}} y=2 x^{2} e^{x} \\
& y_{p}=u_{1} x+u_{2} x^{3}, \text { where } u_{1} \text { and } u_{2} \text { are functions given by } \\
& u_{1}^{\prime}=\frac{W_{1}}{W}, u_{2}^{\prime}=\frac{W_{2}}{W}
\end{aligned}
$$

with

$$
\begin{aligned}
& W=\left|\begin{array}{cc}
x & x^{3} \\
1 & 3 x^{2}
\end{array}\right|=2 x^{3}, W_{1}=\left|\begin{array}{cc}
0 & x^{3} \\
2 x^{2} e^{x} & 3 x^{2}
\end{array}\right|=-2 x^{5} e^{x} \text { and } \\
& W_{2}=\left|\begin{array}{cc}
x & 0 \\
1 & 2 x^{2} e^{x}
\end{array}\right|=2 x^{3} e^{x}
\end{aligned}
$$

So that $\quad u^{\prime}{ }_{1}=\frac{2 x^{5} e^{x}}{2 x^{3}}=-x^{2} e^{x} \quad$ and $u^{\prime}{ }_{2}=\frac{2 x^{3} e^{x}}{2 x^{3}}=e^{x}$

$$
\begin{aligned}
\therefore u_{1} & =-\int x^{2} e^{x} d x=-\left[x^{2} e^{x}-2 \int x e^{x} d x\right] \\
& =-x^{2} e^{x}+2\left[x e^{x}-\int e^{x} d x\right] \\
& =-x^{2} e^{x}+2 x e^{x}-2 e^{x}
\end{aligned}
$$

$$
\text { and } u_{2}=\int e^{x} d x=e^{x}
$$

Therefore

$$
y_{p}=x\left(-x^{2} e^{x}+2 x e^{x}-2 e^{x}\right)+x^{3} e^{x}=2 x^{2} e^{x}-2 x e^{x}
$$

Hence the general solution is:

$$
\begin{aligned}
& y=y_{c}+y_{p} \\
& y=c_{1} x+c_{2} x^{3}+2 x^{2} e^{x}-2 x e^{x}
\end{aligned}
$$

## Example 6

Solve $x^{2} \frac{d^{2} y}{d x^{2}}-x \frac{d y}{d x}+y=\ln x$

## Solution

Consider the associated homogeneous differential equation.

$$
\begin{aligned}
& x^{2} \frac{d^{2} y}{d x^{2}}-x \frac{d y}{d x}+y=0 \\
& \text { or }\left(x^{2} D^{2}-x D+1\right) y=0
\end{aligned}
$$

With the substitution $x=e^{t}$, we have:

$$
x D=\Delta, x^{2} D^{2}=\Delta(\Delta-1)
$$

So the homogeneous differential equation becomes:

$$
\begin{aligned}
& {[\Delta(\Delta-1)-\Delta+1] y=0} \\
& \\
& \text { or } \quad \\
& \frac{\left.\Delta^{2}-2 \Delta+1\right) y=0}{d t^{2}}-2 \frac{d y}{d t}+y=0
\end{aligned}
$$

Putting $y=e^{m t}$, we get the auxiliary equation as:

$$
m^{2}-2 m+1=0 \text { or }(m-1)^{2}=0 \quad \text { or } \quad m=1,1
$$

$$
\begin{aligned}
\therefore y_{C} & =c_{1} e^{t}+c_{2} t e^{t} \\
\text { or } \quad y_{C} & =c_{1} x+c_{2} x \ln x
\end{aligned}
$$

Now the non-homogeneous differential equation becomes:

$$
\frac{d^{2} y}{d t^{2}}-2 \frac{d y}{d t}+y=t
$$

By the method of undetermined coefficients we try a particular solution of the form $y_{p}=A+B t$. This assumption leads to

$$
-2 B+A+B t=t \text { so that } A=2 \text { and } B=1 .
$$

Using $y=y_{c}+y_{p}$, we get

$$
y_{c}=c_{1} e^{t}+c_{2} t e^{t}+2+t
$$

So the general solution of the original differential equation on the interval $(0, \infty)$ is

$$
y_{C}=c_{1} x+c_{2} x \ln x+2+\ln x
$$

## Lecture 28

## Power Series: An Introduction

- A standard technique for solving linear differential equations with variable coefficients is to find a solution as an infinite series. Often this solution can be found in the form of a power series.
- Therefore, in this lecture we discuss some of the more important facts about power series.
- However, for an in-depth review of the infinite series concept one should consult a standard calculus text.


## Power Series

A power series $\operatorname{in}(x-a)$ is an infinite series of the form

$$
\sum_{n=0}^{\infty} c_{n}(x-a)^{n}=c_{0}+c_{1}(x-a)+c_{2}(x-a)^{2}+\cdots
$$

The coefficients $c_{0}, c_{1}, c_{2}, \ldots$ and $a$ are constants and $x$ represents a variable. In this discussion we will only be concerned with the cases where the coefficients, $x$ and $a$ are real numbers. The number $a$ is known as the centre of the power series.

## Example 1

The infinite series

$$
\sum_{n=1}^{\infty} \frac{(-1)^{n+1}}{n^{2}} x^{n}=x-\frac{x^{2}}{2^{2}}+\frac{x^{3}}{3^{2}}-\cdots
$$

is a power series in $x$. This series is centered at zero.

## Convergence and Divergence

- If we choose a specified value of the variable $x$ then the power series becomes an infinite series of constants. If, for the given $x$, the sum of terms of the power series equals a finite real number, then the series is said to be convergent at $x$.
- A power series that is not convergent is said to be a divergent series. This means that the sum of terms of a divergent power series is not equal to a finite real number.


## Example 2

(a) Consider the power series

$$
\sum_{n=0}^{\infty} \frac{x^{n}}{n!}=1+x+\frac{x^{2}}{2!}+\frac{x^{3}}{3!}+\cdots
$$

Since for $x=1$ the series become

$$
\sum_{n=0}^{\infty} \frac{x^{n}}{n!}=1+1+\frac{1}{2!}+\frac{1}{3!}+\cdots=e
$$

Therefore, the power series converges $x=1$ to the number $e$
(b) Consider the power series

$$
\sum_{n=0}^{\infty} n!(x+2)^{n}=1+(x+2)+2!(x+2)^{2}+3!(x+2)^{3}+\cdots
$$

The series diverges $\forall x$, except at $x=-2$. For instance, if we take $x=1$ then the series becomes

$$
\sum_{n=0}^{\infty} n!(x+2)^{n}=1+3+18+\cdots
$$

Clearly the sum of all terms on right hand side is not a finite number. Therefore, the series is divergent at $x=1$. Similarly, we can see its divergence at all other values of $x \neq-2$

## The Ratio Test

To determine for which values of $x$ a power series is convergent, one can often use the Ratio Test. The Ratio test states that if

$$
\sum_{n=0}^{\infty} a_{n}=\sum_{n=0}^{\infty} c_{n}(x-a)^{n}
$$

is a power series and

$$
\lim _{n \rightarrow \infty}\left|\frac{a_{n+1}}{a_{n}}\right|=\lim _{n \rightarrow \infty}\left|\frac{c_{n+1}}{c_{n}}\right||x-a|=L
$$

Then:

- The power series converges absolutely for those values of $x$ for which $L<1$.
- The power series diverges for those values of $x$ for which $L>1$ or $L=\infty$.
- The test is inconclusive for those values of $x$ for which $L=1$.


## Interval of Convergence

The set of all real values of $x$ for which a power series

$$
\sum_{n=0}^{\infty} c_{n}(x-a)^{n}
$$

converges is known as the interval of convergence of the power series.

## Radius of Convergence

Consider a power series

$$
\sum_{n=0}^{\infty} c_{n}(x-a)^{n}
$$

Then exactly one of the following three possibilities is true:

- The series converges only at its center $x=a$.
- The series converges for all values of $x$.
- There is a number $R>0$ such that the series converges absolutely $\forall x$ satisfying $|x-a|<R$ and diverges for $|x-a|>R$. This means that the series converges for $x \in(a-R, a+R)$ and diverges out side this interval.
The number $R$ is called the radius of convergence of the power series. If first possibility holds then $R=0$ and in case of $2^{\text {nd }}$ possibility we write $R=\infty$.
From the Ratio test we can clearly see that the radius of convergence is given by

$$
R=\lim _{n \rightarrow \infty}\left|\frac{c_{n}}{c_{n+1}}\right|
$$

provided the limit exists.

## Convergence at an Endpoint

If the radius of convergence of a power series is $R>0$, then the interval of convergence of the series is one of the following

$$
(a-R, a+R),(a-R, a+R],[a-R, a+R),[a-R, a+R]
$$

To determine which of these intervals is the interval of convergence, we must conduct separate investigations for the numbers $x=a-R$ and $x=a+R$.

## Example 3

Consider the power series

Then

$$
\begin{aligned}
& \sum_{n=1}^{\infty} a_{n}=\sum_{n=1}^{\infty} \frac{1}{\sqrt{n}} x^{n} \\
& \lim _{n \rightarrow \infty}\left|\frac{a_{n+1}}{a_{n}}\right|=\lim _{n \rightarrow \infty}\left|\frac{x^{n+1}}{\sqrt{n+1}} \cdot \frac{\sqrt{n}}{x^{n}}\right|
\end{aligned}
$$

or

$$
\lim _{n \rightarrow \infty}\left|\frac{a_{n+1}}{a_{n}}\right|=\lim _{n \rightarrow \infty}\left|\sqrt{\frac{n}{n+1}} \cdot x\right|=\lim _{n \rightarrow \infty}\left|\sqrt{\frac{n}{n+1}}\right||x|=|x|
$$

Therefore, it follows from the Ratio Test that the power series converges absolutely for those values of $x$ which satisfy

$$
|x|<1
$$

This means that the power series converges if $x$ belongs to the interval

$$
(-1,1)
$$

The series diverges outside this interval i.e. when $x>1$ or $x<-1$. The convergence of the power series at the numbers 1 and -1 must be investigated separately by substituting into the power series.
a) When we substitute $x=1$, we obtain

$$
\sum_{n=1}^{\infty} \frac{1}{\sqrt{n}}(1)^{n}=1+\frac{1}{\sqrt{2}}+\frac{1}{\sqrt{3}}+\cdots+\frac{1}{\sqrt{n}}+\cdots
$$

which is a divergent $p$-series, with $p=\frac{1}{2}$.
b) When we substitute $x=-1$, we obtain

$$
\sum_{n=1}^{\infty} \frac{1}{\sqrt{n}}(-1)^{n}=-1+\frac{1}{\sqrt{2}}-\frac{1}{\sqrt{3}}+\cdots+\frac{(-1)^{n}}{\sqrt{n}}+\cdots
$$

which converges, by alternating series test.
Hence, the interval of convergence of the power series is $[-1,1)$. This means that the series is convergent for those vales of $x$ which satisfy

$$
-1 \leq x<1
$$

## Example 4

Find the interval of convergence of the power series

$$
\sum_{n=1}^{\infty} a_{n}=\sum_{n=1}^{\infty} \frac{(x-3)^{n}}{2^{n} \cdot n}
$$

## Solution

The power series is centered at 3 and the radius of convergence of the series is

$$
R=\lim _{n \rightarrow \infty} \frac{2^{n+1}(n+1)}{2^{n} \cdot n}=2
$$

Hence, the series converges absolutely for those values of $x$ which satisfy the inequality

$$
|x-3|<2 \Rightarrow 1<x<5
$$

(a) At the left endpoint we substitute $x=1$ in the given power series to obtain the series of constants:

$$
\sum_{n=1}^{\infty} a_{n}=\sum_{n=1}^{\infty} \frac{(-1)^{n}}{n}
$$

This series is convergent by the alternating series test.
(b) At the right endpoint we substitute $x=5$ in the given series and obtain the following harmonic series of constants

$$
\sum_{n=1}^{\infty} \frac{1}{n}
$$

Since a harmonic series is always divergent, the above power series is divergent.
Hence, the series the interval of convergence of the given power series is a half open and half closed interval $[1,5)$.

## Absolute Convergence

Within its interval of convergence a power series converges absolutely. In other words, the series of absolute values

$$
\sum_{n=o}^{\infty}\left|c_{n}\right|\left|(x-a)^{n}\right|
$$

converges for all values $x$ in the interval of convergence.

## A Power Series Represent Functions

A power series $\sum_{n=0}^{\infty} c_{n}(x-a)^{n}$ determines a function $f$ whose domain is the interval of convergence of the power series. Thus for all $x$ in the interval of convergence, we write

$$
f(x)=\sum_{n=0}^{\infty} c_{n}(x-a)^{n}=c_{0}+c_{1}(x-a)+c_{2}(x-a)^{2}+c_{3}(x-a)^{3}+\cdots
$$

If a function is $f$ is defined in this way, we say that $\sum_{n=0}^{\infty} c_{n}(x-a)^{n}$ is a power series representation for $f(x)$. We also say that $f$ is represented by the power series

## Theorem

Suppose that a power series $\sum_{n=0}^{\infty} c_{n}(x-a)^{n}$ has a radius of convergence $R>0$ and for every $x$ in the interval of convergence a function $f$ is defined by

$$
f(x)=\sum_{n=0}^{\infty} c_{n}(x-a)^{n}=c_{0}+c_{1}(x-a)+c_{2}(x-a)^{2}+c_{3}(x-a)^{3}+\cdots
$$

Then
a The function $f$ is continuous, differentiable, and integrable on the $\operatorname{interval}(a-R, a+R)$.

- Moreover, $f^{\prime}(x)$ and $\int f(x) d x$ can be found from term-by-term differentiation and ntegration.
Therefore

$$
\begin{aligned}
& f^{\prime}(x)=c_{1}+2 c_{2}(x-a)+3 c_{3}(x-a)^{2}+\cdots=\sum_{n=1}^{\infty} n c_{n}(x-a)^{n-1} \\
& \int f(x) d x=C+c_{0}(x-a)+c_{1} \frac{(x-a)^{2}}{2}+c_{2} \frac{(x-a)^{3}}{3}+\cdots \\
& \quad=C+\sum_{n=0}^{\infty} c_{n} \frac{(x-a)^{n+1}}{n+1}
\end{aligned}
$$

The series obtained by differentiation and integration have same radius of convergence. However, the convergence at the end points $x=a-R$ and $x=a+R$ of the interval may change. This means that the interval of convergence may be different from the interval of convergence of the original series.

## Example 5

Find a function $f$ that is represented by the power series

$$
1-x+x^{2}-x^{3}+\cdots+(-1)^{n} x^{n}+\cdots
$$

## Solution

The given power series is a geometric series whose common ratio is $r=-x$. Therefore, if $|x|<1$ then the series converges and its sum is

$$
S=\frac{a}{1-r}=\frac{1}{1+x}
$$

Hence we can write

$$
\frac{1}{1+x}=1-x+x^{2}-x^{3}+\cdots+(-1)^{n} x^{n}+\cdots
$$

This last expression is the power series representation for the function $f(x)=\frac{1}{1+x}$.

## Series that are Identically Zero

If for all real numbers $x$ in the interval of convergence, a power series is identically zero i.e.

$$
\sum_{n=0}^{\infty} c_{n}(x-a)^{n}=0, \quad R>0
$$

Then all the coefficients in the power series are zero. Thus we can write

$$
c_{n}=0, \quad \forall n=0,1,2, \ldots
$$

## Analytic at a Point

A function $f$ is said to be analytic at point $a$ if the function can be represented by power series in $(x-a)$ with a positive radius of convergence. The notion of analyticity at a point will be important in finding power series solution of a differential equation.

## Example 6

Since the functions $e^{x}, \cos x$, and $\ln (1+x)$ can be represented by the power series

$$
\begin{aligned}
& e^{x}=1+x+\frac{x^{2}}{2!}+\frac{x^{3}}{3!}+\cdots \\
& \cos x=1-\frac{x^{2}}{2}+\frac{x^{4}}{24}-\cdots \\
& \ln (1+x)=x-\frac{x^{2}}{2}+\frac{x^{3}}{3}-\cdots
\end{aligned}
$$

Therefore, these functions are analytic at the point $x=0$.

## Arithmetic of Power Series

- Power series can be combined through the operations of addition, multiplication, and division.
- The procedure for addition, multiplication and division of power series is similar to the way in which polynomials are added, multiplied, and divided.
- Thus we add coefficients of like powers of $x$, use the distributive law and collect like terms, and perform long division.


## Example 7

If both of the following power series converge for $|x|<R$

Then

$$
f(x)=\sum_{n=0}^{\infty} c_{n} x^{n}, \quad g(x)=\sum_{n=0}^{\infty} b_{n} x^{n}
$$

$$
f(x)+g(x)=\sum_{n=0}^{\infty}\left(c_{n}+b_{n}\right) x^{n}
$$

and

$$
f(x) \cdot g(x)=c_{0} b_{0}+\left(c_{0} b_{1}+c_{1} b_{0}\right) x+\left(c_{0} b_{2}+c_{1} b_{1}+c_{2} b_{0}\right) x^{2}+\cdots
$$

## Power Series: An Introduction

## Example 8

Find the first four terms of a power series in $x$ for the product $e^{x} \cos x$.

## Solution

From calculus the Maclaurin series for $e^{x}$ and $\cos x$ are, respectively,

$$
\begin{aligned}
& e^{x}=1+x+\frac{x^{2}}{2}+\frac{x^{3}}{6}+\frac{x^{4}}{24}+\cdots \\
& \cos x=1-\frac{x^{2}}{2}+\frac{x^{4}}{24}-\cdots
\end{aligned}
$$

Multiplying the two series and collecting the like terms yields

$$
\begin{aligned}
e^{x} \cos x & =\left(1+x+\frac{x^{2}}{2}+\frac{x^{3}}{6}+\frac{x^{4}}{24}+\cdots\right)\left(1-\frac{x^{2}}{2}+\frac{x^{4}}{24}-\cdots\right) \\
& =1+(1) x+\left(-\frac{1}{2}+\frac{1}{2}\right) x^{2}+\left(-\frac{1}{2}+\frac{1}{6}\right) x^{3}+\left(\frac{1}{24}-\frac{1}{4}+\frac{1}{24}\right) x^{4}+\cdots \\
& =1+x-\frac{x^{3}}{3}-\frac{x^{4}}{6}+\cdots
\end{aligned}
$$

The interval of convergence of the power series for both the functions $e^{x}$ and $\cos x$ is $(-\infty, \infty)$. Consequently the interval of convergence of the power series for their product $e^{x} \cos x$ is also $(-\infty, \infty)$.

## Example 9

Find the first four terms of a power series in $x$ for the function $\sec x$.

## Solution

We know that

$$
\sec x=\frac{1}{\cos x}, \quad \cos x=1-\frac{x^{2}}{2}+\frac{x^{4}}{24}-\frac{x^{6}}{720}+\cdots
$$

Therefore using long division, we have

$$
\begin{array}{r}
1 - \frac { x ^ { 2 } } { 2 } + \frac { x ^ { 4 } } { 2 4 } - \frac { x ^ { 6 } } { 7 2 0 } + \cdots \longdiv { 1 + \frac { x ^ { 2 } } { 2 } + \frac { 5 x ^ { 4 } } { 2 4 } + \frac { 6 1 x ^ { 6 } } { 7 2 0 } + \cdots } \\
\frac{1-\frac{x^{2}}{2}+\frac{x^{4}}{24}-\frac{x^{6}}{720}+\cdots}{\frac{x^{2}}{2}-\frac{x^{4}}{24}+\frac{x^{6}}{720}-\cdots} \\
\frac{\frac{x^{2}}{2}-\frac{x^{4}}{4}+\frac{x^{6}}{48}-\cdots}{\frac{5 x^{4}}{24}-\frac{7 x^{6}}{360}+\cdots} \\
\frac{5 x^{4}}{24}-\frac{5 x^{6}}{48}+\cdots \\
\hline \frac{61 x^{6}}{720}-\cdots
\end{array}
$$

Hence, the power series for the function $f(x)=\sec x$ is

$$
\sec x=1+\frac{x^{2}}{2}+\frac{5 x^{4}}{24}+\frac{61 x^{6}}{720}+\cdots
$$

The interval of convergence of this series is $(-\pi / 2, \pi / 2)$.

## Note that

- The procedures illustrated in examples 2 and 3 are obviously tedious to do by hand.
- Therefore, problems of this sort can be done using a computer algebra system (CAS) such as Mathematica.
- When we type the command: $\operatorname{Series}[\operatorname{Sec}[x],\{x, 0,8\}]$ and enter, the Mathematica immediately gives the result obtained in the above example.
- For finding power series solutions it is important that we become adept at simplifying the sum of two or more power series, each series expressed in summation (sigma) notation, to an expression with a single $\sum$. This often requires a shift of the summation indices.
- In order to add any two power series, we must ensure that:
(a) That summation indices in both series start with the same number.
(b) That the powers of $x$ in each of the power series be "in phase".

Therefore, if one series starts with a multiple of, say, $x$ to the first power, then the other series must also start with the same power of the same power of $x$.

## Example 10

Write the following sum of two series as one power series

$$
\sum_{n=1}^{\infty} 2 n c_{n} x^{n-1}+\sum_{n=0}^{\infty} 6 n c_{n} x^{n+1}
$$

## Solution

To write the given sum power series as one series, we write it as follows:

$$
\sum_{n=1}^{\infty} 2 n c_{n} x^{n-1}+\sum_{n=0}^{\infty} 6 n c_{n} x^{n+1}=2 \cdot 1 c_{1} x^{0}+\sum_{n=2}^{\infty} 2 n c_{n} x^{n-1}+\sum_{n=0}^{\infty} 6 n c_{n} x^{n+1}
$$

The first series on right hand side starts with $x^{1}$ for $n=2$ and the second series also starts with $x^{1}$ for $n=0$. Both the series on the right side start with $x^{1}$.

To get the same summation index we are inspired by the exponents of $x$ which is $n-1$ in the first series and $n+1$ in the second series. Therefore, we let

$$
k=n-1, \quad k=n+1
$$

in the first series and second series, respectively. So that the right side becomes:

$$
2 c_{1}+\sum_{k=1}^{\infty} 2(k+1) c_{k+1} x^{k}+\sum_{k=1}^{\infty} 6(k-1) c_{k-1} x^{k} .
$$

Recall that the summation index is a "dummy" variable. The fact that $k=n-1$ in one case and $k=n+1$ in the other should cause no confusion if you keep in mind that it is the value of the summation index that is important. In both cases $k$ takes on the same successive values $1,2,3, \ldots$ for $n=2,3,4, \ldots$ (for $k=n-1$ ) and $n=0,1,2, \ldots$ (for $k=n+1$ )
We are now in a position to add the two series in the given sum term by term:

$$
\sum_{n=1}^{\infty} 2 n c_{n} x^{n-1}+\sum_{n=0}^{\infty} 6 n c_{n} x^{n+1}=2 c_{1}+\sum_{k=1}^{\infty}\left[2(k+1) c_{k+1}+6(k-1) c_{k-1}\right] x^{k}
$$

If you are not convinced, then write out a few terms on both series of the last equation.

## Lecture 29 Power Series Solution of a Differential Equation

We know that the explicit solution of the linear first-order differential equation
is

$$
\begin{aligned}
& \frac{d y}{d x}-2 x y=0 \\
& y=e^{x^{2}}
\end{aligned}
$$

Also

$$
e^{x}=1+x+\frac{x^{2}}{2}+\frac{x^{3}}{6}+\frac{x^{4}}{24}+\cdots
$$

If we replace $x$ by $x^{2}$ in the series representation of $e^{x}$, we can write the solution of the differential equation as

$$
y=\sum_{n=0}^{\infty} \frac{x^{2 n}}{n!}
$$

This last series converges for all real values of $x$. In other words, knowing the solution in advance, we were able to find an infinite series solution of the differential equation.
We now propose to obtain a power series solution of the differential equation directly; the method of attack is similar to the technique of undetermined coefficients.

## Example 11

Find a solution of the differential equation

$$
\frac{d y}{d x}-2 x y=0
$$

in the form of power series in $X$.

## Solution

If we assume that a solution of the given equation exists in the form

$$
y=\sum_{n=0}^{\infty} c_{n} x^{n}=c_{0}+\sum_{n=1}^{\infty} c_{n} x^{n}
$$

The question is that: Can we determine coefficients $C_{n}$ for which the power series converges to a function satisfying the differential equation? Now term-by-term differentiation of the proposed series solution gives

$$
\frac{d y}{d x}=\sum_{n=1}^{\infty} n c_{n} x^{n-1}
$$

Using the last result and the assumed solution, we have

$$
\frac{d y}{d x}-2 x y=\sum_{n=1}^{\infty} n c_{n} x^{n-1}-\sum_{n=0}^{\infty} 2 c_{n} x^{n+1}
$$

We would like to add the two series in this equation. To this end we write

$$
\frac{d y}{d x}-2 x y=1 \cdot c_{1} x^{0}+\sum_{n=2}^{\infty} n c_{n} x^{n-1}-\sum_{n=0}^{\infty} 2 c_{n} x^{n+1}
$$

and then proceed as in the previous example by letting

$$
k=n-1, \quad k=n+1
$$

in the first and second series, respectively. Therefore, last equation becomes

$$
\frac{d y}{d x}-2 x y=c_{1}+\sum_{k=1}^{\infty}(k+1) c_{k+1} x^{k}-\sum_{k=1}^{\infty} 2 c_{k-1} x^{k}
$$

After we add the series term wise, it follows that

$$
\frac{d y}{d x}-2 x y=c_{1}+\sum_{k=1}^{\infty}\left[(k+1) c_{k+1}-2 c_{k-1}\right] x^{k}
$$

Substituting in the given differential equation, we obtain

$$
c_{1}+\sum_{k=1}^{\infty}\left[(k+1) c_{k+1}-2 c_{k-1}\right] x^{k}=0
$$

In order to have this true, it is necessary that all the coefficients must be zero. This means that

$$
c_{1}=0, \quad(k+1) c_{k+1}-2 c_{k-1}=0, \quad k=1,2,3, \ldots
$$

This equation provides a recurrence relation that determines the coefficient $c_{k}$. Since $k+1 \neq 0$ for all the indicated values of $k$, we can write as

$$
c_{k+1}=\frac{2 c_{k-1}}{k+1}
$$

Iteration of this last formula then gives

$$
\begin{array}{ll}
k=1, & c_{2}=\frac{2}{2} c_{0}=c_{0} \\
k=2, & c_{3}=\frac{2}{3} c_{1}=0
\end{array}
$$

$$
\begin{array}{ll}
k=3, & c_{4}=\frac{2}{4} c_{2}=\frac{1}{2} c_{0}=\frac{1}{2!} c_{0} \\
k=4, & c_{5}=\frac{2}{5} c_{3}=0 \\
k=5, & c_{6}=\frac{2}{6} c_{4}=\frac{1}{3 \cdot 2!} c_{0}=\frac{1}{3!} c_{0} \\
k=6, & c_{7}=\frac{2}{7} c_{5}=0 \\
k=7, & c_{8}=\frac{2}{8} c_{6}=\frac{1}{4 \cdot 3!} c_{0}=\frac{1}{4!} c_{0}
\end{array}
$$

and so on. Thus from the original assumption (7), we find

$$
\begin{aligned}
y & =\sum_{n=0}^{\infty} c_{n} x^{n}=c_{0}+c_{1} x+c_{2} x^{2}+c_{3} x^{3}+c_{4} x^{4}+c_{5} x^{5}+\cdots \\
& =c_{0}+0+c_{0} x^{2}+0+\frac{1}{2!} c_{0} x^{4}+0+\frac{1}{3!} c_{0} x^{6}+0+\cdots \\
& =c_{0}\left[1+x^{2}+\frac{1}{2!} x^{4}+\frac{1}{3!} x^{6}+\cdots\right]=c_{0} \sum_{n=0}^{\infty} \frac{x^{2 n}}{n!}
\end{aligned}
$$

Since the coefficient $C_{0}$ remains completely undetermined, we have in fact found the general solution of the differential equation.

## Note that

The differential equation in this example and the differential equation in the following example can be easily solved by the other methods. The point of these two examples is to prepare ourselves for finding the power series solution of the differential equations with variable coefficients.

## Example 12

Find solution of the differential equation

$$
4 y^{\prime \prime}+y=0
$$

in the form of a powers series in $X$.

## Solution

We assume that a solution of the given differential equation exists in the form of

$$
y=\sum_{n=0}^{\infty} c_{n} x^{n}=c_{0}+\sum_{n=1}^{\infty} c_{n} x^{n}
$$

Then term by term differentiation of the proposed series solution yields

$$
\begin{aligned}
& y^{\prime}=\sum_{n=1}^{\infty} n c_{n} x^{n-1}=c_{1}+\sum_{n=2}^{\infty} n c_{n} x^{n-1} \\
& y^{\prime \prime}=\sum_{n=2}^{\infty} n(n-1) c_{n} x^{n-2}
\end{aligned}
$$

Substituting the expression for $y^{\prime \prime}$ and $y$, we obtain

$$
4 y^{\prime \prime}+y=\sum_{n=2}^{\infty} 4 n(n-1) c_{n} x^{n-2}+\sum_{n=0}^{\infty} c_{n} x^{n}
$$

Notice that both series start with $x^{0}$. If we, respectively, substitute

$$
k=n-2, \quad k=n, \quad k=0,1,2, \ldots
$$

in the first series and second series on the right hand side of the last equation. Then we after using, in turn, $n=k+2$ and $n=k$, we get
or

$$
\begin{aligned}
& 4 y^{\prime \prime}+y=\sum_{k=0}^{\infty} 4(k+2)(k+1) c_{k+2} x^{k}+\sum_{k=0}^{\infty} c_{k} x^{k} \\
& 4 y^{\prime \prime}+y=\sum_{k=0}^{\infty}\left[4(k+2)(k+1) c_{k+2}+c_{k}\right] x^{k}
\end{aligned}
$$

Substituting in the given differential equation, we obtain

$$
\sum_{k=0}^{\infty}\left[4(k+2)(k+1) c_{k+2}+c_{k}\right] x^{k}=0
$$

From this last identity we conclude that

$$
\begin{aligned}
& 4(k+2)(k+1) c_{k+2}+c_{k}=0 \\
& c_{k+2}=\frac{-c_{k}}{4(k+2)(k+1)}, \quad k=0,1,2, \ldots
\end{aligned}
$$

From iteration of this recurrence relation it follows that

$$
\begin{aligned}
& c_{2}=\frac{-c_{0}}{4.2 .1}=-\frac{c_{0}}{2^{2} .2!} \\
& c_{3}=\frac{-c_{1}}{4.3 \cdot 2}=-\frac{c_{1}}{2^{2} .3!} \\
& c_{4}=\frac{-c_{2}}{4.4 .3}=+\frac{c_{0}}{2^{4} \cdot 4!} \\
& c_{5}=\frac{-c_{3}}{4.5 .4}=+\frac{c_{1}}{2^{4} .5!} \\
& c_{6}=\frac{-c_{4}}{4.6 .5}=-\frac{c_{0}}{2^{6} .6!} \\
& c_{7}=\frac{-c_{5}}{4.7 .6}=-\frac{c_{1}}{2^{6} .7!}
\end{aligned}
$$

and so forth. This iteration leaves both $c_{0}$ and $c_{1}$ arbitrary. From the original assumption we have

$$
\begin{aligned}
y & =c_{0}+c_{1} x+c_{2} x^{2}+c_{3} x^{3}+c_{4} x^{4}+c_{5} x^{5}+c_{6} x^{6}+c_{7} x^{7}+\cdots \\
& =c_{0}+c_{1} x-\frac{c_{0}}{2^{2} \cdot 2!} x^{2}-\frac{c_{1}}{2^{2} \cdot 3!} x^{3}+\frac{c_{0}}{2^{4} \cdot 4!} x^{4}+\frac{c_{1}}{2^{4} \cdot 5!} x^{5}-\frac{c_{0}}{2^{6} \cdot 6!} x^{6}-\frac{c_{1}}{2^{6} \cdot 7!} x^{7}+\cdots
\end{aligned}
$$

or

$$
y=c_{0}\left[1-\frac{1}{2^{2} \cdot 2!} x^{2}+\frac{1}{2^{4} \cdot 4!} x^{4}-\frac{1}{2^{6} \cdot 6!} x^{6}+\cdots\right]+c_{1}\left[x-\frac{1}{2^{2} \cdot 3!} x^{3}+\frac{1}{2^{4} \cdot 5!} x^{5}-\frac{1}{2^{6} \cdot 7!} x^{7}+\cdots\right]
$$

is a general solution. When the series are written in summation notation,

$$
y_{1}(x)=c_{0} \sum_{k=0}^{\infty} \frac{(-1)^{k}}{(2 k)!}\left(\frac{x}{2}\right)^{2 k} \text { and } \quad y_{2}(x)=2 c_{1} \sum_{k=0}^{\infty} \frac{(-1)^{k}}{(2 k+1)!}\left(\frac{x}{2}\right)^{2 k+1}
$$

the ratio test can be applied to show that both series converges for all $x$. You might also recognize the Maclaurin series as $y_{2}(x)=c_{0} \cos (x / 2)$ and $y_{2}(x)=2 c_{1} \sin (x / 2)$.

## Lecture 30 <br> Solution about Ordinary Points

Analytic Function: A function $f$ is said to be analytic at a point $a$ if it can be represented by a power series in ( $x-a$ ) with a positive radius of convergence.

Suppose the linear second-order differential equation

$$
\begin{equation*}
a_{2}(x) y^{\prime \prime}+a_{1}(x) y^{\prime}+a_{0}(x) y=0 \tag{1}
\end{equation*}
$$

is put into the form

$$
\begin{equation*}
y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=0 \tag{2}
\end{equation*}
$$

by dividing by the leading coefficient $a_{2}(x)$.
Ordinary and singular points: A point $x_{0}$ is said to be a ordinary point of a differential equation (1) if both $P(x)$ and $Q(x)$ are analytic at $x_{0}$. A point that is not an ordinary point is said to be singular point of the equation.

## Polynomial Coefficients:

If $a_{2}(x), a_{1}(x)$ and $a_{0}(x)$ are polynomials with no common factors, then $x=x_{0}$ is
(i) an ordinary point if $a_{2}(x) \neq 0$ or
(ii) a singular point if $a_{2}(x)=0$.

## Example

(a) The singular points of the equation $\left(x^{2}-1\right) y^{\prime \prime}+2 x y^{\prime}+6 y=0$ are the solutions of $x^{2}-1=0$ or $x= \pm 1$. All other finite values of $x$ are the ordinary points.
(b) The singular points need not be real numbers.

The equation $\left(x^{2}+1\right) y^{\prime \prime}+2 x y^{\prime}+6 y=0$ has the singular points at the solutions of $x^{2}+1=0$, namely, $x= \pm i$.

All other finite values, real or complex, are ordinary points.

## Example

The Cauchy-Euler equation $a x^{2} y^{\prime \prime}+b x y^{\prime}+c y=0$, where $a, b$ and $c$ are constants, has singular point at $x=0$.
All other finite values of $x$, real or complex, are ordinary points.

## THEOREM (Existence of Power Series Solution)

If $x=x_{0}$ is an ordinary point of the differential equation $y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=0$, we can always find two linearly independent solutions in the form of power series centered at $x_{0}$ :

$$
y=\sum_{n=0}^{\infty} c_{n}\left(x-x_{0}\right)^{n} .
$$

A series solution converges at least for $\left|x-x_{0}\right|<R$, where R is the distance from $x_{0}$ to the closest singular point (real or complex).

## Example

Solve $y^{\prime \prime}-2 x y=0$.

## Solution

We see that $x=0$ is an ordinary point of the equation. Since there are no finite singular points, there exist two solutions of the form $y=\sum_{n=0}^{\infty} c_{n} x^{n}$ convergent for $|x|<\infty$. Proceeding, we write

$$
\begin{aligned}
& y^{\prime}=\sum_{n=1}^{\infty} n c_{n} x^{n-1} \\
& y^{\prime \prime}=\sum_{n=2}^{\infty} n(n-1) c_{n} x^{n-2} \\
& y^{\prime \prime}-2 x y=\sum_{n=2}^{\infty} n(n-1) c_{n} x^{n-2}-\sum_{n=0}^{\infty} 2 c_{n} x^{n+1} \\
& =2 \cdot 1 c_{2} x^{0}+\underbrace{\sum_{n=3}^{\infty} n(n-1) c_{n} x^{n-2}-\sum_{n=0}^{\infty} 2 c_{n} x^{n+1}}
\end{aligned}
$$

## both series start with $x$

Letting $k=n-2$ in the first series and $k=n+1$ in the second, we have

$$
\begin{gathered}
y^{\prime \prime}-2 x y=2 c_{2}+\sum_{k=1}^{\infty}(k+2)(k+1) c_{k+2} x^{k}-\sum_{k=1}^{\infty} 2 c_{k-1} x^{k} \\
=2 c_{2}+\sum_{k=1}^{\infty}\left[(k+2)(k+1) c_{k+2}-2 c_{k-1}\right] x^{k}=0 \\
2 c_{2}=0 \text { and }(k+2)(k+1) c_{k+2}-2 c_{k-1}=0
\end{gathered}
$$

The last expression is same as

$$
\text { Iteration gives } \begin{aligned}
& c_{k+2}=\frac{2 c_{k-1}}{(k+2)(k+1)}, k=1,2,3, \cdots \\
& c_{3}=\frac{2 c_{0}}{3 \cdot 2} \\
& c_{4}=\frac{2 c_{1}}{4 \cdot 3} \\
& c_{5}=\frac{2 c_{2}}{5 \cdot 4}=0 \quad \text { because } c_{2}=0 \\
& c_{6}=\frac{2 c_{3}}{6 \cdot 5}=\frac{2^{2}}{6 \cdot 5 \cdot 3 \cdot 2} c_{0} \\
& c_{7}=\frac{2 c_{4}}{7 \cdot 6}=\frac{2^{2}}{7 \cdot 6 \cdot 4 \cdot 3} c_{1} \\
& c_{8}=\frac{2 c_{5}}{8 \cdot 7}=0 \\
& c_{9}=\frac{2 c_{6}}{9 \cdot 8}=\frac{2^{3}}{9 \cdot 8 \cdot 6 \cdot 5 \cdot 3 \cdot 2} c_{0} \\
& c_{10}=\frac{2 c_{7}}{10 \cdot 9}=\frac{2^{3}}{10 \cdot 9 \cdot 7 \cdot 6 \cdot 4 \cdot 3} c_{1} \\
& c_{11}=\frac{2 c_{8}}{11 \cdot 10}=0 \quad, \text { and so on. }
\end{aligned}
$$

It is obvious that both $c_{0}$ and $c_{1}$ are arbitrary. Now

$$
\begin{aligned}
& y=c_{0}+c_{1} x+c_{2} x^{2}+c_{3} x^{3}+c_{4} x^{4}+c_{5} x^{5}+c_{6} x^{6}+c_{7} x^{7}+c_{8} x^{8}+c_{9} x^{9}+c_{10} x^{10}+c_{11} x^{11}+\cdots \\
& y=c_{0}+c_{1} x+0+\frac{2}{3 \cdot 2} c_{0} x^{3}+\frac{2}{4 \cdot 3} c_{1} x^{4}+0+\frac{2^{2}}{6 \cdot 5 \cdot 3 \cdot 2} c_{0} x^{6}+\frac{2^{2}}{7 \cdot 6 \cdot 4 \cdot 3} c_{1} x^{7}+0 \\
& +\frac{2^{3}}{9 \cdot 8 \cdot 6 \cdot 5 \cdot 3 \cdot 2} c_{0} x^{9}+\frac{2^{3}}{10 \cdot 9 \cdot 7 \cdot 6 \cdot 4 \cdot 3} c_{1} x^{10}+0+\cdots \\
& \quad y=c_{0}\left[1+\frac{2}{3 \cdot 2} x^{3}+\frac{2^{2}}{6 \cdot 5 \cdot 3 \cdot 2} x^{6}+\frac{2^{3}}{9 \cdot 8 \cdot 6 \cdot 5 \cdot 3 \cdot 2} x^{9}+\cdots\right] \\
& \quad+c_{1}\left[x+\frac{2}{4 \cdot 3} x^{4}+\frac{2^{2}}{7 \cdot 6 \cdot 4 \cdot 3} x^{7}+\frac{2^{3}}{10 \cdot 9 \cdot 7 \cdot 6 \cdot 4 \cdot 3} x^{10}+\cdots\right] .
\end{aligned}
$$

## Example

Solve $\left(x^{2}+1\right) y^{\prime \prime}+x y^{\prime}-y=0$.

## Solution

Since the singular points are $x= \pm i, x=0$ is the ordinary point, a power series will converge at least for $|x|<1$. The assumption $y=\sum_{n=0}^{\infty} c_{n} x^{n}$ leads to

$$
\begin{aligned}
& \left(x^{2}+1\right) \sum_{n=2}^{\infty} n(n-1) c_{n} x^{n-2}+x \sum_{n=1}^{\infty} n c_{n} x^{n-1}-\sum_{n=0}^{\infty} c_{n} x^{n} \\
& =\sum_{n=2}^{\infty} n(n-1) c_{n} x^{n}+\sum_{n=2}^{\infty} n(n-1) c_{n} x^{n-2}+\sum_{n=1}^{\infty} n c_{n} x^{n}-\sum_{n=0}^{\infty} c_{n} x^{n} \\
& =2 c_{2} x^{0}-c_{0} x^{0}+6 c_{3} x+c_{1} x-c_{1} x+\underbrace{\sum_{n=2}^{\infty} n(n-1) c_{n} x^{n}}+\underbrace{\sum_{n=4}^{\infty} n(n-1) c_{n} x^{n-2}}+\underbrace{\sum_{n=2}^{\infty} n c_{n} x^{n}}-\underbrace{\sum_{n=2}^{\infty} c_{n} x^{n}} \\
& k=n \quad k=n-2 \quad k=n \quad k=n \\
& =2 c_{2}-c_{0}+6 c_{3} x+\sum_{k=2}^{\infty}\left[k(k-1) c_{k}+(k+2)(k+1) c_{k+2}+k c_{k}-c_{k}\right] x^{k}=0 \\
& \text { or } \quad 2 c_{2}-c_{0}+6 c_{3} x+\sum_{k=2}^{\infty}\left[(k+1)(k-1) c_{k}+(k+2)(k+1) c_{k+2}\right] x^{k}=0 . \\
& \text { Thus } \\
& 2 c_{2}-c_{0}=0 \\
& c_{3}=0 \\
& (k+1)(k-1) c_{k}+(k+2)(k+1) c_{k+2}=0
\end{aligned}
$$

This implies

$$
\begin{aligned}
& c_{2}=\frac{1}{2} c_{0} \\
& c_{3}=0 \\
& c_{k+2}=\frac{-(k-1)}{(k+2)} c_{k}, k=2,3, \cdots
\end{aligned}
$$

Iteration of the last formula gives

$$
\begin{aligned}
& c_{4}=-\frac{1}{4} c_{2}=-\frac{1}{2 \cdot 4} c_{0}=-\frac{1}{2^{2} 2!} c_{0} \\
& c_{5}=-\frac{2}{5} c_{3}=0 \\
& c_{6}=-\frac{3}{6} c_{4}=\frac{3}{2 \cdot 4 \cdot 6} c_{0}=\frac{1 \cdot 3}{2^{3} 3!} c_{0} \\
& c_{7}=-\frac{4}{7} c_{5}=0 \\
& c_{8}=-\frac{5}{8} c_{6}=-\frac{3 \cdot 5}{2 \cdot 4 \cdot 6 \cdot 8} c_{0}=-\frac{1 \cdot 3 \cdot 5}{2^{4} 4!} c_{0} \\
& c_{9}=-\frac{6}{9} c_{7}=0 \\
& c_{10}=-\frac{7}{10} c_{8}=-\frac{3 \cdot 5 \cdot 7}{2 \cdot 4 \cdot 6 \cdot 8 \cdot 10} c_{0}=\frac{1 \cdot 3 \cdot 5 \cdot 7}{2^{5} 5!} c_{0} \text { and so on. }
\end{aligned}
$$

Therefore

$$
\begin{aligned}
& y=c_{0}+c_{1} x+c_{2} x^{2}+c_{3} x^{3}+c_{4} x^{4}+c_{5} x^{5}+c_{6} x^{6}+c_{7} x^{7}+c_{8} x^{8}+\cdots \\
& y=c_{1} x+c_{0}\left[1+\frac{1}{2} x^{2}-\frac{1}{2^{2} 2!} x^{4}+\frac{1 \cdot 3}{2^{3} 3!} x^{6}-\frac{1 \cdot 3 \cdot 5}{2^{4} 4!} x^{8}+\frac{1 \cdot 3 \cdot 5 \cdot 7}{2^{5} 5!} x^{10}-\cdots\right]
\end{aligned}
$$

The solutions are

$$
\begin{aligned}
& y_{1}(x)=c_{0}\left[1+\frac{1}{2} x^{2}+\sum_{n=2}^{\infty}(-1)^{n-1} \frac{1 \cdot 3 \cdot 5 \cdots(2 n-3)}{2^{n} n!} x^{2 n}\right], \quad|x|<1 \\
& y_{2}(x)=c_{1} x .
\end{aligned}
$$

## Example

If we seek a solution $y=\sum_{n=0}^{\infty} c_{n} x^{n}$ for the equation

$$
y^{\prime \prime}-(1+x) y=0
$$

we obtain $c_{2}=c_{0} / 2$ and the three-term recurrence relation

$$
c_{k+2}=\frac{c_{k}+c_{k-1}}{(k+1)(k+2)}, \quad k=1,2,3, \cdots
$$

To simplify the iteration we can first choose $c_{0} \neq 0, c_{1}=0$; this yields one solution. The other solution follows from next choosing $c_{0}=0, c_{1} \neq 0$. With the first assumption we find

$$
\begin{aligned}
& c_{2}=\frac{1}{2} c_{0} \\
& c_{3}=\frac{c_{1}+c_{0}}{2 \cdot 3}=\frac{c_{0}}{2 \cdot 3}=\frac{1}{6} c_{0} \\
& c_{4}=\frac{c_{2}+c_{1}}{3 \cdot 4}=\frac{c_{0}}{2 \cdot 3 \cdot 4}=\frac{1}{24} c_{0} \\
& c_{5}=\frac{c_{3}+c_{2}}{4 \cdot 5}=\frac{c_{0}}{4 \cdot 5}\left[\frac{1}{2 \cdot 3}+\frac{1}{2}\right]=\frac{1}{30} c_{0} \text { and so on. }
\end{aligned}
$$

Thus one solution is

$$
y_{1}(x)=c_{0}\left[1+\frac{1}{2} x^{2}+\frac{1}{6} x^{3}+\frac{1}{24} x^{4}+\frac{1}{30} x^{5}+\cdots\right] .
$$

Similarly if we choose $c_{0}=0$, then

$$
\begin{aligned}
& c_{2}=0 \\
& c_{3}=\frac{c_{1}+c_{0}}{2 \cdot 3}=\frac{c_{1}}{2 \cdot 3}=\frac{1}{6} c_{1} \\
& c_{4}=\frac{c_{2}+c_{1}}{3 \cdot 4}=\frac{c_{1}}{3 \cdot 4}=\frac{1}{12} c_{1} \\
& c_{5}=\frac{c_{3}+c_{2}}{4 \cdot 5}=\frac{c_{1}}{2 \cdot 3 \cdot 4 \cdot 5}=\frac{1}{120} c_{1} \text { and so on. }
\end{aligned}
$$

Hence another solution is

$$
y_{2}(x)=c_{1}\left[x+\frac{1}{6} x^{3}+\frac{1}{12} x^{4}+\frac{1}{120} x^{5}+\cdots\right] .
$$

Each series converges for all finite values of $x$.

## Non-polynomial Coefficients

The next example illustrates how to find a power series solution about an ordinary point of a differential equation when its coefficients are not polynomials. In this example we see an application of multiplication of two power series that we discussed earlier.

## Example

Solve $\quad y^{\prime \prime}+(\cos x) y=0$

## Solution:

The equation has no singular point.
Since $\cos x=1-\frac{x^{2}}{2!}+\frac{x^{4}}{4!}-\frac{x^{6}}{6!}+\cdots$, it is seen that $x=0$ is an ordinary point.
Thus the assumption $y=\sum_{n=0}^{\infty} c_{n} x^{n}$ leads to

$$
\begin{aligned}
& y^{\prime \prime}+(\cos x) y=\sum_{n=2}^{\infty} n(n-1) c_{n} x^{n-2}-\left(1-\frac{x^{2}}{2!}+\frac{x^{4}}{4!}-\cdots\right) \sum_{n=0}^{\infty} c_{n} x^{n} \\
& =\left(2 c_{2}+6 c_{3} x+12 c_{4} x^{2}+20 c_{5} x^{3}+\cdots\right)+\left(1-\frac{x^{2}}{2!}+\frac{x^{4}}{4!}-\frac{x^{6}}{6!}+\cdots\right)\left(c_{0}+c_{1} x+c_{2} x^{2}+\cdots\right) \\
& =2 c_{2}+c_{0}+\left(6 c_{3}+c_{1}\right) x+\left(12 c_{4}+c_{2}-\frac{1}{2} c_{0}\right) x^{2}+\left(20 c_{5}+c_{3}-\frac{1}{2} c_{1}\right) x^{3}+\cdots
\end{aligned}
$$

If the last line be identically zero, we must have

$$
\begin{aligned}
& 2 c_{2}+c_{0}=0 \Rightarrow c_{2}=-\frac{c_{0}}{2} \\
& 6 c_{3}+c_{1}=0 \Rightarrow c_{3}=-\frac{c_{1}}{6} \\
& 12 c_{4}+c_{2}-\frac{1}{2} c_{0}=0 \Rightarrow c_{4}=\frac{c_{0}}{12} \\
& 20 c_{5}+c_{3}-\frac{1}{2} c_{1}=0 \Rightarrow c_{5}=\frac{c_{1}}{30} \text { and so on. } c_{0} \text { and } c_{1} \text { are arbitrary. }
\end{aligned}
$$

Now

$$
y=c_{0}+c_{1} x+c_{2} x^{2}+c_{3} x^{3}+c_{4} x^{4}+c_{5} x^{5}+\cdots
$$

or

$$
y=c_{0}+c_{1} x-\frac{c_{0}}{2} x^{2}-\frac{c_{1}}{6} x^{3}+\frac{c_{0}}{12} x^{4}+\frac{c_{1}}{30} x^{5}-\cdots
$$

$$
y=c_{0}\left(1-\frac{1}{2} x^{2}+\frac{1}{12} x^{4}-\cdots\right)+c_{1}\left(x-\frac{1}{6} x^{3}+\frac{1}{30} x^{5}-\cdots\right)
$$

$y_{1}(x)=c_{0}\left[1-\frac{1}{2} x^{2}+\frac{1}{12} x^{4}-\cdots\right]$ and $y_{2}(x)=c_{1}\left[x-\frac{1}{6} x^{3}+\frac{1}{30} x^{5}-\cdots\right]$
Since the differential equation has no singular point, both series converge for all finite values of $x$.

## Exercise

In each of the following problems find two linearly independent power series solutions about the ordinary point $x=0$.

1. $y^{\prime \prime}+x^{2} y=0$
2. $y^{\prime \prime}-x y^{\prime}+2 y=0$
3. $y^{\prime \prime}+2 x y^{\prime}+2 y=0$
4. $(x+2) y^{\prime \prime}+x y^{\prime}-y=0$
5. $\left(x^{2}+2\right) y^{\prime \prime}-6 y=0$

## Lecture 31 <br> Solution about Singular Points

If $x=\mathrm{x}_{0}$ is singular point, it is not always possible to find a solution of the form

$$
y=\sum_{n=0}^{\infty} c_{n}\left(x-x_{0}\right)^{n} \text { for the equation } a_{2}(x) y^{\prime \prime}+a_{1}(x) y^{\prime}+a_{0}(x) y=0
$$

However, we may be able to find a solution of the form

$$
y=\sum_{n=0}^{\infty} c_{n}\left(x-x_{0}\right)^{n+r}, \text { where } r \text { is constant to be determined. }
$$

To define regular/irregular singular points, we put the given equation into the standard form

$$
y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=0
$$

## Definition: Regular and Irregular Singular Points

A Singular point $x=\mathrm{x}_{0}$ of the given equation $a_{2}(x) y^{\prime \prime}+a_{1}(x) y^{\prime}+a_{0}(x) y=0$ is said to be a regular singular point if both $\left(x-x_{0}\right) P(x)$ and $\left(x-x_{0}\right)^{2} Q(x)$ are analytic at $x_{0}$. A singular point that is not regular is said to be an irregular singular point of the equation.

## Polynomial Coefficients

If the coefficients in the given differential equation $a_{2}(x) y^{\prime \prime}+a_{1}(x) y^{\prime}+a_{0}(x) y=0$ are polynomials with no common factors, above definition is equivalent to the following:

Let $a_{2}\left(x_{0}\right)=0$ Form $P(x)$ and $Q(x)$ by reducing $\frac{a_{1}(x)}{a_{2}(x)}$ and $\frac{a_{0}(x)}{a_{2}(x)}$ to lowest terms, respectively. If the factor $\left(x-x_{0}\right)$ appears at most to the first powers in the denominator of $P(x)$ and at most to the second power in the denominator of $Q(x)$, then $x=x_{0}$ is a regular singular point.

## Example 1

$$
\begin{aligned}
& x= \pm 2 \quad \text { are singular points of the equation } \\
& \left(x^{2}-4\right)^{2} y^{\prime \prime}+(x-2) y^{\prime}+y=0
\end{aligned}
$$

Dividing the equation by $\left(x^{2}-4\right)^{2}=(x-2)^{2}(x+2)^{2}$, we find that
$P(x)=\frac{1}{(x-2)(x+2)^{2}}$ and $Q(x)=\frac{1}{(x-2)^{2}(x+2)^{2}}$

1. $\quad x=2$ is a regular singular point because power of $x-2$ in $P(x)$ is 1 and in $Q(x)$ is 2 .
2. $\quad x=-2$ is an irregular singular point because power of $x+2$ in $P(x)$ is 2 .

The 1st condition is violated.

## Example 2

Both $x=0$ and $x=-1$ are singular points of the differential equation

$$
x^{2}(x+1)^{2} y^{\prime \prime}+\left(x^{2}-1\right) y^{\prime}+2 y=0
$$

Because $x^{2}(x+1)^{2}=0 \quad$ or $x=0,-1$
Now write the equation in the form

$$
\begin{aligned}
& y^{\prime \prime}+\frac{x^{2}-1}{x^{2}(x+1)^{2}} y^{\prime}+\frac{2}{x^{2}(x+1)^{2}} y=0 \\
& \text { or } y^{\prime \prime}+\frac{x-1}{x^{2}(x+1)} y^{\prime}+\frac{2}{x^{2}(x+1)^{2}} y=0 \\
& \text { So } P(x)=\frac{x-1}{x^{2}(x+1)} \text { and } Q(x)=\frac{2}{x^{2}(x+1)^{2}}
\end{aligned}
$$

Shows that $x=0 \quad$ is a irregular singular point since $(x-0)$ appears to the second powers in the denominator of $P(x)$.
Note, however, $x=-1$ is a regular singular point.

## Example 3

a) $x=1$ and $x=-1$ are singular points of the differential equation

$$
\left(1-x^{2}\right) y^{\prime \prime}+-2 x y^{\prime}+30 y=0
$$

Because $1-x^{2}=0$ or $x= \pm 1$.
Now write the equation in the form

$$
\begin{gathered}
y^{\prime \prime}-\frac{2 x}{\left(1-x^{2}\right)} y^{\prime}+\frac{30}{1-x^{2}} y=0 \\
\text { or } \quad y^{\prime \prime}-\frac{2 x}{(1-x)(1+x)} y^{\prime}+\frac{30}{(1-x)(1+x)} y=0
\end{gathered}
$$

$P(x)=\frac{-2 x}{(1-x)(1+x)} \quad$ and $\quad Q(x)=\frac{30}{(1-x)(1+x)}$
Clearly $x= \pm 1$ are regular singular points.
(b) $\quad x=0$ is an irregular singular points of the differential equation

$$
x^{3} y^{\prime \prime}-2 x y^{\prime}+5 y=0
$$

or $\quad y^{\prime \prime}-\frac{2}{x^{2}} y^{\prime}+\frac{5}{x^{3}} y=0$ giving $Q(x)=\frac{5}{x^{3}}$.
(c) $x=0$ is a regular singular points of the differential equation

$$
x y^{\prime \prime}-2 x y^{\prime}+5 y=0
$$

Because the equation can be written as $y^{\prime \prime}-2 y^{\prime}+\frac{5}{x} y=0$ giving $P(x)=-2$ and $Q(x)=\frac{5}{x}$

In part (c) of Example 3 we noticed that $(x-0)$ and $(x-0)^{2}$ do not even appear in the denominators of $P(x)$ and $Q(x)$ respectively. Remember, these factors can appear at most in this fashion. For a singular point $x=x_{0}$, any nonnegative power of $\left(x-x_{0}\right)$ less than one (namely, zero) and nonnegative power less than two (namely, zero and one) in the denominators of $P(x)$ and $Q(x)$, respectively, imply $x_{0}$ is a regular singular point.

Please note that the singular points can also be complex numbers.
For example, $x= \pm 3 \mathrm{i}$ are regular singular points of the equation

$$
\left(x^{2}+9\right) y^{\prime \prime}+-3 x y^{\prime}+(1-x) y=0
$$

Because the equation can be written as

$$
\begin{aligned}
& y^{\prime \prime}-\frac{3 x}{x^{2}+9} y^{\prime}+\frac{1-x}{x^{2}+9} y=0 . \\
& \therefore P(x)=\frac{-3 x}{(x-3 i)(x+3 i)} \cdot Q(x)=\frac{1-x}{(x-3 i)(x+3 i)} .
\end{aligned}
$$

## Method of Frobenius

To solve a differential equation $a_{2}(x) y^{\prime \prime}+a_{1}(x) y^{\prime}+a_{0}(x) y=0$ about a regular singular point we employ the Frobenius' Theorem.

## Frobenius' Theorem

If $x=\mathrm{x}_{0}$ is a regular singular point of equation $a_{2}(x) y^{\prime \prime}+a_{1}(x) y^{\prime}+a_{0}(x) y=0$, then there exists at least one series solution of the form

$$
y=\left(x-x_{0}\right)^{r} \sum_{n=0}^{\infty} c_{n}\left(x-x_{0}\right)^{n}=\sum_{n=0}^{\infty} c_{n}\left(x-x_{0}\right)^{n+r}
$$

where the number $r$ is a constant that must be determined. The series will converge at least on some interval $0<x-x_{0}<R$.
Note that the solutions of the form $y=\sum_{n=0}^{\infty} c_{n}\left(x-x_{0}\right)^{n+r}$ are not guaranteed.

## Method of Frobenius

1. Identify regular singular point $x_{0}$,
2. Substitute $y=\sum_{n=0}^{\infty} c_{n}\left(x-x_{0}\right)^{n+r}$ in the given differential equation,
3. Determine the unknown exponent $r$ and the coefficients $c_{n}$.
4. For simplicity assume that $x_{0}=0$.

## Example 4

As $x=0$ is regular singular points of the differential equation

$$
3 x y^{\prime \prime}+y^{\prime}-y=0
$$

We try a solution of the form $y=\sum_{n=0}^{\infty} c_{n} x^{n+r}$.
Therefore $\quad y^{\prime}=\sum_{n=0}^{\infty}(n+r) c_{n} x^{n+r-1}$.
And

$$
y^{\prime \prime}=\sum_{n=0}^{\infty}(n+r)(n+r-1) c_{n} x^{n+r-2}
$$

$3 x y^{\prime \prime}+y^{\prime}-y=3 \sum_{n=0}^{\infty}(n+r)(n+r-1) c_{n} x^{n+r-1}+\sum_{n=0}^{\infty}(n+r) c_{n} x^{n+r-1}-\sum_{n=0}^{\infty} c_{n} x^{n+r}$.
$=\sum_{n=0}^{\infty}(n+r)(3 n+3 r-2) c_{n} x^{n+r-1}-\sum_{n=0}^{\infty} c_{n} x^{n+r}$.
$=x^{r}\left[r(3 r-2) c_{0} x^{-1}+\sum_{n=1}^{\infty}(n+r)(3 n+3 r-2) c_{n} x^{n-1}-\sum_{n=0}^{\infty} c_{n} x^{n}\right]$
$k=n-1$,
$=x^{r}\left[r(3 r-2) c_{0} x^{-1}+\sum_{k=0}^{\infty}\left[(k+r+1)(3 k+3 r+1) c_{k+1}-c_{k}\right] x^{k}\right]=0$
which implies $r(3 r-2) c_{0}=0$
$(k+r+1)(3 k+3 r+1) c_{k+1}-c_{k}=0, k=0,1,2, \ldots$
Since nothing is gained by taking $c_{0}=0$, we must then have
$r(3 r-2)=0 \quad$ [called the indicial equation and its roots $r=\frac{2}{3}, 0$ are called indicial roots or exponents of the singularity.]
and $\quad c_{k+1}=\frac{c_{k}}{(k+r+1)(3 k+3 r+1)}, k=0,1,2, \ldots$
Substitute $r_{1}=\frac{2}{3}$ and $r_{2}=0$ in the above equation and these values will give two different recurrence relations:
For $\quad r_{1}=\frac{2}{3}, \quad c_{k+1}=\frac{c_{k}}{(3 k+5)(k+1)}, k=0,1,2, \ldots$
For $\quad r_{2}=0 \quad c_{k+1}=\frac{c_{k}}{(k+1)(3 k+1)}, \quad k=0,1,2, \ldots$
Iteration of (1) gives

$$
\begin{align*}
& c_{1}=\frac{c_{0}}{5.1}  \tag{2}\\
& c_{2}=\frac{c_{1}}{8.2}=\frac{c_{0}}{2!5.8} \\
& c_{3}=\frac{c_{2}}{11.3}=\frac{c_{0}}{3!5.8 .11} \\
& c_{4}=\frac{c_{3}}{14.4}=\frac{c_{0}}{4!5.8 .11 .14}
\end{align*}
$$

In general $\quad c_{n}=\frac{c_{0}}{n!5 \cdot 8.11 .14 \ldots(3 n+2)}, \quad n=1,2, \ldots$
Iteration of (2) gives

$$
\begin{aligned}
& c_{1}=\frac{c_{0}}{1.1} \\
& c_{2}=\frac{c_{1}}{2.4}=\frac{c_{0}}{2!1.4} \\
& c_{3}=\frac{c_{2}}{3.7}=\frac{c_{0}}{3!1.4 .7} \\
& c_{4}=\frac{c_{3}}{4.10}=\frac{c_{0}}{4!1.4 .7 .10}
\end{aligned}
$$

In general

$$
c_{n}=\frac{c_{0}}{n!1 \cdot 4 \cdot 7 \ldots(3 n-2)}, \quad n=1,2, \ldots
$$

Thus we obtain two series solutions

$$
\begin{align*}
& y_{1}=c_{0} x^{\frac{2}{3}}\left[1+\sum_{n=1}^{\infty} \frac{1}{n!5 \cdot 8.11 .14 \ldots(3 n+2)} x^{n}\right]  \tag{3}\\
& y_{2}=c_{0} x^{0}\left[1+\sum_{n=1}^{\infty} \frac{1}{n!1 \cdot 4.7 \ldots(3 n-2)} x^{n}\right] . \tag{4}
\end{align*}
$$

By the ratio test it can be demonstrated that both (3) and (4) converge for all finite values of x . Also it should be clear from the form of (3) and (4) that neither series is a constant multiple of the other and therefore, $y_{1}(x)$ and $y_{2}(x)$ are linearly independent on the x axis. Hence by the superposition principle

$$
\begin{aligned}
y=C_{1} y_{1}(x)+C_{2} y_{2}(x)=C_{1} & {\left[x^{\frac{2}{3}}+\sum_{n=1}^{\infty} \frac{1}{n!5.8 .11 .14 \ldots(3 n+2)} x^{n+\frac{2}{3}}\right] } \\
& +C_{2}\left[1+\sum_{n=1}^{\infty} \frac{1}{n!1.4 .7 \ldots(3 n-2)} x^{n}\right], \quad|x|<\infty
\end{aligned}
$$

is an other solution of the differential equation. On any interval not containing the origin, this combination represents the general solution of the differential equation

Remark: The method of Frobenius may not always provide 2 solutions.

## Example 5

The differential equation

$$
x y^{\prime \prime}+3 y^{\prime}-y=0 \text { has regular singular point at } x=0
$$

We try a solution of the form $y=\sum_{n=0}^{\infty} c_{n} x^{n+r}$
Therefore $\quad y^{\prime}=\sum_{n=0}^{\infty}(n+r) c_{n} x^{n+r-1}$ and $y^{\prime \prime}=\sum_{n=0}^{\infty}(n+r)(n+r-1) c_{n} x^{n+r-2}$.
so that
$x y^{\prime \prime}+3 y^{\prime}-y=x^{r}\left[r(r+2) c_{0} x^{-1}+\sum_{k=0}^{\infty}\left[(k+r+1)(k+r+3) c_{k+1}-c_{k}\right] x^{k}\right]=0$
so that the indicial equation and exponent are $r(r+2)=0$ and $r_{1}=0, r_{2}=-2$, respectively.

Since $(k+r+1)(k+r+3) c_{k+1}-c_{k}=0, \quad k=0,1,2, \ldots$
it follows that when $r_{1}=0$,

$$
\begin{aligned}
c_{k+1} & =\frac{c_{k}}{(k+1)(k+3)}, \\
c_{1} & =\frac{c_{0}}{1.3} \\
c_{2} & =\frac{c_{1}}{2.4}=\frac{2 c_{0}}{2!4!} \\
c_{3} & =\frac{c_{2}}{3.5}=\frac{2 c_{0}}{3!5!} \\
c_{4} & =\frac{c_{3}}{4.6}=\frac{2 c_{0}}{4!6!} \\
c_{n} & =\frac{2 c_{0}}{n!(n+2)!}, \quad n=1,2, \ldots
\end{aligned}
$$

Thus one series solution is

$$
y_{1}=c_{0} x^{0}\left[1+\sum_{n=1}^{\infty} \frac{2}{n!(n+2)!} x^{n}\right]=c_{0} \sum_{n=0}^{\infty} \frac{2}{n!(n+2)!} x^{n},|x|<\infty .
$$

Now when $r_{2}=-2$, (1) becomes

$$
\begin{equation*}
(k-1)(k+1) c_{k+1}-c_{k}=0 \tag{2}
\end{equation*}
$$

but note here that we do not divide by $(k-1)(k+1)$ immediately since this term is zero for $k=1$. However, we use the recurrence relation (2) for the cases $k=0$ and $k=1$ :

$$
-1.1 c_{1}-c_{0}=0 \quad \text { and } 0.2 c_{2}-c_{1}=0
$$

The latter equation implies that $c_{1}=0$ and so the former equation implies that $c_{0}=0$.
Continuing, we find

$$
\begin{aligned}
c_{k+1} & =\frac{c_{k}}{(k-1)(k+1)} \quad k=2,3, \ldots \\
c_{3} & =\frac{c_{2}}{1.3} \\
c_{4} & =\frac{c_{3}}{2.4}=\frac{2 c_{2}}{2!.4!} \\
c_{5} & =\frac{c_{4}}{3.5}=\frac{2 c_{2}}{3!.5!}, \ldots \\
\text { In general } \quad c_{n} & =\frac{2 c_{2}}{(n-2)!n!}, n=3,4,5, \ldots
\end{aligned}
$$

Thus $\quad y_{2}=c_{2} x^{-2}\left[x^{2}+\sum_{n=3}^{\infty} \frac{2}{(n-2)!n!} x^{n}\right]$.
However, close inspection of (3) reveals that $y_{2}$ is simply constant multiple of $y_{1}$.
To see this, let $k=n-2$ in (3). We conclude that the method of Frobenius gives only one series solution of the given differential equation.

## Cases of Indicial Roots

When using the method of Frobenius, we usually distinguish three cases corresponding to the nature of the indicial roots. For the sake of discussion let us suppose that $r_{1}$ and $r_{2}$ are the real solutions of the indicial equation and that, when appropriate, $r_{1}$ denotes the largest root.

## Case I: Roots not Differing by an Integer

If $r_{1}$ and $r_{2}$ are distinct and do not differ by an integer, then their exist two linearly independent solutions of the differential equation of the form

$$
y_{1}=\sum_{n=0}^{\infty} c_{n} x^{n+r_{1}} . . c_{0} \neq 0, \text { and } y_{2}=\sum_{n=0}^{\infty} b_{n} x^{n+r_{2}}, \quad b_{0} \neq 0 .
$$

## Example 6

Solve

$$
2 x y^{\prime \prime}+(1+x) y^{\prime}+y=0
$$

## Solution

If $\quad y=\sum_{n=0}^{\infty} c_{n} x^{n+r}$, then

$$
\begin{aligned}
2 x y^{\prime \prime}+(1+x) y^{\prime}+y= & 2 \sum_{n=0}^{\infty}(n+r)(n+r-1) c_{n} x^{n+r-1}+\sum_{n=0}^{\infty}(n+r) c_{n} x^{n+r-1}+ \\
& \sum_{n=0}^{\infty}(n+r) c_{n} x^{n+r}+\sum_{n=0}^{\infty} c_{n} x^{n+r}
\end{aligned}
$$

$$
=\sum_{n=0}^{\infty}(n+r)(2 n+2 r-1) c_{n} x^{n+r-1}+\sum_{n=0}^{\infty}(n+r+1) c_{n} x^{n+r}
$$

$$
=x^{r}\left[r(2 r-1) c_{0} x^{-1}+\sum_{n=1}^{\infty}(n+r)(2 n+2 r-1) c_{n} x^{n-1}+\sum_{n=0}^{\infty}(n+r+1) c_{n} x^{n}\right]
$$

$$
n=k+1 \quad k=n
$$

$$
=x^{r}\left[r(2 r-1) c_{0} x^{-1}+\sum_{k=0}^{\infty}\left[(k+r+1)(2 k+2 r+1) c_{k+1}+(k+r+1) c_{k}\right] x^{k}\right]=0
$$

which implies $\quad r(2 r-1)=0$

$$
\begin{equation*}
(k+r+1)(2 k+2 r+1) c_{k+1}+(k+r+1) c_{k}=0, k=0,1,2, \ldots \tag{1}
\end{equation*}
$$

For $r_{1}=\frac{1}{2}$, we can divide by $k+\frac{3}{2}$ in the above equation to obtain

$$
\begin{aligned}
& c_{k+1}=\frac{-c_{k}}{2(k+1)}, \\
& c_{1}=\frac{-c_{0}}{2.1} \\
& c_{2}=\frac{-c_{1}}{2.2}=\frac{c_{0}}{2^{2} .2!} \\
& c_{3}=\frac{-c_{2}}{2.3}=\frac{-c_{0}}{2^{3} \cdot 3!} \\
& \text { ! } \\
& \text { In general } \quad c_{n}=\frac{(-1)^{n} c_{0}}{2^{n} n!}, n=1,2,3, \ldots
\end{aligned}
$$

Thus we have

$$
y_{1}=c_{0} x^{\frac{1}{2}}\left[1+\sum_{n=1}^{\infty} \frac{(-1)^{n}}{2^{n} n!} x^{n}\right], \text { which converges for } \mathrm{x} \geq 0
$$

As given, the series is not meaningful for $x<0$ because of the presence of $x^{\frac{1}{2}}$.
Now for $r_{2}=0$, (1) becomes

$$
\begin{aligned}
& c_{k+1}=\frac{-c_{k}}{2 k+1} \\
& c_{1}=\frac{-c_{0}}{1} \\
& c_{2}=\frac{-c_{1}}{3}=\frac{c_{0}}{1.3} \\
& c_{3}=\frac{-c_{2}}{5}=\frac{-c_{0}}{1.3 .5} \\
& c_{4}=\frac{-c_{3}}{7}=\frac{c_{0}}{1.3 .5 .7}
\end{aligned}
$$

In general

$$
c_{n}=\frac{(-1)^{n} c_{0}}{1 \cdot 3 \cdot 5 \cdot 7 \ldots(2 n-1)}, n=1,2,3, \ldots
$$

Thus second solution is

$$
y_{2}=c_{0}\left[1+\sum_{n=1}^{\infty} \frac{(-1)^{n}}{1 \cdot 3 \cdot 5 \cdot 7 . . .(2 n-1)} x^{n}\right] . \quad|x|<\infty .
$$

On the interval $(0, \infty)$, the general solution is

$$
y=C_{1} y_{1}(x)+C_{2} y_{2}(x)
$$

## Lecture 32 Solutions about Singular Points

## Method of Frobenius-Cases II and III

When the roots of the indicial equation differ by a positive integer, we may or may not be able to find two solutions of

$$
\begin{equation*}
a_{2}(x) y^{\prime \prime}+a_{1}(x) y^{\prime}+a_{0}(x) y=0 \tag{1}
\end{equation*}
$$

having form

$$
\begin{equation*}
y=\sum_{n=0}^{\infty} c_{n}\left(x-x_{0}\right)^{n+r} \tag{2}
\end{equation*}
$$

If not, then one solution corresponding to the smaller root contains a logarithmic term. When the exponents are equal, a second solution always contains a logarithm. This latter situation is similar to the solution of the Cauchy-Euler differencial equation when the roots of the auxiliary equation are equal. We have the next two cases.

## Case II: Roots Differing by a Positive Integer

If $r_{1}-r_{2}=N$, where N is a positive integer, then there exist two linearly independent solutions of the form

$$
\begin{align*}
& y_{1}=\sum_{n=0}^{\infty} c_{n} x^{n+r_{1}}, c_{0} \neq 0  \tag{3a}\\
& y_{2}=C y_{1}(x) \ln x+\sum_{n=0}^{\infty} b_{n} x^{n+r_{2}}, b_{0} \neq 0 \tag{3b}
\end{align*}
$$

Where C is a constant that could be zero.

## Case III: Equal Indicial Roots:

If $r_{1}=r_{2}$, there always exist two linearly independent solutions of (1) of the form

$$
\begin{align*}
& y_{1}=\sum_{n=0}^{\infty} c_{n} x^{n+r_{1}}, c_{0} \neq 0  \tag{4a}\\
& y_{2}=y_{1}(x) \ln x+\sum_{n=1}^{\infty} b_{n} x^{n+r_{1}} \quad \because r_{1}=r_{2} \tag{4b}
\end{align*}
$$

Example 7: Solve $x y^{\prime \prime}+(x-6) y^{\prime}-3 y=0$
Solution: The assumption $y=\sum_{n=0}^{\infty} c_{n} x^{n+r}$ leads to

$$
\begin{aligned}
& x y^{\prime \prime}+(x-6) y^{\prime}-3 y \\
& =\sum_{n=0}^{\infty}(n+r)(n+r-1) c_{n} x^{n+r-1}-6 \sum_{n=0}^{\infty}(n+r) c_{n} x^{n+r-1}+\sum_{n=0}^{\infty}(n+r) c_{n} x^{n+r}-3 \sum_{n=0}^{\infty} c_{n} x^{n+r} \\
& =x^{r}\left[r(r-7) c_{0} x^{-1}+\sum_{n=1}^{\infty}(n+r)(n+r-7) c_{n} x^{n-1}+\sum_{n=0}^{\infty}(n+r-3) c_{n} x^{n}\right] \\
& x^{r}\left[r(r-7) c_{0} x^{-1}+\sum_{k=0}^{\infty}\left[(k+r+1)(k+r-6) c_{k+1}+(k+r-3) c_{k}\right] x^{k}\right]=0
\end{aligned}
$$

Thus $\mathrm{r}(\mathrm{r}-7)=0$ so that $r_{1}=7, r_{2}=0, r_{1}-r_{2}=7$, and
$(k+r+1)(k+r-6) c_{k+1}+(k+r-3) c_{k}=0, \quad k=0,1,2,3, \ldots$

For smaller root $r_{2}=0$,(2)becomes

$$
\begin{equation*}
(k+1)(k-6) c_{k+1}+(k-3) c_{k}=0 \tag{3}
\end{equation*}
$$

recurrence relation becomes
$c_{k+1}=-\frac{(k-3)}{(k+1)(k-6)} c_{k}$
Since $\mathrm{k}-6=0$, when, $\mathrm{k}=6$, we do not divide by this term until $\mathrm{k}>6$.we find

$$
\begin{aligned}
& \text { 1. }(-6) c_{1}+(-3) c_{0}=0 \\
& \text { 2. }(-5) c_{2}+(-2) c_{1}=0 \\
& \text { 3. }(-4) c_{3}+(-1) \cdot c_{2}=0 \\
& \text { 4. }(-3) c_{4}+0 . c_{3}=0 \\
& \text { 5. }(-2) c_{5}+1 \cdot c_{4}=0 \\
& \text { 6. }(-1) c_{6}+2 \cdot c_{5}=0 \\
& \text { 7.0. } c_{7}+3 \cdot c_{6}=0
\end{aligned}
$$

This implies that
$c_{4}=c_{5}=c_{6}=0$, But $c_{0}$ and $c_{7}$ can be chosen arbitrarily.
Hence

$$
c_{1}=-\frac{1}{2} c_{0}
$$

$$
\begin{align*}
& c_{2}=-\frac{1}{5} c_{1}=\frac{1}{10} c_{0} \\
& c_{3}=-\frac{1}{12} c_{2}=-\frac{1}{120} c_{0} \tag{4}
\end{align*}
$$

and for $\mathrm{k} \geq 7$

$$
\begin{aligned}
& c_{k+1}=\frac{-(k-3)}{(k+1)(k-6)} c_{k} \\
& c_{8}=\frac{-4}{8.1} c_{7} \\
& c_{9}=-\frac{5}{9.2} c_{8}=\frac{4.5}{2!8.9} c_{7} \\
& c_{10}=\frac{-6}{10.3} c_{9}=\frac{-4.5 .6}{3!8.9 .10} c_{7}
\end{aligned}
$$

- 

$$
\begin{equation*}
c_{n}=\frac{(-1)^{n+1} 4 \cdot 5 \cdot 6 \cdots(n-4)}{(n-7)!8 \cdot 9 \cdot 10 \cdots(n)} c_{7}, \quad n=8,9,10, \cdots \tag{5}
\end{equation*}
$$

If we choose $c_{7}=0$ andc $c_{0} \neq 0$ It follows that we obtain the polynomial solution

$$
y_{1}=\quad c_{0}\left[1-\frac{1}{2} x+\frac{1}{10} x^{2}-\frac{1}{120} x^{3}\right]
$$

But when $\quad c_{7} \neq=0 a n d c_{0}=0$, It follows that a second, though infinite series solution is

$$
\begin{align*}
y_{2} & =c_{7}\left[x^{7}+\sum_{n=8}^{\infty} \frac{(-1)^{n+1} 4 \cdot 5 \cdot 6 \cdots(n-4)}{(n-7)!8 \cdot 9 \cdot 10 \cdots n} x^{n}\right] \\
& =c_{7}\left[x^{7}+\sum_{k=1}^{\infty} \frac{(-1)^{k} 4 \cdot 5 \cdot 6 \cdots(k+3)}{k!8 \cdot 9 \cdot 10 \cdots(k+7)} x^{k+3}\right], \quad|x|<\infty \tag{6}
\end{align*}
$$

Finally the general solution of equation (1) on the interval $(0, \infty)$ is

$$
\begin{aligned}
\mathrm{Y} & =c_{1} y_{1}(x)+c_{2} y_{2}(x) \\
& =c_{1}\left[1-\frac{1}{2} x+\frac{1}{10} x^{2}-\frac{1}{120} x^{3}\right]+c_{2}\left[x^{7}+\sum_{n=1}^{\infty} \frac{(-1)^{k} 4 \cdot 5 \cdot 6 \cdots(k+3)}{k!8 \cdot 9 \cdot 10 \cdots(k+7)} x^{k+7}\right]
\end{aligned}
$$

It is interesting to observe that in example 9 the larger root $r_{1}=7$ were not used. Had we done so, we would have obtained a series solution of the form*

$$
\begin{equation*}
y=\sum_{n=0}^{\infty} c_{n} x^{n+7} \tag{7}
\end{equation*}
$$

Where $c_{n}$ are given by equation (2) with $r_{1}=7$

$$
c_{k+1}=\frac{-(k+4)}{(k+8)(k+1)} c_{k}, \quad k=0,1,2 \ldots
$$

Iteration of this latter recurrence relation then would yield only one solution, namely the solution given by (6) with $c_{0}$ playing the role of $c_{7}$ )
When the roots of indicial equation differ by a positive integer, the second solution may contain a logarithm.
On the other hand if we fail to find second series type solution, we can always use the fact that

$$
\begin{equation*}
y_{2}=y_{1}(x) \int \frac{e^{-\int p(x) d x}}{y_{1}^{2}(x)} d x \tag{8}
\end{equation*}
$$

is a solution of the equation $y^{\prime \prime}+P(x) y^{\prime}+Q(x) y=0$, whenever $y_{1}$ is a known solution.
Note: In case 2 it is always a good idea to work with smaller roots first.

## Example8:

Find the general solution of $x y^{\prime \prime}+3 y^{\prime}-y=0$
Solution The method of frobenius provide only one solution to this equation, namely,

$$
\begin{equation*}
y_{1}=\sum_{n=0}^{\infty} \frac{2}{n!(n+2)!} x^{n}=1+\frac{1}{3} x+\frac{1}{24} x^{2}+\frac{1}{360} x^{3}+\cdots \tag{9}
\end{equation*}
$$

From (8) we obtain a second solution

$$
\begin{align*}
& \begin{aligned}
y_{2}=y_{1}(x) \int \frac{e^{-\int p(x) d x}}{y_{1}^{2}(x)} d x & =y_{1}(x) \int \frac{d x}{x^{3}\left[1+\frac{1}{3} x+\frac{1}{24} x^{2}+\frac{1}{360} x^{3}+\cdots\right]^{2}} \\
& =y_{1}(x) \int \frac{d x}{x^{3}\left[1+\frac{2}{3} x+\frac{7}{36} x^{2}+\frac{1}{30} x^{3}+\cdots\right]} \\
& =y_{1}(x) \int \frac{1}{x^{3}}\left[1-\frac{2}{3} x+\frac{1}{4} x^{2}-\frac{19}{270} x^{3}+\cdots\right] d x
\end{aligned} \\
& =y_{1}(x)\left[-\frac{1}{2 x^{2}}+\frac{2}{3 x}+\frac{1}{4} \ln x-\frac{19}{270} x+\ldots\right] \\
& =\frac{1}{4} y_{1}(x) \ln x+y_{1}(x)\left[-\frac{1}{2 x^{2}}+\frac{2}{3 x}-\frac{19}{270} x+\ldots\right] \\
& \therefore y=c_{1} y_{1}(x)+c_{2}\left[\frac{1}{4} y_{1}(x) \ln x+y_{1}(x)\left(-\frac{1}{2 x^{2}}+\frac{2}{3 x}-\frac{19}{270} x+\ldots\right)\right]
\end{align*}
$$

## Example 9:

## Find the general solution of

$x y^{\prime \prime}+3 y^{\prime}-y=0$
Solution:
$y_{2}=y_{1} \ln x+\sum_{\mathrm{n}=0}^{\infty} \mathrm{b}_{\mathrm{n}} \mathrm{x}^{\mathrm{n}-2}$
$y_{1}=\sum_{n=0}^{\infty} \frac{2}{n!(n+2)!} x^{n}$
differentiate (10) gives
$\mathrm{y}_{2}^{\prime}=\frac{\mathrm{y}_{1}}{\mathrm{x}}+\mathrm{y}_{1}^{\prime} \ln \mathrm{x}+\sum_{\mathrm{n}=0}^{\infty}(\mathrm{n}-2) \mathrm{b}_{\mathrm{n}} \mathrm{x}^{\mathrm{n}-3}$
$\mathrm{y}_{2}{ }^{\prime \prime}=-\frac{\mathrm{y}_{1}}{\mathrm{x}^{2}}+\frac{2 \mathrm{y}_{1}{ }^{\prime}}{\mathrm{x}}+\mathrm{y}_{1}{ }^{\prime \prime} \ln \mathrm{x}+\sum_{\mathrm{n}=0}^{\infty}(\mathrm{n}-2)(\mathrm{n}-3) \mathrm{b}_{\mathrm{n}} \mathrm{x}^{\mathrm{n}-4}$
so that

$$
\begin{align*}
& x y_{2}^{\prime \prime}+3 y_{2}^{\prime}-y_{2}=\ln x\left[x y_{1}^{\prime \prime}+3 y_{1}^{\prime}-y_{1}\right]+2 y_{1}^{\prime}+\frac{2 y_{1}}{x}+\sum_{n=0}^{\infty}(n-2)(n-3) b_{n} x^{n-3} \\
&+3 \sum_{n=0}^{\infty}(n-2) b_{n} x^{n-3}-\sum_{n=0}^{\infty} b_{n} x^{n-2} \\
&=2 y_{1}^{\prime}+\frac{2 y_{1}}{x}+\sum_{n=0}^{\infty}(n-2) n b_{n} x^{n-3}-\sum_{n=0}^{\infty} b_{n} x^{n-2} \tag{12}
\end{align*}
$$

where we have combined the1st two summations and used the fact that
$x_{1}^{\prime \prime}+3 y_{1}^{\prime}-y_{1}=0$
Differentiate (11) we can write (12) as

$$
\begin{align*}
& \sum_{n=0}^{\infty} \frac{4 n}{n!(n+2)!} x^{n-1}+\sum_{n=0}^{\infty} \frac{4}{n!(n+2)!} x^{n-1}+\sum_{n=0}^{\infty}(n-2) n b_{n} x^{n-3}-\sum_{n=0}^{\infty} b_{n} x^{n-2} \\
& =0(-2) b_{0} x^{-3}+\left(-b_{0}-b_{1}\right) x^{-2}+\sum_{n=0}^{\infty} \frac{4(n+1)}{n!(n+2)!} x^{n-1}+\sum_{n=2}^{\infty}(n-2) n b_{n} x^{n-3}-\sum_{n=1}^{\infty} b_{n} x^{n-2} \\
& \quad-\left(b_{0}+b_{1}\right) x^{-2}+\sum_{k=0}^{\infty}\left[\frac{4(k+1)}{k!(k+2)!}+k(k+2) b_{k+2}-b_{k+1}\right] x^{k-1} . \tag{13}
\end{align*}
$$

Setting (13) equal to zero then gives $b_{1}=-b_{0}$ and

$$
\begin{equation*}
\frac{4(k+1)}{k!(k+1)!}+k(k+2) b_{k+2}-b_{k+1}=0, \quad \text { For } k=\mathbf{0}, \mathbf{1}, \mathbf{2}, \ldots \tag{14}
\end{equation*}
$$

When $\mathrm{k}=0$ in equation (14) we have $2+0 \cdot 2 b_{2}-b_{1}=0$ so that but
$b_{1}=2, b_{0}=-2$, but $b_{2}$ is arbitrary
Rewriting equation (14) as

$$
\begin{equation*}
b_{k+2}=\frac{b_{k+1}}{k(k+2)}-\frac{4(k+1)}{k!(k+2)!k(k+2)} \tag{15}
\end{equation*}
$$

and evaluating for $\mathrm{k}=1,2, \ldots$ gives

$$
\begin{aligned}
& b_{3}=\frac{b_{2}}{3}-\frac{4}{9} \\
& b_{4}=\frac{1}{8} b_{3}-\frac{1}{32}=\frac{1}{24} b_{2}-\frac{25}{288}
\end{aligned}
$$

and so on. Thus we can finally write

$$
\begin{align*}
y_{2} & =y_{1} \ln x+b_{0} x^{-2}+b_{1} x^{-1}+b_{2}+b_{3} x+\cdots \\
& =y_{1} \ln x-2 x^{-2}+2 x^{-1}+b_{2}+\left(\frac{b_{2}}{3}-\frac{4}{9}\right) x+\cdot \tag{16}
\end{align*}
$$

Where $b_{2}$ is arbitrary.

## Equivalent Solution

At this point you may be wondering whether (*) and (16) are really equivalent. If we choose $c_{2}=4$ in equation ( ${ }^{* *}$ ), then

$$
\begin{gathered}
y_{2}=y_{1} \ln x+\left(-\frac{2}{x^{2}}+\frac{8}{3 x}-\frac{38}{135} x+\cdots\right) \\
y_{2}=y_{1} \ln x+\left(1+\frac{1}{3} x+\frac{1}{24} x^{2}+\frac{1}{360} x^{3}+\cdots\right)\left(-\frac{2}{x^{2}}+\frac{8}{3 x}-\frac{38}{135} x+\cdots\right) \\
=y_{1} \ln x-2 x^{-2}+2 x^{-1}+\frac{29}{36}-\frac{19}{108} x+\ldots
\end{gathered}
$$

Which is precisely obtained what we obtained from (16). If $b_{2}$ is chosen as $\frac{29}{36}$ The next example illustrates the case when the indicial roots are equal.

Example:10
Find the general solution of $x y^{\prime \prime}+y^{\prime}-4 y=0$
Solution:The assumption $\mathrm{y}=\sum_{\mathrm{n}=0}^{\infty} \mathrm{c}_{\mathrm{n}} x^{n+r}$ leads to

$$
\begin{aligned}
x y^{\prime \prime}+y^{\prime}-4 y & =\sum_{\mathrm{n}=0}^{\infty}(\mathrm{n}+\mathrm{r})(\mathrm{n}+\mathrm{r}-1) \mathrm{c}_{\mathrm{n}} x^{n+r-1}+\sum_{\mathrm{n}=0}^{\infty}(\mathrm{n}+\mathrm{r}) \mathrm{c}_{\mathrm{n}} x^{n+r-1}-4 \sum_{\mathrm{n}=0}^{\infty} \mathrm{c}_{\mathrm{n}} x^{n+r} \\
= & \sum_{\mathrm{n}=0}^{\infty}(\mathrm{n}+\mathrm{r})^{2} \mathrm{c}_{\mathrm{n}} x^{n+r-1}-4 \sum_{\mathrm{n}=0}^{\infty} \mathrm{c}_{\mathrm{n}} x^{n+r} \\
= & x^{r}\left[r^{2} c_{0} x^{-1}+\sum_{\mathrm{n}=1}^{\infty}(\mathrm{n}+\mathrm{r})^{2} \mathrm{c}_{\mathrm{n}} x^{n-1}-4 \sum_{\mathrm{n}=0}^{\infty} \mathrm{c}_{\mathrm{n}} x^{n}\right] \\
= & x^{r}\left[r^{2} c_{0} x^{-1}+\sum_{\mathrm{k}=0}^{\infty}(\mathrm{k}+\mathrm{r}+1)^{2} \mathrm{c}_{\mathrm{k}+1}-4 \mathrm{c}_{\mathrm{k}}\right] x^{k}=0
\end{aligned}
$$

Therefore $r^{2}=0$, and so the indicial roots are equal: $r_{1}=r_{2}=0$. Moreover we have

$$
\begin{equation*}
(k+r+1)^{2} c_{k+1}-4 c_{k}=0, \mathrm{k}=0,1,2, \ldots \tag{19}
\end{equation*}
$$

Clearly the roots $r_{1}=0$ will yield one solution corresponding to the coefficients defined by the iteration of

$$
c_{k+1}=\frac{4 c_{k}}{(k+1)^{2}} \quad \mathrm{k}=0,1,2, \ldots
$$

The result is

$$
\begin{align*}
& y_{1}=c_{0} \sum_{n=0}^{\infty} \frac{4^{n}}{(n!)^{2}} x^{n},|x|<\infty  \tag{20}\\
& y_{2}=y_{1}(x) \int \frac{e^{\left.-\int \frac{1}{x}\right) d x}}{y_{1}^{2}(x)} d x=y_{1}(x) \int \frac{d x}{x\left[1+4 x+4 x^{2}+\frac{16}{9} x^{3}+\cdots\right]^{2}} \\
&=y_{1}(\mathrm{x}) \int \frac{1}{\mathrm{x}}\left[1-8 \mathrm{x}+40 \mathrm{x}^{2}-\frac{1472}{9} \mathrm{x}^{3}+\cdots\right] \mathrm{dx} \\
&=\mathrm{y}_{1}(\mathrm{x}) \int\left[\frac{1}{\mathrm{x}}-8+40 \mathrm{x}-\frac{1472}{9} \mathrm{x}^{2}+\ldots\right] \mathrm{dx}
\end{align*}
$$

$=y_{1}(x)\left[\ln x-8 x+20 x^{2}-\frac{1472}{27} x^{3}+\cdots\right]$
Thus on the interval $(0, \infty)$ the general solution of (18) is

$$
y=c_{1} y_{1}(x)+c_{2}\left[y_{1}(x) \ln x+y_{1}(x)\left(-8 x+20 x^{2}-\frac{1472}{27} x^{3}+\ldots\right)\right]
$$

where $y_{1}(x)$ is defined by (20)
In caseII we can also determine $y_{2}(x)$ of example9 directly from assumption (4b)

## Lecture 33

## Bessel's Differential Equation

A second order linear differential equation of the form

$$
x^{2} \frac{d^{2} y}{d x^{2}}+x \frac{d y}{d x}+\left(x^{2}-v^{2}\right) y=0
$$

is called Bessel's differential equation.
Solution of this equation is usually denoted by $\mathrm{J}_{\mathrm{v}}(\mathrm{x})$ and is known as Bessel's function. This equation occurs frequently in advanced studies in applied mathematics, physics and engineering.

## Series Solution of Bessel's Differential Equation

Bessel's differential equation is

$$
\begin{equation*}
x^{2} y^{\prime \prime}+x y^{\prime}+\left(x^{2}-v^{2}\right) y=0 \tag{1}
\end{equation*}
$$

If we assume that

$$
y=\sum_{n=0}^{\infty} C_{n} x^{n+r}
$$

Then

$$
\begin{aligned}
& y^{\prime}=\sum_{n=0}^{\infty} C_{n}(n+r) x^{n+r-1} \\
& y^{\prime \prime}=\sum_{n=0}^{\infty} C_{n}(n+r)(n+r-1) x^{n+r-2}
\end{aligned}
$$

So that

$$
\left.\begin{array}{rl}
x^{2} y^{\prime \prime}+x y^{\prime}+\left(x^{2}-v^{2}\right) y= & \sum_{n=0}^{\infty} C_{n}(n+r)(n+r-1) x^{n+r}+\sum_{n=0}^{\infty} C_{n}(n+r) x^{n+r} \\
& +\sum_{n=0}^{\infty} C_{n} x^{n+r+2}-v^{2} \sum_{n=0}^{\infty} C_{n} x^{n+r}=0
\end{array}\right\}
$$

From (2) we see that the indicial equation is $r^{2}-v^{2}=0$, so the indicial roots are $r_{1}=v$, $r_{2}=-v$. When $r_{1}=v$ then (2) becomes

$$
\begin{aligned}
& x^{v} \sum_{n=1}^{\infty} C_{n} n(n+2 v) x^{n}+x^{v} \sum_{n=0}^{\infty} C_{n} x^{n+2}=0 \\
& x^{v}[(1+2 v) C_{1} x+\underbrace{\sum_{n=2}^{\infty} C_{n} n(n+2 v) x^{n}}+\underbrace{\sum_{n=0}^{\infty} C_{n} x^{n+2}}_{k=n-2}]=0 \\
& x^{v}\left[(1+2 v) C_{1} x+\sum_{k=0}^{\infty}\left[(k+2)(k+2+2 v) C_{k+2}+C_{k}\right] x^{k+2}\right]=0
\end{aligned}
$$

We can write

$$
\begin{align*}
& (1+2 v) C_{1}=0 \\
& (k+2)(k+2+2 v) C_{k+2}+C_{k}=0 \\
& C_{k+2}=\frac{-C_{k}}{(k+2)(k+2+2 v)}  \tag{3}\\
& k=0,1,2, \ldots
\end{align*}
$$

The choice $C_{1}=0$ in (3) implies

$$
C_{1}=C_{3}=C_{5}=\ldots=0
$$

so for $k=0,2,4, \ldots$ we find, after letting $k+2=2 n, n=1,2,3, \ldots$ that

$$
\begin{equation*}
C_{2 n}=\frac{-C_{2 n-2}}{2^{2} n(n+v)} \tag{4}
\end{equation*}
$$

Thus

$$
\begin{align*}
& C_{2}=-\frac{C_{0}}{2^{2} \cdot 1 \cdot(1+v)} \\
& C_{4}=-\frac{C_{2}}{2^{2} \cdot 2 \cdot(2+v)}=\frac{C_{0}}{2^{4} \cdot 1 \cdot 2 \cdot(1+v)(2+v)} \\
& C_{6}=-\frac{C_{4}}{2^{2} \cdot 3 \cdot(3+v)}=-\frac{C_{0}}{2^{6} \cdot 1 \cdot 2 \cdot 3 \cdot(1+v)(2+v)(3+v)}  \tag{5}\\
& \ldots \\
& C_{2 n}=\frac{\cdots}{2^{2 n} \cdot n!(1+v)(2+v) \cdots(n+v)} \quad n=1,2,3, \ldots
\end{align*}
$$

It is standard practice to choose $C_{0}$ to be a specific value namely

$$
C_{0}=\frac{1}{2^{v} \Gamma(1+v)}
$$

where $\Gamma(1+v)$ the Gamma function. Also

$$
\Gamma(1+\alpha)=\alpha \Gamma(\alpha)
$$

Using this property, we can reduce the indicated product in the denominator of (5) to one term. For example

$$
\begin{aligned}
\Gamma(1+v+1) & =(1+v) \Gamma(1+v) \\
\Gamma(1+v+2) & =(2+v) \Gamma(2+v) \\
& =(2+v)(1+v) \Gamma(1+v)
\end{aligned}
$$

Hence we can write (5) as

$$
\begin{aligned}
& C_{2 n}=\frac{(-1)^{n}}{2^{2 n+v} n!(1+v)(2+v) \cdots(n+v) \Gamma(1+v)} \\
& =\frac{(-1)^{n}}{2^{2 n+v} n!\Gamma(1+v+n)}, \quad n=0,1,2, \ldots
\end{aligned}
$$

So the solution is

$$
y=\sum_{n=0}^{\infty} C_{2 n} x^{2 n+v}=\sum_{n=0}^{\infty} \frac{(-1)^{n}}{n!\Gamma(1+v+n)}\left(\frac{x}{2}\right)^{2 n+v}
$$

If $v \geq 0$, the series converges at least on the interval $\left[\begin{array}{ll}0 & \infty\end{array}\right)$.

## Bessel's Function of the First Kind

As for $r_{1}=v$, we have

$$
\begin{equation*}
\mathrm{J}_{v}(x)=\sum_{n=0}^{\infty} \frac{(-1)^{n}}{(n!) \Gamma(1+v+n)}\left(\frac{x}{2}\right)^{2 n+v} \tag{6}
\end{equation*}
$$

Also for the second exponent $r_{2}=-v$, we have

$$
\begin{equation*}
\mathrm{J}_{-v}(x)=\sum_{n=0}^{\infty} \frac{(-1)^{n}}{(n!) \Gamma(1-v+n)}\left(\frac{x}{2}\right)^{2 n-v} \tag{7}
\end{equation*}
$$

The function $\mathrm{J}_{v}(x)$ and $\mathrm{J}_{-v}(x)$ are called Bessel function of the first kind of order $v$ and $-v$ respectively.

Now some care must be taken in writing the general solution of (1). When $v=0$, it is clear that (6) and (7) are the same. If $v>0$ and $r_{1}-r_{2}=v-(-v)=2 v$ is not a positive integer, then $\mathrm{J}_{v}(x)$ and $\mathrm{J}_{-v}(x)$ are linearly independent solutions of $(1)$ on $(0, \infty)$ and so the general solution of the interval would be

$$
y=C_{1} \mathrm{~J}_{v}(x)+C_{2} \mathrm{~J}_{-v}(x)
$$

If $r_{1}-r_{2}=2 v$ is a positive integer, a second series solution of (1) may exists.

## Example 1

Find the general solution of the equation

$$
x^{2} y^{\prime \prime}+x y^{\prime}+\left(x^{2}-\frac{1}{4}\right) y=0 \text { on }(0, \infty)
$$

## Solution

The Bessel differential equation is

$$
\begin{align*}
& x^{2} y^{\prime \prime}+x y^{\prime}+\left(x^{2}-v^{2}\right) y=0  \tag{1}\\
& x^{2} y^{\prime \prime}+x y^{\prime}+\left(x^{2}-\frac{1}{4}\right) y=0 \tag{2}
\end{align*}
$$

Comparing (1) and (2), we get $\quad v^{2}=\frac{1}{4}$, therefore $v= \pm \frac{1}{2}$
So general solution of (1) is

$$
y=C_{1} \mathrm{~J}_{1 / 2}(x)+C_{2} \mathrm{~J}_{-1 / 2}(x)
$$

## Example 2

Find the general solution of the equation

$$
x^{2} y^{\prime \prime}+x y^{\prime}+\left(x^{2}-\frac{1}{9}\right) y=0
$$

## Solution

We identify

$$
v^{2}=\frac{1}{9} \text {, therefore } v= \pm \frac{1}{3}
$$

So general solution is

$$
y=C_{1} \mathrm{~J}_{1 / 3}(x)+C_{2} \mathrm{~J}_{-1 / 3}(x)
$$

## Example 3

Derive the formula

$$
x \mathrm{~J}_{v}^{\prime}(x)=v \mathrm{~J}_{v}(x)-x \mathrm{~J}_{v+1}(x)
$$

## Solution

As $\mathrm{J}_{v}(x)=\sum_{n=0}^{\infty} \frac{(-1)^{n}}{n!\Gamma(1+v+n)}\left(\frac{x}{2}\right)^{2 n+v}$

$$
x \mathrm{~J}_{v}^{\prime}(x)=\sum_{n=0}^{\infty} \frac{(-1)^{n}(2 n+v)}{n!\Gamma(1+v+n)}\left(\frac{x}{2}\right)^{2 n+v}
$$

$$
=v \cdot \sum_{n=0}^{\infty} \frac{(-1)^{n}}{n!\Gamma(1+v+n)}\left(\frac{x}{2}\right)^{2 n+v}+2 \cdot \sum_{n=0}^{\infty} \frac{(-1)^{n} n}{n!\Gamma(1+v+n)}\left(\frac{x}{2}\right)^{2 n+v}
$$

$$
=v \mathrm{~J}_{v}(x)+x \cdot \underbrace{\sum_{n=0}^{\infty} \frac{(-1)^{n}}{(n-1)!\Gamma(1+v+n)}\left(\frac{x}{2}\right)^{2 n+v-1}}_{k=n-1}
$$

$$
=v \mathrm{~J}_{v}(x)-x \sum_{k=0}^{\infty} \frac{(-1)^{k}}{k!\Gamma(2+v+k)}\left(\frac{x}{2}\right)^{2 k+v+1}
$$

$$
=v \mathrm{~J}_{v}(x)-x \mathrm{~J}_{v+1}(x)
$$

So

$$
x \mathrm{~J}_{v}^{\prime}(x)=v \mathrm{~J}_{v}(x)-x \mathrm{~J}_{v+1}(x)
$$

## Example 4

Derive the recurrence relation $\quad 2 J_{n}^{\prime}(x)=J_{n-1}(x)-J_{n+1}(x)$

## Solution:

As $\quad J_{n}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n+s)!}\left(\frac{x}{2}\right)^{n+2 s}$

$$
\begin{aligned}
& J_{n}^{\prime}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n+s)!}(n+2 s)\left(\frac{x}{2}\right)^{n+2 s-1}\left(\frac{1}{2}\right) \\
& =\sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n+s)!}(n+s+s)\left(\frac{x}{2}\right)^{n+2 s-1}\left(\frac{1}{2}\right)
\end{aligned}
$$

$$
\begin{aligned}
& =\sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n+s)!}(\overline{n+s})\left(\frac{x}{2}\right)^{n+2 s-1}\left(\frac{1}{2}\right)+\sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n+s)!} s \cdot\left(\frac{x}{2}\right)^{n+2 s-1}\left(\frac{1}{2}\right) \\
& =\sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n+s)(n+s-1)!}(n+s)\left(\frac{x}{2}\right)^{n+2 s-1}\left(\frac{1}{2}\right) \\
& +\sum_{s=0}^{\infty} \frac{(-1)^{s} s}{s(s-1)!(n+s)!} \cdot\left(\frac{x}{2}\right)^{n+2 s-1}\left(\frac{1}{2}\right) \\
& =\frac{1}{2} \sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n-1+s)!}\left(\frac{x}{2}\right)^{n-1+2 s}+\frac{1}{2} \sum_{s=1}^{\infty} \frac{(-1)^{s}}{(s-1)!(n+s)!} \cdot\left(\frac{x}{2}\right)^{n+2 s-1} \\
& =\frac{1}{2} J_{n-1}(x)+\frac{1}{2} \sum_{s=1}^{\infty} \frac{(-1)^{s}}{(s-1)!(n+s)!}\left(\frac{x}{2}\right)^{n+2 s-1}
\end{aligned}
$$

Put $s-1=p$ in $2^{\text {nd }}$ term $\Rightarrow s=p+1$

$$
\begin{aligned}
& =\frac{1}{2} J_{n-1}(x)+\frac{1}{2} \sum_{p=0}^{\infty} \frac{(-1)^{p+1}}{p!(n+p+1)!}\left(\frac{x}{2}\right)^{n+2(p+1)-1} \\
& =\frac{1}{2} J_{n-1}(x)+\frac{1}{2} \sum_{p=0}^{\infty} \frac{-1(-1)^{p}}{p!\left(\frac{(n+1}{n+p}\right)!}\left(\frac{x}{2}\right)^{\overline{n+1}+2 p} \\
& J_{n}^{\prime}(x)=\frac{1}{2} J_{n-1}(x)-\frac{1}{2} J_{n+1}(x) \\
& \Rightarrow 2 J_{n}^{\prime}(x)=J_{n-1}(x)-J_{n+1}(x)
\end{aligned}
$$

## Example 5

Derive the expression of $J_{n}(x)$ for $n= \pm \frac{1}{2}$

## Solution:

Consider $\quad J_{n}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n+s)!}\left(\frac{x}{2}\right)^{n+2 s}$
As $n!=\Gamma(n+1)$

$$
\Rightarrow J_{n}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{\Gamma(s+1) \Gamma(n+s+1)}\left(\frac{x}{2}\right)^{n+2 s}
$$

put $n=1 / 2$

$$
J_{1 / 2}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{\Gamma(s+1) \Gamma(1 / 2+s+1)}\left(\frac{x}{2}\right)^{\frac{1}{2}+2 s}
$$

$$
=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{\Gamma(s+1) \Gamma(s+3 / 2)}\left(\frac{x}{2}\right)^{\frac{1}{2}+2 s}
$$

Expanding R.H.S of above

$$
\begin{aligned}
J_{1 / 2}(x) & =\frac{(-1)^{0}}{\Gamma(0+1) \Gamma(0+3 / 2)}\left(\frac{x}{2}\right)^{\frac{1}{2}+0}+\frac{(-1)^{1}}{\Gamma(1+1) \Gamma(1+3 / 2)}\left(\frac{x}{2}\right)^{\frac{1}{2}+2(1)} \\
& +\frac{(-1)^{2}}{\Gamma(2+1) \Gamma(2+3 / 2)}\left(\frac{x}{2}\right)^{\frac{1}{2}+2(2)}+\frac{(-1)^{3}}{\Gamma(3+1) \Gamma(3+3 / 2)}\left(\frac{x}{2}\right)^{\frac{1}{2}+2(3)}+\cdots \\
& =\frac{2}{\sqrt{\pi}}\left(\frac{x}{2}\right)^{\frac{1}{2}}-\frac{2 \cdot 2}{3 \sqrt{\pi}}\left(\frac{x}{2}\right)^{\frac{5}{2}}+\frac{2 \cdot 2 \cdot 2}{2 \cdot 5 \cdot 3 \sqrt{\pi}}\left(\frac{x}{2}\right)^{\frac{9}{2}}-\cdots \\
& =\frac{1}{\sqrt{\pi}}\left[2 \cdot \frac{\sqrt{x}}{\sqrt{2}}-\frac{4}{3} \frac{\sqrt{x} \cdot x^{2}}{2^{5 / 2}}+\frac{4}{15} \frac{\sqrt{x} \cdot x^{4}}{2^{9 / 2}}-\cdots\right] \\
& =\frac{\sqrt{x}}{\sqrt{\pi}}\left[\frac{2}{\sqrt{2}}-\frac{4 x^{2}}{3 \cdot 2^{5 / 2}}+\frac{4}{15} \frac{x^{4}}{2^{9 / 2}}-\cdots\right] \\
& =\frac{\sqrt{2} \cdot \sqrt{x}}{\sqrt{\pi}}\left[\frac{2}{\sqrt{2} \sqrt{2}}-\frac{4 x^{2}}{3 \cdot \sqrt{2} \cdot 2^{5 / 2}}+\frac{4 x^{4}}{15 \cdot \sqrt{2} \cdot 2^{9 / 2}}-\cdots\right] \\
& =\frac{\sqrt{2} \cdot \sqrt{x}}{\sqrt{\pi}}\left[1-\frac{x^{2}}{6}+\frac{x^{4}}{120}-\cdots\right] \\
& =\frac{\sqrt{2} \cdot \sqrt{x}}{\sqrt{\pi}} \cdot \frac{1}{x}\left(x-\frac{x^{3}}{3!}+\frac{x^{5}}{5!}-\cdots\right) \\
& =\frac{\sqrt{2} \cdot \sqrt{x}}{\sqrt{\pi}} \sin x \\
\Rightarrow J_{1 / 2} & (x)=\sqrt{\frac{2}{\pi x}} \sin x
\end{aligned}
$$

Similarly for $n=-1 / 2$, we proceed further as before,

$$
\begin{aligned}
& J_{n}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{s!(n+s)!}\left(\frac{x}{2}\right)^{n+2 s} \text { where } n!=\Gamma(n+1) \\
& \Rightarrow J_{n}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{\Gamma(s+1) \Gamma(n+s+1)}\left(\frac{x}{2}\right)^{n+2 s} \\
& \text { put } n=-\frac{1}{2}
\end{aligned}
$$

$$
J_{-1 / 2}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{\Gamma(s+1) \Gamma(-1 / 2+s+1)}\left(\frac{x}{2}\right)^{-\frac{1}{2}+2 s}
$$

$$
J_{-1 / 2}(x)=\sum_{s=0}^{\infty} \frac{(-1)^{s}}{\Gamma(s+1) \Gamma(s+1 / 2)}\left(\frac{x}{2}\right)^{-\frac{1}{2}+2 s}
$$

Expanding the R.H.S of above we get

$$
\begin{aligned}
J_{-1 / 2}(x)= & \frac{(-1)^{0}}{\Gamma(0+1) \Gamma(0+1 / 2)}\left(\frac{x}{2}\right)^{-\frac{1}{2}}+\frac{(-1)^{1}}{\Gamma(1+1) \Gamma(1+1 / 2)}\left(\frac{x}{2}\right)^{-\frac{1}{2}+2(1)} \\
& +\frac{(-1)^{2}}{\Gamma(2+1) \Gamma(2+1 / 2)}\left(\frac{x}{2}\right)^{-\frac{1}{2}+2(2)}+\cdots \\
J_{-1 / 2}(x)= & \frac{1}{\Gamma(1) \Gamma(1 / 2)} \sqrt{\frac{2}{x}}-\frac{1}{\Gamma(2) \Gamma(3 / 2)}\left(\frac{x}{2}\right)^{\frac{3}{2}}+\frac{1}{\Gamma(3) \Gamma(5 / 2)}\left(\frac{x}{2}\right)^{\frac{7}{2}}-\cdots
\end{aligned}
$$

$$
=\frac{1}{(1) \Gamma(1 / 2)} \sqrt{\frac{2}{x}}-\frac{1}{1 \cdot \frac{1}{2} \cdot \Gamma(1 / 2)}\left(\frac{x}{2}\right)^{\frac{3}{2}}+\frac{1}{2 \cdot \frac{3}{2} \cdot \frac{1}{2} \Gamma(1 / 2)}\left(\frac{x}{2}\right)^{\frac{7}{2}}-\cdots
$$

$$
=\frac{1}{\Gamma(1 / 2)}\left[\frac{\sqrt{2}}{\sqrt{x}}-\frac{2 x^{3 / 2}}{2^{3 / 2}}+\frac{2 \cdot 2}{2 \cdot 3} \frac{x^{7 / 2}}{2^{7 / 2}}-\cdots\right]
$$

$$
=\frac{1}{\sqrt{\pi}}\left[\frac{\sqrt{2}}{\sqrt{x}}-\frac{2 x^{3 / 2}}{2^{3 / 2}}+\frac{2}{3} \frac{x^{7 / 2}}{2^{7 / 2}}-\cdots\right]
$$

$$
=\frac{\sqrt{2}}{\sqrt{\pi}}\left[\frac{\sqrt{2}}{\sqrt{x} \sqrt{2}}-\frac{2 x^{3 / 2}}{4}+\frac{2}{3} \frac{x^{7 / 2}}{16}-\cdots\right]
$$

$$
\begin{aligned}
& =\frac{\sqrt{2}}{\sqrt{\pi}}\left[\frac{\sqrt{2}}{\sqrt{x} \sqrt{2}}-\frac{x^{3 / 2}}{2}+\frac{1}{3} \frac{x^{7 / 2}}{8}-\cdots\right] \\
& =\frac{\sqrt{2}}{\sqrt{\pi}}\left[\frac{1}{\sqrt{x}}-\frac{x^{3 / 2}}{2}+\frac{x^{7 / 2}}{24}-\cdots\right] \\
& =\frac{\sqrt{2}}{\sqrt{\pi} \sqrt{x}}\left[\frac{\sqrt{x}}{\sqrt{x}}-\frac{x^{3 / 2}}{2}+\frac{x^{7 / 2}}{24}-\cdots\right] \\
& =\frac{\sqrt{2}}{\sqrt{\pi x}}\left[1-\frac{x^{2}}{2!}+\frac{x^{4}}{4!}-\cdots\right] \\
& =\sqrt{\frac{2}{\pi x}} \cos x \quad \because \cos x=1-\frac{x^{2}}{2!}+\frac{x^{4}}{4!}-\cdots \\
& \Rightarrow J_{-1 / 2}(x)=\sqrt{\frac{2}{\pi x}} \cos x
\end{aligned}
$$

Remarks:
Bessel functions of index half an odd integer are called Spherical Bessel functions. Like other Bessel functions spherical Bessel functions are used in many physical problems.

## Legendre's Differential Equation

A second order linear differential equation of the form

$$
\left(1-x^{2}\right) y^{\prime \prime}-2 x y^{\prime}+n(n+1) y=0
$$

is called Legendre's differential equation and any of its solution is called Legendre's function. If $n$ is positive integer then the solution of Legendre's differential equation is called a Legendere's polynomial of degree $n$ and is denoted by $P_{n}(x)$.

We assume a solution of the form $\quad y=\sum_{k=0}^{\infty} C_{k} x_{k}$

$$
\begin{aligned}
& \therefore\left(1-x^{2}\right) y^{\prime \prime}-2 x y^{\prime}+n(n+1) y= \\
& \left(1-x^{2}\right) \sum_{k=2}^{\infty} C_{k} k(k-1) x^{k-2}-2 \sum_{k=1}^{\infty} C_{k} k x^{k}+n(n+1) \sum_{k=0}^{\infty} C_{k} x^{k} \\
& =\sum_{k=2}^{\infty} C_{k} k(k-1) x^{k-2}-\sum_{k=2}^{\infty} C_{k} k(k-1) x^{k}-2 \sum_{k=1}^{\infty} C_{k} k x^{k}+n(n+1) \sum_{k=0}^{\infty} C_{k} x^{k} \\
& =\left[n(n+1) C_{0}+2 C_{2}\right] x^{0}+\left[n(n+1) C_{1}-2 C_{1}+6 C_{3}\right] x+\underbrace{\sum_{k=4}^{\infty} C_{k} k(k-1) x^{k-2}}_{j=k-2} \\
& -\underbrace{\sum_{k=2}^{\infty} C_{k} k(k-1) x^{k}}_{j=k}-2 \underbrace{\sum_{k=2}^{\infty} C_{k} k x^{k}}_{j=k}+n(n+1) \underbrace{\sum_{k=2}^{\infty} C_{k} x^{k}}_{j=k} \\
& =\left[n(n+1) C_{0}+2 C_{2}\right]+\left[(n-1)(n+2) C_{1}+6 C_{3}\right] x \\
& +\sum_{j=2}^{\infty}\left[(j+2)(j+1) C_{j+2}+(n-j)(n+j+1) C_{j}\right] x^{j}=0 \\
& \Rightarrow \quad n(n+1) C_{0}+2 C_{2}=0 \\
& (n-1)(n+2) C_{1}+6 C_{3}=0 \\
& (j+2)(j+1) C_{j+2}+(n-j)(n+j+1) C_{j}=0, j=2,3,4, \ldots \\
& \text { or } \\
& C_{2}=-\frac{n(n+1)}{2!} C_{0}
\end{aligned}
$$

$$
\begin{align*}
& C_{3}=-\frac{(n-1)(n+2)}{3!} C_{1} \\
& C_{j+2}=-\frac{(n-j)(n+j+1)}{(j+2)(j+1)} C_{j} ; \quad j=2,3, \ldots \tag{1}
\end{align*}
$$

From Iteration formula (1)

$$
\begin{aligned}
& C_{4}=-\frac{(n-2)(n+3)}{4 \cdot 3} C_{2}=\frac{(n-2)(n)(n+1)(n+3)}{4!} C_{0} \\
& C_{5}=-\frac{(n-3)(n+4)}{5 \cdot 4} C_{3}=\frac{(n-3)(n-1)(n+2)(n+4)}{5!} C_{1} \\
& C_{6}=-\frac{(n-4)(n+5)}{5 \cdot 6} C_{4}=-\frac{(n-4)(n-2) n(n+1)(n+3)(n+5)}{6!} C_{0} \\
& C_{7}=-\frac{(n-5)(n+6)}{7 \cdot 6} C_{5}=-\frac{(n-5)(n-3)(n-1)(n+2)(n+4)(n+6)}{7!} C_{1}
\end{aligned}
$$

and so on. Thus at least $|x|<1$, we obtain two linearly independent power series solutions.

$$
\begin{aligned}
y_{1}(x) & =C_{0}\left[1-\frac{n(n+1)}{2!} x^{2}+\frac{(n-2) n(n+1)(n+3)}{4!} x^{4}\right. \\
& \left.-\frac{(n-4)(n-2) n(n+1)(n+3)(n+5)}{6!} x^{6}+\cdots\right] \\
y_{2}(x) & =C_{1}\left[x-\frac{(n-1)(n+2)}{3!} x^{3}+\frac{(n-3)(n-1)(n+2)(n+4)}{5!} x^{5}\right. \\
& \left.-\frac{(n-5)(n-3)(n-1)(n+2)(n+4)(n+6)}{7!} x^{7}+\cdots\right]
\end{aligned}
$$

Note that if $n$ is even integer, the first series terminates, where $y_{2}(x)$ is an infinite series. For example if $n=4$, then

$$
y_{1}(x)=C_{0}\left[1-\frac{4 \cdot 5}{2!} x^{2}+\frac{2 \cdot 4 \cdot 5 \cdot 7}{4!} x^{4}\right]=C_{0}\left[1-10 x^{2}+\frac{35}{3} x^{4}\right]
$$

Similarly, when $n$ is an odd integer, the series for $y_{2}(x)$ terminates with $x^{n}$.i.e when $n$ is a non-negative integer, we obtain an nth-degree polynomial solution of Legendre's equation. Since we know that a constant multiple of a solution of Legendre's equation is
also a solution, it is traditional to choose specific values for $C_{0}$ and $C_{1}$ depending on whether $n$ is even or odd positive integer, respectively.
For $n=0$, we choose $C_{0}=1$ and for $n=2,4,6, \ldots$

$$
C_{0}=(-1)^{n / 2} \frac{1 \cdot 3 \cdot \ldots(n-1)}{2 \cdot 4 \cdot \ldots(n)}
$$

Whereas for $n=1$, we choose $C_{1}=1$ and for $n=3,5,7, \ldots$

$$
C_{1}=(-1)^{(n-1) / 2} \frac{1 \cdot 3 \cdot \ldots n}{2 \cdot 4 \cdot \ldots(n-1)}
$$

For example, when $n=4$, we have

$$
\begin{aligned}
& y_{1}(x)=(-1)^{4 / 2} \frac{1 \cdot 3}{2 \cdot 4}\left[1-10 x^{2}+\frac{35}{3} x^{4}\right] \\
& =\frac{3}{8}-\frac{30}{8} x^{2}+\frac{35}{8} x^{4} \\
& y_{1}(x)=\frac{1}{8}\left(35 x^{4}-30 x^{2}+3\right)
\end{aligned}
$$

Legendre's Polynomials are specific $\mathrm{n}^{\text {th }}$ degree polynomials and are denoted by $P_{n}(x)$. From the series for $y_{1}(x)$ and $y_{2}(x)$ and from the above choices of $C_{0}$ and $C_{1}$, we find that the first several Legendre's polynomials are

$$
\begin{aligned}
& P_{0}(x)=1 \\
& P_{1}(x)=x \\
& P_{2}(x)=\frac{1}{2}\left(3 x^{2}-1\right) \\
& P_{3}(x)=\frac{1}{2}\left(5 x^{3}-3 x\right) \\
& P_{4}(x)=\frac{1}{8}\left(35 x^{4}-30 x^{2}+3\right) \\
& P_{5}(x)=\frac{1}{8}\left(63 x^{5}-70 x^{3}+15 x\right)
\end{aligned}
$$

Note that $P_{0}(x), P_{1}(x), P_{2}(x), P_{3}(x), \ldots$ are, in turn particular solution of the differential equations

$$
\begin{array}{ll}
n=0 & \left(1-x^{2}\right) y^{\prime \prime}-2 x y^{\prime}=0 \\
n=1 & \left(1-x^{2}\right) y^{\prime \prime}-2 x y^{\prime}-2 y=0 \\
n=2 & \left(1-x^{2}\right) y^{\prime \prime}-2 x y^{\prime}+6 y=0 \\
n=3 & \left(1-x^{2}\right) y^{\prime \prime}-2 x y^{\prime}+12 y=0
\end{array}
$$

## Rodrigues Formula for Legendre's Polynomials

The Legendre Polynomials are also generated by Rodrigues formula

$$
P_{n}(x)=\frac{1}{2^{n} n!} \frac{d^{n}}{d x^{n}}\left(x^{2}-1\right)^{n}
$$

## Generating Function For Legendre's Polynomials

The Legendre's polynomials are the coefficient of $z^{n}$ in the expansion of

$$
\phi=\left(1-2 x z+z^{2}\right)^{-\frac{1}{2}}
$$

in ascending powers of $z$.

Now

$$
\phi=\left(1-2 x z+z^{2}\right)^{-\frac{1}{2}}=\{1-z(2 x-z)\}^{-\frac{1}{2}}
$$

Therefore by Binomial Series

$$
\begin{align*}
& \phi=1+\frac{1}{2} z(2 x-z)+\frac{-\frac{1}{2}\left(\frac{-3}{2}\right)}{2!}\{-z(2 x-z)\}^{2}+\frac{-\frac{1}{2}\left(\frac{-3}{2}\right)\left(\frac{-5}{2}\right)}{3!}\{-z(2 x-z)\}^{3}+\cdots \\
& =1+\frac{1}{2} z(2 x-z)+\frac{3}{8} z^{2}\left(4 x^{2}+z^{2}-4 x z\right)+\frac{5}{16} z^{3}\left(8 x^{3}-z^{3}-12 x^{2} z+6 x z^{2}\right)+\cdots \\
& =1+z x-\frac{1}{2} z^{2}+\frac{3}{2} x^{2} z^{2}+\frac{3}{8} z^{4}-\frac{3}{2} x z^{3}-\frac{5}{2} x^{3} z^{3}-\frac{5}{16} z^{6}-\frac{15}{4} x^{2} z^{4}+\frac{15}{8} x z^{5}+\cdots \\
& =1+x z+\frac{1}{2}\left(3 x^{2}-1\right) z^{2}+\frac{1}{2}\left(5 x^{3}-3 x\right) z^{3}+\frac{1}{8}\left(35 x^{4}-30 x^{2}+3\right) z^{4}+\cdots \tag{1}
\end{align*}
$$

Also

$$
\sum_{n=0}^{\infty} P_{n}(x) z^{n}=P_{0}(x)+P_{1}(x) z+P_{2}(x) z^{2}+P_{3}(x) z^{3}+\cdots
$$

Equating Coefficients of (1) and (2)

$$
\begin{aligned}
& P_{0}(x)=1 \\
& P_{1}(x)=x \\
& P_{2}(x)=\frac{1}{2}\left(3 x^{2}-1\right) \\
& P_{3}(x)=\frac{1}{2}\left(5 x^{3}-3 x\right) \\
& P_{4}(x)=\frac{1}{8}\left(35 x^{4}-30 x^{2}+3\right)
\end{aligned}
$$

Which are Legendre's Polynomials

## Recurrence Relation

Recurrence relations that relate Legendre’s polynomials of different degrees are also very important in some aspects of their application. We shall derive one such relation using the formula

$$
\begin{equation*}
\left(1-2 x t+t^{2}\right)^{-\frac{1}{2}}=\sum_{n=0}^{\infty} P_{n}(x) \cdot t^{n} \tag{1}
\end{equation*}
$$

Differentiating both sides of (1) with respect to $t$ gives

$$
\left(1-2 x t+t^{2}\right)^{-\frac{3}{2}}(x-t)=\sum_{n=0}^{\infty} n P_{n}(x) t^{n-1}=\sum_{n=1}^{\infty} n P_{n}(x) t^{n-1}
$$

so that after multiplying by $1-2 x t+t^{2}$, we have

$$
\begin{aligned}
& (x-t)\left(1-2 x t+t^{2}\right)^{-\frac{1}{2}}=\left(1-2 x t+t^{2}\right) \sum_{n=1}^{\infty} n P_{n}(x) t^{n-1} \\
& (x-t) \sum_{n=0}^{\infty} P_{n}(x) t^{n}=\left(1-2 x t+t^{2}\right) \sum_{n=1}^{\infty} n P_{n}(x) t^{n-1} \\
& \sum_{n=0}^{\infty} x P_{n}(x) t^{n}-\sum_{n=0}^{\infty} P_{n}(x) t^{n+1}-\sum_{n=1}^{\infty} n P_{n}(x) t^{n-1}+2 x \sum_{n=1}^{\infty} n P_{n}(x) t^{n} \\
& -\sum_{n=1}^{\infty} n P_{n}(x) t^{n+1}=0 \\
& x+x^{2} t+\sum_{n=2}^{\infty} x P_{n}(x) t^{n}-t-\sum_{n=1}^{\infty} P_{n}(x) t^{n+1}-x-2\left(\frac{3 x^{2}-1}{2}\right) t \\
& -\sum_{n=3}^{\infty} n P_{n}(x) t^{n-1}+2 x^{2} t+2 x \sum_{n=2}^{\infty} n P_{n}(x) t^{n}-\sum_{n=1}^{\infty} n P_{n}(x) t^{n+1}=0
\end{aligned}
$$

Observing the appropriate cancellations, simplifying and changing the summation indices

$$
\sum_{k=2}^{\infty}\left[-(k+1) P_{k+1}(x)+(2 k+1) x P_{k}(x)-k P_{k-1}(x)\right] t^{k}=0
$$

Equating the total coefficient of $t^{k}$ to zero gives the three-term recurrence relation

$$
(k+1) P_{k+1}(x)-(2 k+1) x P_{k}(x)+k P_{k-1}(x)=0, \quad k=2,3,4, \ldots
$$

## Legendre's Polynomials are orthogonal

## Proof:

Legendre's Differential Equation is $\left(1-x^{2}\right) y^{\prime \prime}-2 x y^{\prime}+n(n+1) y=0$
Let $P_{n}(x)$ and $P_{m}(x)$ are two solutions of Legendre's differential equation then

$$
\begin{aligned}
& \left(1-x^{2}\right) P_{n}^{\prime \prime}(x)-2 x P_{n}^{\prime}(x)+n(n+1) P_{n}(x)=0, \text { and } \\
& \left(1-x^{2}\right) P_{m}^{\prime \prime}(x)-2 x P_{m}^{\prime}(x)+m(m+1) P_{m}(x)=0
\end{aligned}
$$

which we can write

$$
\begin{align*}
& {\left[\left(1-x^{2}\right) P_{n}^{\prime}(x)\right]^{\prime}+n(n+1) P_{n}(x)=0}  \tag{1}\\
& {\left[\left(1-x^{2}\right) P_{m}^{\prime}(x)\right]^{\prime}+m(m+1) P_{m}(x)=0} \tag{2}
\end{align*}
$$

Multiplying (1) by $P_{m}(x)$ and (2) by $P_{n}(x)$ and subtracting, we get

$$
\begin{align*}
& P_{m}(x)\left\{\left(1-x^{2}\right) P_{n}^{\prime}\right\}^{\prime}-P_{n}(x)\left\{\left(1-x^{2}\right) P_{m}^{\prime}(x)\right\}^{\prime}  \tag{3}\\
& +\{n(n+1)-m(m+1)\} P_{m}(x) P_{n}(x)=0
\end{align*}
$$

Now

$$
\text { Add and subtract }\left(1-x^{2}\right) P_{m}^{\prime} P_{n}^{\prime} \text { to formulize the above }
$$

$$
P_{m}(x)\left\{\left(1-x^{2}\right) P_{n}^{\prime}\right\}^{\prime}-P_{n}(x)\left\{\left(1-x^{2}\right) P_{m}^{\prime}\right\}^{\prime}
$$

$$
\begin{aligned}
& =\left(1-x^{2}\right) P_{m}^{\prime}(x) P_{n}^{\prime}(x)+P_{m}(x)\left[\left(1-x^{2}\right) P_{n}^{\prime}(x)\right]^{\prime} \\
& -\left(1-x^{2}\right) P_{m}^{\prime}(x) P_{n}^{\prime}(x)+P_{n}(x)\left[\left(1-x^{2}\right) P_{m}^{\prime}(x)\right]^{\prime} \\
& =\left(1-x^{2}\right)\left[P_{n}(x) P_{n}^{\prime}(x)-P_{m}^{\prime}(x) P_{n}(x)\right]^{\prime}
\end{aligned}
$$

Which shows that (3) can be written as

$$
\begin{gathered}
{\left[\left(1-x^{2}\right)\left\{P_{m}(x) P_{n}^{\prime}(x)-P_{m}^{\prime}(x) P_{n}(x)\right\}\right]^{\prime}} \\
+[n(n+1)-m(m+1)] P_{m}(x) P_{n}(x)=0 \\
\left(\left(1-x^{2}\right)\left\{P_{m}(x) P_{n}^{\prime}(x)-P_{m}^{\prime}(x) P_{n}\right\}\right)^{\prime}+(n-m)(n+m+1) P_{m}(x) P_{n}(x)=0 \\
(n-m)(m+n+1) P_{m}(x) P_{n}(x)=\left(\left(1-x^{2}\right)\left\{P_{m}^{\prime}(x) P_{n}(x)-P_{m}(x) P_{n}^{\prime}(x)\right\}\right)^{\prime} \\
(n-m)(m+n+1) \int_{a}^{b} P_{m}(x) P_{n}(x) d x=\int_{a}^{b}\left(\left(1-x^{2}\right)\left\{P_{m}^{\prime}(x) P_{n}(x)-P_{m}(x) P_{n}^{\prime}(x)\right\}\right)^{\prime} d x \\
(n-m)(m+n+1) \int_{a}^{b} P_{m}(x) P_{n}(x) d x=\left.\left(1-x^{2}\right)\left\{P_{m}^{\prime}(x) P_{n}(x)-P_{m}(x) P_{n}^{\prime}(x)\right\}\right|_{a} ^{b}
\end{gathered}
$$

$$
\text { As } 1-x^{2}=0 \text { for } x= \pm 1 \text { so }
$$

$$
(n-m)(n+m+1) \int_{-1}^{1} P_{m}(x) P_{n}(x) d x=0 \quad \text { for } x= \pm 1
$$

Since $m \& n$ are non-negative

$$
\Rightarrow \int_{-1}^{1} P_{m}(x) P_{n}(x) d x=0 \text { for } m \neq n
$$

which shows that Legendre's Polynomials are orthogonal w.r.to the weight function $w(x)=1$ over the interval $\left[\begin{array}{ll}-1 & 1\end{array}\right]$

## Normality condition for Legendre’ Polynomials

Consider the generating function

$$
\begin{equation*}
\left(1-2 x t+t^{2}\right)^{-\frac{1}{2}}=\sum_{m=0}^{\infty} P_{m}(x) t^{m} \tag{1}
\end{equation*}
$$

Also

$$
\begin{equation*}
\left(1-2 x t+t^{2}\right)^{-\frac{1}{2}}=\sum_{n=0}^{\infty} P_{n}(x) t^{n} \tag{2}
\end{equation*}
$$

Multiplying (1) and (2)

$$
\left(1-2 x t+t^{2}\right)^{-1}=\sum_{m=0}^{\infty} \sum_{n=0}^{\infty} P_{m}(x) P_{n}(x) t^{m+n}
$$

Integrating from -1 to 1

$$
\begin{aligned}
& \int_{-1}^{1} \frac{1}{\left(1-2 x t+t^{2}\right)} d x=\sum_{m=0}^{\infty} \sum_{n=0}^{\infty} \int_{-1}^{1} P_{m}(x) P_{n}(x) t^{m+n} d x \\
&-\frac{1}{2 t} \int_{-1}^{1} \frac{-2 t}{\left(1-2 x t+t^{2}\right)} d x=\sum_{m=0}^{\infty} \sum_{n=0}^{\infty} \int_{-1}^{1} P_{m}(x) P_{n}(x) t^{m+n} d x \\
&-\left.\frac{1}{2 t} \ln \left(1-2 x t+t^{2}\right)\right|_{-1} ^{1}=\sum_{m=0}^{\infty} \sum_{n=0}^{\infty} \int_{-1}^{1} P_{m}(x) P_{n}(x) t^{m+n} d x \\
& \Rightarrow \sum_{m=0}^{\infty} \sum_{n=0}^{\infty} \int_{-1}^{1} P_{m}(x) P_{n}(x) t^{m+n} d x=-\frac{1}{2 t}\left[\ln \left(1-2 t+t^{2}\right)-\ln \left(1+2 t+t^{2}\right)\right] \\
&=-\frac{1}{2 t}\left[\ln (1-t)^{2}-\ln \left(1+t^{2}\right)\right] \\
&=-\frac{1}{2 t}\left\{\ln (1+t)^{2}-\ln \left(1-t^{2}\right)\right\}
\end{aligned}
$$

$$
\begin{aligned}
&=-\frac{1}{t}[\ln (1+t)-\ln (1-t)] \\
&=\frac{1}{t}\left[\left(t-\frac{t^{2}}{2}+\frac{t^{3}}{3}-\frac{t^{4}}{4}+\cdots\right)-\left(-t-\frac{t^{2}}{2}-\frac{t^{3}}{3}-\frac{t^{4}}{4}-\cdots\right)\right] \\
&=\frac{1}{t}\left\{2 t+\frac{2 t^{3}}{3}+\frac{2 t^{5}}{5}+\cdots\right\} \\
&=\frac{2}{t}\left\{t+\frac{t^{3}}{3}+\frac{t^{5}}{5}+\cdots\right\} \\
&=2\left\{1+\frac{t^{2}}{3}+\frac{t^{4}}{5}+\cdots\right\} \\
& \Rightarrow \sum_{m=0}^{\infty} \sum_{n=0}^{\infty} \int_{-1}^{1} P_{m}(x) P_{n}(x) t^{m+n} d x=2\left\{1+\frac{t^{2}}{3}+\frac{t^{4}}{5}+\cdots\right\} \\
& f o r m=n \\
& \Rightarrow \sum_{n=0}^{\infty} \int_{-1}^{1} P_{n}(x) P_{n}(x) t^{n+n} d x=2\left\{1+\frac{t^{2}}{3}+\frac{t^{4}}{5}+\cdots\right\} \\
& \Rightarrow \sum_{n=0}^{\infty} \int_{-1}^{1}\left[P_{n}(x)\right]^{2} t^{2 n} d x=2\left\{1+\frac{t^{2(1)}}{2(1)+1}+\frac{t^{2(2)}}{2(2)+1}+\cdots+\frac{t^{2 n}}{2(n)+1}\right\}
\end{aligned}
$$

Equating coefficient of $t^{2 n}$ on both sides

$$
\begin{aligned}
& \Rightarrow \int_{-1}^{1}\left[P_{n}(x)\right]^{2} d x=\frac{2}{2 n+1} \\
& \Rightarrow \int_{-1}^{1} P_{n}(x) P_{n}(x) d x=\frac{2}{2 n+1} \\
& \Rightarrow \int_{-1}^{1} P_{n}(x) P_{n}(x) \frac{2 n+1}{2} d x=1
\end{aligned}
$$

which shows that Legender polynomials are normal with respect to the weight function $w(x)=\frac{2 n+1}{2}$ over the interval $-1<x<1$.

## Remark:

Orthognality condition for $P_{n}(x)$ can also be written as

$$
\begin{aligned}
& \int_{-1}^{1} P_{n}(x) P_{n}(x) d x=\left(\frac{2}{2 n+1}\right) \delta_{m, n} \\
& \text { where } \delta_{m, n}= \begin{cases}0 & , \quad \text { if } m \neq n \\
1 & , \text { otherwise }\end{cases}
\end{aligned}
$$

## Systems of Linear Differential Equations

- Recall that the mathematical model for the motion of a mass attached to a spring or for the response of a series electrical circuit is a differential equation.

$$
a \frac{d^{2} y}{d x^{2}}+b \frac{d y}{d x}+c y=f(x)
$$

- However, we can attach two or more springs together to hold two masses $m_{1}$ and $m_{2}$. Similarly a network of parallel circuits can be formed.

- To model these latter situations, we would need two or more coupled or simultaneous equations to describe the motion of the masses or the response of the network.
- Therefore, in this lecture we will discuss the theory and solution of the systems of simultaneous linear differential equations with constant coefficients.


## Note that

An $n t h$ order linear differential equation with constant coefficients $a_{0}, a_{1}, \ldots, a_{n}$ is an equation of the form

$$
a_{n} \frac{d^{n} y}{d x^{n}}+a_{n-1} \frac{d^{n-1} y}{d x^{n-1}}+\cdots+a_{1} \frac{d y}{d x}+a_{0} y=g(x)
$$

If we write $D=\frac{d}{d x}, D^{2}=\frac{d^{2}}{d x^{2}}, \cdots, D^{n}=\frac{d^{n}}{d x^{n}}$ then this equation can be written as follows

$$
\left(a_{n} D^{n}+a_{n-1} D^{(n-1)}+\cdots+a_{1} D+a_{0}\right) y=g(t)
$$

## Simultaneous Differential Equations

The simultaneous ordinary differential equations involve two or more equations that contain derivatives of two or more unknown functions of a single independent variable.

## Example 1

If $x, y$ and $z$ are functions of the variable $t$, then

$$
\begin{aligned}
& 4 \frac{d^{2} x}{d t^{2}}=-5 x+y \\
& 2 \frac{d^{2} y}{d t^{2}}=3 x-y
\end{aligned}
$$

and

$$
\begin{aligned}
& x^{\prime}-3 x+y^{\prime}+z^{\prime}=5 \\
& x+y^{\prime}-6 z^{\prime}=t-1
\end{aligned}
$$

are systems of simultaneous differential equations.

## Solution of a System

A solution of a system of differential equations is a set of differentiable functions

$$
x=f(t), \quad y=g(t), x=h(t), \ldots
$$

those satisfy each equation of the system on some interval $I$.

## Systematic Elimination: Operator Method

- This method of solution of a system of linear homogeneous or linear nonhomogeneous differential equations is based on the process of systematic elimination of the dependent variables.
- This elimination provides us a single differential equation in one of the dependent variables that has not been eliminated.
- This equation would be a linear homogeneous or a linear non-homogeneous differential equation and can be solved by employing one of the methods discussed earlier to obtain one of the dependent variables.

Notice that the analogue of multiplying an algebraic equation by a constant is operating on a differential equation with some combination of derivatives.

## The Method

Step 1 First write the differential equations of the system in a form that involves the differential operator $D$.
Step 2 We retain first of the dependent variables and eliminate the rest from the differential equations of the system.
Step 3 The result of this elimination is to be a single linear differential equation with constant coefficients in the retained variable. We solve this equation to obtain the value of this variable.

Step 4 Next, we retain second of the dependent variables and eliminate all others variables

Step 5 The result of the elimination performed in step 4 is to be again a single linear differential equation with constant coefficients in the retained $2^{\text {nd }}$ variable. We again solve this equation and obtain the value of the second dependent variable. This process of elimination is continued untill all the variables are taken care of.

Step 6 The computed values of the dependent variables don't satisfy the given system for every choice of all the arbitrary constants. By substituting the values of the dependent variables computed in step 5 into an equation of the original system, we can reduce the number of constant from the solution set.

Step 7 We use the work done in step number 6 to write the solution set of the given system of linear differential equations.

## Example 1

Solve the system of differential equations

$$
\frac{d y}{d t}=2 x, \quad \frac{d x}{d t}=3 y
$$

## Solution:

Step 1 The given system of linear differential equations can be written in the differential operator form as
or

$$
\begin{array}{ll}
D y=2 x, & D x=3 y \\
2 x-D y=0, & D x-3 y=0
\end{array}
$$

Step 2 Next we eliminate one of the two variables, say $x$, from the two differential equations. Operating on the first equation by $D$ while multiplying the second by 2 and then subtracting eliminates $x$ from the system. It follows that

$$
-D^{2} y+6 y=0 \text { or } D^{2} y-6 y=0
$$

Step 3 Clearly, the result is a single linear differential equation with constant coefficients in the retained variable $y$. The roots of the auxiliary equation are real and distinct

Therefore,

$$
m_{1}=\sqrt{6} \text { and } m_{2}=-\sqrt{6}
$$

Step 4 We now eliminate the variable $y$ that was retained in the previous step. Multiplying the first equation by -3 , while operating on the second by $D$ and then adding gives the differential equation for $x$,

$$
D^{2} x-6 x=0
$$

Step 5 Again, the result is a single linear differential equation with constant coefficients in the retained variable $x$. We now solve this equation and obtain the value of the second dependent variable. The roots of the auxiliary equation are $m= \pm \sqrt{6}$. It follows that

$$
x(t)=c_{3} e^{\sqrt{6} t}+c_{4} e^{-\sqrt{6} t}
$$

Hence the values of the dependent variables $x(t), y(t)$ are.

$$
\begin{aligned}
& x(t)=c_{3} e^{\sqrt{6} t}+c_{4} e^{-\sqrt{6} t} \\
& y(t)=c_{1} e^{\sqrt{6} t}+c_{2} e^{-\sqrt{6} t}
\end{aligned}
$$

Step 6 Substituting the values of $x(t)$ and $y(t)$ from step 5 into first equation of the given system, we have

$$
\left(\sqrt{6} c_{1}-2 c_{3}\right) e^{\sqrt{6} t}+\left(-\sqrt{6} c_{2}-2 c_{4}\right) e^{-\sqrt{6} t}=0
$$

Since this expression is to be zero for all values of $t$, we must have

$$
\begin{array}{ll} 
& \sqrt{6} c_{1}-2 c_{3}=0, \\
\text { or } & -\sqrt{6} c_{2}-2 c_{4}=0 \\
c_{3}=\frac{\sqrt{6}}{2} c_{1}, & c_{4}=-\frac{\sqrt{6}}{2} c_{2}
\end{array}
$$

Notice that if we substitute the computed values of $x(t)$ and $y(t)$ into the second equation of the system, we shall find that the same relationship holds between the constants.

Step 7 Hence, by using the above values of $c_{1}$ and $c_{2}$, we write the solution of the given system as

$$
\begin{aligned}
& x(t)=\frac{\sqrt{6}}{2} c_{1} e^{\sqrt{6} t}-\frac{\sqrt{6}}{2} c_{2} c^{-\sqrt{6} t} \\
& y(t)=c_{1} e^{\sqrt{6} t}+c_{2} e^{-\sqrt{6} t}
\end{aligned}
$$

## Example 2

Solve the following system of differential equations

$$
\begin{aligned}
D x+(D+2) y & =0 \\
(D-3) x-2 y & =0
\end{aligned}
$$

## Solution:

Step 1 The differential equations of the given system are already in the operator form.
Step 2 We eliminate the variable $x$ from the two equations of the system. Thus operating on the first equation by $D-3$ and on the second by $D$ and then subtracting eliminates $x$ from the system. The resulting differential equation for the retained variable $y$ is

$$
\begin{aligned}
{[(D-3)(D+2)+2 D] y } & =0 \\
\left(D^{2}+D-6\right) y & =0
\end{aligned}
$$

Step 3 The auxiliary equation of the differential equation for $y$ obtained in the last step is

$$
m^{2}+m-6=0 \Rightarrow(m-2)(m+3)=0
$$

Since the roots of the auxiliary equation are

$$
m_{1}=2, \quad m_{2}=-3
$$

Therefore, the solution for the dependent variable $y$ is

$$
y(t)=c_{1} e^{2 t}+c_{2} e^{-3 t}
$$

Step 4 Multiplying the first equation by 2 while operating on the second by $(D+2)$ and then adding yields the differential equation for $x$

$$
\left(D^{2}+D-6\right) x=0
$$

Step 5 The auxiliary equation for this equation for $x$ is

$$
m^{2}+m-6=0=(m-2)(m+3)
$$

The roots of this auxiliary equation are

$$
m_{1}=2, \quad m_{2}=-3
$$

Thus, the solution for the retained variable $x$ is

$$
x(t)=c_{3} e^{2 t}+c_{4} e^{-3 t}
$$

Writing two solutions together, we have

$$
\begin{aligned}
& x(t)=c_{3} e^{2 t}+c_{4} e^{-3 t} \\
& y(t)=c_{1} e^{2 t}+c_{2} e^{-3 t}
\end{aligned}
$$

Step 6 To reduce the number of constants, we substitute the last two equations into the first equation of the given system to obtain

$$
\left(4 c_{1}+2 c_{3}\right) e^{2 t}+\left(-c_{2}-3 c_{4}\right) e^{-3 t}=0
$$

Since this relation is to hold for all values of the independent variable $t$. Therefore, we must have

$$
\begin{array}{ll}
4 c_{1}+2 c_{3}=0, & -c_{2}-3 c_{4}=0 . \\
\text { or } & c_{3}=-2 c_{1},
\end{array} \quad c_{4}=-\frac{1}{3} c_{2} .
$$

Step 7 Hence, a solution of the given system of differential equations is

$$
\begin{aligned}
& x(t)=-2 c_{1} e^{2 t}-\frac{1}{3} c_{2} e^{-3 t} \\
& y(t)=c_{1} e^{2 t}+c_{2} e^{-3 t}
\end{aligned}
$$

## Example 3

Solve the system

$$
\begin{array}{r}
\frac{d x}{d t}-4 x+\frac{d^{2} y}{d t^{2}}=t^{2} \\
\frac{d x}{d t}+x+\frac{d y}{d t}=0
\end{array}
$$

## Solution:

Step 1 First we write the differential equations of the system in the differential operator form:

$$
\begin{aligned}
& (D-4) x+D^{2} y=t^{2} \\
& (D+1) x+D y=0
\end{aligned}
$$

Step 2 Then we eliminate one of the dependent variables, say $x$. Operating on the first equation with the operator $D+1$, on the second equation with the operator $D-4$ and then subtracting, we obtain

$$
\left[(D+1) D^{2}-(D-4) D\right] y=(D+1) t^{2}
$$

or

$$
\left(D^{3}+4 D\right) y=t^{2}+2 t
$$

Step 3 The auxiliary equation of the differential equation found in the previous step is

$$
m^{3}+4 m=0=m\left(m^{2}+4\right)
$$

Therefore, roots of the auxiliary equation are

$$
m_{1}=0, \quad m_{2}=2 i, \quad m_{3}=-2 i
$$

So that the complementary function for the retained variable $y$ is

$$
y_{c}=c_{1}+c_{2} \cos 2 t+c_{3} \sin 2 t
$$

To determine the particular solution $y_{p}$ we use undetermined coefficients. Therefore, we assume

$$
y_{p}=A t^{3}+B t^{2}+C t
$$

So that

$$
y_{p}^{\prime}=3 A t^{2}+2 B t+C
$$

$$
y_{p}^{\prime \prime}=6 A t+2 B, y_{p}^{\prime \prime \prime}=6 A
$$

Thus

$$
y_{p}^{\prime \prime \prime}+4 y_{p}^{\prime}=12 A t^{2}+8 B t+6 A+4 C
$$

Substituting in the differential equation found in step, we obtain

$$
12 A t^{2}+8 B t+6 A+4 C=t^{2}+2 t
$$

Equating coefficients of $t^{2}, t$ and constant terms yields

$$
12 A=1, \quad 8 B=2, \quad 6 A+4 C=0,
$$

Solving these equations give

$$
A=1 / 12, B=1 / 4, C=-1 / 8
$$

Hence, the solution for the variable $y$ is given by
or

$$
\begin{aligned}
& y=y_{c}+y_{p} \\
& y=c_{1}+c_{2} \cos 2 t+c_{3} \sin 2 t+\frac{1}{12} t^{3}+\frac{1}{4} t^{2}-\frac{1}{8} t
\end{aligned}
$$

Step 4 Next we eliminate the variable $y$ from the given system. For this purpose we multiply first equation with 1 while operate on the second equation with the operator $D$ and then subtracting, we obtain

$$
[(D-4)-D(D+1)] x=t^{2}
$$

or

$$
\left(D^{2}+4\right) x \quad=-t^{2}
$$

Step 5 The auxiliary equation of the differential equation for $x$ is

$$
m^{2}+4=0 \Rightarrow m= \pm 2 i
$$

The roots of the auxiliary equation are complex. Therefore, the complementary function for $x$

$$
x_{c}=c_{4} \cos 2 t+c_{5} \sin 2 t
$$

The method of undetermined coefficients can be applied to obtain a particular solution. We assume that

$$
x_{p}=A t^{2}+B t+C
$$

Then

$$
x_{p}^{\prime}=2 A t+B, x_{p}^{\prime \prime}=2 A
$$

Therefore

$$
x_{p}^{\prime \prime}+4 x_{p}=2 A+4 A t^{2}+4 B t+4 C
$$

Substituting in the differential equation for $x$, we obtain

$$
4 A t^{2}+4 B t+2 A+4 C=-t^{2}
$$

Equating the coefficients of $t^{2}, t$ and constant terms, we have

$$
4 A=-1, \quad 4 B=0, \quad 2 A+4 C=0
$$

Solving these equations we obtain

Thus

$$
A=-1 / 4, B=0, C=1 / 8
$$

So that

$$
x_{p}=-\frac{1}{4} t^{2}+\frac{1}{8}
$$

$$
x=x_{C}+x_{p}=c_{4} \cos 2 t+c_{5} \sin 2 t-\frac{1}{4} t^{2}+\frac{1}{8}
$$

Hence, we have

$$
\begin{aligned}
& x=x_{C}+x_{p}=c_{4} \cos 2 t+c_{5} \sin 2 t-\frac{1}{4} t^{2}+\frac{1}{8} \\
& y=c_{1}+c_{2} \cos 2 t+c_{3} \sin 2 t+\frac{1}{12} t^{3}+\frac{1}{4} t^{2}-\frac{1}{8} t
\end{aligned}
$$

Step 6 Now $c_{4}$ and $c_{5}$ can be expressed in terms of $c_{2}$ and $c_{3}$ by substituting these values of $x$ and $y$ into the second equation of the given system and we find, after combining the terms,

$$
\left(c_{5}-2 c_{4}-2 c_{2}\right) \sin 2 t+\left(2 c_{5}+c_{4}+2 c_{3}\right) \cos 2 t=0
$$

So that

$$
c_{5}-2 c_{4}-2 c_{2}=0, \quad 2 c_{5}+c_{4}+2 c_{3}=0
$$

Solving the last two equations for $c_{4}$ and $c_{5}$ in terms of $c_{2}$ and $c_{3}$ gives

$$
c_{4}=-\frac{1}{5}\left(4 c_{2}+2 c_{3}\right), \quad c_{5}=\frac{1}{5}\left(2 c_{2}-4 c_{3}\right) .
$$

Step 7 Finally, a solution of the given system is found to be

$$
\begin{aligned}
& x(t)=-\frac{1}{5}\left(4 c_{2}+2 c_{3}\right) \cos 2 t+\frac{1}{5}\left(2 c_{2}-4 c_{3}\right) \sin 2 t-\frac{1}{4} t^{2}+\frac{1}{8} t \\
& y(t)=c_{1}+c_{2} \cos 2 t+c_{3} \sin 2 t+\frac{1}{12} t^{3}+\frac{1}{4} t^{2}-\frac{1}{8} t .
\end{aligned}
$$

## Exercise

Solve, if possible, the given system of differential equations by either systematic elimination.

1. $\frac{d x}{d t}=x+7 y, \quad \frac{d y}{d t}=x-2 y$
2. $\frac{d x}{d t}-4 y=1, \quad x+\frac{d y}{d t}=2$
3. $(D+1) x+(D-1) y=2, \quad 3 x+(D+2) y=-1$

## Systems of Linear Differential Equations

## Solution of Using Determinants

If $L_{1}, L_{2}, L_{3}$ and $L_{4}$ denote linear differential operators with constant coefficients, then a system of linear differential equations in two variables $x$ and $y$ can be written as

$$
\begin{aligned}
& L_{1} x+L_{2} y=g_{1}(t) \\
& L_{3} x+L_{4} y=g_{2}(t)
\end{aligned}
$$

To eliminate $y$, we operate on the first equation with $L_{4}$ and on the second equation with $L_{2}$ and then subtracting, we obtain

$$
\left(L_{1} L_{4}-L_{2} L_{3}\right) x=L_{4} g_{1}-L_{2} g_{2}
$$

Similarly, operating on the first equation with $L_{3}$ and second equation with $L_{1}$ and then subtracting, we obtain

$$
\left(L_{1} L_{4}-L_{2} L_{3}\right) y=L_{1} g_{2}-L_{3} g_{1}
$$

Since

Therefore

$$
L_{1} L_{4}-L_{2} L_{3}=\left|\begin{array}{ll}
L_{1} & L_{2} \\
L_{3} & L_{4}
\end{array}\right|
$$

and

$$
\begin{aligned}
& L_{4} g_{1}-L_{2} g_{2}=\left|\begin{array}{ll}
g_{1} & L_{2} \\
g_{2} & L_{4}
\end{array}\right| \\
& L_{1} g_{2}-L_{3} g_{1}=\left|\begin{array}{ll}
L_{1} & g_{1} \\
L_{3} & g_{2}
\end{array}\right|
\end{aligned}
$$

Hence, the given system of differential equations can be decoupled into nth order differential equations. These equations use determinants similar to those used in Cramer's rule:

$$
\left|\begin{array}{ll}
L_{1} & L_{2} \\
L_{3} & L_{4}
\end{array}\right| x=\left|\begin{array}{ll}
g_{1} & L_{2} \\
g_{2} & L_{4}
\end{array}\right| \text { and }\left|\begin{array}{ll}
L_{1} & L_{2} \\
L_{3} & L_{4}
\end{array}\right| y=\left|\begin{array}{ll}
L_{1} & g_{1} \\
L_{3} & g_{2}
\end{array}\right|
$$

The uncoupled differential equations can be solved in the usual manner.

## Note that

- The determinant on left hand side in each of these equations can be expanded in the usual algebraic sense. This means that the symbol $D$ occurring in $L_{i}$ is to be treated as an algebraic quantity. The result of this expansion is a differential operator of order $n$, which is operated on $x$ and $y$.
- However, some care should be exercised in the expansion of the determinant on the right hand side. We must expand these determinants in the sense of the internal differential operators actually operating on the functions $g_{1}$ and $g_{2}$. Therefore, the symbol $D$ occurring in $L_{i}$ is to be treated as an algebraic quantity.


## The Method

The steps involved in application of the method of detailed above can be summarized as follows:

Step 1 First we have to write the differential equations of the given system in the differential operator form

$$
\begin{aligned}
& L_{1} x+L_{2} y=g_{1}(t) \\
& L_{3} x+L_{4} y=g_{2}(t)
\end{aligned}
$$

Step 2 We find the determinants

$$
\left|\begin{array}{ll}
L_{1} & L_{2} \\
L_{3} & L_{4}
\end{array}\right|,\left|\begin{array}{ll}
g_{1} & L_{2} \\
g_{2} & L_{4}
\end{array}\right|,\left|\begin{array}{ll}
L_{1} & g_{1} \\
L_{3} & g_{2}
\end{array}\right|
$$

Step 3 If the first determinant is non-zero, then it represents an $n^{\text {th }}$ order differential operator and we decoupled the given system by writing the differential equations

$$
\begin{aligned}
& \left|\begin{array}{ll}
L_{1} & L_{2} \\
L_{3} & L_{4}
\end{array}\right| \cdot x=\left|\begin{array}{ll}
g_{1} & L_{2} \\
g_{2} & L_{4}
\end{array}\right| \\
& \left|\begin{array}{ll}
L_{1} & L_{2} \\
L_{3} & L_{4}
\end{array}\right| \cdot y=\left|\begin{array}{ll}
L_{1} & g_{1} \\
L_{3} & g_{2}
\end{array}\right|
\end{aligned}
$$

Step 4 Find the complementary functions for the two equations. Remember that the auxiliary equation and hence the complementary function of each of these differential equations is the same.
Step 5 Find the particular integrals $x_{p}$ and $y_{p}$ using method of undetermined coefficients or the method of variation of parameters.
Step 6 Finally, we write the general solutions for both the dependent variables $x$ and $y$

$$
x=x_{c}+x_{p}, \quad y=y_{c}+y_{p} .
$$

Step 7 Reduce the number of constants by substituting in one of the differential equations of the given system

## Note that

If the determinant found in step 2 is zero, then the system may have a solution containing any number of independent constants or the system may have no solution at all. Similar remarks hold for systems larger than system indicated in the previous discussion.

## Example 1

Solve the following homogeneous system of differential equations

$$
\begin{aligned}
& 2 \frac{d x}{d t}-5 x+\frac{d y}{d t}=e^{t} \\
& \frac{d x}{d t}-x+\frac{d y}{d t}=5 e^{t}
\end{aligned}
$$

## Solution:

Step 1 First we write the differential equations of the system in terms of the differential operator $D$

$$
\begin{aligned}
(2 D-5) x+D y & =e^{t} \\
(D-1) x+D y & =5 e^{t}
\end{aligned}
$$

Step 2 We form the determinant

$$
\left|\begin{array}{cc}
2 D-5 & D \\
D-1 & D
\end{array}\right|, \quad\left|\begin{array}{cc}
e^{t} & D \\
5 e^{t} & D
\end{array}\right|, \quad\left|\begin{array}{cc}
2 D-5 & e^{t} \\
D-1 & 5 e^{t}
\end{array}\right|
$$

Step 3 Since the $1^{\text {st }}$ determinant is non-zero

$$
\begin{aligned}
& \left|\begin{array}{cc}
2 D-5 & D \\
D-1 & D
\end{array}\right|=(2 D-5) D-(D-1) D \\
& \left|\begin{array}{cc}
2 D-5 & D \\
D-1 & D
\end{array}\right|=D^{2}-4 D \neq 0
\end{aligned}
$$

Therefore, we write the decoupled equations

$$
\begin{aligned}
& \left|\begin{array}{cc}
2 D-5 & D \\
D-1 & D
\end{array}\right| x=\left|\begin{array}{cc}
e^{t} & D \\
5 e^{t} & D
\end{array}\right| \\
& \left|\begin{array}{cc}
2 D-5 & D \\
D-1 & D
\end{array}\right| y=\left|\begin{array}{cc}
2 D-5 & e^{t} \\
D-1 & 5 e^{t}
\end{array}\right|
\end{aligned}
$$

After expanding we find that

$$
\begin{aligned}
& \left(D^{2}-4 D\right) x=D e^{t}-D\left(5 e^{t}\right)=-4 e^{t} \\
& \left(D^{2}-4 D\right) y=(2 D-5)\left(5 e^{t}\right)-(D-1) e^{t}=-15 e^{t}
\end{aligned}
$$

Step 4 We find the complementary function for the two equations. The auxiliary equation for both of the differential equations is:

$$
m^{2}-4 m=0 \Rightarrow m=0,4
$$

The auxiliary equation has real and distinct roots

$$
\begin{aligned}
& x_{C}=c_{1}+c_{2} e^{4 t} \\
& y_{C}=c_{3}+c_{4} e^{4 t}
\end{aligned}
$$

Step 5 We now use the method of undetermined coefficients to find the particular integrals $x_{p}$ and $y_{p}$.
Since

$$
g_{1}(t)=-4 e^{t}, \quad g_{2}(t)=-15 e^{t}
$$

We assume that

$$
x_{p}=A e^{t}, \quad y_{p}=B e^{t}
$$

Then

$$
D x_{p}=A e^{t}, \quad D^{2} x_{p}=A e^{t}
$$

And

$$
D y_{p}=B e^{t}, \quad D^{2} y_{p}=B e^{t}
$$

Substituting in the differential equations, we have
or

$$
\begin{aligned}
& A e^{t}-4 A e^{t}=-4 e^{t} \\
& B e^{t}-4 B e^{t}=-15 e^{t} \\
& -3 A e^{t}=-4 e^{t}, \quad-3 B e^{t}=-15 e^{t}
\end{aligned}
$$

Equating coefficients of $e^{t}$ and constant terms, we obtain

So that

$$
A=\frac{4}{3}, \quad B=5
$$

$$
x_{p}=\frac{4}{3} e^{t}, \quad y_{p}=5 e^{t}
$$

Step 6 Hence, the general solution of the two decoupled equations

$$
\begin{aligned}
& x=x_{C}+x_{p}=c_{1}+c_{2} e^{4 t}+\frac{4}{3} e^{t} \\
& y=y_{C}+y_{p}=c_{3}+c_{4} e^{4 t}+5 e^{t}
\end{aligned}
$$

Step 7 Substituting these solutions for $x$ and $y$ into the second equation of the given system, we obtain

$$
\begin{aligned}
& -c_{1}+\left(3 c_{2}+4 c_{4}\right) e^{4 t}=0 \\
& \text { or } \quad c_{1}=0, \quad c_{4}=-\frac{3}{4} c_{2}
\end{aligned}
$$

Hence, the general solution of the given system of differential equations is

$$
\begin{aligned}
& x(t)=c_{2} e^{4 t}+\frac{4}{3} e^{t} \\
& y(t)=c_{3}-\frac{3}{4} c_{2} e^{4 t}+5 e^{t}
\end{aligned}
$$

If we re-notate the constants $c_{2}$ and $c_{3}$ as $c_{1}$ and $c_{2}$, respectively. Then the solution of the system can be written as:

$$
\begin{aligned}
& x(t)=c_{1} e^{4 t}+\frac{4}{3} e^{t} \\
& y(t)=-\frac{3}{4} c_{1} e^{4 t}+c_{2}+5 e^{t}
\end{aligned}
$$

## Example 2

Solve

$$
\begin{gathered}
x^{\prime}=3 x-y-1 \\
y^{\prime}=x+y+4 e^{t}
\end{gathered}
$$

## Solution:

Step 1 First we write the differential equations of the system in terms of the differential operator $D$

$$
\begin{aligned}
(D-3) x+y & =-1 \\
-x+(D-1) y & =4 e^{t}
\end{aligned}
$$

Step 2 We form the determinant

$$
\left|\begin{array}{cc}
D-3 & 1 \\
-1 & D-1
\end{array}\right|,\left|\begin{array}{cc}
-1 & 1 \\
4 e^{t} & D-1
\end{array}\right|,\left|\begin{array}{cc}
D-3 & 1 \\
-1 & 4 e^{t}
\end{array}\right|
$$

Step 3 Since the $1^{\text {st }}$ determinant is non-zero

$$
\left|\begin{array}{cc}
D-3 & 1 \\
-1 & D-1
\end{array}\right|=D^{2}-4 D+4 \neq 0
$$

Therefore, we write the decoupled equations

$$
\begin{aligned}
& \left|\begin{array}{cc}
D-3 & 1 \\
-1 & D-1
\end{array}\right| x=\left|\begin{array}{cc}
-1 & 1 \\
4 e^{t} & D-1
\end{array}\right| \\
& \left|\begin{array}{cc}
D-3 & 1 \\
-1 & D-1
\end{array}\right| y=\left|\begin{array}{cc}
D-3 & -1 \\
-1 & 4 e^{t}
\end{array}\right|
\end{aligned}
$$

After expanding we find that

$$
\begin{aligned}
& (D-2)^{2} x=1-4 e^{t} \\
& (D-2)^{2} y=-1-8 e^{t}
\end{aligned}
$$

Step 4 We find the complementary function for the two equations. The auxiliary equation for both of the differential equations is:

$$
(m-2)^{2}=0 \Rightarrow m=2,2
$$

The auxiliary equation has real and equal roots

$$
\begin{aligned}
& x_{C}=c_{1} e^{2 t}+c_{2} t e^{2 t} \\
& y_{C}=c_{3} e^{2 t}+c_{4} t e^{2 t}
\end{aligned}
$$

Step 5 We now use the method of undetermined coefficients to find the particular integrals $x_{p}$ and $y_{p}$.

Since

$$
g_{1}(t)=1-4 e^{t}, \quad g_{2}(t)=-1-8 e^{t}
$$

We assume that

$$
x_{p}=A+B e^{t}, \quad y_{p}=C+E e^{t}
$$

Then

$$
D x_{p}=B e^{t}, \quad D^{2} x_{p}=B e^{t}
$$

And

$$
D y_{p}=E e^{t}, \quad D^{2} y_{p}=E e^{t}
$$

Substituting in the differential equations

$$
\begin{aligned}
& (D-2)^{2} x_{p}=D^{2} x_{p}-4 D x_{p}+4 x_{p}=1-4 e^{t} \\
& (D-2)^{2} y_{p}=D^{2} y_{p}-4 D y_{p}+4 y_{p}=-1-8 e^{t}
\end{aligned}
$$

Therefore, we have
or
or

$$
\begin{aligned}
& B e^{t}-4 B e^{t}+4 A+4 B e^{t}=1-4 e^{t} \\
& E e^{t}-4 E e^{t}+4 C+4 E e^{t}=-1-8 e^{t} \\
& B e^{t}+4 A=1-4 e^{t}, \quad E e^{t}+4 C=-1-8 e^{t}
\end{aligned}
$$

Equating coefficients of $e^{t}$ and constant terms, we obtain

$$
\begin{aligned}
& B=\quad-4, \quad A=\frac{1}{4} \\
& C=-\frac{1}{4}, \quad E=-8
\end{aligned}
$$

So that

$$
x_{p}=\frac{1}{4}-4 e^{t}, \quad y_{p}=-\frac{1}{4}-8 e^{t}
$$

Step 6 Hence, the general solution of the two decoupled equations

$$
\begin{aligned}
& x=x_{C}+x_{p}=c_{1} e^{2 t}+c_{2} t e^{2 t}+\frac{1}{4}-4 e^{t} \\
& y=y_{C}+y_{p}=c_{3} e^{2 t}+c_{4} t e^{2 t}-\frac{1}{4}-8 e^{t}
\end{aligned}
$$

Step 7 Substituting these solutions for $x$ and $y$ into the second equation of the given system, we obtain
or

$$
\begin{aligned}
& \left(c_{3}-c_{1}+c_{4}\right) e^{2 t}+\left(c_{4}-c_{2}\right) t e^{2 t}=0 \\
& c_{4}=c_{2}, \quad c_{3}=c_{1}-c_{4}=c_{1}-c_{2} .
\end{aligned}
$$

Hence, a solution of the given system of differential equations is

$$
\begin{aligned}
& x(t)=c_{1} e^{2 t}+c_{2} t e^{2 t}+\frac{1}{4}-4 e^{t} \\
& y(t)=\left(c_{1}-c_{2}\right) e^{2 t}+c_{2} t e^{2 t}-\frac{1}{4}-8 e^{t}
\end{aligned}
$$

## Example 3

Given the system

$$
\begin{aligned}
D x+D z & =t^{2} \\
2 x+D^{2} y & =e^{t} \\
-2 D x-2 y+(D+1) z & =0
\end{aligned}
$$

Find the differential equation for the dependent variables $x, y$ and $z$.

## Solution:

Step1 The differential equations of the system are already written in the differential operator form.
Step 2 We form the determinant

$$
\left|\begin{array}{ccc}
D & 0 & D \\
2 & D^{2} & 0 \\
-2 D & -2 & D+1
\end{array}\right|,\left|\begin{array}{ccc}
t^{2} & 0 & D \\
e^{t} & D^{2} & 0 \\
0 & -2 & D+1
\end{array}\right|,\left|\begin{array}{ccc}
D & t^{2} & D \\
2 & e^{t} & 0 \\
-2 D & 0 & D+1
\end{array}\right|,\left|\begin{array}{ccc}
D & 0 & t^{2} \\
2 & D^{2} & e^{t} \\
-2 D & -2 & 0
\end{array}\right|
$$

Step 3 Since the first determinant is non-zero.

$$
\left|\begin{array}{ccc}
D & 0 & D \\
2 & D^{2} & 0 \\
-2 D & -2 & D+1
\end{array}\right|=D\left|\begin{array}{cc}
D^{2} & 0 \\
-2 & D+1
\end{array}\right|+D\left|\begin{array}{cc}
2 & D^{2} \\
-2 D & -2
\end{array}\right|
$$

or $\quad\left|\begin{array}{ccc}D & 0 & D \\ 2 & D^{2} & 0 \\ -2 D & -2 & D+1\end{array}\right|=D\left(3 D^{3}+D^{2}-4\right) \neq 0$
Therefore, we can write the decoupled equations

$$
\begin{aligned}
& \left|\begin{array}{ccc}
D & 0 & D \\
2 & D^{2} & 0 \\
-2 D & -2 & D+1
\end{array}\right| \cdot x=\left|\begin{array}{ccc}
t^{2} & 0 & D \\
e^{t} & D^{2} & 0 \\
0 & -2 & D+1
\end{array}\right| \\
& \left|\begin{array}{ccc}
D & 0 & D \\
2 & D^{2} & 0 \\
-2 D & -2 & D+1
\end{array}\right| \cdot y=\left|\begin{array}{ccc}
D & t^{2} & D \\
2 & e^{t} & 0 \\
-2 D & 0 & D+1
\end{array}\right| \\
& \left|\begin{array}{ccc}
D & 0 & D \\
2 & D^{2} & 0 \\
-2 D & -2 & D+1
\end{array}\right| \cdot z=\left|\begin{array}{ccc}
D & 0 & t^{2} \\
2 & D^{2} & e^{t} \\
-2 D & -2 & 0
\end{array}\right|
\end{aligned}
$$

The determinant on the left hand side in these equations has already been expanded. Now we expand the determinants on the right hand side by the cofactors of an appropriate row.

$$
\begin{aligned}
\left|\begin{array}{ccc}
t^{2} & 0 & D \\
e^{t} & D^{2} & 0 \\
0 & -2 & D+1
\end{array}\right| & =\left|\begin{array}{cc}
D^{2} & 0 \\
-2 & D+1
\end{array}\right| t^{2}+D\left|\begin{array}{cc}
e^{t} & D^{2} \\
0 & -2
\end{array}\right| \\
& =D^{2}(D+1) t^{2}+D\left(-2 e^{t}\right)=\left(D^{3}+D^{2}\right) t^{2}-2 e^{t} \\
& =2-2 e^{t}
\end{aligned}
$$

$$
\begin{aligned}
\left|\begin{array}{ccc}
D & t^{2} & D \\
2 & e^{t} & 0 \\
-2 D & 0 & D+1
\end{array}\right| & =D\left|\begin{array}{cc}
e^{t} & 0 \\
0 & D+1
\end{array}\right|-\left|\begin{array}{cc}
2 & 0 \\
-2 D & D+1
\end{array}\right| t^{2}+D\left|\begin{array}{cc}
2 & e^{t} \\
-2 D & 0
\end{array}\right| \\
& =D\left[(D+1) e^{t}\right]-\left[(D+1)\left(2 t^{2}\right)\right]+D\left[2 D e^{t}\right] \\
& =2 e^{t}-4 t-2 t^{2}+2 e^{t}=4 e^{t}-2 t^{2}-4 t .
\end{aligned}
$$

$$
\begin{aligned}
& \left|\begin{array}{ccc}
D & 0 & t^{2} \\
2 & D^{2} & e^{t} \\
-2 D & -2 & 0
\end{array}\right|=D\left|\begin{array}{cc}
D^{2} & e^{t} \\
-2 & 0
\end{array}\right|+\left|\begin{array}{cc}
2 & D^{2} \\
-2 D & -2
\end{array}\right| t^{2} \\
& =D\left(2 e^{t}\right)+\left(-4+2 D^{3}\right) t^{2}=2 e^{t}-4 t^{2}+0 \\
& =2 e^{t}-4 t^{2}
\end{aligned}
$$

Hence the differential equations for the dependent variables $x, y$ and $z$ can be written as
or

$$
\begin{aligned}
& D\left(3 D^{3}+D^{2}-4 y\right) x=2-2 e^{t} \\
& D\left(3 D^{3}+D^{2}-4 y\right) y=4 e^{t}-2 t^{2}-4 t \\
& D\left(3 D^{3}+D^{2}-4 y\right) z=2 e^{t}-4 t^{2}
\end{aligned}
$$

Again we remind that the $D$ symbol on the left-hand side is to be treated as an algebraic quantity, but this is not the case on the right-hand side.

## Exercise

Solve, if possible, the given system of differential equations by use of determinants.

1. $\frac{d x}{d t}=2 x-y, \quad \frac{d y}{d t}=x-2 y$

10. $2 D x+(D-1) y=t, \quad D x+D y=t^{2}$

## Systems of Linear First-Order Equation

## In Previous Lecture

In the preceding lectures we dealt with linear systems of the form

$$
\begin{aligned}
& P_{11}(D) x_{1}+P_{12}(D) x_{2}+\cdots+P_{1 n}(D) x_{n}=b_{1}(t) \\
& P_{21}(D) x_{1}+P_{22}(D) x_{2}+\cdots+P_{2 n}(D) x_{n}=b_{2}(t) \\
& \vdots \quad \vdots \quad \vdots \quad \vdots \\
& P_{n 1}(D) x_{1}+P_{n 2}(D) x_{2}+\cdots+P_{n n}(D) x_{n}=b_{n}(t)
\end{aligned}
$$

where the $P_{i j}$ were polynomials in the differential operator $D$.

## The nth Order System

1. The study of systems of first-order differential equations

$$
\begin{aligned}
& \frac{d x_{1}}{d t}=g_{1}\left(t, x_{1}, x_{2}, \ldots, x_{n}\right) \\
& \frac{d x_{2}}{d t}=g_{2}\left(t, x_{1}, x_{2}, \ldots, x_{n}\right) \\
& \vdots \\
& \frac{d x_{n}}{d t}=g_{n}\left(t, x_{1}, x_{2}, \ldots, x_{n}\right)
\end{aligned}
$$

is also particularly important in advanced mathematics. This system of $n$ first-order equations is called and $\boldsymbol{n t h}$-order system.
2. Every $n$ th-order differential equation

$$
y^{(n)}=F\left(t, y, y^{\prime}, \ldots, y^{(n-1)}\right)
$$

as well as most systems of differential equations, can be reduced to the nth-order system.

## Linear Normal Form

A particularly, but important, case of the nth-order system is of those systems having the linear normal or canonical form:

$$
\begin{gathered}
\frac{d x_{1}}{d t}=a_{11}(t) x_{1}+a_{12}(t) x_{2}+\cdots+a_{1 n}(t) x_{n}+f_{1}(t) \\
\frac{d x_{2}}{d t}=a_{21}(t) x_{1}+a_{22}(t) x_{2}+\cdots+a_{2 n}(t) x_{n}+f_{2}(t) \\
\vdots \\
\vdots \\
\frac{d x_{n}}{d t}=a_{n 1}(t) x_{1}+a_{n 2}(t) x_{2}+\cdots+a_{n n}(t) x_{n}+f_{n}(t)
\end{gathered}
$$

where the coefficients $a_{i j}$ and the $f_{i}$ are the continuous functions on a common interval $I$. When $f_{i}(t)=0, i=1,2, \ldots, n$, the system is said to be homogeneous; otherwise it is called non-homogeneous.

## Reduction of Equation to a System

Suppose a linear $n$ th-order differential equation is first written as

$$
\frac{d^{n} y}{d t^{n}}=-\frac{a_{0}}{a_{n}} y-\frac{a_{1}}{a_{n}} y^{\prime}-\cdots-\frac{a_{n-1}}{a_{n}} y^{(n-1)}+f(t)
$$

If we then introduce the variables

$$
y=x_{1}, \quad y^{\prime}=x_{2}, \quad y^{\prime \prime}=x_{3}, \ldots, y^{(n-1)}=x_{n}
$$

it follows that

$$
y^{\prime}=x_{1}^{\prime}=x_{2}, y^{\prime \prime}=x_{2}^{\prime}=x_{3}, \ldots, y^{(n-1)}=x_{n-1}^{\prime}=x_{n}, y^{(n)}=x_{n}^{\prime}
$$

Hence the given $n$ th-order differential equation can be expressed as an $n$ th-order system:

$$
\begin{aligned}
x_{1}^{\prime} & =x_{2} \\
x_{2}^{\prime} & =x_{3} \\
x_{3}^{\prime} & =x_{4} \\
& \vdots \\
x_{n-1}^{\prime} & =x_{n} \\
x_{n}^{\prime} & =-\frac{a_{0}}{a_{n}} x_{1}-\frac{a_{1}}{a_{n}} x_{2}-\cdots-\frac{a_{n-1}}{a_{n}} x_{n}+f(t)
\end{aligned}
$$

Inspection of this system reveals that it is in the form of an $n$ th-order system.

## Example 1

Reduce the third-order equation
or

$$
\begin{aligned}
& 2 y^{\prime \prime \prime}=-y-4 y^{\prime}+6 y^{\prime \prime}+\sin t \\
& 2 y^{\prime \prime \prime}-6 y^{\prime \prime}+4 y^{\prime}+y=\sin t
\end{aligned}
$$

to the normal form.
Solution: Write the differential equation as

$$
y^{\prime \prime \prime}=-\frac{1}{2} y-2 y^{\prime}+3 y^{\prime \prime}+\frac{1}{2} \sin t
$$

Now introduce the variables

$$
y=x_{1}, y^{\prime}=x_{2}, y^{\prime \prime}=x_{3} .
$$

Then

$$
\begin{aligned}
& x_{1}^{\prime}=y^{\prime}=x_{2} \\
& x_{2}^{\prime}=y^{\prime \prime}=x_{3} \\
& x_{3}^{\prime}=y^{\prime \prime \prime \prime}
\end{aligned}
$$

Hence, we can write the given differential equation in the linear normal form

$$
\begin{aligned}
& x_{1}^{\prime}=x_{2} \\
& x_{2}^{\prime}=x_{3} \\
& x_{3}^{\prime}=-\frac{1}{2} x_{1}-2 x_{2}+3 x_{3}+\frac{1}{2} \sin t
\end{aligned}
$$

## Example 2

Rewrite the given second order differential equation as a system in the normal form

$$
2 \frac{d^{2} y}{d x^{2}}+4 \frac{d y}{d x}-5 y=0
$$

## Solution:

We write the given the differential equation as

$$
\frac{d^{2} y}{d x^{2}}=-2 \frac{d y}{d x}+\frac{5}{2} y
$$

Now introduce the variables

$$
y=x_{1}, \quad y^{\prime}=x_{2}
$$

Then

$$
\begin{aligned}
& y^{\prime}=x_{1}^{\prime}=x_{2} \\
& y^{\prime \prime}=x_{2}^{\prime}
\end{aligned}
$$

So that the given differential equation can be written in the form of a system

$$
\begin{aligned}
& x_{1}^{\prime}=x_{2} \\
& x_{2}^{\prime}=-2 x_{2}+\frac{5}{2} x_{1}
\end{aligned}
$$

This is the linear normal or canonical form.

## Example 3

Write the following differential equation as an equivalent system in the Canonical form.

$$
4 \frac{d^{3} y}{d t^{3}}+y=e^{t}
$$

## Solution:

First write the given differential equation as

$$
4 \frac{d^{3} y}{d t^{3}}=-y+e^{t}
$$

dividing by 4 on both sides
or

$$
\frac{d^{3} y}{d t^{3}}=-\frac{1}{4} y+\frac{1}{4} e^{t}
$$

Now introduce the variables

$$
y=x_{1}, y^{\prime}=x_{2}, y^{\prime \prime}=x_{3}
$$

Then

$$
\begin{aligned}
& y^{\prime}=x_{1}^{\prime}=x_{2} \\
& y^{\prime \prime}=x_{2}^{\prime}=x_{3} \\
& y^{\prime \prime \prime}=x_{3}^{\prime}
\end{aligned}
$$

Hence, the given differential equation can be written as an equivalent system.

$$
\begin{aligned}
x_{1}^{\prime} & =x_{2} \\
x_{2}^{\prime} & =x_{3} \\
x_{3}^{\prime} & =-\frac{1}{4} x_{1}+\frac{1}{4} e^{t}
\end{aligned}
$$

Clearly, this system is in the linear normal or the Canonical form.

## Example 4

Rewrite the differential equation in the linear normal form

$$
t^{2} y^{\prime \prime}+t y^{\prime}+\left(t^{2}-4\right) y=0
$$

## Solution:

First we write the equation in the form
or

$$
\begin{aligned}
& t^{2} y^{\prime \prime}=-t y^{\prime}-\left(t^{2}-4\right) y \\
& y^{\prime \prime}=-\frac{1}{t} y^{\prime}-\frac{\left(t^{2}-4\right)}{t^{2}} y, \quad t \neq 0 \\
& y^{\prime \prime}=-\frac{1}{t} y^{\prime}-\frac{t^{2}-4}{t^{2}} y
\end{aligned}
$$

Then introduce the variables

$$
y=x_{1}, y^{\prime}=x_{2}
$$

Then

$$
\begin{aligned}
& y^{\prime}=x_{1}^{\prime}=x_{2} \\
& y^{\prime \prime}=x_{2}^{\prime}
\end{aligned}
$$

Hence, the given equation is equivalent to the following system.

$$
\begin{aligned}
& x_{1}^{\prime}=x_{2} \\
& x_{2}^{\prime}=-\frac{1}{t} x_{2}-\frac{t^{2}-4}{t^{2}} x_{1}
\end{aligned}
$$

The system is in the required linear normal or the cnonical form.

## Systems Reduced to Normal Form

Using Procedure similar to that used for a single equation, we can reduce most systems of the linear form

$$
\begin{gathered}
P_{11}(D) x_{1}+P_{12}(D) x_{2}+\cdots+P_{1 n}(D) x_{n}=b_{1}(t) \\
P_{21}(D) x_{1}+P_{22}(D) x_{2}+\cdots+P_{2 n}(D) x_{n}=b_{2}(t) \\
\vdots \\
\vdots
\end{gathered} \vdots \vdots \vdots \vdots+x_{n 1}(D) x_{1}+P_{n 2}(D) x_{2}+\cdots+P_{n n}(D) x_{n}=b_{n}(t) \text { 有 }
$$

to the canonical form. To accomplish this we need to solve the system for the highest order derivative of each dependent variable.

## Note:

It is not always possible to solve the given system for the highest-order derivative of each dependent variable.

## Example 5

Reduce the following system to the normal form.

$$
\begin{aligned}
& \left(D^{2}-D+5\right) x+2 D^{2} y=e^{t} \\
& -2 x+\left(D^{2}+2\right) y=3 t^{2}
\end{aligned}
$$

## Solution:

First write the given system in the differential operator form

$$
\begin{aligned}
D^{2} x+2 D^{2} y & =e^{t}-5 x+D x \\
D^{2} y & =3 t^{2}+2 x-2 y
\end{aligned}
$$

Then eliminate $D^{2} y$ by multiplying the second equation by 2 and subtracting from first equation to have

$$
D^{2} x=e^{t}-6 t^{2}-9 x+4 y+D x
$$

Also

$$
D^{2} y=3 t^{2}+2 x-2 y
$$

We are now in a position to introduce the new variables. Therefore, we suppose that

$$
D x=u, \quad D y=v
$$

Thus, the expressions for $D^{2} x$ and $D^{2} y$, respectively, become

$$
\begin{aligned}
& D u=e^{t}-6 t^{2}-9 x+4 y+u \\
& D v=3 t^{2}+2 x-2 y
\end{aligned}
$$

Thus the original system can be written as

$$
\begin{aligned}
& D x=u \\
& D y=v \\
& D u=-9 x+4 y+u+e^{t}-6 t^{2} \\
& D v=2 x-2 y+3 t^{2}
\end{aligned}
$$

Clearly, this system is in the canonical form.

## Example 6

If possible, re-write the given system in the canonical form

$$
\begin{aligned}
x^{\prime}+4 x-y^{\prime} & =7 t \\
x^{\prime}+\quad y^{\prime}-2 y & =3 t
\end{aligned}
$$

## Solution:

First we write the differential equations of the system in the differential operator form

$$
\begin{aligned}
& D x+4 x-D y=7 t \\
& D x+D y-2 y=3 t
\end{aligned}
$$

To eliminate $D y$ we add the two equations of the system, to obtain
or

$$
2 D x=10 t-4 x+2 y
$$

Next to solve for the $D y$, we eliminate $D x$. For this purpose we simply subtract the first equation from second equation of the system, to have

$$
\begin{gathered}
-4 x+2 D y-2 y=-4 t \\
2 D y=4 x+2 y-4 t \\
D y=2 x+y-2 t
\end{gathered}
$$

or
Hence the original system is equivalent to the following system

$$
\begin{aligned}
& D x=-2 x+y+5 t \\
& D y=2 x+y-2 t
\end{aligned}
$$

Clearly the system is in the normal form.

## Example 7

If possible, re-write the given system in the linear normal form

$$
\begin{aligned}
& \frac{d^{3} x}{d t^{3}}=4 x-3 \frac{d^{2} x}{d t^{2}}+4 \frac{d y}{d t} \\
& \frac{d^{2} y}{d t^{2}}=10 t^{2}-4 \frac{d x}{d t}+3 \frac{d y}{d t}
\end{aligned}
$$

## Solution:

First write the given system in the differential operator form

$$
\begin{aligned}
& D^{3} x=4 x-3 D^{2} x+4 D y \\
& D^{2} y=10 t^{2}-4 D x+3 D y
\end{aligned}
$$

No need to eliminate anything as the equations are already expressing the highest-order derivatives of $x$ and $y$ in terms of the remaining functions and derivatives. Therefore, we are now in a position to introduce new variables. Suppose that

$$
\begin{aligned}
& D x=u, \quad D y=v \\
& D^{2} x=D u=w \\
& D^{2} y=D v, \quad D^{3} x=D w
\end{aligned}
$$

Then the expressions for $D^{3} x$ and for $D^{2} y$ can be written as

$$
\begin{aligned}
& D w=4 x+4 v-3 w \\
& D v=10 t^{2}-4 u+3 v
\end{aligned}
$$

Hence, the given system of differential equations is equivalent to the following system

$$
\begin{aligned}
& D x=u \\
& D y=v \\
& D u=w \\
& D v=10 t^{2}-4 u+3 v \\
& D w=4 x+4 v-3 w
\end{aligned}
$$

This new system is clearly in the linear normal form.

## Degenerate Systems

The systems of differential equations of the form

$$
\begin{gathered}
P_{11}(D) x_{1}+P_{12}(D) x_{2}+\cdots+P_{1 n}(D) x_{n}=b_{1}(t) \\
P_{21}(D) x_{1}+P_{22}(D) x_{2}+\cdots+P_{2 n}(D) x_{n}=b_{2}(t) \\
\vdots \\
\vdots
\end{gathered} \vdots \vdots \vdots \vdots+x_{n 1}(D) x_{n}=b_{n}(t)
$$

those cannot be reduced to a linear system in normal form is said to be a degenerate system.

## Example 8

If possible, re-write the following system in a linear normal form

$$
\begin{aligned}
(D+1) x+(D+1) y & =0 \\
2 D x+(2 D+1) y & =0
\end{aligned}
$$

## Solution:

The given system is already written in the differential operator form. The system can be written in the form

$$
\begin{aligned}
& D x+x+D y+y=0 \\
& 2 D x+2 D y+y=0
\end{aligned}
$$

We eliminate $D x$ to solve for the highest derivative $D y$ by multiplying the first equation with 2 and then subtracting second equation from the first one. Thus we have

$$
\begin{array}{r}
2 D x+2 x+2 D y+2 y=0 \\
\pm 2 D x \quad \pm 2 D y \pm y=0 \\
\hline 2 x \quad+y=0
\end{array}
$$

Therefore, it is impossible to solve the system for the highest derivative of each dependent variable; the system cannot be reduced to the canonical form. Hence the system is a degenerate.

## Example 9

If possible, re-write the following system of differential equations in the canonical form

$$
\begin{aligned}
& x^{\prime \prime}+y^{\prime}=1 \\
& x^{\prime \prime}+y^{\prime}=-1
\end{aligned}
$$

## Solution:

We write the system in the operator form

$$
\begin{aligned}
& D^{2} x+D y=1 \\
& D^{2} x+D y=-1
\end{aligned}
$$

To solve for a highest order derivative of $y$ in terms of the remaining functions and derivatives, we subtract the second equation from the first and we obtain

$$
\begin{gathered}
D^{2} x+D y=1 \\
\pm D^{2} x \pm D y=-1 \\
\hline 0=2
\end{gathered}
$$

This is absurd. Thus the given system cannot be reduced to a canonical form. Hence the system is a degenerate system.

## Example 10

If possible, re-write the given system

$$
\begin{aligned}
(2 D+1) x-2 D y & =4 \\
D x-D y & =e^{t}
\end{aligned}
$$

## Solution:

The given system is already in the operator form and can be written as

$$
\begin{aligned}
2 D x+x-2 D y & =4 \\
D x-D y & =e^{t}
\end{aligned}
$$

To solve for the highest derivative $D y$, we eliminate the highest derivative $D x$. Therefore, multiply the second equation with 2 and then subtract from the first equation to have

$$
\begin{aligned}
& 2 D x+x-2 D y=4 \\
& \pm 2 D x \quad \mp 2 D y= \pm 2 \mathrm{e}^{\mathrm{t}} \\
& x=4-2 e^{t}
\end{aligned}
$$

Therefore, it is impossible to solve the system for the highest derivatives of each variable. Thus the system cannot be reduced to the linear normal form. Hence, the system is a degenerate system.

## Applications

The systems having the linear normal form arise naturally in some physical applications. The following example provides an application of a homogeneous linear normal system in two dependent variables.

## Example 11

Tank A contains 50 gallons of water in which 25 pounds of salt are dissolved. A second tank $B$ contains 50 gallons of pure water. Liquid is pumped in and out of the tank at rates shown in Figure. Derive the differential equations that describe the number of pounds $x_{1}(t)$ and $x_{2}(t)$ of salt at any time in tanks $A$ and $B$, respectively.


## Solution:

Tank A
Input through pipe $a=(3 \mathrm{gal} / \mathrm{min}) \cdot(0 \mathrm{lb} / \mathrm{gal})=0$
Input through pipe $b=(1 \mathrm{gal} / \mathrm{min}) \cdot\left(\frac{x_{2}}{50} \mathrm{lb} / \mathrm{gal}\right)=\frac{x_{2}}{50} \mathrm{lb} / \mathrm{min}$
Thus, total input for the tank $A=0+\frac{x_{2}}{50}=\frac{x_{2}}{50}$
Output through pipe $c=(4 \mathrm{gal} / \mathrm{min}) \cdot\left(\frac{x_{1}}{50} \mathrm{lb} / \mathrm{gal}\right)=\frac{4 x_{1}}{50} \mathrm{lb} / \mathrm{min}$
Hence, the net rate of change of $x_{1}(t)$ in $\mathrm{lb} / \mathrm{min}$ is given by
or
or

$$
\begin{aligned}
& \frac{d x_{1}}{d t}=\text { input }- \text { output } \\
& \frac{d x_{1}}{d t}=\frac{x_{2}}{50}-\frac{4 x_{1}}{50} \\
& \frac{d x_{1}}{d t}=\frac{-2}{25} x_{1}+\frac{x_{2}}{50}
\end{aligned}
$$

Tank B
Input through pipe $c$ is $4 \mathrm{gal} / \mathrm{min}=\frac{4 x_{1}}{50} \mathrm{lb} / \mathrm{min}$
Output through pipe $b$ is $1 \mathrm{gal} / \mathrm{min}=\frac{x_{2}}{50} \mathrm{lb} / \mathrm{min}$
Similarly output through pipe $d$ is $3 \mathrm{gal} / \mathrm{min}=\frac{3 x_{2}}{50} \mathrm{lb} / \mathrm{min}$
Total output for the tank $b=\frac{x_{2}}{50}+\frac{3 x_{2}}{50}=\frac{4 x_{2}}{50}$
Hence, the net rate of change of $x_{2}(t)$ in $l b / m i n$
or
or

$$
\begin{aligned}
\frac{d x_{2}}{d t} & =\text { input }- \text { output } \\
\frac{d x_{2}}{d t} & =\frac{4 x_{1}}{50}-\frac{4 x_{2}}{50} \\
\frac{d x_{2}}{d t} & =\frac{2 x_{1}}{25}-\frac{2 x_{2}}{25}
\end{aligned}
$$

Thus we obtain the first order system

$$
\begin{aligned}
\frac{d x_{1}}{d t} & =\frac{-2}{25} x_{1}+\frac{x_{2}}{50} \\
\frac{d x_{2}}{d t} & =\frac{2 x_{1}}{25}-\frac{2 x_{2}}{25}
\end{aligned}
$$

We observe that the foregoing system is accompanied the initial conditions

$$
x_{1}(0)=25, x_{2}(0)=0 .
$$

## Exercise

## Introduction to Matrices

## Matrix

A rectangular array of numbers or functions subject to certain rules and conditions is called a matrix. Matrices are denoted by capital letters $A, B, \ldots, Y, Z$. The numbers or functions are called elements or entries of the matrix. The elements of a matrix are denoted by small letters $a, b, \ldots, y, z$.

## Rows and Columns

The horizontal and vertical lines in a matrix are, respectively, called the rows and columns of the matrix.
Order of a Matrix
If a matrix has $m$ rows and $n$ columns then we say that the size or order of the matrix is $m \times n$. If $A$ is a matrix having $m$ rows and $n$ columns then the matrix can be written as

$$
A=\left(\begin{array}{cccc}
a_{11} & a_{12} & \ldots & a_{1 n} \\
a_{21} & a_{22} & \ldots & a_{2 n} \\
\ldots & \ldots & \ldots & \ldots \\
\ldots & \ldots & \ldots & \ldots \\
a_{m 1} & a_{m 2} & \ldots & a_{m n}
\end{array}\right)
$$

## Square Matrix

A matrix having $n$ rows and $n$ columns is said to be a $n \times n$ square matrix or a square matrix of order $n$. The element, or entry, in the ith row and $j$ th column of a $m \times n$ matrix A is written as $a_{i j}$. Therefore a $1 \times 1$ matrix is simply a constant or a function.

## Equality of matrix

Any two matrices $A$ and $B$ are said to be equal if and only if they have the same orders and the corresponding elements of the two matrices are equal. Thus if $A=\left[a_{i j}\right]_{m \times n}$ and $B=\left[b_{i j}\right]_{m \times n}$ then

$$
A=B \Leftrightarrow a_{i j}=b_{i j}, \quad \forall i, j
$$

## Column Matrix

A column matrix $X$ is any matrix having $n$ rows and only one column. Thus the column matrix $X$ can be written as

$$
X=\left(\begin{array}{c}
b_{11} \\
b_{21} \\
b_{31} \\
\vdots \\
b_{n 1}
\end{array}\right)=\left[b_{i 1}\right]_{n \times 1}
$$

A column matrix is also called a column vector or simply a vector.

## Multiple of matrices

A multiple of a matrix $A$ is defined to be

$$
k A=\left[\begin{array}{cccc}
k a_{11} & k a_{12} & \cdots & k a_{1 n} \\
k a_{21} & k a_{22} & \ldots & k a_{2 n} \\
\vdots & \vdots & \ldots & \vdots \\
k a_{m 1} & k a_{m 2} & \cdots & k a_{m n}
\end{array}\right]=\left[k a_{i j}\right]_{m \times n}
$$

Where $k$ is a constant or it is a function. Notice that the product $k A$ is same as the product $A k$. Therefore, we can write

$$
k A=A k
$$

## Example 1

(a)

$$
5 \cdot\left[\begin{array}{cc}
2 & -3 \\
4 & -1 \\
1 / 5 & 6
\end{array}\right]=\left[\begin{array}{cc}
10 & -15 \\
20 & -5 \\
1 & 30
\end{array}\right]
$$

(b)

$$
e^{t} \cdot\left[\begin{array}{c}
1 \\
-2 \\
4
\end{array}\right]=\left[\begin{array}{c}
e^{t} \\
-2 e^{t} \\
4 e^{t}
\end{array}\right]
$$

Since we know that $k A=A k$. Therefore, we can write

$$
e^{-3 t} \cdot\left[\begin{array}{l}
2 \\
5
\end{array}\right]=\left[\begin{array}{l}
2 e^{-3 t} \\
5 e^{-3 t}
\end{array}\right]=\left[\begin{array}{l}
2 \\
5
\end{array}\right] e^{-3 t}
$$

## Addition of Matrices

Any two matrices can be added only when they have same orders and the resulting matrix is obtained by adding the corresponding entries. Therefore, if $A=\left[a_{i j}\right]$ and $B=\left[b_{i j}\right]$ are two $m \times n$ matrices then their sum is defined to be the matrix $A+B$ defined by

$$
A+B=\left[a_{i j}+b_{i j}\right]
$$

## Example 2

Consider the following two matrices of order $3 \times 3$

$$
A=\left(\begin{array}{ccc}
2 & -1 & 3 \\
0 & 4 & 6 \\
-6 & 10 & -5
\end{array}\right), \quad B=\left(\begin{array}{ccc}
4 & 7 & -8 \\
9 & 3 & 5 \\
1 & -1 & 2
\end{array}\right)
$$

Since the given matrices have same orders. Therefore, these matrices can be added and their sum is given by

$$
A+B=\left(\begin{array}{ccc}
2+4 & -1+7 & 3+(-8) \\
0+9 & 4+3 & 6+5 \\
-6+1 & 10+(-1) & -5+2
\end{array}\right)=\left(\begin{array}{ccc}
6 & 6 & -5 \\
9 & 7 & 11 \\
-5 & 9 & -3
\end{array}\right)
$$

## Example 3

Write the following single column matrix as the sum of three column vectors

$$
\left(\begin{array}{c}
3 t^{2}-2 e^{t} \\
t^{2}+7 t \\
5 t
\end{array}\right)
$$

## Solution

$$
\left(\begin{array}{c}
3 t^{2}-2 e^{t} \\
t^{2}+7 t \\
5 t
\end{array}\right)=\left(\begin{array}{c}
3 t^{2} \\
t^{2} \\
0
\end{array}\right)+\left(\begin{array}{c}
0 \\
7 t \\
5 t
\end{array}\right)+\left(\begin{array}{c}
-2 e^{t} \\
0 \\
0
\end{array}\right)=\left(\begin{array}{l}
3 \\
1 \\
0
\end{array}\right) t^{2}+\left(\begin{array}{l}
0 \\
7 \\
5
\end{array}\right) t+\left(\begin{array}{c}
-2 \\
0 \\
0
\end{array}\right) e^{t}
$$

## Difference of Matrices

The difference of two matrices $A$ and $B$ of same order $m \times n$ is defined to be the matrix

$$
A-B=A+(-B)
$$

The matrix $-B$ is obtained by multiplying the matrix $B$ with -1 . So that

$$
-B=(-1) B
$$

## Multiplication of Matrices

Any two matrices $A$ and $B$ are conformable for the product $A B$, if the number of columns in the first matrix $A$ is equal to the number of rows in the second matrix $B$. Thus if the order of the matrix $A$ is $m \times n$ then to make the product $A B$ possible order of the matrix $B$ must be $n \times p$. Then the order of the product matrix $A B$ is $m \times p$. Thus

$$
A_{m \times n} \cdot B_{n \times p}=C_{m \times p}
$$

If the matrices $A$ and $B$ are given by

$$
A=\left[\begin{array}{cccc}
a_{11} & a_{12} & \cdots & a_{1 n} \\
a_{21} & a_{22} & \cdots & a_{2 n} \\
\vdots & \vdots & \cdots & \vdots \\
a_{m 1} & a_{m 2} & \cdots & a_{m n}
\end{array}\right], B=\left[\begin{array}{cccc}
b_{11} & b_{12} & \cdots & b_{1 p} \\
b_{21} & b_{22} & \cdots & b_{2 p} \\
\vdots & \vdots & \cdots & \vdots \\
b_{n 1} & b_{n 2} & \cdots & b_{n p}
\end{array}\right]
$$

Then

$$
\begin{aligned}
A B & =\left[\begin{array}{cccc}
a_{11} & a_{12} & \cdots & a_{1 n} \\
a_{21} & a_{22} & \cdots & a_{2 n} \\
\vdots & \vdots & \cdots & \vdots \\
a_{m 1} & a_{m 2} & \cdots & a_{m n}
\end{array}\right]\left[\begin{array}{cccc}
b_{11} & b_{12} & \cdots & b_{1 p} \\
b_{21} & b_{22} & \cdots & b_{2 p} \\
\vdots & \vdots & \cdots & \vdots \\
b_{n 1} & b_{n 2} & \cdots & b_{n p}
\end{array}\right] \\
& =\left(\begin{array}{c}
a_{11} b_{11}+a_{12} b_{21}+\cdots+a_{1 n} b_{n 1} \cdots a_{11} b_{1 p}+a_{12} b_{2 p}+\cdots+a_{1 n} b_{n p} \\
a_{21} b_{11}+a_{22} b_{21}+\cdots+a_{2 n} b_{n 1} \cdots a_{21} b_{1 p}+a_{22} b_{2 p}+\cdots+a_{2 n} b_{n p} \\
\vdots \\
\vdots \\
a_{m 1} b_{11}+a_{m 2} b_{21}+\cdots+a_{m n} b_{n 1} \cdots a_{m 1} b_{1 p}+a_{m 2} b_{2 p}+\cdots+a_{m n} b_{n p}
\end{array}\right) \\
& =\left(\begin{array}{l}
\sum_{k=1}^{n} a_{i k} b_{k j}
\end{array}\right)
\end{aligned}
$$

## Example 4

If possible, find the products $A B$ and $B A$, when
(a)

$$
A=\left(\begin{array}{ll}
4 & 7 \\
3 & 5
\end{array}\right), \quad B=\left(\begin{array}{cc}
9 & -2 \\
6 & 8
\end{array}\right)
$$

$$
A=\left(\begin{array}{ll}
5 & 8 \\
1 & 0 \\
2 & 7
\end{array}\right), \quad B=\left(\begin{array}{cc}
-4 & -3 \\
2 & 0
\end{array}\right)
$$

## Solution

(a) The matrices $A$ and $B$ are square matrices of order 2. Therefore, both of the products $A B$ and $B A$ are possible.

$$
\begin{aligned}
& A B=\left(\begin{array}{ll}
4 & 7 \\
3 & 5
\end{array}\right)\left(\begin{array}{cc}
9 & -2 \\
6 & 8
\end{array}\right)=\left(\begin{array}{cc}
4 \cdot 9+7 \cdot 6 & 4 \cdot(-2)+7 \cdot 8 \\
3 \cdot 9+5 \cdot 6 & 3 \cdot(-2)+5 \cdot 8
\end{array}\right)=\left(\begin{array}{ll}
78 & 48 \\
57 & 34
\end{array}\right) \\
& B A=\left(\begin{array}{cc}
9 & -2 \\
6 & 8
\end{array}\right)\left(\begin{array}{ll}
4 & 7 \\
3 & 5
\end{array}\right)=\left(\begin{array}{cc}
9 \cdot 4+(-2) \cdot 3 & 9 \cdot 7+(-2) \cdot 5 \\
6 \cdot 4+8 \cdot 3 & 6 \cdot 7+8 \cdot 5
\end{array}\right)=\left(\begin{array}{ll}
30 & 53 \\
48 & 82
\end{array}\right)
\end{aligned}
$$

(b) The product $A B$ is possible as the number of columns in the matrix $A$ and the number of rows in $B$ is 2 . However, the product $B A$ is not possible because the number of rows in the matrix $B$ and the number of rows in $A$ is not same.

$$
A B=\left(\begin{array}{ll}
5 \cdot(-4)+8 \cdot 2 & 5 \cdot(-3)+8 \cdot 0 \\
1 \cdot(-4)+0 \cdot 2 & 1 \cdot(-3)+0 \cdot 0 \\
2 \cdot(-4)+7 \cdot 2 & 2 \cdot(-3)+7 \cdot 0
\end{array}\right)=\left(\begin{array}{cc}
-4 & -15 \\
-4 & -3 \\
6 & -6
\end{array}\right)
$$

## Note that

In general, matrix multiplication is not commutative. This means that $A B \neq B A$. For example, we observe in part (a) of the previous example

$$
A B=\left(\begin{array}{ll}
78 & 48 \\
57 & 34
\end{array}\right), \quad B A=\left(\begin{array}{ll}
30 & 53 \\
48 & 82
\end{array}\right)
$$

Clearly $A B \neq B A$. Similarly in part (b) of the example, we have

$$
A B=\left(\begin{array}{cc}
-4 & -15 \\
-4 & -3 \\
6 & -6
\end{array}\right)
$$

However, the product $B A$ is not possible.

## Example 5

(a)

$$
\left(\begin{array}{ccc}
2 & -1 & 3 \\
0 & 4 & 5 \\
1 & -7 & 9
\end{array}\right)\left(\begin{array}{c}
-3 \\
6 \\
4
\end{array}\right)=\left(\begin{array}{c}
2 \cdot(-3)+(-1) \cdot 6+3 \cdot 4 \\
0 \cdot(-3)+4 \cdot 6+5 \cdot 6 \\
1 \cdot(-3)+(-7) \cdot 6+9 \cdot 4
\end{array}\right)=\left(\begin{array}{c}
0 \\
44 \\
-9
\end{array}\right)
$$

(b)

$$
\left(\begin{array}{cc}
-4 & 2 \\
3 & 8
\end{array}\right)\binom{x}{y}=\binom{-4 x+2 y}{3 x+8 y}
$$

## Multiplicative Identity

For a given positive integer $n$, the $n \times n$ matrix

$$
I=\left(\begin{array}{ccccc}
1 & 0 & 0 & \cdots & 0 \\
0 & 1 & 0 & \cdots & 0 \\
0 & 0 & 1 & \cdots & 0 \\
\vdots & \vdots & \vdots & \cdots & \vdots \\
0 & 0 & 0 & \cdots & 1
\end{array}\right)
$$

is called the multiplicative identity matrix. If $A$ is a matrix of order $n \times n$, then it can be verified that

$$
I \cdot A=A \cdot I=A
$$

Also, it is readily verified that if $X$ is any $n \times 1$ column matrix, then $I \cdot X=X$

## Zero Matrix

A matrix consisting of all zero entries is called a zero matrix or null matrix and is denoted by $O$. For example

$$
O=\binom{0}{0}, \quad O=\left(\begin{array}{ll}
0 & 0 \\
0 & 0
\end{array}\right), \quad O=\left(\begin{array}{ll}
0 & 0 \\
0 & 0 \\
0 & 0
\end{array}\right)
$$

and so on. If $A$ and $O$ are $m \times n$ matrices, then

$$
A+O=O+A=A
$$

## Associative Law

The matrix multiplication is associative. This means that if $A, B$ and $C$ are $m \times p$, $p \times r$ and $r \times n$ matrices, then

$$
A(B C)=(A B) C
$$

The result is a $m \times n$ matrix.

## Distributive Law

If $B$ and $C$ are matrices of order $r \times n$ and $A$ is a matrix of order $m \times r$, then the distributive law states that

$$
A(B+C)=A B+A C
$$

Furthermore, if the product $(A+B) C$ is defined, then

$$
(A+B) C=A C+B C
$$

## Determinant of a Matrix

Associated with every square matrix A of constants, there is a number called the determinant of the matrix, which is denoted by $\operatorname{det}(A)$ or $|A|$

## Example 6

Find the determinant of the following matrix

$$
A=\left(\begin{array}{ccc}
3 & 6 & 2 \\
2 & 5 & 1 \\
-1 & 2 & 4
\end{array}\right)
$$

## Solution

The determinant of the matrix $A$ is given by

$$
\operatorname{det}(A)=\left|\begin{array}{ccc}
3 & 6 & 2 \\
2 & 5 & 1 \\
-1 & 2 & 4
\end{array}\right|
$$

We expand the $\operatorname{det}(A)$ by cofactors of the first row, we obtain

$$
\operatorname{det}(A)=\left|\begin{array}{ccc}
3 & 6 & 2 \\
2 & 5 & 1 \\
-1 & 2 & 4
\end{array}\right|=3\left|\begin{array}{ll}
5 & 1 \\
2 & 4
\end{array}\right|-6\left|\begin{array}{cc}
2 & 1 \\
-1 & 4
\end{array}\right|+2\left|\begin{array}{cc}
2 & 5 \\
-1 & 2
\end{array}\right|
$$

or

$$
\operatorname{det}(A)=3(20-2)-6(8+1)+2(4+5)=18
$$

## Transpose Of a Matrix

The transpose of a $m \times n$ matrix $A$ is obtained by interchanging rows and columns of the matrix and is denoted by $A^{t r}$. In other words, rows of A become the columns of $A^{t r}$. If

$$
A=\left(\begin{array}{ccccccc}
a_{11} & a_{12} & \cdot & \cdot & \cdot & \cdots & a_{1 n} \\
a_{21} & a_{22} & \cdot & \cdot & \cdot & \cdots & a_{2 n} \\
\vdots & \cdots & \cdots & \cdots & . & \cdots & \vdots \\
a_{m 1} & a_{m 2} & \cdot & \cdot & \cdot & \cdot & a_{m n}
\end{array}\right)
$$

Then

$$
A^{t r}=\left(\begin{array}{cccc}
a_{11} & a_{21} & \cdots & a_{m 1} \\
a_{12} & a_{22} & \cdots & a_{m 2} \\
& & & \\
\vdots & \vdots & & \vdots \\
a_{1 n} & a_{2 n} & \cdots & a_{m n}
\end{array}\right)
$$

Since order of the matrix $A$ is $m \times n$, the order of the transpose matrix $A^{t r}$ is $n \times m$.

## Example 7

(a) The transpose of matrix

$$
A=\left(\begin{array}{ccc}
3 & 6 & 2 \\
2 & 5 & 1 \\
-1 & 2 & 4
\end{array}\right)
$$

is

$$
A^{t r}=\left(\begin{array}{ccc}
3 & 2 & -1 \\
6 & 5 & 2 \\
2 & 1 & 4
\end{array}\right)
$$

(b) If $X$ denotes the matrix

$$
X=\left(\begin{array}{l}
5 \\
0 \\
3
\end{array}\right)
$$

Then

$$
X^{t r}=\left[\begin{array}{lll}
5 & 0 & 3
\end{array}\right]
$$

## Multiplicative Inverse of a Matrix

Suppose that $A$ is a square matrix of order $n \times n$. If there exists an $n \times n$ matrix $B$ such that

$$
A B=B A=I
$$

Then $B$ is said to be the multiplicative inverse of the matrix $A$ and is denoted by $B=A^{-1}$ 。

## Non-Singular Matrices

A square matrix $A$ of order $n \times n$ is said to be a non-singular matrix if

$$
\operatorname{det}(A) \neq 0
$$

Otherwise the square matrix $A$ is said to be singular. Thus for a singular $A$ we must have

$$
\operatorname{det}(A)=0
$$

## Theorem

If $A$ is a square matrix of order $n \times n$ then the matrix has a multiplicative inverse $A^{-1}$ if and only if the matrix $A$ is non-singular.

## Theorem

Let $A$ be a non singular matrix of order $n \times n$ and let $C_{i j}$ denote the cofactor (signed minor) of the corresponding entry $a_{i j}$ in the matrix $A$ i.e.

$$
C_{i j}=(-1)^{i+j} M_{i j}
$$

$\mathrm{M}_{i j}$ is the determinant of the $(n-1) \times(n-1)$ matrix obtained by deleting the ith row and $j$ th column from $A$. Then inverse of the matrix $A$ is given by

$$
A^{-1}=\frac{1}{\operatorname{det}(A)}\left(C_{i j}\right)^{t r}
$$

## Further Explanation

1. For further reference we take $n=2$ so that $A$ is a $2 \times 2$ non-singular matrix given by

$$
A=\left(\begin{array}{ll}
a_{11} & a_{12} \\
a_{21} & a_{22}
\end{array}\right)
$$

Therefore $C_{11}=a_{22}, C_{12}=-a_{21}, C_{21}=-a_{12}$ and $C_{22}=a_{11}$. So that

$$
A^{-1}=\frac{1}{\operatorname{det}(A)}\left(\begin{array}{cc}
a_{22} & -a_{21} \\
-a_{12} & a_{11}
\end{array}\right)^{\operatorname{tr}}=\frac{1}{\operatorname{det}(A)}\left(\begin{array}{cc}
a_{22} & -a_{12} \\
-a_{21} & a_{11}
\end{array}\right)
$$

2. For a $3 \times 3$ non-singular matrix

$$
\begin{aligned}
& \mathrm{A}=\left(\begin{array}{lll}
a_{11} & a_{12} & a_{13} \\
a_{21} & a_{22} & a_{23} \\
a_{31} & a_{32} & a_{33}
\end{array}\right) \\
& C_{11}=\left|\begin{array}{ll}
a_{22} & a_{23} \\
a_{32} & a_{33}
\end{array}\right|, C_{12}=-\left|\begin{array}{ll}
a_{21} & a_{23} \\
a_{31} & a_{33}
\end{array}\right|, \mathrm{C}_{13}=\left|\begin{array}{ll}
a_{21} & a_{22} \\
a_{31} & a_{32}
\end{array}\right|
\end{aligned}
$$

and so on. Therefore, inverse of the matrix $A$ is given by

$$
A^{-1}=\frac{1}{\operatorname{det} A}\left(\begin{array}{ccc}
C_{11} & C_{21} & a_{31} \\
C_{12} & C_{22} & C_{32} \\
C_{13} & C_{23} & C_{33}
\end{array}\right)
$$

## Example 8

Find, if possible, the multiplicative inverse for the matrix

$$
A=\left(\begin{array}{ll}
1 & 4 \\
2 & 10
\end{array}\right)
$$

## Solution:

The matrix $A$ is non-singular because

$$
\operatorname{det}(A)=\left|\begin{array}{cc}
1 & 4 \\
2 & 10
\end{array}\right|=10-8=2
$$

Therefore, $A^{-1}$ exists and is given by

$$
A^{-1}=\frac{1}{2}\left(\begin{array}{cc}
10 & -4 \\
-2 & 1
\end{array}\right)=\left(\begin{array}{cc}
5 & -2 \\
-1 & 1 / 2
\end{array}\right)
$$

## Check

$$
\begin{aligned}
& A A^{-1}=\left(\begin{array}{cc}
1 & 4 \\
2 & 10
\end{array}\right)\left(\begin{array}{cc}
5 & -2 \\
-1 & 1 / 2
\end{array}\right)=\left(\begin{array}{cc}
5-4 & -2+2 \\
10-10 & -4+5
\end{array}\right)=\left(\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right)=I \\
& A A^{-1}=\left(\begin{array}{cc}
5 & -2 \\
-1 & 1 / 2
\end{array}\right)\left(\begin{array}{cc}
1 & 4 \\
2 & 10
\end{array}\right)=\left(\begin{array}{cc}
5-4 & 20-20 \\
-1+1 & -4+5
\end{array}\right)=\left(\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right)=I
\end{aligned}
$$

## Example 9

Find, if possible, the multiplicative inverse of the following matrix

$$
A=\left(\begin{array}{ll}
2 & 2 \\
3 & 3
\end{array}\right)
$$

## Solution:

The matrix is singular because

$$
\operatorname{det}(A)=\left|\begin{array}{ll}
2 & 2 \\
3 & 3
\end{array}\right|=2 \cdot 3-2 \cdot 3=0
$$

Therefore, the multiplicative inverse $A^{-1}$ of the matrix does not exist.

## Example 10

Find the multiplicative inverse for the following matrix

$$
A=\left(\begin{array}{ccc}
2 & 2 & 0 \\
-2 & 1 & 1 \\
3 & 0 & 1
\end{array}\right)
$$

## Solution:

Since

$$
\operatorname{det}(A)=\left|\begin{array}{ccc}
2 & 2 & 0 \\
-2 & 1 & 1 \\
3 & 0 & 1
\end{array}\right|=2(1-0)-2(-2-3)+0(0-3)=12 \neq 0
$$

Therefore, the given matrix is non singular. So that, the multiplicative inverse $A^{-1}$ of the matrix $A$ exists. The cofactors corresponding to the entries in each row are

Hence

$$
\begin{aligned}
& C_{11}=\left|\begin{array}{ll}
1 & 1 \\
0 & 1
\end{array}\right|=1, \quad C_{12}=-\left|\begin{array}{cc}
-2 & 1 \\
3 & 1
\end{array}\right|=5, \quad C_{13}=\left|\begin{array}{cc}
-2 & 1 \\
3 & 0
\end{array}\right|=-3 \\
& C_{21}=-\left|\begin{array}{ll}
2 & 0 \\
0 & 1
\end{array}\right|=-2, \quad C_{22}=\left|\begin{array}{ll}
2 & 0 \\
3 & 1
\end{array}\right|=2, \quad C_{23}=-\left|\begin{array}{ll}
2 & 2 \\
3 & 0
\end{array}\right|=6 \\
& C_{31}=\left|\begin{array}{cc}
2 & 0 \\
1 & 1
\end{array}\right|=2, \quad C_{32}=-\left|\begin{array}{cc}
2 & 0 \\
-2 & 1
\end{array}\right|=-2, \quad C_{33}=\left|\begin{array}{cc}
2 & 2 \\
-2 & 1
\end{array}\right|=6 \\
& \mathrm{~A}^{-1}=\frac{1}{12}\left(\begin{array}{ccc}
1 & -2 & 2 \\
5 & 2 & -2 \\
-3 & 6 & 6
\end{array}\right)=\left(\begin{array}{ccc}
1 / 12 & -1 / 6 & 1 / 6 \\
5 / 12 & 1 / 6 & -1 / 6 \\
-1 / 4 & 1 / 2 & 1 / 2
\end{array}\right)
\end{aligned}
$$

Please verify that $A \cdot A^{-1}=A^{-1} \cdot A=I$

## Derivative of a Matrix of functions

Suppose that

$$
A(t)=\left[a_{i j}(t)\right]_{m \times n}
$$

is a matrix whose entries are functions those are differentiable on a common interval, then derivative of the matrix $A(t)$ is a matrix whose entries are derivatives of the corresponding entries of the matrix $A(t)$. Thus

$$
\frac{d A}{d t}=\left[\frac{d a_{i j}}{d t}\right]_{m \times n}
$$

The derivative of a matrix is also denoted by $A^{\prime}(t)$.

## Integral of a Matrix of Functions

Suppose that $A(t)=\left(a_{i j}(t)\right)_{m \times n}$ is a matrix whose entries are functions those are continuous on a common interval containing $t$, then integral of the matrix $A(t)$ is a matrix whose entries are integrals of the corresponding entries of the matrix $A(t)$. Thus

$$
\int_{t_{0}}^{t} A(s) d s=\left(\int_{t_{0}}^{t} a_{i j}(s) d s\right)_{m \times n}
$$

## Example 11

Find the derivative and the integral of the following matrix

$$
X(t)=\left(\begin{array}{c}
\sin 2 t \\
e^{3 t} \\
8 t-1
\end{array}\right)
$$

## Solution:

The derivative and integral of the given matrix are, respectively, given by

$$
\begin{aligned}
& X^{\prime}(t)=\left(\begin{array}{l}
\frac{d}{d t}(\sin 2 t) \\
\frac{d}{d t}\left(e^{3 t}\right) \\
\frac{d}{d t}(8 t-1)
\end{array}\right)=\left(\begin{array}{c}
2 \cos 2 t \\
3 e^{3 t} \\
8
\end{array}\right) \\
& \int_{0}^{t} X(s) d s=\left(\begin{array}{l}
\int_{0}^{t} \sin 2 t d s \\
0 \\
\int_{0}^{t} e^{3 t} d s \\
\int_{0}^{t} 8 t-1 d s \\
0
\end{array}\right)=\left(\begin{array}{l}
-1 / 2 \cos 2 t+1 / 2 \\
1 / 3 e^{3 t}-1 / 3 \\
4 t^{2}-t
\end{array}\right)
\end{aligned}
$$

## Augmented Matrix

Consider an algebraic system of $n$ linear equations in $n$ unknowns

$$
\begin{gathered}
a_{11} x_{1}+a_{12} x_{2}+\cdots+a_{1 n} x_{n}=b_{1} \\
a_{21} x_{1}+a_{22} x_{2}+\cdots+a_{2 n} x_{n}=b_{2} \\
\vdots \quad \vdots \quad \vdots \\
a_{n 1} x_{1}+a_{n 2} x_{2}+\cdots+a_{n n} x_{n}=b_{n}
\end{gathered}
$$

Suppose that $A$ denotes the coefficient matrix in the above algebraic system, then

$$
A=\left[\begin{array}{cccc}
a_{11} & a_{12} & \cdots & a_{1 n} \\
a_{21} & a_{22} & \cdots & a_{2 n} \\
\vdots & \vdots & \cdots & \vdots \\
a_{m 1} & a_{m 2} & \cdots & a_{m n}
\end{array}\right]
$$

It is well known that Cramer's rule can be used to solve the system, whenever $\operatorname{det}(A) \neq 0$. However, it is also well known that a Herculean effort is required to solve the system if $n>3$. Thus for larger systems the Gaussian and Gauss-Jordon elimination methods are preferred and in these methods we apply elementary row operations on augmented matrix. The augmented matrix of the system of linear equations is the following $n \times(n+1)$ matrix

$$
A_{b}=\left[\begin{array}{ccccc}
a_{11} & a_{12} & \cdots & a_{1 n} & b_{1} \\
a_{211} & a_{22} & \cdots & a_{2 n} & b_{2} \\
\vdots & \vdots & \cdots & \vdots & \vdots \\
a_{n 1} & a_{n 2} & \cdots & a_{n n} & b_{n}
\end{array}\right]
$$

If $B$ denotes the column matrix of the $b_{i}, \forall i=1,2, \ldots, n$ then the augmented matrix of the above mentioned system of linear algebraic equations can be written as $(A \mid B)$.

## Elementary Row Operations

The elementary row operations consist of the following three operations

- Multiply a row by a non-zero constant.
- Interchange any row with another row.
- Add a non-zero constant multiple of one row to another row.

These row operations on the augmented matrix of a system are equivalent to, multiplying an equation by a non-zero constant, interchanging position of any two equations of the system and adding a constant multiple of an equation to another equation.

## The Gaussian and Gauss-Jordon Methods

In the Gaussian Elimination method we carry out a succession of elementary row operations on the augmented matrix of the system of linear equations to be solved until it is transformed into row-echelon form, a matrix that has the following structure:

- The first non-zero entry in a non-zero row is 1.
- In consecutive nonzero rows the first entry 1 in the lower row appears to the right of the first 1 in the higher row.
- Rows consisting of all 0 's are at the bottom of the matrix.

In the Gauss-Jordan method the row operations are continued until the augmented matrix is transformed into the reduced row-echelon form. A reduced row-echelon matrix has the structure similar to row-echelon, but with an additional property.

- The first non-zero entry in a non-zero row is 1.
- In consecutive nonzero rows the first entry 1 in the lower row appears to the right of the first 1 in the higher row.
- Rows consisting of all 0's are at the bottom of the matrix.
- A column containing a first entry 1 has 0 's everywhere else.


## Example 1

(a) The following two matrices are in row-echelon form.

$$
\left(\begin{array}{ccc|c}
1 & 5 & 0 & 2 \\
0 & 1 & 0 & -1 \\
0 & 0 & 0 & 0
\end{array}\right),\left(\begin{array}{ccccc|c}
0 & 0 & 1 & -6 & 2 & 2 \\
0 & 0 & 0 & 0 & 1 & 4
\end{array}\right)
$$

Please verify that the three conditions of the structure of the echelon form are satisfied.
(b) The following two matrices are in reduced row-echelon form.

$$
\left(\begin{array}{ccc|c}
1 & 0 & 0 & 7 \\
0 & 1 & 0 & -1 \\
0 & 0 & 0 & 0
\end{array}\right),\left(\begin{array}{ccccc|c}
0 & 0 & 1 & -6 & 0 & -6 \\
0 & 0 & 0 & 0 & 1 & 4
\end{array}\right)
$$

Please notice that all remaining entries in the columns containing a leading entry 1 are 0 .

## Notation

To keep track of the row operations on an augmented matrix, we utilized the following notation:

| Symbol | Meaning |
| :--- | :--- |
| $R_{i j}$ | Interchange the rows $i$ and $j$. |
| $c R_{i}$ | Multiply the $i$ ith row by a nonzero constant $c$. |
| $c R_{i}+R_{j}$ | Multiply the $i$ ith row by c and then add to the $j$ th row. |

## Example 2

Solve the following system of linear algebraic equations by the (a) Gaussian elimination and (b) Gauss-Jordan elimination

$$
\begin{aligned}
2 x_{1}+6 x_{2}+x_{3}= & 7 \\
x_{1}+2 x_{1}-x_{3}= & -1 \\
5 x_{1}+7 x_{2}-4 x_{3}= & 9
\end{aligned}
$$

## Solution

(a) The augmented matrix of the system is

$$
\left(\begin{array}{ccc|c}
2 & 6 & 1 & 7 \\
1 & 2 & -1 & -1 \\
5 & 7 & -4 & 9
\end{array}\right)
$$

By interchanging first and second row i.e. by $R_{12}$, we obtain

$$
\left(\begin{array}{ccc|c}
1 & 2 & -1 & -1 \\
2 & 6 & 1 & 7 \\
5 & 7 & -4 & 9
\end{array}\right)
$$

Multiplying first row with -2 and -5 and then adding to $2^{\text {nd }}$ and $3^{\text {rd }}$ row i.e. by $-R_{1}+R_{2}$ and $-5 R_{1}+R_{3}$, we obtain

$$
\left(\begin{array}{ccc|c}
1 & 2 & -1 & -1 \\
0 & 2 & 3 & 9 \\
0 & -3 & 1 & 14
\end{array}\right)
$$

Multiply the second row with $1 / 2$, i.e. the operation $\frac{1}{2} R_{2}$, yields

$$
\left(\begin{array}{ccc|c}
1 & 2 & -1 & -1 \\
0 & 1 & 3 / 2 & 9 / 2 \\
0 & -3 & 1 & 14
\end{array}\right)
$$

Next add three times the second row to the third row, the operation $3 R_{2}+R_{3}$ gives

$$
\left(\begin{array}{ccc|c}
1 & 2 & -1 & -1 \\
0 & 1 & 3 / 2 & 9 / 2 \\
0 & 0 & 11 / 2 & 55 / 2
\end{array}\right)
$$

Finally, multiply the third row with $2 / 11$. This means the operation $\frac{2}{11} R_{1}$

$$
\left(\begin{array}{ccc|c}
1 & 2 & -1 & -1 \\
0 & 1 & 3 / 2 & 9 / 2 \\
0 & 0 & 1 & 5
\end{array}\right)
$$

The last matrix is in row-echelon form and represents the system

$$
\begin{aligned}
& x_{1}+x_{2}-x_{3}=1 \\
& x_{2}+\frac{3}{2} x_{3}=9 / 2 \\
& x_{3}=5
\end{aligned}
$$

Now by the backward substitution we obtain the solution set of the given system of linear algebraic equations

$$
x_{1}=10, \quad x_{2}=-3, \quad x_{3}=5
$$

(b) W start with the last matrix in part (a). Since the first in the second and third rows are 1 's we must, in turn, making the remaining entries in the second and third columns 0 s:

$$
\left(\begin{array}{ccc|c}
1 & 2 & -1 & -1 \\
0 & 1 & 3 / 2 & 9 / 2 \\
0 & 0 & 1 & 5
\end{array}\right)
$$

Adding - 2 times the 2nd row to first row, this means the operation $-2 R_{2}+R_{1}$, we have

$$
\left(\begin{array}{ccc|c}
1 & 0 & -4 & -10 \\
0 & 1 & 3 / 2 & 9 / 2 \\
0 & 0 & 1 & 5
\end{array}\right)
$$

Finally by 4 times the third row to first and $-1 / 2$ times the third row to second row, i.e. the operations $4 R_{3}+R_{1}$ and $\frac{-1}{2} R_{3}+R_{2}$, yields

$$
\left(\begin{array}{lll|c}
1 & 0 & 0 & -10 \\
0 & 1 & 0 & -3 \\
0 & 0 & 1 & 5
\end{array}\right)
$$

The last matrix is now in reduce row-echelon form .Because of what the matrix means in terms of equations, it evident that the solution of the system

$$
x_{1}=10, \quad x_{2}=-3, \quad x_{3}=5
$$

## Example 3

Use the Gauss-Jordan elimination to solve the following system of linear algebraic equations.

$$
\begin{aligned}
& x+3 y-2 z=-7 \\
& 4 x+y+3 z=5 \\
& 2 x-5 y+7 z=19
\end{aligned}
$$

## Solution:

The augmented matrix is

$$
\left(\begin{array}{ccc|c}
1 & 3 & -2 & -7 \\
4 & 1 & 3 & 5 \\
2 & -5 & 7 & 19
\end{array}\right)
$$

$-4 R_{1}+R_{2}$ and $-2 R_{1}+R_{3}$ yields

$$
\left(\begin{array}{ccc|c}
1 & 3 & -2 & -7 \\
0 & -11 & 11 & 33 \\
0 & -11 & 11 & 33
\end{array}\right)
$$

$\frac{-1}{11} R_{2}$ and $\frac{-1}{11} R_{3}$ produces

$$
\left(\begin{array}{lll|l}
1 & 3 & -2 & -7 \\
0 & 1 & -1 & -3 \\
0 & 1 & -1 & -3
\end{array}\right)
$$

$3 R_{2}+R_{1}$ and $-R_{2}+R_{3}$ gives

$$
\left(\begin{array}{ccc|c}
1 & 0 & 1 & 2 \\
0 & 1 & -1 & -3 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

In this case the last matrix in reduced row-echelon form implies that the original system of three equations in three unknowns.

$$
x+z=2, \quad y-z=-3
$$

We can assign an arbitrarily value to $z$. If we let $z=t, t \in R$, then we see that the system has infinitely many solutions:

$$
x=2-t, y=-3+t, z=t
$$

Geometrically, these equations are the parametric equations for the line of intersection of the planes

$$
x+0 y+0 z=2,0 x+y-z=-3
$$

## The Eigenvalue problem

## Eigenvalues and Eigenvectors

Let $A$ be a $n \times n$ matrix. A number $\lambda$ is said to be an eigenvalue of $A$ if there exists a nonzero solution vector $K$ of the system of linear differential equations:

$$
A K=\lambda K
$$

The solution vector $K$ is said to be an eigenvector corresponding to the eigenvalue $\lambda$. Using properties of matrix algebra, we can write the above equation in the following alternative form

$$
(A-\lambda I) K=0
$$

where $I$ is the identity matrix.

If we let

$$
K=\left(\begin{array}{l}
k_{1} \\
k_{2} \\
k_{3} \\
\vdots \\
k_{n}
\end{array}\right)
$$

Then the above system is same as the following system of linear algebraic equations

$$
\begin{gathered}
\left(a_{11}-\lambda\right) k_{1}+a_{12} k_{2}+\cdots+a_{1 n} k_{n}=0 \\
a_{21} k_{1}+\left(a_{22}-\lambda\right) k_{2}+\cdots+a_{2 n} k_{n}=0 \\
\vdots \\
\vdots \\
a_{n 1} k_{n}+a_{n 2} k_{2}+\cdots+\left(a_{n n}-\lambda\right) k_{n}=0
\end{gathered}
$$

Clearly, an obvious solution of this system is the trivial solution

$$
k_{1}=k_{2}=\ldots=k_{n}=0
$$

However, we are seeking only a non-trivial solution of the system.

## The Non-trivial solution

The non-trivial solution of the system exists only when

$$
\operatorname{det}(A-\lambda I)=0
$$

This equation is called the characteristic equation of the matrix $A$. Thus the Eigenvalues of the matrix $A$ are given by the roots of the characteristic equation. To find an eigenvector corresponding to an eigenvalue $\lambda$ we simply solve the system of linear algebraic equations

$$
\operatorname{det}(A-\lambda I) K=0
$$

This system of equations can be solved by applying the Gauss-Jordan elimination to the augmented matrix

$$
(A-\lambda I \mid 0) .
$$

## Example 4

Verify that the following column vector is an eigenvector

$$
K=\left(\begin{array}{r}
1 \\
-1 \\
1
\end{array}\right)
$$

is an eigenvector of the following $3 \times 3$ matrix

$$
A=\left(\begin{array}{ccc}
0 & -1 & -3 \\
2 & 3 & 3 \\
-2 & 1 & 1
\end{array}\right)
$$

## Solution:

By carrying out the multiplication $A K$, we see that

$$
A K=\left(\begin{array}{ccc}
0 & -1 & -3 \\
2 & 3 & 3 \\
-2 & 1 & 1
\end{array}\right)\left(\begin{array}{c}
1 \\
-1 \\
1
\end{array}\right)=(-2)\left(\begin{array}{c}
-2 \\
2 \\
1
\end{array}\right)=(-2) K
$$

Hence the number $\lambda=-2$ is an eigenvalue of the given matrix $A$.

## Example 5

Find the eigenvalues and eigenvectors of

$$
A=\left(\begin{array}{ccc}
1 & 2 & 1 \\
6 & -1 & 0 \\
-1 & -2 & -1
\end{array}\right)
$$

## Solution:

## Eigenvalues

The characteristic equation of the matrix $A$ is

$$
\operatorname{det}(A-\lambda I)=\left|\begin{array}{ccc}
1-\lambda & 2 & 1 \\
6 & -1-\lambda & 0 \\
-1 & -2 & -1-\lambda
\end{array}\right|=0
$$

Expanding the determinant by the cofactors of the second row, we obtain

$$
-\lambda^{3}-\lambda^{2}+12 \lambda=0
$$

\lambda(\lambda+4)(\lambda-3)=0
$$

Hence the eigenvalues of the matrix are

$$
\lambda_{1}=0, \quad \lambda_{2}=-4, \quad \lambda_{3}=3 .
$$

## Eigenvectors

For $\lambda_{1}=0$ we have

$$
(A-0 \mid 0)=\left(\begin{array}{ccc|c}
1 & 2 & 1 & 0 \\
6 & -1 & 0 & 0 \\
-1 & -2 & -1 & 0
\end{array}\right)
$$

By $-6 R_{1}+R_{2}, R_{1}+R_{3}$

$$
\left(\begin{array}{ccc|c}
1 & 2 & 1 & 0 \\
0 & -13 & -6 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

By $-\frac{1}{13} R_{2}$

$$
\left(\begin{array}{ccc|c}
1 & 2 & 1 & 0 \\
0 & 1 & 6 / 13 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

By $-2 R_{2}+R_{1}$

$$
\left(\begin{array}{ccc|c}
1 & 0 & 1 / 13 & 0 \\
0 & 1 & 6 / 13 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

Thus we have the following equations in $k_{1}$, $k_{2}$ and $k_{3}$. The number $k_{3}$ can be chosen arbitrarily

$$
k_{1}=-(1 / 13) k_{3}, k_{2}=-(6 / 13) k_{3}
$$

Choosing $k_{3}=-13$, we get $k_{1}=1$ and $k_{2}=6$. Hence, the eigenvector corresponding $\lambda_{1}=0$ is

$$
K_{1}=\left(\begin{array}{c}
1 \\
6 \\
-13
\end{array}\right)
$$

For $\lambda_{2}=-4$, we have

$$
(A+4 \mid 0)=\left(\begin{array}{ccc|c}
5 & 2 & 1 & 0 \\
6 & 3 & 0 & 0 \\
-1 & -2 & 3 & 0
\end{array}\right)
$$

By $(-1) R_{3}, R_{32}$

$$
\left(\begin{array}{ccc|c}
1 & 2 & -3 & 0 \\
6 & 3 & 0 & 0 \\
5 & 2 & 1 & 0
\end{array}\right)
$$

By $-6 R_{1}+R_{2},-5 R_{1}+R_{3}$

$$
\left(\begin{array}{ccc|c}
1 & 2 & -3 & 0 \\
0 & -9 & 18 & 0 \\
0 & -8 & 16 & 0
\end{array}\right)
$$

By $-\frac{1}{9} R_{2},-\frac{1}{8} R_{3}$

$$
\left(\begin{array}{lll|l}
1 & 2 & -3 & 0 \\
0 & 1 & -2 & 0 \\
0 & 1 & -2 & 0
\end{array}\right)
$$

$\mathrm{By}-2 R_{2}+R_{1},-R_{2}+R_{3}$

$$
\left(\begin{array}{ccc|c}
1 & 0 & 1 & 0 \\
0 & 1 & -2 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

Hence we obtain the following two equations involving $k_{1}, k_{2}$ and $k_{3}$.

$$
k_{1}=-k_{3}, k_{2}=2 k_{3}
$$

Choosing $k_{3}=1$, we have $k_{1}=-1, k_{2}=2$. Hence we have an eigenvector corresponding to the eigenvalue $\lambda_{2}=-4$

$$
K_{2}=\left(\begin{array}{l}
1 \\
2 \\
1
\end{array}\right)
$$

Finally, for $\lambda_{3}=3$, we have

$$
(A-3 I \mid 0)=\left(\begin{array}{ccc|c}
-2 & 2 & 1 & 0 \\
6 & -4 & 0 & 0 \\
-1 & -2 & -4 & 0
\end{array}\right)
$$

By using the Gauss Jordon elimination as used for other values, we obtain (verify!)

$$
\left(\begin{array}{ccc|c}
1 & 0 & 1 & 0 \\
0 & 1 & 3 / 2 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

So that we obtain the equations

$$
k_{1}=-k_{3}, \quad k_{2}=(-3 / 2) k_{3}
$$

The choice $k_{3}=-2$ leads to $k_{1}=2, k_{2}=3$. Hence, we have the following eigenvector

$$
K_{3}=\left(\begin{array}{c}
2 \\
3 \\
-2
\end{array}\right)
$$

## Note that

The component $k_{3}$ could be chosen as any nonzero number. Therefore, a nonzero constant multiple of an eigenvector is also an eigenvector.

## Example 6

Find the eigenvalues and eigenvectors of

$$
A=\left(\begin{array}{cc}
3 & 4 \\
-1 & 7
\end{array}\right)
$$

## Solution:

From the characteristic equation of the given matrix is

$$
\operatorname{det}(A-\lambda I)=\left|\begin{array}{cc}
3-\lambda & 4 \\
-1 & 7-\lambda
\end{array}\right|=0
$$

or

$$
(3-\lambda)(7-\lambda)+4=0 \Rightarrow(\lambda-5)^{2}=0
$$

Therefore, the characteristic equation has repeated real roots. Thus the matrix has an eigenvalue of multiplicity two.

$$
\lambda_{1}=\lambda_{2}=5
$$

In the case of a $2 \times 2$ matrix there is no need to use Gauss-Jordan elimination. To find the eigenvector(s) corresponding to $\lambda_{1}=5$ we resort to the system of linear equations

$$
(A-5 I) K=0
$$

or in its equivalent form

$$
\begin{array}{r}
-2 k_{1}+4 k_{2}=0 \\
k_{1}+2 k_{2}=0
\end{array}
$$

It is apparent from this system that

$$
k_{1}=2 k_{2} .
$$

Thus if we choose $k_{2}=1$, we find the single eigenvector

$$
K_{1}=\binom{2}{1}
$$

## Example 7

Find the eigenvalues and eigenvectors of

$$
A=\left(\begin{array}{lll}
9 & 1 & 1 \\
1 & 9 & 1 \\
1 & 1 & 9
\end{array}\right)
$$

## Solution

The characteristic equation of the given matrix is
or

$$
\begin{aligned}
& \operatorname{det}(A-\lambda I)=\left|\begin{array}{ccc}
9-\lambda & 1 & 1 \\
1 & 9-\lambda & 1 \\
1 & 1 & 9-\lambda
\end{array}\right|=0 \\
& (\lambda-11)(\lambda-8)^{2}=0 \Rightarrow \lambda=11,8,8
\end{aligned}
$$

Thus the eigenvalues of the matrix are $\quad \lambda_{1}=11, \lambda_{2}=\lambda_{3}=8$
For $\lambda_{1}=11$, we have

$$
(A-11 I \mid 0)=\left(\begin{array}{ccc|c}
-2 & 1 & 1 & 0 \\
1 & -2 & 1 & 0 \\
1 & 1 & -2 & 0
\end{array}\right)
$$

The Gauss-Jordan elimination gives

$$
\left(\begin{array}{rrr|r}
1 & 0 & -1 & 0 \\
0 & 1 & -1 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

Hence, $k_{1}=k_{3}, k_{2}=k_{3}$. If $k_{3}=1$, then

$$
K_{1}=\left(\begin{array}{l}
1 \\
1 \\
1
\end{array}\right)
$$

Now for $\lambda_{2}=8$ we have

$$
(A-8 I \mid 0)=\left(\begin{array}{lll|l}
1 & 1 & 1 & 0 \\
1 & 1 & 1 & 0 \\
1 & 1 & 1 & 0
\end{array}\right)
$$

Again the Gauss-Jordon elimination gives

$$
\left(\begin{array}{lll|l}
1 & 1 & 1 & 0 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

Therefore,

$$
k_{1}+k_{2}+k_{3}=0
$$

We are free to select two of the variables arbitrarily. Choosing, on the one hand, $k_{2}=1, k_{3}=0$ and, on the other, $k_{2}=0, k_{3}=1$, we obtain two linearly independent eigenvectors corresponding to a single eigenvalue

$$
K_{2}=\left(\begin{array}{l}
-1 \\
1 \\
0
\end{array}\right), K_{3}=\left(\begin{array}{l}
-1 \\
0 \\
1
\end{array}\right)
$$

## Note that

Thus we note that when a $n \times n$ matrix $A$ possesses $n$ distinct eigenvalues $\lambda_{1}, \lambda_{2}, \ldots, \lambda_{n}$, a set of $n$ linearly independent eigenvectors $K_{1}, K_{2}, \ldots, K_{n}$ can be found.

However, when the characteristic equation has repeated roots, it may not be possible to find $n$ linearly independent eigenvectors of the matrix.

## Matrix form of a system

Consider the following system of linear first-order differential equations

$$
\begin{aligned}
& \frac{d x_{1}}{d t}=a_{11}(t) x_{1}+a_{12}(t) x_{2}+\cdots+a_{1 n}(t) x_{n}+f_{1}(t) \\
& \frac{d x_{2}}{d t}=a_{21}(t) x_{1}+a_{22}(t) x_{2}+\cdots+a_{2 n}(t) x_{n}+f_{2}(t) \\
& \vdots \\
& \frac{d x_{n}}{d t}=a_{n 1}(t) x_{1}+a_{n 2}(t) x_{2}+\cdots+a_{n n}(t) x_{n}+f_{n}(t)
\end{aligned}
$$

Suppose that $X, A(t)$ and $F(t)$, respectively, denote the following matrices

$$
X=\left(\begin{array}{c}
x_{1}(t) \\
x_{2}(t) \\
\vdots \\
x_{n}(t)
\end{array}\right), \quad A(t)=\left(\begin{array}{cccc}
a_{11}(t) & a_{12}(t) & \cdots & a_{1 n}(t) \\
a_{21}(t) & a_{22}(t) & \cdots & a_{2 n}(t) \\
\vdots & \vdots & \cdots & \vdots \\
a_{n 1}(t) & a_{n 2}(t) & \cdots & a_{n n}(t)
\end{array}\right), \quad \mathrm{F}(\mathrm{t})=\left(\begin{array}{c}
f_{1}(t) \\
f_{2}(t) \\
\vdots \\
f_{n}(t)
\end{array}\right)
$$

Then the system of differential equations can be written as

$$
\frac{d}{d t}\left(\begin{array}{c}
x_{1}(t) \\
x_{2}(t) \\
\vdots \\
x_{n}(t)
\end{array}\right)=\left(\begin{array}{cccc}
a_{11}(t) & a_{12}(t) & \cdots & a_{1 n}(t) \\
a_{21}(t) & a_{22}(t) & \cdots & a_{2 n}(t) \\
\vdots & \vdots & \cdots & \vdots \\
a_{n 1}(t) & a_{n 2}(t) & \cdots & a_{n n}(t)
\end{array}\right)\left(\begin{array}{c}
x_{1}(t) \\
x_{2}(t) \\
\vdots \\
x_{n}(t)
\end{array}\right)+\left(\begin{array}{c}
f_{1}(t) \\
f_{2}(t) \\
\vdots \\
f_{n}(t)
\end{array}\right)
$$

or simply

$$
\frac{d X}{d t}=A(t) X+F(t)
$$

If the system of differential equations is homogenous, then $F(t)=0$ and we can write

$$
\frac{d X}{d t}=A(t) X
$$

Both the non-homogeneous and the homogeneous systems can also be written as

$$
X^{\prime}=A X+F, \quad X^{\prime}=A X
$$

## Example 1

Write the following non-homogeneous system of differential equations in the matrix form

$$
\begin{aligned}
& \frac{d x}{d t}=-2 x+5 y+e^{t}-2 t \\
& \frac{d y}{d t}=4 x-3 y+10 t
\end{aligned}
$$

## Solution:

If we suppose that

$$
X=\binom{x}{y}
$$

Then, the given non-homogeneous differential equations can be written as
or

$$
\begin{aligned}
\frac{d X}{d t} & =\left(\begin{array}{cc}
-2 & 5 \\
4 & -3
\end{array}\right) X+\binom{e^{t}-2 t}{10 t} \\
X^{\prime} & =\left(\begin{array}{cc}
-2 & 5 \\
4 & -3
\end{array}\right) X+\binom{1}{0} e^{t}+\binom{-2}{10} t
\end{aligned}
$$

## Solution Vector

Consider a homogeneous system of differential equations

$$
\frac{d X}{d t}=A X
$$

A solution vector on an interval $I$ of the homogeneous system is any column matrix

$$
X=\left(\begin{array}{c}
x_{1}(t) \\
x_{2}(t) \\
\vdots \\
x_{n}(t)
\end{array}\right)
$$

The entries of the solution vector have to be differentiable functions satisfying each equation of the system on the interval $I$.

## Example 2

Verify that

$$
X_{1}=\binom{1}{-1} e^{-2 t}=\binom{e^{-2 t}}{-e^{-2 t}}, \quad X_{2}=\binom{3}{5} e^{6 t}=\binom{3 e^{6 t}}{5 e^{6 t}}
$$

are solution of the following system of the homogeneous differential equations

$$
X^{\prime}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X
$$

on the interval $(-\infty, \infty)$

## Solution:

Since

$$
X_{1}=\binom{e^{-2 t}}{-e^{-2 t}} \Rightarrow X_{1}^{\prime}=\binom{-2 e^{-2 t}}{2 e^{-2 t}}
$$

Further

$$
\begin{aligned}
& A X_{1}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right)\binom{e^{-2 t}}{-e^{-2 t}}=\binom{e^{-2 t}-3 e^{-2 t}}{5 e^{-2 t}-3 e^{-2 t}} \\
& A X_{1}=\binom{-2 e^{-2 t}}{2 e^{-2 t}}=X_{1}^{\prime}
\end{aligned}
$$

Similarly

$$
X_{2}=\binom{3 e^{6 t}}{5 e^{6 t}} \Rightarrow X_{2}^{\prime}=\binom{18 e^{6 t}}{30 e^{6 t}}
$$

and

$$
\begin{aligned}
& A X_{2}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right)\binom{3 e^{6 t}}{5 e^{6 t}}=\binom{3 e^{6 t}+15 e^{6 t}}{15 e^{6 t}+15 e^{6 t}} \\
& A X_{2}=\binom{18 e^{6 t}}{30 e^{6 t}}=X_{2}^{/}
\end{aligned}
$$

Thus, the vectors $X_{1}$ and $X_{2}$ satisfy the homogeneous linear system

$$
X^{\prime}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X
$$

Hence, the given vectors are solutions of the given homogeneous system of differential equations.

## Note that

Much of the theory of the systems of $n$ linear first-order differential equations is similar to that of the linear $n t h$-order differential equations.

## Initial -Value Problem

Let $t_{0}$ denote any point in some interval denoted by $I$ and

$$
X\left(t_{O}\right)=\left(\begin{array}{c}
x_{1}\left(t_{O}\right) \\
x_{2}\left(t_{0}\right) \\
\vdots \\
x_{n}\left(t_{0}\right)
\end{array}\right), \quad X_{O}=\left(\begin{array}{c}
\gamma_{1} \\
\gamma_{2} \\
\vdots \\
\gamma_{n}
\end{array}\right)
$$

$\gamma_{i} ; i=1,2, \ldots, n$ are given constants. Then the problem of solving the system of differential equations

$$
\frac{d X}{d t}=A(t) X+F(t)
$$

Subject to the initial conditions

$$
X\left(t_{0}\right)=X_{0}
$$

is called an initial value problem on the interval $I$.
Theorem: Existence of a unique Solution
Suppose that the entries of the matrices $A(t)$ and $F(t)$ in the system of differential equations

$$
\frac{d X}{d t}=A(t) X+F(t)
$$

being considered in the above mentioned initial value problem, are continuous functions on a common interval $I$ that contains the point $t_{0}$. Then there exist a unique solution of the initial-value problem on the interval $I$.

## Superposition Principle

Suppose that $X_{1}, X_{2}, \ldots, X_{n}$ be a set of solution vectors of the homogenous system

$$
\frac{d X}{d t}=A(t) X
$$

on an interval $I$. Then the principle of superposition states that linear combination

$$
X=c_{1} X_{1}+c_{2} X_{2}+\cdots+c_{k} X_{k}
$$

$c_{i} ; i=1,2, \ldots, k$ being arbitrary constants, is also a solution of the system on the same interval $I$.

## Note that

An immediate consequence of the principle of superposition is that a constant multiple of any solution vector of a homogenous system of first order differential equation is also a solution of the system.

## Example 3

Consider the following homogeneous system of differential equations

$$
X^{\prime}=\left(\begin{array}{ccc}
1 & 0 & 1 \\
1 & 1 & 0 \\
-2 & 0 & -1
\end{array}\right) X
$$

Also consider a solution vector $X_{1}$ of the system that is given by

$$
X_{1}=\left(\begin{array}{c}
\cos t \\
-\frac{1}{2} \cos t+\frac{1}{2} \sin t \\
-\cos t-\sin t
\end{array}\right)
$$

For any constant $c_{1}$ the vector $X=c_{1} X_{1}$ is also a solution of the homogeneous system. To verify this we differentiae the vector $X$ with respect to $t$

$$
\frac{d X}{d t}=c_{1} \frac{d X}{d t}=c_{1}\left(\begin{array}{c}
-\sin t \\
\frac{1}{2} \cos t+\frac{1}{2} \sin t \\
-\cos t+\sin t
\end{array}\right)
$$

Also

$$
\begin{aligned}
& A X=c_{1}\left(\begin{array}{ccc}
1 & 0 & 1 \\
1 & 1 & 0 \\
-2 & 0 & -1
\end{array}\right)\left(\begin{array}{c}
\cos t \\
-\frac{1}{2} \cos t+\frac{1}{2} \sin t \\
-\cos t-\sin t
\end{array}\right) \\
& A X=c_{1}\left(\begin{array}{c}
-\sin t \\
\frac{1}{2} \cos t+\frac{1}{2} \sin t \\
-\cos t+\sin t
\end{array}\right)
\end{aligned}
$$

Thus, we have verified that:

$$
\frac{d X}{d t}=A X
$$

Hence the vector $c_{1} X_{1}$ is also a solution vector of the homogeneous system of differential equations.

## Example 4

Consider the following system considered in the previous example 4

$$
X^{\prime}=\left(\begin{array}{ccc}
1 & 0 & 1 \\
1 & 1 & 0 \\
-2 & 0 & -1
\end{array}\right) X
$$

We know from the previous example that the vector $X_{1}$ is a solution of the system

If

Then

$$
X_{1}=\left(\begin{array}{c}
\cos t \\
-\frac{1}{2} \cos t+\frac{1}{2} \sin t \\
-\cos t-\sin t
\end{array}\right)
$$

$$
\mathrm{X}_{2}=\left(\begin{array}{c}
0 \\
e^{t} \\
0
\end{array}\right)
$$

$$
\mathrm{X}_{2}^{\prime}=\left(\begin{array}{c}
0 \\
e^{t} \\
0
\end{array}\right)
$$

and

$$
A X_{2}=\left(\begin{array}{ccc}
1 & 0 & 1 \\
1 & 1 & 0 \\
-2 & 0 & -1
\end{array}\right)\left(\begin{array}{c}
0 \\
e^{t} \\
0
\end{array}\right)=\left(\begin{array}{c}
0 \\
e^{t} \\
0
\end{array}\right)
$$

Therefore

$$
A X_{2}=X_{2}^{\prime}
$$

Hence the vector $X_{2}$ is a solution vector of the homogeneous system. We can verify that the following vector is also a solution of the homogeneous system.
or

$$
X=c_{1} X_{1}+c_{2} X_{2}
$$

$$
X=c_{1}\left(\begin{array}{c}
\cos t \\
-\frac{1}{2} \cos t+\frac{1}{2} \sin t \\
-\cos t-\sin t
\end{array}\right)+c_{2}\left(\begin{array}{c}
0 \\
e^{t} \\
0
\end{array}\right)
$$

## Linear Dependence of Solution Vectors

Let $X_{1}, X_{2}, X_{3}, \ldots, X_{k}$ be a set of solution vectors, on an interval I, of the homogenous system of differential equations

$$
\frac{d X}{d t}=A X
$$

We say that the set is linearly dependent on $I$ if there exist constants $c_{1}, c_{2}, c_{3} \ldots, c_{k}$ not all zero such that

$$
X(t)=c_{1} X_{1}(t)+c_{2} X_{2}(t)+\cdots+c_{k} X_{k}(t)=0, \quad \forall t \in I
$$

## Note that

- Any two solution vectors $X_{1}$ and $X_{2}$ are linearly dependent if and only if one of the two vectors is a constant multiple of the other.
- For $k>2$ if the set of $k$ solution vectors is linearly dependent then we can express at least one of the solution vectors as a linear combination of the remaining vectors.


## Linear Independence of Solution Vectors

Suppose that $X_{1}, X_{2}, \ldots, X_{k}$ is a set of solution vectors, on an interval I, of the homogenous system of differential equations

$$
\frac{d X}{d t}=A X
$$

Then the set of solution vectors is said to be linearly independent if it is not linearly dependent on the interval $I$. This means that

$$
X(t)=c_{1} X_{1}(t)+c_{2} X_{2}(t)+\cdots+c_{k} X_{k}(t)=0
$$

only when each $c_{i}=0$.

## Example 5

Consider the following two column vectors

$$
X_{1}=\binom{3 e^{t}}{e^{t}}, \quad X_{2}=\binom{e^{-t}}{e^{-t}}
$$

Since $\quad \frac{d X_{1}}{d t}=\binom{3 e^{t}}{e^{t}}, \frac{d X_{2}}{d t}=\binom{-e^{-t}}{-e^{-t}}$
and $\quad\left(\begin{array}{ll}2 & -3 \\ 1 & -2\end{array}\right)\binom{3 e^{t}}{e^{t}}=\binom{6 e^{t}-3 e^{t}}{3 e^{t}-2 e^{t}}=\binom{3 e^{t}}{e^{t}}=\frac{d X_{1}}{d t}$

Similarly

$$
\left(\begin{array}{ll}
2 & -3 \\
1 & -2
\end{array}\right)\binom{e^{-t}}{e^{-t}}=\binom{2 e^{-t}-3 e^{-t}}{e^{-t}-2 e^{-t}}=\binom{-e^{-t}}{-e^{-t}}=\frac{d X_{2}}{d t}
$$

Hence both the vectors $X_{1}$ and $X_{2}$ are solutions of the homogeneous system

$$
X^{\prime}=\left(\begin{array}{ll}
2 & -3 \\
1 & -2
\end{array}\right) X
$$

Now suppose that $c_{1}, c_{2}$ are any two arbitrary real constants such that

$$
c_{1} X_{1}+c_{2} X_{2}=0
$$

or

$$
c_{1}\binom{3}{1} e^{t}+c_{2}\binom{1}{1} e^{-t}=\binom{0}{0}
$$

This means that

$$
\begin{aligned}
3 c_{1} e^{t}+c_{2} e^{-t} & =0 \\
c_{1} e^{t}+c_{2} e^{-t} & =0
\end{aligned}
$$

The only solution of these equations for the arbitrary constants $c_{1}$ and $c_{2}$ is

$$
c_{1}=c_{2}=0
$$

Hence, the solution vectors $X_{1}$ and $X_{2}$ are linearly independent on $(-\infty, \infty)$.

## Example 6

Again consider the same homogeneous system as considered in the previous example

$$
X^{\prime}=\left(\begin{array}{ll}
2 & -3 \\
1 & -2
\end{array}\right) X
$$

We have already seen that the vectors $X_{1}, X_{2}$ i.e.

$$
X_{1}=\binom{3 e^{t}}{e^{t}}, \quad X_{2}=\binom{e^{-t}}{e^{-t}}
$$

are solutions of the homogeneous system. We can verify that the following vector $X_{3}$

$$
X_{3}=\binom{e^{t}+\cosh t}{\cosh t}
$$

is also a solution of the homogeneous system However, the set of solutions that consists of $X_{1}, X_{2}$ and $X_{3}$ is linearly dependent because $X_{3}$ is a linear combination of the other two vectors

$$
X_{3}=\frac{1}{2} X_{1}+\frac{1}{2} X_{2}
$$

Theorem: A necessary and sufficient condition that the set of solutions, on an interval I., consisting of the vectors

$$
X_{1}=\left(\begin{array}{c}
x_{11} \\
x_{21} \\
\vdots \\
x_{n 1}
\end{array}\right), X_{2}=\left(\begin{array}{c}
x_{12} \\
x_{21} \\
\vdots \\
x_{n 2}
\end{array}\right), \ldots, X_{n}=\left(\begin{array}{c}
x_{1 n} \\
x_{2 n} \\
\vdots \\
x_{n n}
\end{array}\right)
$$

of the homogenous system $X^{/}=A X$ to be linearly independent is that the Wronskian of these solutions is non-zero for every $t \in I$. Thus

$$
W\left(X_{1}, X_{2}, \ldots, X_{n}\right)=\left|\begin{array}{cccc}
x_{11} & x_{12} & \ldots & x_{1 n} \\
x_{21} & x_{22} & \ldots & x_{2 n} \\
\vdots & \vdots & \ldots & \vdots \\
x_{n 1} & x_{n 2} & \ldots & x_{n n}
\end{array}\right| \neq 0, \quad \forall t \in I
$$

## Note that

- It can be shown that if $X_{1}, X_{2}, \ldots, X_{n}$ are solution vectors of the system, then either
or

$$
W\left(X_{1}, X_{2}, \ldots, X_{n}\right) \neq 0, \forall t \in I
$$

Thus if we can show that $W \neq 0$ for some $t_{0} \in I$, then $W \neq 0, \forall t \in I$ and hence the solutions are linearly independent on $I$

- Unlike our previous definition of the Wronskian, the determinant does not involve any differentiation.


## Example 1

As verified earlier that the vectors

$$
X_{1}=\binom{1}{-1} e^{-2 t}, \quad X_{2}=\binom{3}{5} e^{6 t}
$$

are solutions of the following homogeneous system.

$$
X^{\prime}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X
$$

Clearly, $X_{1}$ and $X_{2}$ are linearly independent on $(-\infty, \infty)$ as neither of the vectors is a constant multiple of the other. We now compute Wronskian of the solution vectors $X_{1}$ and $X_{2}$.

$$
W\left(X_{1}, X_{2}\right)=\left|\begin{array}{cc}
e^{-2 t} & 3 e^{6 t} \\
-e^{-2 t} & 5 e^{6 t}
\end{array}\right|=8 e^{4 t} \neq 0, \quad \forall t \in(-\infty, \infty)
$$

## Fundamental set of solution

Suppose that $\left\{X_{1}, X_{2}, \ldots, X_{n}\right\}$ is a set of $n$ solution vectors, on an interval $I$, of a homogenous system $X^{\prime}=A X$. The set is said to be a fundamental set of solutions of the system on the interval $I$ if the solution vectors $X_{1}, X_{2}, \ldots, X_{n}$ are linearly independent.

Theorem: Existence of a Fundamental Set
There exist a fundamental set of solution for the homogenous system $X^{\prime}=A X$ on an interval $I$

## General solution

Suppose that $X_{1}, X_{2}, \ldots, X_{n}$ is a fundamental set of solution of the homogenous system $X^{\prime}=A X$ on an interval $I$. Then any linear combination of the solution vectors $X_{1}, X_{2}, \ldots, X_{n}$ of the form

$$
X=c_{1} X_{1}+c_{2} X_{2}+\cdots+c_{n} X_{n}
$$

$c_{i} ; i=1,2, \ldots, n$ being arbitrary constants is said to be the general solution of the system on the interval $I$.

## Note that

For appropriate choices of the arbitrary constants $c_{1}, c_{2}, \ldots, c_{n}$ any solution, on the interval I, of the homogeneous system $X^{\prime}=A X$ can be obtained from the general solution.

## Example 2

As discussed in the Example 1, the following vectors are linearly independent solutions

$$
X_{1}=\binom{1}{-1} e^{-2 t}, \quad X_{2}=\binom{3}{5} e^{6 t}
$$

of the following homogeneous system of differential equations on $(-\infty, \infty)$

$$
X^{\prime}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X
$$

Hence $X_{1}$ and $X_{2}$ form a fundamental set of solution of the system on the interval $(-\infty, \infty)$. Hence, the general solution of the system on $(-\infty, \infty)$ is

$$
X=c_{1} X_{1}+c_{2} X_{2}=c_{1}\binom{1}{-1} e^{-2 t}+c_{2}\binom{3}{5} e^{6 t}
$$

## Example 3

Consider the vectors $X_{1}, X_{2}$ and $X_{3}$ these vectors are given by

$$
X_{1}=\left(\begin{array}{c}
\cos t \\
-\frac{1}{2} \cos t+\frac{1}{2} \sin t \\
-\cos t-\sin t
\end{array}\right), X_{2}=\left(\begin{array}{l}
0 \\
1 \\
0
\end{array}\right) e^{t}, X_{3}=\left(\begin{array}{c}
\sin t \\
-\frac{1}{2} \sin t-\frac{1}{2} \cos t \\
-\sin t+\cos t
\end{array}\right)
$$

It has been verified in the last lecture that the vectors $X_{1}$ and $X_{2}$ are solutions of the homogeneous system

$$
X^{\prime}=\left(\begin{array}{ccc}
1 & 0 & 1 \\
1 & 1 & 0 \\
-2 & 0 & -1
\end{array}\right) X
$$

It can be easily verified that the vector $X_{3}$ is also a solution of the system. We now compute the Wronskian of the solution vectors $X_{1}, X_{2}$ and $X_{3}$

$$
W\left(X_{1}, X_{2}, X_{3}\right)=\left|\begin{array}{ccc}
\cos t & 0 & \sin t \\
-\frac{1}{2} \cos t+\frac{1}{2} \sin t & e^{t} & -\frac{1}{2} \sin t-\frac{1}{2} \cos t \\
-\cos t-\sin t & 0 & -\sin t+\cos t
\end{array}\right|
$$

## Expand from $2^{\text {nd }}$ column

or
or

$$
\begin{aligned}
& W\left(X_{1}, X_{2}, X_{3}\right)=e^{t}\left|\begin{array}{cc}
\cos t & \sin t \\
-\cos t-\sin t & -\sin t+\cos t
\end{array}\right| \\
& W\left(X_{1}, X_{2}, X_{3}\right)=e^{t} \neq 0, \quad \forall t \in R
\end{aligned}
$$

Thus, we conclude that $X_{1}, X_{2}$ and $X_{3}$ form a fundamental set of solution on $(-\infty, \infty)$.
Hence, the general solution of the system on $(-\infty, \infty)$ is

$$
X=c_{1} X_{1}+c_{2} X_{2}+c_{3} X_{3}
$$

or

$$
X=c_{1}\left(\begin{array}{c}
\cos t \\
-\frac{1}{2} \cos t+\frac{1}{2} \sin t \\
-\cos t-\sin t
\end{array}\right)+c_{2}\left(\begin{array}{l}
0 \\
1 \\
0
\end{array}\right) e^{t}+c_{3}\left(\begin{array}{c}
\sin t \\
-\frac{1}{2} \sin t-\frac{1}{2} \cos t \\
-\sin t+\cos t
\end{array}\right)
$$

## Non-homogeneous Systems

As stated earlier in this lecture that a system of differential equations such as

$$
\frac{d X}{d t}=A(t) X+F(t)
$$

is non-homogeneous if $F(t) \neq 0, \forall t$. The general solution of such a system consists of a complementary function and a particular integral.

## Particular Integral

A particular solution, on an interval $I$, of a non-homogeneous system is any vector $X_{p}$ free of arbitrary parameters, whose entries are functions that satisfy each equation of the system.

## Example 4

Show that the vector

$$
X_{p}=\binom{3 t-4}{-5 t+6}
$$

is a particular solution of the following non-homogeneous system on the interval $(-\infty, \infty)$

$$
X^{\prime}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X+\binom{12 t-11}{-3}
$$

## Solution:

Differentiating the given vector with respect to $t$, we obtain

$$
X_{p}^{\prime}=\binom{3}{-5}
$$

Further
or
or

$$
\begin{aligned}
& \left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X_{p}+\binom{12 t-11}{-3}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right)\binom{3 t-4}{-5 t+6}+\binom{12 t-11}{-3} \\
& \left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X_{p}+\binom{12 t-11}{-3}=\binom{(3 t-4)+3(-5 t+6)}{5(3 t-4)+3(-5 t+6)}+\binom{12 t-11}{-3} \\
& \left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X_{p}+\binom{12 t-11}{-3}=\binom{-12 t+14}{-2}+\binom{12 t-11}{-3}
\end{aligned}
$$

or $\quad\left(\begin{array}{ll}1 & 3 \\ 5 & 3\end{array}\right) X_{p}+\binom{12 t-11}{-3}=\binom{3}{-5}=X_{P}^{\prime}$
Thus the given vector $X_{p}$ satisfies the non-homogeneous system of differential equations. Hence, the given vector $X_{p}$ is a particular solution of the non-homogeneous system.

## Theorem

Let $X_{1}, X_{2}, \ldots, X_{k}$ be a set of solution vectors of the homogenous system $X^{\prime}=A X$ on an interval $I$ and let $X_{p}$ be any solution vector of the non-homogenous system $X^{\prime}=A X+F(t)$ on the same interval $I$. Then $\exists$ constants $c_{1}, c_{2}, \ldots, c_{k}$ such that

$$
X_{p}=c_{1} X_{1}+c_{2} X_{2}+\ldots+c_{k} X_{k}+X_{p}
$$

is also a solution of the non-homogenous system on the interval.

## Complementary function

Let $X_{1}, X_{2}, \ldots, X_{n}$ be solution vectors of the homogenous system $X^{\prime}=A X$ on an interval $I$, then the general solution

$$
X=c_{1} X_{1}+c_{2} X_{2}+\ldots+c_{n} X_{n}
$$

of the homogeneous system is called the complementary function of the nonhomogeneous system $X^{\prime}=A X+F(t)$ on the same interval $I$.

## General solution-Non homogenous systems

Let $X_{p}$ be a particular integral and $X_{C}$ the complementary function, on an interval $I$, of the non-homogenous system

$$
X^{\prime}=A(t) X+F(t)
$$

The general solution of the non-homogenous system on the interval $I$ is defined to be

$$
X=X_{c}+X_{p}
$$

## Example 5

In Example 4 it was verified that

$$
X_{p}=\binom{3 t-4}{-5 t+6}
$$

is a particular solution, on $(-\infty, \infty)$, of the non-homogenous system

$$
X^{\prime}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X+\binom{12 t-11}{-3}
$$

As we have seen earlier, the general solution of the associated homogeneous system i.e. the complementary function of the given non-homogeneous system is

$$
X_{C}=c_{1}\binom{1}{-1} e^{-2 t}+c_{2}\binom{3}{5} e^{6 t}
$$

Hence the general solution, on $(-\infty, \infty)$, of the non-homogeneous system is

$$
\begin{aligned}
& X=X_{C}+X_{p} \\
& X=c_{1}\binom{1}{-1} e^{-2 t}+c_{2}\binom{3}{5} e^{6 t}+\binom{3 t-4}{-5 t+6}
\end{aligned}
$$

## Fundamental Matrix

Suppose that the a fundamental set of $n$ solution vectors of a homogeneous system $X^{/}=A X$, on an interval $I$, consists of the vectors

$$
X_{1}=\left(\begin{array}{c}
x_{11} \\
x_{21} \\
\vdots \\
x_{n 1}
\end{array}\right), X_{2}=\left(\begin{array}{c}
x_{12} \\
x_{22} \\
\vdots \\
x_{n 2}
\end{array}\right), \ldots, X_{n}=\left(\begin{array}{c}
x_{1 n} \\
x_{2 n} \\
\vdots \\
x_{n n}
\end{array}\right)
$$

Then a fundamental matrix of the system on the interval $I$ is given by

$$
\phi(t)=\left(\begin{array}{cccc}
x_{11} & x_{12} & \ldots & x_{1 n} \\
x_{21} & x_{22} & \ldots & x_{2 n} \\
\vdots & \vdots & \ldots & \vdots \\
x_{n 1} & x_{n 2} & \ldots & x_{n n}
\end{array}\right)
$$

## Example 6

As verified earlier, the following vectors

$$
\begin{aligned}
& X_{1}=\binom{1}{-1} e^{-2 t}=\binom{e^{-2 t}}{-e^{-2 t}} \\
& X_{2}=\binom{3}{5} e^{6 t}=\binom{3 e^{6 t}}{5 e^{6 t}}
\end{aligned}
$$

form a fundamental set of solutions of the system on $(-\infty, \infty)$

$$
X^{\prime}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X
$$

So that the general solution of the system is

$$
X=c_{1}\binom{1}{-1} e^{-2 t}+c_{2}\binom{3}{5} e^{6 t}
$$

Hence, a fundamental matrix of the system on the interval is

$$
\phi(t)=\left(\begin{array}{cc}
e^{-2 t} & 3 e^{6 t} \\
-e^{-2 t} & 5 e^{6 t}
\end{array}\right)
$$

## Note that

- The general solution of the system can be written as

$$
X=\left(\begin{array}{cc}
e^{-2 t} & 3 e^{6 t} \\
-e^{-2 t} & 5 e^{6 t}
\end{array}\right)\binom{c_{1}}{c_{2}}
$$

$$
\text { Or } \quad X=\phi(t) C, \quad \mathrm{C}=\left(\begin{array}{ll}
c_{1} & c_{2}
\end{array}\right)^{t r}
$$

- Since $X=\phi(t) C$ is a solution of the system $X^{\prime}=A(t) X$. Therefore

$$
\phi^{\prime}(t) C=A(t) \phi(t) C
$$

Or

$$
\left[\phi^{\prime}(t)-A(t) \phi(t)\right] C=0
$$

Since the last equation is to hold for every $t$ in the interval $I$ for every possible column matrix of constants $C$, we must have

Or

$$
\phi^{\prime}(t)-A(t) \phi(t)=0
$$

$$
\text { Or } \quad \phi^{\prime}(t)=A(t) \phi(t)
$$

## Note that

- The fundamental matrix $\phi(t)$ of a homogenous system $X^{\prime}=A(t) X$ is nonsingular because the determinant $\operatorname{det}(\phi(t))$ coincides with the Wronskian of the solution vectors of the system and linear independence of the solution vectors guarantees that $\operatorname{det}(\phi(t)) \neq 0$.
a Let $\phi(t)$ be a fundamental matrix of the homogenous system $X^{\prime}=A(t) X$ on an interval $I$. Then, in view of the above mentioned observation, the inverse of the matrix $\phi^{-1}(t)$ exists for every value of $t$ in the interval $I$.


## Exercise

The given vectors are the solutions of a system $X^{\prime}=A X$. Determine whether the vectors form a fundamental set on $(-\infty, \infty)$.

1. $X_{1}=\binom{1}{-1} e^{t}, X_{2}=\binom{2}{6} e^{t}+\binom{8}{-8} t e^{t}$
2. $X_{1}=\left(\begin{array}{c}1 \\ 6 \\ -13\end{array}\right), X_{2}=\left(\begin{array}{c}1 \\ -2 \\ -1\end{array}\right) e^{-4 t}, X_{3}=\left(\begin{array}{c}2 \\ 3 \\ -2\end{array}\right) e^{3 t}$

5. $\quad X^{\prime}=\left(\begin{array}{cc}2 & 1 \\ 1 & -1\end{array}\right) X+\binom{-5}{2} ; \quad X_{p}=\binom{1}{3}$

2 \\
1 \\
1
\end{array}\right) e^{3 t}
$$

## Lecture 42

Homogeneous Linear Systems
Most of the theory developed for a single linear differential equation can be extended to a system of such differential equations. The extension is not entirely obvious. However, using the notation and some ideas of matrix algebra discussed in a previous lecture most effectively carry it out. Therefore, in the present and in the next lecture we will learn to solve the homogeneous linear systems of linear differential equations with real constant coefficients.

## Example 1

Consider the homogeneous system of differential equations

$$
\begin{aligned}
& \frac{d x}{d t}=x+3 y \\
& \frac{d y}{d t}=5 x+3 y
\end{aligned}
$$

In matrix form the system can be written as

$$
\binom{d x / d t}{d y / d t}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right)\binom{x}{y}
$$

If we suppose that

$$
X=\binom{x}{y}
$$

Then the system can again be re-written as

$$
X^{\prime}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right) X
$$

Now suppose that $X_{1}$ and $X_{2}$ denote the vectors

$$
X_{1}=\binom{e^{-2 t}}{-e^{-2 t}}, \quad X_{2}=\binom{3 e^{6 t}}{5 e^{6 t}}
$$

Then

$$
X_{1}^{\prime}=\binom{-2 e^{-2 t}}{2 e^{-2 t}}, \quad X_{2}^{\prime}=\binom{18 e^{6 t}}{30 e^{6 t}}
$$

Now

$$
A X_{1}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right)\binom{e^{-2 t}}{-e^{-2 t}}=\binom{e^{-2 t}-3 e^{-2 t}}{5 e^{-2 t}-3 e^{-2 t}}
$$

or $\quad A X_{1}=\binom{-2 e^{-2 t}}{2 e^{-2 t}}=X_{1}^{\prime}$

Similarly

$$
\begin{aligned}
& A X_{2}=\left(\begin{array}{ll}
1 & 3 \\
5 & 3
\end{array}\right)\binom{3 e^{6 t}}{5 e^{6 t}}=\binom{3 e^{6 t}+15 e^{6 t}}{15 e^{6 t}+15 e^{6 t}} \\
& \text { or } \quad A X_{2}=\binom{18 e^{6 t}}{30 e^{6 t}}=X_{2}^{\prime}
\end{aligned}
$$

Hence, $X_{1}$ and $X_{2}$ are solutions of the homogeneous system of differential equations $X^{\prime}=A X$. Further

$$
W\left(X_{1}, X_{2}\right)=\left|\begin{array}{cc}
e^{-2 t} & 3 e^{6 t} \\
-e^{-2 t} & 5 e^{6 t}
\end{array}\right|=8 e^{4 t} \neq o, \forall t \in R
$$

Thus, the solutions vectors $X_{1}$ and $X_{2}$ are linearly independent. Hence, these vectors form a fundamental set of solutions on $(-\infty, \infty)$. Therefore, the general solution of the system on $(-\infty, \infty)$ is

$$
\begin{aligned}
& X=c_{1} X_{1}+c_{2} X_{2} \\
& X=c_{1}\binom{1}{-1} e^{-2 t}+c_{2}\binom{3}{5} e^{6 t}
\end{aligned}
$$

## Note that

- Each of the solution vectors $X_{1}$ and $X_{2}$ are of the form

$$
X=\binom{k_{1}}{k_{2}} e^{\lambda t}
$$

Where $k_{1}$ and $k_{2}$ are constants.

- The question arises whether we can always find a solution of the homogeneous system $X^{\prime}=A X, A$ is $n \times n$ matrix of constants, of the form

$$
X=\left(\begin{array}{c}
k_{1} \\
k_{2} \\
\vdots \\
k_{n}
\end{array}\right) e^{\lambda t}=K e^{\lambda t}
$$

for the homogenous linear $1^{\text {st }}$ order system.

## Eigenvalues and Eigenvectors

Suppose that

$$
X=\left(\begin{array}{c}
k_{1} \\
k_{2} \\
\vdots \\
k_{n}
\end{array}\right) e^{\lambda t}=K e^{\lambda t}
$$

is a solution of the system

$$
\frac{d X}{d t}=A X
$$

where $A$ is an $n \times n$ matrix of constants then

$$
\frac{d X}{d t}=K \lambda e^{\lambda t}
$$

Substituting this last equation in the homogeneous system $X^{\prime}=A X$, we have

$$
K \lambda e^{\lambda t}=A K e^{\lambda t} \Rightarrow A K=\lambda K
$$

or

$$
(A-\lambda I) K=0
$$

This represents a system of linear algebraic equations. The linear $1^{\text {st }}$ order homogenous system of differential equations

$$
\frac{d X}{d t}=A X
$$

has a non-trivial solution $X$ if there exist a non-trivial solution $K$ of the system of algebraic equations

$$
\operatorname{det}(A-\lambda I)=0
$$

This equation is called characteristic equation of the matrix $A$ and represents an $n t h$ degree polynomial in $\lambda$.

## Case 1 Distinct real eigenvalues

Suppose that the coefficient matrix $A$ in the homogeneous system of differential equations

$$
\frac{d X}{d t}=A X
$$

has $n$ distinct eigenvalues $\lambda_{1}, \lambda_{2}, \lambda_{3}, \ldots, \lambda_{n}$ and $K_{1}, K_{2}, \ldots, K_{n}$ be the corresponding eigenvectors. Then the general solution of the system on $(-\infty, \infty)$ is given by

$$
X=c_{1} k_{1} e^{\lambda_{1} t}+c_{2} k_{2} e^{\lambda_{2} t}+c_{3} k_{3} e^{\lambda_{3} t}+\ldots \ldots+c_{n} k_{n} e^{\lambda_{n} t}
$$

## Example 2

Solve the following homogeneous system of differential equations

$$
\begin{aligned}
& \frac{d x}{d t}=2 x+3 y \\
& \frac{d y}{d t}=2 x+y
\end{aligned}
$$

## Solution

The given system can be written in the matrix form as

$$
\binom{\frac{d x}{d t}}{\frac{d y}{d t}}=\left(\begin{array}{ll}
2 & 3 \\
2 & 1
\end{array}\right)\binom{x}{y}
$$

Therefore, the coefficient matrix

$$
A=\left(\begin{array}{ll}
2 & 3 \\
2 & 1
\end{array}\right)
$$

Now we find the eigenvalues and eigenvectors of the coefficient $A$. The characteristics equation is

$$
\begin{aligned}
& \operatorname{det}(A-\lambda I)=\left|\begin{array}{cc}
2-\lambda & 3 \\
2 & 1-\lambda
\end{array}\right| \\
& \operatorname{det}(A-\lambda I)=\lambda^{2}-3 \lambda-4
\end{aligned}
$$

Therefore, the characteristic equation is
or

$$
\begin{aligned}
& \operatorname{det}(A-\lambda I)=0=\lambda^{2}-3 \lambda-4 \\
& (\lambda+1)(\lambda-4)=0 \Rightarrow \lambda=-1,4
\end{aligned}
$$

Therefore, roots of the characteristic equation are real and distinct and so are the eigenvalues.

For $\lambda=-1$, we have
or

$$
\begin{aligned}
& (A-\lambda I) K=\left(\begin{array}{cc}
2+1 & 3 \\
2 & 1+1
\end{array}\right)\binom{k_{1}}{k_{2}} \\
& (A-\lambda I) K=\binom{3 k_{1}+3 k_{2}}{2 k_{1}+2 k_{2}} \\
& (A-\lambda I) K=0 \Rightarrow\left\{\begin{array}{l}
3 k_{1}+3 k_{2}=0 \\
2 k_{1}+2 k_{2}=0
\end{array}\right.
\end{aligned}
$$

These two equations are no different and represent the equation

$$
k_{1}+k_{2}=0 \Rightarrow k_{1}=-k_{2}
$$

Thus we can choose value of the constant $k_{2}$ arbitrarily. If we choose $k_{2}=-1$ then $k_{1}=1$. Hence the corresponding eigenvector is

$$
K_{1}=\binom{1}{-1}
$$

For $\lambda=4$ we have
or

$$
(A-\lambda I) K=\left(\begin{array}{cc}
2-4 & 3 \\
2 & 1-4
\end{array}\right)\binom{k_{1}}{k_{2}}
$$

Hence

$$
(A-\lambda I) K=0 \Rightarrow\left\{\begin{array}{l}
-2 k_{1}+3 k_{2}=0 \\
2 k_{1}-3 k_{2}=0
\end{array}\right.
$$

Again the above two equations are not different and represent the equation

$$
2 k_{1}-3 k_{2}=0 \Rightarrow k_{1}=\frac{3 k_{2}}{2}
$$

Again, the constant $k_{2}$ can be chosen arbitrarily. Let us choose $k_{2}=2$ then $k_{1}=3$. Thus the corresponding eigenvector is

$$
K_{2}=\binom{3}{2}
$$

Therefore, we obtain two linearly independent solution vectors of the given homogeneous system.

$$
X_{1}=\binom{1}{-1} e^{-t}, \quad X_{2}=\binom{3}{2} e^{4 t}
$$

Hence the general solution of the system is the following

$$
X=c_{1} X_{1}+c_{2} X_{2}
$$

or

$$
\begin{array}{ll}
\text { or } & X=c_{1}\binom{1}{-1} e^{-t}+c_{2}\binom{3}{2} e^{4 t} \\
\text { or } & \binom{x(t)}{y(t)}=\binom{c_{1} e^{-t}+3 c_{2} e^{4 t}}{-c_{1} e^{-t}+2 c_{2} e^{4 t}}
\end{array}
$$

This means that the solution of the system is

$$
\begin{aligned}
& x(t)=c_{1} e^{-t}+3 c_{2} e^{4 t} \\
& y(t)=-c_{1} e^{-t}+2 c_{2} e^{4 t}
\end{aligned}
$$

## Example 3

Solve the homogeneous system

$$
\begin{aligned}
& \frac{d x}{d t}=-4 x+y+z \\
& \frac{d y}{d t}=x+5 y-z \\
& \frac{d z}{d t}=y-3 z
\end{aligned}
$$

## Solution:

The given system can be written as

$$
\left(\begin{array}{l}
d x / d t \\
d y / d t \\
d z / d t
\end{array}\right)=\left(\begin{array}{ccc}
-4 & 1 & 1 \\
1 & 5 & -1 \\
0 & 1 & -3
\end{array}\right)\left(\begin{array}{l}
x \\
y \\
z
\end{array}\right)
$$

Therefore the coefficient matrix of the system of differential equations is

Therefore

$$
\begin{gathered}
A=\left(\begin{array}{ccc}
-4 & 1 & 1 \\
1 & 5 & -1 \\
0 & 1 & -3
\end{array}\right) \\
A-\lambda I=\left(\begin{array}{ccc}
-4-\lambda & 1 & 1 \\
1 & 5-\lambda & -1 \\
0 & 1 & -3-\lambda
\end{array}\right)
\end{gathered}
$$

Thus the characteristic equation is

$$
\operatorname{det}(A-\lambda I)=\left|\begin{array}{ccc}
-4-\lambda & 1 & 1 \\
1 & 5-\lambda & -1 \\
0 & 1 & -3-\lambda
\end{array}\right|=0
$$

Expanding the determinant using cofactors of third row, we obtain

$$
\begin{aligned}
& -(\lambda+3)(\lambda+4)(\lambda-5)=0 \\
& \lambda=-3,-4,5
\end{aligned}
$$

Thus the characteristic equation has real and distinct roots and so are the eigenvalues of the coefficient matrix $A$. To find the eigenvectors corresponding to these computed eigenvalues, we need to solve the following system of linear algebraic equations for $k_{1}, k_{2}$ and $k_{3}$ when $\lambda=-3,-4,5$, successively.

$$
\operatorname{det}(A-\lambda I) K=0 \Rightarrow\left(\begin{array}{ccc}
-4-\lambda & 1 & 1 \\
1 & 5-\lambda & -1 \\
0 & 1 & -3-\lambda
\end{array}\right)\left(\begin{array}{l}
k_{1} \\
k_{2} \\
k_{3}
\end{array}\right)=\left(\begin{array}{l}
0 \\
0 \\
0
\end{array}\right)
$$

For solving this system we use Gauss-Jordon elimination technique, which consists of reducing the augmented matrix to the reduced echelon form by applying the elementary row operations. The augmented matrix of the system of linear algebraic equations is

$$
\left(\begin{array}{cccc}
-4-\lambda & 1 & 1 & 0 \\
1 & 5-\lambda & -1 & 0 \\
0 & 1 & -3-\lambda & 0
\end{array}\right)
$$

For $\lambda=-3$, the augmented matrix becomes:

$$
\left(\begin{array}{ccrc}
-1 & 1 & 1 & 0 \\
1 & 8 & -1 & 0 \\
0 & 1 & 0 & 0
\end{array}\right)
$$

Appling the row operation $R_{12}, R_{2}+R_{1}, R_{23}, R_{3}-9 R_{2}, R_{1}-8 R_{2}$ in succession reduces the augmented matrix in the reduced echelon form.

$$
\left(\begin{array}{cccc}
1 & 0 & -1 & 0 \\
0 & 1 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

So that we have the following equivalent system

$$
\left(\begin{array}{ccc}
1 & 0 & -1 \\
0 & 1 & 0 \\
0 & 0 & 0
\end{array}\right)\left(\begin{array}{l}
k_{1} \\
k_{2} \\
k_{3}
\end{array}\right)=\left(\begin{array}{l}
0 \\
0 \\
0
\end{array}\right)
$$

or

$$
k_{1}=k_{3}, k_{2}=0
$$

Therefore, the constant $k_{3}$ can be chosen arbitrarily. If we choose $k_{3}=1$, then $k_{1}=1$, So that the corresponding eigenvector is

$$
K_{1}=\left(\begin{array}{l}
1 \\
0 \\
1
\end{array}\right)
$$

For $\lambda_{2}=-4$, the augmented matrix becomes

$$
((A+4 I) \mid 0)=\left(\begin{array}{cccc}
0 & 1 & 1 & 0 \\
1 & 9 & -1 & 0 \\
0 & 1 & 1 & 0
\end{array}\right)
$$

We apply elementary row operations to transform the matrix to the following reduced echelon form:

$$
\left(\begin{array}{cccc}
1 & 0 & -10 & 0 \\
0 & 1 & 1 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

Thus

$$
k_{1}=10 k_{3}, k_{2}=-k_{3}
$$

Again $k_{3}$ can be chosen arbitrarily, therefore choosing $k_{3}=1$ we get $k_{1}=10, k_{2}=-1$ Hence, the second eigenvector is

$$
K_{2}=\left(\begin{array}{c}
10 \\
-1 \\
1
\end{array}\right)
$$

Finally, when $\lambda_{3}=5$ the augmented matrix becomes

$$
((\mathrm{A}-5 \mathrm{I}) \mid 0)=\left(\begin{array}{cccc}
-9 & 1 & 1 & 0 \\
1 & 0 & -1 & 0 \\
0 & 1 & -8 & 0
\end{array}\right)
$$

The application of the elementary row operation transforms the augmented matrix to the reduced echelon form

Thus

$$
\left(\begin{array}{cccc}
1 & 0 & -1 & 0 \\
0 & 1 & -8 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

$$
k_{1}=k_{3}, \quad k_{2}=8 k_{3}
$$

If we choose $k_{3}=1$, then $k_{1}=1$ and $k_{2}=8$. Thus the eigenvector corresponding to $\lambda_{3}=5$ is

$$
K_{3}=\left(\begin{array}{l}
1 \\
8 \\
1
\end{array}\right)
$$

Thus we obtain three linearly independent solution vectors

$$
X_{1}=\left(\begin{array}{l}
1 \\
0 \\
1
\end{array}\right) e^{-3 t}, X_{2}=\left(\begin{array}{c}
10 \\
-1 \\
1
\end{array}\right) e^{-4 t}, X_{3}=\left(\begin{array}{l}
1 \\
8 \\
1
\end{array}\right) e^{5 t}
$$

Hence, the general solution of the given homogeneous system is

$$
X=c_{1}\left(\begin{array}{l}
1 \\
0 \\
1
\end{array}\right) e^{-3 t}+c_{2}\left(\begin{array}{c}
10 \\
-1 \\
1
\end{array}\right) e^{-4 t}+c_{3}\left(\begin{array}{l}
1 \\
8 \\
1
\end{array}\right) e^{5 t}
$$

## Case 2 Complex eigenvalues

Suppose that the coefficient matrix $A$ in the homogeneous system of differential equations

$$
\frac{d X}{d t}=A X
$$

has complex eigenvalues. This means that roots of the characteristic equation

$$
\operatorname{det}(A-\lambda I)=0
$$

are imaginary.

## Theorem: Solutions corresponding to complex eigenvalues

Suppose that $K$ is an eigenvector corresponding to the complex eigenvalue

$$
\lambda_{1}=\alpha+i \beta ; \quad \alpha, \beta \in R
$$

of the coefficient matrix A with real entries, then the vectors $X_{1}$ and $X_{2}$ given by

$$
X_{1}=K_{1} e^{\lambda_{1} t}, \quad X_{2}=\bar{K}_{1} e^{\bar{\lambda}_{1} t}
$$

are solution of the homogeneous system.

$$
\frac{d X}{d t}=A X
$$

## Example 4

Consider the following homogeneous system of differential equations

$$
\begin{aligned}
& \frac{d x}{d t}=6 x-y \\
& \frac{d y}{d t}=5 x+4 y
\end{aligned}
$$

The system can be written as
or

$$
\binom{d x / d t}{d y / d t}=\left(\begin{array}{cc}
6 & -1 \\
5 & 4
\end{array}\right)\binom{x}{y}
$$

Therefore the coefficient matrix of the system is

$$
A=\left(\begin{array}{cc}
6 & -1 \\
5 & 4
\end{array}\right)
$$

So that the characteristic equation is
or

$$
\begin{aligned}
& \operatorname{det}(A-\lambda I)=\left|\begin{array}{cc}
6-\lambda & -1 \\
5 & 4-\lambda
\end{array}\right|=0 \\
& (6-\lambda)(4-\lambda)+5=0=\lambda^{2}-10 \lambda+29
\end{aligned}
$$

Now using the quadratic formula we have

$$
\lambda_{1}=5+2 i, \quad \lambda_{2}=5-2 i
$$

For, $\lambda_{1}=5+2 i$, we must solve the system of linear algebraic equations

$$
\left.\begin{array}{l}
(1-2 i) k_{1}-k_{2}=0 \\
5 k_{1}-(1+2 i) k_{2}=0
\end{array}\right\} \Rightarrow(1-2 i) k_{1}-k_{2}=0
$$

or

$$
k_{2}=(1-2 i) k_{1}
$$

Therefore, it follows that after we choose $k_{1}=1$ then $k_{2}=1-2 i$. So that one eigenvector is given by

$$
K_{1}=\binom{1}{1-2 i}
$$

Similarly for $\lambda_{2}=5-2 i$ we must solve the system of linear algebraic equations

$$
\left.\begin{array}{l}
(1+2 i) k_{1}-k_{2}=0 \\
5 k_{1}-(1-2 i) k_{2}=0
\end{array}\right\} \Rightarrow(1+2 i) k_{1}-k_{2}=0
$$

or

$$
k_{2}=(1+2 i) k_{1}
$$

Therefore, it follows that after we choose $k_{1}=1$ then $k_{2}=1+2 i$. So that second eigenvector is given by

$$
K_{2}=\binom{1}{1+2 i}
$$

Consequently, two solution of the homogeneous system are

$$
X_{1}=\binom{1}{1-2 i} e^{(5+2 i) t}, X_{2}=\binom{1}{1+2 i} e^{(5-2 i) t}
$$

By the superposition principle another solution of the system is

$$
X=c_{1}\binom{1}{1-2 i} e^{(5+2 i) t}+c_{2}\binom{1}{1+2 i} e^{(5-2 i) t}
$$

## Note that

The entries in $K_{2}$ corresponding to $\lambda_{2}$ are the conjugates of the entries in $K_{1}$ corresponding to $\lambda_{1}$. Further, $\lambda_{2}$ is conjugate of $\lambda_{1}$. Therefore, we can write this as

$$
\lambda_{2}=\bar{\lambda}_{1}, \quad K_{2}=\bar{K}_{1}
$$

Theorem Real solutions corresponding to a complex eigenvalue

Suppose that

- $\quad \lambda_{1}=\alpha+i \beta$ is a complex eigenvalue of the matrix $A$ in the system

$$
\frac{d X}{d t}=A X
$$

- $K_{1}$ is an eigenvector corresponding to the eigen value $\lambda_{1}$

$$
\quad B_{1}=\frac{1}{2}\left(K_{1}+\bar{K}_{1}\right)=\operatorname{Re}\left(K_{1}\right), B_{2}=\frac{i}{2}\left(-K_{1}+\bar{K}_{1}\right)=\operatorname{Im}\left(K_{1}\right)
$$

Then two linearly independent solutions of the system on $(-\infty, \infty)$ are given by

$$
\begin{aligned}
& X_{1}=\left(B_{1} \cos \beta t-B_{2} \sin \beta t\right) e^{\alpha t} \\
& X_{2}=\left(B_{2} \cos \beta t+B_{1} \sin \beta t\right) e^{\alpha t}
\end{aligned}
$$

## Example 5

Solve the system

$$
X^{\prime}=\left(\begin{array}{cc}
2 & 8 \\
-1 & -2
\end{array}\right) X
$$

The coefficient matrix of the system is

$$
A=\left(\begin{array}{cc}
2 & 8 \\
-1 & -2
\end{array}\right)
$$

Therefore

$$
A-\lambda I=\left(\begin{array}{cc}
2-\lambda & 8 \\
-1 & -2-\lambda
\end{array}\right)
$$

Thus, the characteristic equation is

$$
\begin{aligned}
& \operatorname{det}(A-\lambda I)=0=\left|\begin{array}{cc}
2-\lambda & 8 \\
-1 & -2-\lambda
\end{array}\right| \\
& -(2-\lambda)(2+\lambda)+8=0=\lambda^{2}+4
\end{aligned}
$$

Thus the Eigenvalues are of the coefficient matrix are $\lambda_{1}=2 i$ and $\lambda_{2}=\bar{\lambda}_{1}=-2 i$.
For $\lambda_{1}$ we see that the system of linear algebraic equations $(A-\lambda I) K=0$

$$
\begin{aligned}
(2-2 i) k_{1}+8 k_{2} & =0 \\
-k_{1}-(2+2 i) k_{2} & =0
\end{aligned}
$$

Solving these equations, we obtain

$$
k_{1}=-(2+2 i) k_{2}
$$

Choosing $k_{2}=-1$ gives $k_{1}=(2+2 i) k_{2}$. Thus the corresponding eigenvector is

$$
K_{1}=\binom{2+2 i}{-1}=\binom{2}{-1}+i\binom{2}{0}
$$

So that

$$
B_{1}=\operatorname{Re}\left(K_{1}\right)=\binom{2}{-1}, B_{2}=\operatorname{Im}\left(K_{1}\right)=\binom{2}{0}
$$

Since $\alpha=0$, the general solution of the given system of differential equations is

$$
\begin{aligned}
& X=c_{1}\left[\binom{2}{-1} \cos 2 t-\binom{2}{0} \sin 2 t\right]+c_{2}\left[\binom{2}{0} \cos 2 t+\binom{2}{-1} \sin 2 t\right] \\
& X=c_{1}\binom{2 \cos 2 t-2 \sin 2 t}{-\cos 2 t}+c_{2}\binom{2 \cos 2 t+2 \sin 2 t}{-\sin 2 t}
\end{aligned}
$$

## Example 6

Solve the following system of differential equations

$$
X^{\prime}=\left(\begin{array}{cc}
1 & 2 \\
-1 / 2 & 1
\end{array}\right) X
$$

## Solution:

The coefficient matrix of the given system is

Thus

$$
\begin{aligned}
& A=\left(\begin{array}{cc}
1 & 2 \\
-1 / 2 & 1
\end{array}\right) \\
& A-\lambda I=\left(\begin{array}{cc}
1-\lambda & 2 \\
-1 / 2 & 1-\lambda
\end{array}\right)
\end{aligned}
$$

So that the characteristic equation is
or $\quad \lambda^{2}-2 \lambda+2=0$
Therefore, by the quadratic formula we obtain

$$
\lambda=(2 \pm \sqrt{4-8}) / 2
$$

Thus the eigenvalues of the coefficient matrix are

$$
\lambda_{1}=1+i, \quad \lambda_{2}=\bar{\lambda}_{1}=1-i
$$

Now an eigenvector associated with the eigenvalue $\lambda_{1}$ is

From

$$
\begin{aligned}
& K_{1}=\binom{2}{i}=\binom{2}{0}+i\binom{0}{1} \\
& B_{1}=\binom{2}{0}, \quad B_{2}=\binom{0}{1}
\end{aligned}
$$

So that we have the following two linearly independent solutions of the system

$$
X_{1}=\left[\binom{2}{0} \cos t-\binom{0}{1} \sin t\right] e^{t}, \quad X_{2}=\left[\binom{0}{1} \cos t+\binom{2}{0} \sin t\right] e^{t}
$$

Hence, the general solution of the system is

$$
X=c_{1}\left[\binom{2}{0} \cos t-\binom{0}{1} \sin t\right] e^{t}+c_{2}\left[\binom{0}{1} \cos t+\binom{2}{0} \sin t\right] e^{t}
$$

or

$$
X=c_{1}\binom{2 \cos t}{-\sin t} e^{t}+c_{2}\binom{2 \sin t}{\cos t} e^{t}
$$

## Lecture 43

## Real and Repeated Eigenvalues

In the previous lecture we tried to learn how to solve a system of linear differential equations having a coefficient matrix that has real distinct and complex eigenvalues. In this lecture, we consider the systems

$$
X^{\prime}=A X
$$

in which some of the $n$ eigenvalue $\lambda_{1}, \lambda_{2}, \lambda_{3}, \ldots, \lambda_{n}$ of the $n \times n$ coefficient matrix $A$ are repeated.

## Eigenvalue of multiplicity $m$

Suppose that $m$ is a positive integer and $\left(\lambda-\lambda_{1}\right)^{m}$ is a factor of the characteristic equation

$$
\operatorname{det}(A-\lambda I)=0
$$

Further, suppose that $\left(\lambda-\lambda_{1}\right)^{m+1}$ is not a factor of the characteristic equation. Then the number $\lambda_{1}$ is said to be an eigenvalue of the coefficient matrix of multiplicity $m$.

## Method of solution:

Consider the following system of $n$ linear differential equations in $n$ unknowns

$$
X^{\prime}=A X
$$

Suppose that the coefficient matrix has an eigenvalue of multiplicity of $m$. There are two possibilities of the existence of the eigenvectors corresponding to this repeated eigenvalue:

- For the $n \times n$ coefficient matrix $A$, it may be possible to find $m$ linearly independent eigenvectors $K_{1}, K_{2}, \ldots, K_{m}$ corresponding to the eigenvalue $\lambda_{1}$ of multiplicity $m \leq n$. In this case the general solution of the system contains the linear combination

$$
c_{1} K_{1} e^{\lambda_{1} t}+c_{2} K_{2} e^{\lambda_{1} t}+\cdots+c_{n} K_{n} e^{\lambda_{1} t}
$$

- If there is only one eigenvector corresponding to the eigenvalue $\lambda_{1}$ of multiplicity $m$, then $m$ linearly independent solutions of the form

$$
\begin{aligned}
& X_{1}=K_{11} e^{\lambda_{1} t} \\
& X_{2}=K_{21} e^{\lambda_{1} t}+K_{22} e^{\lambda_{1} t} \\
& \vdots \\
& X_{m}=K_{m 1} \frac{t^{m-1}}{(m-1)!} e^{\lambda_{1} t}+K_{m 2} \frac{t^{m-2}}{(m-2)!} e^{\lambda_{1} t}+\cdots+K_{m m} e^{\lambda_{1} t}
\end{aligned}
$$

where the column vectors $K_{i j}$ can always be found.

## Eigenvalue of Multiplicity Two

We begin by considering the systems of differential equations $X^{\prime}=A X$ in which the coefficient matrix $A$ has an eigenvalue $\lambda_{1}$ of multiplicity two. Then there are two possibilities;

- Whether we can find two linearly independent eigenvectors corresponding to eigenvalue $\lambda_{1}$ or
- We cannot find two linearly independent eigenvectors corresponding to eigenvalue
$\lambda_{1}$

The case of the possibility of us being able to find two linearly independent eigenvectors $K_{1}, K_{2}$ corresponding to the eigenvalue $\lambda_{1}$ is clear. In this case the general solution of the system contains the linear combination

$$
c_{1} K_{1} t e^{\lambda_{1} t}+c_{2} K_{2} e^{\lambda_{1} t}
$$

Therefore, we suppose that there is only one eigenvector $K_{1}$ associated with this eigenvalue and hence only one solution vector $X_{1}$. Then, a second solution can be found of the following form:

$$
X_{2}=K t e^{\lambda_{1} t}+P e^{\lambda_{1} t}
$$

In this expression for a second solution, $K$ and $P$ are column vectors

$$
K=\left(\begin{array}{c}
k_{1} \\
k_{2} \\
\vdots \\
k_{n}
\end{array}\right), \quad P=\left(\begin{array}{c}
p_{1} \\
p_{2} \\
\vdots \\
p_{n}
\end{array}\right)
$$

We substitute the expression for $X_{2}$ into the system $X^{\prime}=A X$ and simplify to obtain

$$
\left(A K-\lambda_{1} K\right) t e^{\lambda_{1} t}+\left(A P-\lambda_{1} P-K\right) e^{\lambda_{1} t}=0
$$

Since this last equation is to hold for all values of $t$, we must have:

$$
\left(A-\lambda_{1} I\right) K=0, \quad\left(A-\lambda_{1} I\right) P=K
$$

First equation does not tell anything new and simply states that $K$ must be an eigenvector of the coefficient matrix $A$ associated with the eigenvalue $\lambda_{1}$. Therefore, by solving this equation we find one solution

$$
X_{1}=K e^{\lambda_{1} t}
$$

To find the second solution $X_{2}$, we only need to solve, for the vector $P$, the additional system

$$
\left(A-\lambda_{1} I\right) P=K
$$

First we solve a homogeneous system of differential equations having coefficient matrix for which we can find two distinct eigenvectors corresponding to a double eigenvalue and then in the second example we consider the case when cannot find two eigenvectors.

## Example 1

Find general solution of the following system of linear differential equations

$$
X^{\prime}=\left(\begin{array}{cc}
3 & -18 \\
2 & -9
\end{array}\right) X
$$

## Solution:

The coefficient matrix of the system is

Thus

$$
\begin{aligned}
& A=\left(\begin{array}{ll}
3 & -18 \\
2 & -9
\end{array}\right) \\
& \operatorname{det}(A-\lambda I)=\left|\begin{array}{cc}
3-\lambda & -18 \\
2 & -9-\lambda
\end{array}\right|
\end{aligned}
$$

Therefore, the characteristic equation of the coefficient matrix $A$ is
or

$$
\operatorname{det}(A-\lambda I)=0=\left|\begin{array}{cc}
3-\lambda & -18 \\
2 & -9-\lambda
\end{array}\right|
$$

$$
-(3-\lambda)(9+\lambda)+36=0
$$

or

$$
(\lambda+3)^{2}=0 \Rightarrow \lambda=-3,-3
$$

Therefore, the coefficient matrix $A$ of the given system has an eigenvalue of multiplicity two. This means that

$$
\lambda_{1}=\lambda_{2}=-3
$$

Now $\quad(A-\lambda I) K=0 \Rightarrow\left(\begin{array}{cc}3-\lambda & -18 \\ 2 & -9-\lambda\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0}$
For $\lambda=-3$, this system of linear algebraic equations becomes

$$
\left(\begin{array}{ll}
6 & -18 \\
2 & -6
\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0} \Rightarrow\left\{\begin{array}{l}
6 k_{1}-18 k_{2}=0 \\
2 k_{1}-6 k_{2}=0
\end{array}\right.
$$

However

$$
\left.\begin{array}{l}
6 k_{1}-18 k_{2}=0 \\
2 k_{1}-6 k_{2}=0
\end{array}\right\} \Rightarrow k_{1}-3 k_{2}=0
$$

Thus

$$
k_{1}=3 k_{2}
$$

This means that the value of the constant $k_{2}$ can be chosen arbitrarily. If we choose $k_{2}=1$, we find the following single eigenvector for the eigenvalue $\lambda=-3$.

$$
K=\binom{3}{1}
$$

The corresponding one solution of the system of differential equations is given by

$$
X_{1}=\binom{3}{1} e^{-3 t}
$$

But since we are interested in forming the general solution of the system, we need to pursue the question of finding a second solution. We identify the column vectors $K$ and $P$ as:

Then

$$
\begin{gathered}
K=\binom{3}{1}, P=\binom{p_{1}}{p_{2}} \\
(A+3 I) P=K \Rightarrow\left(\begin{array}{cc}
6 & -18 \\
2 & -6
\end{array}\right)\binom{p_{1}}{p_{2}}=\binom{3}{1}
\end{gathered}
$$

Therefore, we need to solve the following system of linear algebraic equations to find $P$

$$
\left.\begin{array}{r}
6 p_{1}-18 p_{2}=3 \\
2 p_{1}-6 p_{2}=1
\end{array}\right\} \Rightarrow 2 p_{1}-6 p_{2}=1
$$

or

$$
p_{2}=-\left(1-2 p_{1}\right) / 6
$$

Therefore, the number $p_{1}$ can be chosen arbitrarily. So we have an infinite number of choices for $p_{1}$ and $p_{2}$. However, if we choose $p_{1}=1$, we find $p_{2}=1 / 6$. Similarly, if we choose the value of $p_{1}=1 / 2$ then $p_{2}=0$. Hence the column vector $P$ is given by

$$
P=\binom{\frac{1}{2}}{0}
$$

Consequently, the second solution is given by

$$
X_{2}=\binom{3}{1} t e^{-3 t}+\binom{\frac{1}{2}}{0} e^{-3 t}
$$

Hence the general solution of the given system of linear differential equations is then

$$
\begin{aligned}
& X=c_{1} X_{1}+c_{2} X_{2} \\
& X=c_{1}\binom{3}{1} e^{-3 t}+c_{2}\left[\binom{3}{1} t e^{-3 t}+\binom{\frac{1}{2}}{0} e^{-3 t}\right]
\end{aligned}
$$

## Example 2

Solve the homogeneous system

$$
X^{\prime}=\left(\begin{array}{ccc}
1 & -2 & 2 \\
-2 & 1 & -2 \\
2 & -2 & 1
\end{array}\right) X
$$

## Solution:

The coefficient matrix of the system is:

$$
A=\left(\begin{array}{ccc}
1 & -2 & 2 \\
-2 & 1 & -2 \\
2 & -2 & 1
\end{array}\right)
$$

To write the characteristic we find the expansion of the determinant:

$$
\operatorname{det}(A-\lambda I)=\left|\begin{array}{ccc}
1-\lambda & -2 & 2 \\
-2 & 1-\lambda & -2 \\
2 & -2 & 1-\lambda
\end{array}\right|
$$

The value of the determinant is

$$
\operatorname{det}(A-\lambda I)=5+9 \lambda+3 \lambda^{2}-\lambda^{3}
$$

Therefore, the characteristic equation is

$$
5+9 \lambda+3 \lambda^{2}-\lambda^{3}=0
$$

or

$$
-(\lambda+1)^{2}(\lambda-5)=0
$$

or $\quad \lambda=-1,-1,5$
Therefore, the eigenvalues of the coefficient matrix $A$ are

$$
\lambda_{1}=\lambda_{2}=-1, \quad \lambda_{3}=5
$$

Clearly -1 is a double root of the coefficient matrix $A$.

Now $\quad(A-\lambda I) K=0 \Rightarrow\left(\begin{array}{ccc}1-\lambda & -2 & 2 \\ -2 & 1-\lambda & -2 \\ 2 & -2 & 1-\lambda\end{array}\right)\left(\begin{array}{l}k_{1} \\ k_{2} \\ k_{3}\end{array}\right)=\left(\begin{array}{l}0 \\ 0 \\ 0\end{array}\right)$
For $\lambda_{1}=-1$, this system of the algebraic equations become

$$
\left(\begin{array}{ccc}
2 & -2 & 2 \\
-2 & 2 & -2 \\
2 & -2 & 2
\end{array}\right)\left(\begin{array}{l}
k_{1} \\
k_{2} \\
k_{3}
\end{array}\right)=\left(\begin{array}{l}
0 \\
0 \\
0
\end{array}\right)
$$

The augmented matrix of the system is

$$
(A+\mathrm{I} \mid 0)=\left(\begin{array}{ccc|c}
2 & -2 & 2 & 0 \\
-2 & 2 & -2 & 0 \\
2 & -2 & 2 & 0
\end{array}\right)
$$

By applying the Gauss-Jordon method, the augmented matrix reduces to the reduced echelon form

$$
\left(\begin{array}{ccc|c}
1 & -1 & 1 & 0 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

Thus

$$
k_{1}-k_{2}+k_{3}=0 \Rightarrow k_{1}=k_{2}-k_{3}
$$

By choosing $k_{2}=1$ and $k_{3}=0$ in $k_{1}=k_{2}-k_{3}$, we obtain $k_{1}=1$ and so one eigenvector is

$$
K_{1}=\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right)
$$

But the choice $k_{2}=1, k_{3}=1$ implies $k_{1}=0$. Hence, a second eigenvector is given by

$$
K_{2}=\left(\begin{array}{l}
0 \\
1 \\
1
\end{array}\right)
$$

Since neither eigenvector is a constant multiple of the other, we have found, corresponding to the same eigenvalue, two linearly independent solutions

$$
X_{1}=\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right) e^{-t}, \quad X_{2}=\left(\begin{array}{l}
0 \\
1 \\
1
\end{array}\right) e^{-t}
$$

Last for $\lambda_{3}=5$ we obtain the system of algebraic equations

$$
\left(\begin{array}{ccc}
-4 & -2 & 2 \\
-2 & -4 & -2 \\
2 & -2 & -4
\end{array}\right)\left(\begin{array}{l}
k_{1} \\
k_{2} \\
k_{3}
\end{array}\right)=\left(\begin{array}{l}
0 \\
0 \\
0
\end{array}\right)
$$

The augmented matrix of the algebraic system is

$$
(A-5 I \mid 0)=\left(\begin{array}{ccc|c}
-4 & -2 & 2 & 0 \\
-2 & -4 & -2 & 0 \\
2 & -2 & -4 & 0
\end{array}\right)
$$

By the elementary row operation we can transform the augmented matrix to the reduced echelon form
or

$$
\left(\begin{array}{ccc|c}
1 & 0 & -1 & 0 \\
0 & 1 & 1 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

$$
k_{1}=k_{3}, k_{2}=-k_{3}
$$

Picking $k_{3}=1$, we obtain $k_{1}=1, k_{2}=-1$. Thus a third eigenvector is the following

$$
K_{3}=\left(\begin{array}{l}
1 \\
-1 \\
1
\end{array}\right)
$$

Hence, we conclude that the general solution of the system is

$$
X=c_{1}\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right) e^{-t}+c_{2}\left(\begin{array}{l}
0 \\
1 \\
1
\end{array}\right) e^{-t}+c_{3}\left(\begin{array}{l}
1 \\
-1 \\
1
\end{array}\right) e^{5 t}
$$

## Eigenvalues of Multiplicity Three

When a matrix $A$ has only one eigenvector associated with an eigenvalue $\lambda_{1}$ of multiplicity three of the coefficient matrix $A$, we can find a second solution $X_{2}$ and a third solution $X_{3}$ of the following forms

$$
\begin{aligned}
& X_{2}=K t e^{\lambda_{1} t}+P e^{\lambda_{1} t} \\
& X_{3}=K \frac{t^{2}}{2} e^{\lambda_{1} t}+P t e^{\lambda_{1} t}+Q e^{\lambda_{1} t}
\end{aligned}
$$

The $K, P$ and $Q$ are vectors given by

$$
K=\left(\begin{array}{c}
k_{1} \\
k_{2} \\
\vdots \\
k_{n}
\end{array}\right), \quad P=\left(\begin{array}{c}
p_{1} \\
p_{2} \\
\vdots \\
p_{n}
\end{array}\right) \text { and } Q=\left(\begin{array}{c}
q_{1} \\
q_{2} \\
\vdots \\
q_{n}
\end{array}\right)
$$

By substituting $X_{3}$ into the system $X^{\prime}=A X$, we find the column vectors $K, P$ and $Q$ must satisfy the equations

$$
\begin{aligned}
& \left(A-\lambda_{1} I\right) K=0 \\
& \left(A-\lambda_{1} I\right) P=K \\
& \left(A-\lambda_{1} I\right) Q=P
\end{aligned}
$$

The solutions of first and second equations can be utilized in the formulation of the solution $X_{1}$ and $X_{2}$.

## Example

Find the general solution of the following homogeneous system

$$
X^{\prime}=\left(\begin{array}{lll}
4 & 1 & 0 \\
0 & 4 & 1 \\
0 & 0 & 4
\end{array}\right) X
$$

## Solution

The coefficient matrix of the system is

Then

$$
\begin{aligned}
& A=\left(\begin{array}{lll}
4 & 1 & 0 \\
0 & 4 & 1 \\
0 & 0 & 4
\end{array}\right) \\
& \operatorname{det}(A-\lambda I)=\left|\begin{array}{ccc}
4-\lambda & 1 & 0 \\
0 & 4-\lambda & 1 \\
0 & 0 & 4-\lambda
\end{array}\right|
\end{aligned}
$$

Therefore, the characteristic equation is

$$
\operatorname{det}(A-\lambda I)=0=\left|\begin{array}{ccc}
4-\lambda & 1 & 0 \\
0 & 4-\lambda & 1 \\
0 & 0 & 4-\lambda
\end{array}\right|
$$

Expanding the determinant in the last equation w.r.to the $3^{\text {rd }}$ row to obtain

$$
(-1)^{3+3}(4-\lambda)\left|\begin{array}{cc}
4-\lambda & 1 \\
0 & 4-\lambda
\end{array}\right|=0
$$

or

$$
(4-\lambda)[(4-\lambda)(4-\lambda)-0]=0
$$

or

$$
(4-\lambda)^{3}=0 \Rightarrow \lambda=4,4,4
$$

Thus, $\lambda=4$ is an eigenvalue of the coefficient matrix $A$ of multiplicity three. For $\lambda=4$, we solve the following system of algebraic equations

$$
(A-\lambda \mathrm{I}) K=0
$$

$$
\left(\begin{array}{ccc}
4-\lambda & 1 & 0 \\
0 & 4-\lambda & 1 \\
0 & 0 & 4-\lambda
\end{array}\right)\left(\begin{array}{l}
k_{1} \\
k_{2} \\
k_{3}
\end{array}\right)=\left(\begin{array}{l}
0 \\
0 \\
0
\end{array}\right)
$$

or $\quad\left(\begin{array}{ccc}0 & 1 & 0 \\ 0 & 0 & 1 \\ 0 & 0 & 0\end{array}\right)\left(\begin{array}{l}k_{1} \\ k_{2} \\ k_{3}\end{array}\right)=\left(\begin{array}{l}0 \\ 0 \\ 0\end{array}\right)$
or

$$
\left.\begin{array}{c}
0 k_{1}+1 k_{2}+0 k_{3}=0 \\
0 k_{1}+0 k_{2}+1 k_{3}=0 \\
0 k_{1}+0 k_{2}+0 k_{3}=0
\end{array}\right\} \Rightarrow \begin{aligned}
& k_{2}=0 \\
& k_{3}=0
\end{aligned}
$$

Therefore, the value of $k_{1}$ is arbitrary. If we choose $k_{1}=1$, then the eigen vector $K$ is

$$
K=\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right)
$$

Hence the first solution vector

$$
X_{1}=K e^{\lambda t}=\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right) e^{4 t}
$$

Now for the second solution we solve the system

$$
\begin{aligned}
& (A-\lambda I) P=K \\
& \text { or } \quad\left(\begin{array}{lll}
0 & 1 & 0 \\
0 & 0 & 1 \\
0 & 0 & 0
\end{array}\right)\left(\begin{array}{l}
p_{1} \\
p_{2} \\
p_{3}
\end{array}\right)=\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right)
\end{aligned}
$$

$$
\left.\begin{array}{c}
0 p_{1}+1 p_{2}+0 p_{3}=1 \\
0 p_{1}+0 p_{2}+1 p_{3}=0 \\
0 p_{1}+0 p_{2}+0 p_{3}=0
\end{array}\right\} \Rightarrow \begin{aligned}
& p_{1}=1 \\
& p_{2}=1 \\
& p_{3}=0
\end{aligned}
$$

Hence, the vector $P$ is given by

$$
P=\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right)
$$

Therefore, a second solution is

$$
\begin{aligned}
& X_{2}=K t e^{\lambda t}+P e^{\lambda t} \\
& X_{2}=\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right) t e^{4 t}+\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right) e^{4 t} \\
& X_{2}=\left[\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right) t+\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right)\right] e^{4 t}
\end{aligned}
$$

Finally for the third solution we solve

$$
\begin{array}{ll} 
& (A-\lambda I) Q=P \\
\text { or } \quad & \left(\begin{array}{lll}
0 & 1 & 0 \\
0 & 0 & 1 \\
0 & 0 & 0
\end{array}\right)\left(\begin{array}{l}
q_{1} \\
q_{2} \\
q_{3}
\end{array}\right)=\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right) \\
\text { or } \left.\quad \begin{array}{l}
0 q_{1}+1 q_{2}+0 q_{3}=1 \\
0 q_{1}+0 q_{2}+1 q_{3}=0 \\
0 q_{1}+0 q_{2}+0 q_{3}=0
\end{array}\right\} \Rightarrow \begin{array}{r}
q_{1}=1 \\
q_{2}=1 \\
q_{3}=1
\end{array}
\end{array}
$$

Hence, the vector $Q$ is given by

$$
Q=\left(\begin{array}{l}
1 \\
1 \\
1
\end{array}\right)
$$

Therefore, third solution vector is

$$
\begin{aligned}
& X_{3}=K \frac{t^{2}}{2} e^{\lambda t}+P t e^{\lambda t}+Q e^{\lambda t} \\
& X_{3}=\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right) \frac{t^{2}}{2} e^{4 t}+\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right) t e^{4 t}+\left(\begin{array}{l}
1 \\
1 \\
1
\end{array}\right) e^{4 t} \\
& X_{3}=\left[\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right) \frac{t^{2}}{2}+\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right) t+\left(\begin{array}{l}
1 \\
1 \\
1
\end{array}\right)\right] e^{4 t}
\end{aligned}
$$

The general solution of the given system is

$$
X=c_{1} X_{1}+c_{2} X_{2}+c_{3} X_{3}
$$

$$
X=c_{1}\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right) e^{4 t}+c_{2}\left[\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right) t+\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right)\right] e^{4 t}+\left[\left(\begin{array}{l}
1 \\
0 \\
0
\end{array}\right) \frac{t^{2}}{2}+\left(\begin{array}{l}
1 \\
1 \\
0
\end{array}\right) t+\left(\begin{array}{l}
1 \\
1 \\
1
\end{array}\right)\right] e^{4 t}
$$

## Non-Homogeneous System

## Definition

Consider the system of linear first order differential equations

$$
\begin{aligned}
& \frac{d x_{1}}{d t}=a_{11}(t) x_{1}+a_{12}(t) x_{2}+\cdots+a_{1 n}(t) x_{n}+f_{1}(t) \\
& \frac{d x_{2}}{d t}=a_{21}(t) x_{1}+a_{22}(t) x_{2} \cdots+a_{2 n}(t) x_{n}+f_{2}(t) \\
& \frac{d x_{n}}{d t}=a_{n 1}(t) x_{1}+a_{n 2}(t) x_{2}+\cdots+a_{n n}(t) x_{n}+f_{n}(t)
\end{aligned}
$$

where $a_{i j}$ are coefficients and $f_{i}$ are continuous on common interval $I$. The system is said to be non-homogeneous when $f_{i}(t) \neq 0, \forall i=1,2, \ldots, n$. Otherwise it is called a homogeneous system.

## Matrix Notation

In the matrix notation we can write the above system of differential can be written as

$$
\frac{d}{d t}\left(\begin{array}{c}
x_{1} \\
x_{2} \\
\vdots \\
x_{n}
\end{array}\right)=\left(\begin{array}{ccc}
a_{11}(t) & a_{12}(t) \ldots & a_{1 n}(t) \\
a_{21}(t) & a_{22}(t) \ldots & a_{2 n}(t) \\
\vdots & \vdots & \vdots \\
a_{n 1}(t) & a_{n 2}(t) \ldots & a_{n n}(t)
\end{array}\right)\left(\begin{array}{c}
x_{1} \\
x_{2} \\
\vdots \\
x_{n}
\end{array}\right)+\left(\begin{array}{c}
f_{1}(t) \\
f_{2}(t) \\
\vdots \\
f_{n}(t)
\end{array}\right)
$$

Or $X^{\prime}=A X+F(t)$

## Method of Solution

To find general solution of the non-homogeneous system of linear differential equations, we need to find:

- The complementary function $X_{C}$, which is general solution of the corresponding homogeneous system $X^{\prime}=A X$.
- Any particular solution $X_{p}$ of the non-homogeneous system $X^{\prime}=A X+F(t)$ by the method of undetermined coefficients and the variation of parameters.
The general solution $X$ of the system is then given by sum of the complementary function and the particular solution.

$$
X=X_{c}+X_{p}
$$

## Method of Undetermined Coefficients

## The form of $F(t)$

As mentioned earlier in the analogous case of a single $n t h$ order non-homogeneous linear differential equations. The entries in the matrix $F(t)$ can have one of the following forms:

- Constant functions.
- Polynomial functions
- Exponential functions
- $\sin (\beta x), \cos (\beta x)$
- Finite sums and products of these functions.

Otherwise, we cannot apply the method of undetermined coefficients to find a particular solution of the non-homogeneous system.

## Duplication of Terms

The assumption for the particular solution $X_{p}$ has to be based on the prior knowledge of the complementary function $X_{C}$ to avoid duplication of terms between $X_{C}$ and $X_{p}$.

## Example 1

Solve the system on the interval $(-\infty, \infty)$

$$
X^{\prime}=\left(\begin{array}{ll}
-1 & 2 \\
-1 & 1
\end{array}\right) X+\binom{-8}{3}
$$

## Solution

To find $X_{C}$, we solve the following homogeneous system

$$
X^{\prime}=\left(\begin{array}{ll}
-1 & 2 \\
-1 & 1
\end{array}\right) X
$$

We find the determinant

$$
\begin{aligned}
& \operatorname{det}(\mathrm{A}-\lambda \mathrm{I})=\left|\begin{array}{cc}
-1-\lambda & 2 \\
-1 & 1-\lambda
\end{array}\right| \\
& \operatorname{det}(\mathrm{A}-\lambda \mathrm{I})=(-1-\lambda) \\
& (1-\lambda)+2 \\
& \operatorname{det}(\mathrm{~A}-\lambda \mathrm{I})=\lambda^{2}+\lambda-\lambda-1+2=\lambda^{2}+1
\end{aligned}
$$

The characteristic equation is

$$
\operatorname{det}(\mathrm{A}-\lambda \mathrm{I})=0=\lambda^{2}+1
$$

or

$$
\lambda^{2}=-1 \Rightarrow \lambda= \pm i
$$

So that the coefficient matrix of the system has complex eigenvalues $\lambda_{1}=i$ and $\lambda_{2}=-i$ with $\alpha=0$ and $\beta= \pm 1$.

To find the eigenvector corresponding to $\lambda_{1}$, we must solve the system of linear algebraic equations

$$
\left(\begin{array}{cc}
-1-i & 2 \\
-1 & 1-i
\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0}
$$

or

$$
\begin{aligned}
-(1+i) k_{1}+2 k_{2} & =0 \\
-k_{1}+(1-i) \quad k_{2} & =0
\end{aligned}
$$

Clearly, the second equation of the system is $(1+i)$ times the first equation. So that both of the equations can be reduced to the following single equation

$$
k_{1}=(1-i) k_{2}
$$

Thus, the value of $k_{2}$ can be chosen arbitrarily. Choosing $k_{2}=1$, we get $k_{1}=1-i$. Hence, the eigenvector corresponding to $\lambda_{1}$ is

$$
K_{1}=\binom{1-i}{1}=\binom{1}{1}+i\binom{-1}{0}
$$

Now we form the matrices $B_{1}$ and $B_{2}$

$$
B_{1}=\operatorname{Re}\left(k_{1}\right)=\binom{1}{1}, \quad B_{2}=\operatorname{Im} \quad\left(k_{1}\right)=\binom{-1}{0}
$$

Then, we obtain the following two linearly independent solutions from:

Therefore

$$
\begin{aligned}
& X_{1}=\left(B_{1} \cos \beta t-B_{2} \sin \beta t\right) e^{\alpha t} \\
& X_{2}=\left(B_{2} \cos \beta t+B_{1} \sin \beta t\right) e^{\alpha t}
\end{aligned}
$$

or

$$
\begin{aligned}
& X_{1}=\left[\binom{1}{1} \cos t-\binom{-1}{0} \sin t\right] e^{0 t} \\
& X_{2}=\left[\begin{array}{c}
\left.\cos t\binom{-1}{0}+\binom{1}{1} \sin t\right] e^{0 t} \\
X_{1}=\binom{\cos t}{\cos t}+\binom{\sin t}{0}=\binom{\cos t+\sin t}{\cos t} \\
X_{2}=\binom{-\cos t}{0}+\binom{\sin t}{\sin t}=\binom{-\cos t+\sin t}{\sin t}
\end{array} .=\begin{array}{l}
\end{array}\right)
\end{aligned}
$$

Thus the complementary function is given by
or

$$
\begin{aligned}
& X_{c}=c_{1} X_{1}+c_{1} X_{2} \\
& X_{C}=c_{1}\binom{\cos t+\sin t}{\cos t}+c_{2}\binom{-\cos t+\sin t}{\sin t}
\end{aligned}
$$

Now since $F(t)$ is a constant vector, we assume a constant particular solution vector

$$
X_{p}=\binom{a_{1}}{b_{1}}
$$

Substituting this vector into the original system leads to

Since

$$
X_{p}^{\prime}=\left(\begin{array}{ll}
-1 & 2 \\
-1 & 1
\end{array}\right)\binom{a_{1}}{b_{1}}+\binom{-8}{3}
$$

$$
X_{p}^{\prime}=\binom{0}{0}
$$

Thus

$$
\begin{aligned}
& \binom{0}{0}=\left(\begin{array}{l}
-a_{1}+2 b_{1} \\
-a_{1}+ \\
b_{1}
\end{array}\right)+\binom{-8}{3} \\
& \binom{0}{0}=\left(\begin{array}{l}
-a_{1}+2 b_{1}-8 \\
-a_{1}+ \\
b_{1}+3
\end{array}\right)
\end{aligned}
$$

This leads to the following pair of linear algebraic equations

$$
\begin{aligned}
& -a_{1}+2 b_{1}-8=0 \\
& -a_{1}+b_{1}+3=0
\end{aligned}
$$

Subtracting, we have

$$
b_{1}-11=0 \Rightarrow b_{1}=11
$$

Substituting this value of $b_{1}$ into the second equation of the above system of algebraic equations yields

$$
a_{1}=11+3=14
$$

Thus our particular solution is

$$
X_{p}=\binom{14}{11}
$$

Hence, the general solution of the non-homogeneous system is

$$
X=c_{1}\binom{\cos t+\sin t}{\cos t}+c_{2}\binom{-\cos t+\sin t}{\sin t}+\binom{14}{11}
$$

## Note that

- In the above example the entries of the matrix $F(t)$ were constants and the complementary function $X_{c}$ did not involve any constant vector. Thus there was no duplication of terms between $X_{C}$ and $X_{p}$.
- However, if $F(t)$ were a constant vector and the coefficient matrix had an eigenvalue $\lambda=0$. Then $X_{c}$ contains a constant vector. In such a situation the assumption for the particular solution $X_{p}$ would be

$$
X_{p}=\binom{a_{2}}{b_{2}} t+\binom{a_{1}}{b_{1}}
$$

instead of

$$
X_{p}=\binom{a_{1}}{b_{1}}
$$

## Example 2

Solve the system

& \frac{d y}{d t}=4 x+3 y-10 t+4
\end{aligned}
$$

## Solution

In the matrix notation
or

\begin{aligned}
& X^{\prime}=\left(\begin{array}{ll}
6 & 1 \\
4 & 3
\end{array}\right) X+\binom{6}{-10} t+\binom{0}{4} \\
& X^{\prime}=\left(\begin{array}{ll}
6 & 1 \\
4 & 3
\end{array}\right) X+F(t)
\end{aligned}
$$

Where $F(t)=\binom{6}{-10} t+\binom{0}{4}$
We first solve the homogeneous system

$$
X^{\prime}=\left(\begin{array}{ll}
6 & 1 \\
4 & 3
\end{array}\right) X
$$

Now, we use characteristic equation to find the eigen values

$$
\begin{aligned}
& \operatorname{det}(A-\lambda I)=\left|\begin{array}{cc}
6-\lambda & 1 \\
4 & 3-\lambda
\end{array}\right|=0 \\
& \Rightarrow(6-\lambda)(3-\lambda)-4=0 \\
& \Rightarrow \lambda^{2}-9 \lambda+14=0
\end{aligned}
$$

So

$$
\lambda_{1}=2 \text { and } \lambda_{2}=7
$$

The eigen vector corresponding to eigen value $\lambda=\lambda_{1}=2$, is obtained from

$$
(\mathrm{A}-\lambda \mathrm{I}) K_{1}=0, \text { Where } K_{1}=\binom{k_{1}}{k_{2}}
$$

Or

$$
(\mathrm{A}-2 \mathrm{I}) K_{1}=0
$$

Therefore

$$
\begin{aligned}
\left(\begin{array}{cc}
6-2 & 1 \\
4 & 3-2
\end{array}\right)\binom{k_{1}}{k_{2}} & =\binom{0}{0} \Rightarrow\left(\begin{array}{ll}
4 & 1 \\
4 & 1
\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0} \\
\binom{4 k_{1}+k_{2}}{4 k_{1}+k_{2}} & =\binom{0}{0}
\end{aligned}
$$

or

$$
\left.\begin{array}{l}
4 k_{1}+k_{2}=0 \\
4 k_{1}+k_{2}=0
\end{array}\right\} \Rightarrow 4 k_{1}+k_{2}=0
$$

we choose $k_{1}=1$ arbitrarily then $k_{2}=-4$
Hence the related corresponding eigen vector is

$$
K_{1}=\binom{1}{-4}
$$

Now an eigen vector associated with $\lambda=\lambda_{2}=7$ is determined from the following system

$$
\left(\mathrm{A}-\lambda_{2} \mathrm{I}\right) K_{2}=0 \text {, where } K_{2}=\binom{k_{1}}{k_{2}}
$$

or $\quad\left(\begin{array}{cc}-1 & 1 \\ 4 & -4\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0}$
or

$$
\left.\begin{array}{l}
-k_{1}+k_{2}=0 \\
4 k_{1}-4 k_{2}=0
\end{array}\right\} \Rightarrow-k_{1}+k_{2}=0
$$

Therefore

$$
K_{2}=\binom{1}{1}
$$

Consequently the complementary function is

Since

$$
\begin{aligned}
& X_{c}=c_{1}\binom{1}{-4} e^{2 t}+c_{2}\binom{1}{1} e^{7 t} \\
& F(t)=\binom{6}{-10} t+\binom{0}{4}
\end{aligned}
$$

Now we find a particular solution of the system having the same form.

$$
X_{p}=\binom{a_{2}}{b_{2}} t+\binom{a_{1}}{b_{1}}
$$

where $a_{1}, a_{2}, b_{1}$ and $b_{2}$ are constants to be determined.
in the matrix terms we must have

$$
\begin{aligned}
& X_{p}^{\prime}=\left(\begin{array}{ll}
6 & 1 \\
4 & 3
\end{array}\right) X_{p}+\binom{6}{-10} t+\binom{0}{4} \\
& \binom{a_{2}}{b_{2}}=\left(\begin{array}{ll}
6 & 1 \\
4 & 3
\end{array}\right)\left[\binom{a_{2}}{b_{2}} t+\binom{a_{1}}{b_{1}}\right]+\binom{6}{-10} t+\binom{0}{4} \\
& \binom{a_{2}}{b_{2}}=\left(\begin{array}{ll}
6 & 1 \\
4 & 3
\end{array}\right)\binom{a_{2} t+a_{1}}{b_{2} t+b_{1}}+\binom{6 t+0}{-10 t+4} \\
& \binom{a_{2}}{b_{2}}=\binom{6 a_{2} t+6 a_{1}+b_{2} t+b_{1}}{4 a_{2} t+4 a_{1}+3 b_{2} t+3 b_{1}}+\binom{6 t+0}{-10 t+4} \\
& \binom{a_{2}}{b_{2}}=\binom{6 a_{2} t+b_{2} t+6 t+6 a_{1}+b_{1}}{4 a_{2} t+3 b_{2} t-10 t+4 a_{1}+3 b_{1}+4}
\end{aligned}
$$

or $\quad\binom{\left(6 a_{2}+b_{2}+6\right) t+\left(6 a_{1}+b_{1}-a_{2}\right)}{\left(4 a_{2}+3 b_{2}-10\right) t+\left(4 a_{1}+3 b_{1}-b_{2}+4\right)}=\binom{0}{0}$
from this last identity we conclude that

& 6 a_{2}+b_{2}+6=0 \\
& 4 a_{2}+3 b_{2}-10=0
\end{aligned} \quad \text { And } \quad \begin{aligned}
6 a_{1}+b_{1}-a_{2}=0 \\
4 a_{1}+3 b_{1}-b_{2}+4=0
\end{aligned}
$$

Solving the first two equations simultaneously yields

a_{2}=-2 \text { and } b_{2}=6
$$

Substituting these values into the last two equations and solving for $a_{1}$ and $b_{1}$ gives

& a_{1}=-\frac{4}{7} \\
& b_{1}=\frac{10}{7}
\end{aligned}
$$

It follows therefore that a particular solution vector is

X_{p}=\binom{-2}{6} t+\binom{-4 / 7}{10 / 7}

and so the general solution of the system on $(-\infty, \infty)$ is

X & =X_{c}+X_{p} \\
& =c_{1}\binom{1}{-4} e^{2 t}+c_{2}\binom{1}{1} e^{7 t}+\binom{-2}{6} t+\binom{-4 / 7}{10 / 7}
\end{aligned}
$$

Determine the form of the particular solution vector $X_{p}$ for

## Solution

First, we write the system in the matrix form

5 & 3 \\
-1 & 1
\end{array}\right)\binom{x}{y}+\binom{-2}{1} e^{-t}+\binom{0}{-5} t+\binom{1}{7} \\
& X^{\prime}=\left(\begin{array}{cc}
5 & 3 \\
-1 & 1
\end{array}\right) X+F(t)
\end{aligned}
$$

where $\quad X^{\prime}=\binom{d x / d t}{d y / d t}, \quad X=\binom{x}{y}$ and $F(t)=\binom{-2}{1} e^{-t}+\binom{0}{-5} t+\binom{1}{7}$
Now we solve the homogeneous system $X^{\prime}=\left(\begin{array}{cc}5 & 3 \\ -1 & 1\end{array}\right) X$ to determine the eigen values, we use the characteristic equation

$$
\begin{gathered}
\text { or } \operatorname{det}(\mathrm{A}-\lambda \mathrm{I})=0 \\
\Rightarrow\left|\begin{array}{cc}
5-\lambda & 3 \\
-1 & 1-\lambda
\end{array}\right|=(5-\lambda)(1-\lambda)+3=0 \\
\Rightarrow \lambda^{2}-6 \lambda+8=0 \\
\Rightarrow \lambda=2,4
\end{gathered}
$$

So the eigen values are $\lambda_{1}=2$ and $\lambda_{2}=4$
For $\lambda=\lambda_{1}=2$, an eigen vector corresponding to this eigen value is obtained from

Where

$$
\begin{gathered}
(\mathrm{A}-2 \mathrm{I}) K_{1}=0 \\
K_{1}=\binom{k_{1}}{k_{2}} \\
\left(\begin{array}{cc}
5-2 & 3 \\
-1 & 1-2
\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0} \\
\left(\begin{array}{cc}
3 & 3 \\
-1 & -1
\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0} \\
\left.\begin{array}{c}
3 k_{1}+3 k_{2}=0 \\
-k_{1}-k_{2}=0
\end{array}\right\} \Rightarrow-k_{1}-k_{2}=0
\end{gathered}
$$

We choose $k_{2}=-1$ then $k_{1}=1$

Therefore

$$
K_{1}=\binom{1}{-1}
$$

Similarly for $\lambda=\lambda_{2}=4$

$$
\begin{aligned}
& \left.\begin{array}{cc}
\left(\begin{array}{cc}
1 & 3 \\
-1 & -3
\end{array}\right)
\end{array}\right)\binom{k_{1}}{k_{2}} \\
& \left.\begin{array}{l}
k_{1}+3 k_{2}=0 \\
-k_{1}-3 k_{2}=0
\end{array}\right\} \Rightarrow k_{1}+3 k_{2}=0
\end{aligned}
$$

Choosing $k_{2}=-1$, we get $k_{1}=3$
Therefore $\quad K_{2}=\binom{3}{-1}$
Hence the complementary solution is

$$
X_{c}=c_{1}\binom{1}{-1} e^{2 t}+c_{2}\binom{3}{-1} e^{4 t}
$$

Now since

$$
F(t)=\binom{-2}{1} e^{-t}+\binom{0}{-5} t+\binom{1}{7}
$$

We assume a particular solution of the form

$$
X_{p}=\binom{a_{3}}{b_{3}} e^{-t}+\binom{a_{2}}{b_{2}} t+\binom{a_{1}}{b_{1}}
$$

## Note:

If we replace $e^{-t}$ in $F(t)$ on $e^{2 t}$ ( $\lambda=2$ an eigen value), then the correct form of the particular solution is

$$
X_{p}=\binom{a_{4}}{b_{4}} t e^{2 t}+\binom{a_{3}}{b_{3}} e^{2 t}+\binom{a_{2}}{b_{2}} t+\binom{a_{1}}{b_{1}}
$$

## Variation of Parameters

Variation of parameters is more powerful technique than the method of undetermined coefficients.
We now develop a systematic produce for finding a solution of the non-homogeneous linear vector differential equation

$$
\begin{equation*}
\frac{d X}{d t}=A X+F(t) \tag{1}
\end{equation*}
$$

Assuming that we know the corresponding homogeneous vector differential equation

$$
\begin{equation*}
\frac{d X}{d t}=A X \tag{2}
\end{equation*}
$$

Let $\phi(t)$ be a fundamental matrix of the homogeneous system (2), then we can express the general solution of (2) in the form

$$
X_{c}=\phi(t) C
$$

where $C$ is an arbitrary n-rowed constant vector. We replace the constant vector $C$ by a column matrix of functions
so that

$$
\begin{align*}
& U(t)=\left(\begin{array}{c}
u_{1}(t) \\
u_{2}(t) \\
\vdots \\
u_{n}(t)
\end{array}\right) \\
& X_{p}=\phi(t) U(t) \tag{3}
\end{align*}
$$

is particular solution of the non-homogeneous system (1).
The derivative of (3) by the product rule is

$$
\begin{equation*}
X_{p}^{\prime}=\phi(t) U^{\prime}(t)+\phi^{\prime}(t) U(t) \tag{4}
\end{equation*}
$$

Now we substitute equation (3) and (4) in the equation (1) then we have

$$
\begin{equation*}
\phi(t) U^{\prime}(t)+\phi^{\prime}(t) U(t)=A \phi(t) U(t)+F(t) \tag{5}
\end{equation*}
$$

Since $\quad \phi^{\prime}(t)=A \phi(t)$
On substituting this value of $\phi^{\prime}(t)$ into (5),
We have

$$
\phi(t) U^{\prime}(t)+A \phi(t) U(t)=A \phi(t) U(t)+F(t)
$$

Thus, equation (5) become s
or

$$
\begin{equation*}
\phi(t) U^{\prime}(t)=F(t) \tag{6}
\end{equation*}
$$

Multiplying $\phi^{-1}(t)$ on both sides of equation (6), we get

$$
\phi^{-1}(t) \phi(t) U^{\prime}(t)=\phi^{-1}(t) F(t)
$$

or $\quad U^{\prime}(t)=\phi^{-1}(t) F(t)$
or

$$
U(t)=\int \phi^{-1}(t) F(t) d t
$$

Hence by equation (3)

$$
\begin{equation*}
X_{p}=\phi(t) \int \phi^{-1}(t) F(t) d t \tag{7}
\end{equation*}
$$

is particular solution of the non-homogeneous system (1).
To calculate the indefinite integral of the column matrix $\phi^{-1}(t) F(t)$ in (7), we integrate each entry. Thus the general solution of the system (1) is

X=X_{c}+X_{p}
$$

or

$$
\begin{equation*}
X=\phi(t) C+\phi(t) \int \phi^{-1}(t) F(t) d t \tag{8}
\end{equation*}
$$

Find the general solution of the non-homogeneous system

We first solve the corresponding homogeneous system

-3 & 1 \\
2 & -4
\end{array}\right) X
$$

The characteristic equation of the coefficient matrix is
or

\operatorname{det}(\mathrm{A}-\lambda \mathrm{I})=\left|\begin{array}{cc}
-3-\lambda & 1 \\
2 & -4-\lambda
\end{array}\right|=0
$$

$$
\begin{aligned}
& (-3-\lambda)(-4-\lambda)-2=0 \\
\Rightarrow & \lambda^{2}+4 \lambda+3 \lambda+12-2=0 \\
\Rightarrow & \lambda^{2}+7 \lambda+10=0 \\
\Rightarrow & \lambda^{2}+5 \lambda+2 \lambda+10=0 \\
\Rightarrow & \lambda(\lambda+5)+2(\lambda+5)=0 \\
\Rightarrow & (\lambda+5)(\lambda+2)=0 \\
\Rightarrow & \lambda_{1}=-2, \quad \lambda_{2}=-5
\end{aligned}
$$

So the eigen values are $\lambda_{1}=-2$ and $\lambda_{2}=-5$

Now we find the eigen vectors corresponding to $\lambda_{1}$ and $\lambda_{2}$ respectively, Therefore

& \left(\mathrm{~A}-2 \mathrm{I}_{2}\right) K_{1}=0 \\
& \left(\begin{array}{cc}
-3+2 & 1 \\
2 & -4+2
\end{array}\right) \\
& \binom{-k_{1}+k_{2}}{2 k_{1}-2 k_{2}}=\binom{0}{0}
\end{aligned}
$$

$$
\text { so } \quad\left(\begin{array}{cc}
-3+2 & 1 \\
2 & -4+2
\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0}
$$

or

$$
\left.\begin{array}{c}
-k_{1}+k_{2}=0 \\
2 k_{1}-2 k_{2}=0
\end{array}\right\} \Rightarrow k_{1}=k_{2}
$$

We choose $k_{2}=1$ arbitrarily then $k_{1}=1$
Hence the eigen vector is

$$
K_{1}=\binom{1}{1}
$$

Now an eigen vector associated with $\lambda_{2}=\lambda=-5$ is determined from the following system
or

$$
\begin{aligned}
&\left(\begin{array}{cc}
\left.\mathrm{A}-\lambda_{2} \mathrm{I}_{2}\right) K_{2}=0 \\
2 & -4+5
\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0} \\
& \Rightarrow\left(\begin{array}{ll}
2 & 1 \\
2 & 1
\end{array}\right)\binom{k_{1}}{k_{2}}=\binom{0}{0} \\
& \Rightarrow\binom{2 k_{1}+k_{2}}{2 k_{1}+k_{2}}=\binom{0}{0} \\
&\left.\Rightarrow \begin{array}{l}
2 k_{1}+k_{2}=0 \\
2 k_{1}+k_{2}=0
\end{array}\right\} \Rightarrow k_{2}=-2 k_{1}
\end{aligned}
$$

We choose arbitrarily $k_{1}=1$ then $k_{2}=-2$
Therefore

$$
K_{2}=\binom{1}{-2}
$$

The solution vectors of the homogeneous system are

$$
X_{1}=\binom{1}{1} e^{-2 t} \text { And } X_{2}=\binom{1}{-2} e^{-5 t}
$$

$X_{1}$ and $X_{2}$ can be written as

$$
X_{1}=\binom{e^{-2 t}}{e^{-2 t}}, X_{2}=\binom{e^{-5 t}}{-2 e^{-5 t}}
$$

The complementary solution

$$
\begin{aligned}
& X_{c}=c_{1} X_{1}+c_{2} X_{2} \\
& =c_{1}\binom{e^{-2 t}}{e^{-2 t}}+c_{2}\binom{e^{-5 t}}{-2 e^{-5 t}}
\end{aligned}
$$

Next, we form the fundamental matrix

$$
\phi(t)=\left(\begin{array}{cc}
e^{-2 t} & e^{-5 t} \\
e^{-2 t} & -2 e^{-5 t}
\end{array}\right)
$$

and the inverse of this fundamental matrix is

$$
\phi^{-1}(t)=\left(\begin{array}{ll}
\frac{2}{3} e^{2 t} & \frac{1}{3} e^{2 t} \\
\frac{1}{3} e^{5 t} & \frac{-1}{3} e^{5 t}
\end{array}\right)
$$

Now we find $X_{p}$ by

& X_{p}=\phi(t) \int \phi^{-1}(t) F(t) d t \\
& X_{p}=\left(\begin{array}{cc}
e^{-2 t} & e^{-5 t} \\
e^{-2 t} & -2 e^{-5 t}
\end{array}\right) \int\left(\begin{array}{cc}
\frac{2}{3} e^{2 t} & \frac{1}{3} e^{2 t} \\
\frac{1}{3} e^{5 t} & \frac{-1}{3} e^{5 t}
\end{array}\right)\binom{3 t}{e^{-t}} d t \\
& X_{p}=\left(\begin{array}{cc}
e^{-2 t} & e^{-5 t} \\
e^{-2 t} & -2 e^{-5 t}
\end{array}\right)\left(\binom{2 t e^{2 t}+\frac{1}{3} e^{t}}{t e^{5 t}-\frac{1}{3} e^{4 t}} d t=\left(\begin{array}{cc}
e^{-2 t} & e^{-5 t} \\
e^{-2 t} & -2 e^{-5 t}
\end{array}\right)\binom{\int 2 t e^{2 t} d t+\int \frac{1}{3} e^{t} d t}{\int t e^{5 t} d t-\int \frac{1}{3} e^{4 t} d t}\right. \\
& X_{p}=\left(\begin{array}{cc}
e^{-2 t} & e^{-5 t} \\
e^{-2 t} & -2 e^{-5 t}
\end{array}\right)\binom{2 t \frac{e^{2 t}}{2}-2 \int \frac{e^{2 t}}{2} d t+\frac{1}{3} e^{t}}{t \frac{e^{5 t}}{5}-\int \frac{e^{5 t}}{5} d t-\frac{1}{3.4} e^{4 t}} \\
& X_{p}=\left(\begin{array}{cc}
e^{-2 t} & e^{-5 t} \\
e^{-2 t} & -2 e^{-5 t}
\end{array}\right)\binom{2 t \frac{e^{2 t}}{2}-\frac{e^{2 t}}{2}+\frac{1}{3} e^{t}}{\frac{t e^{5 t}}{5}-\frac{e^{5 t}}{25}-\frac{1}{12} e^{4 t}} \\
& X_{p}=\binom{t-\frac{1}{2}+\frac{1}{3} e^{-t}+\frac{t}{5}-\frac{1}{25}-\frac{1}{12} e^{-t}}{t-\frac{1}{2}+\frac{1}{3} e^{-t}-\frac{2 t}{5}+\frac{2}{25}+\frac{1}{6} e^{-t}} \\
& X_{p}=\binom{\frac{6}{5} t-\frac{27}{50}+\frac{1}{4} e^{-t}}{\frac{3}{5} t-\frac{21}{50}+\frac{1}{2} e^{-t}}
\end{aligned}
$$

Hence the general solution of the non-homogeneous system on the interval $(-\infty, \infty)$ is

X=X_{c}+X_{p}
$$

$$
\begin{aligned}
& =\phi(t) C+\phi(t) \int \phi^{-1}(t) F(t) d t \\
& =c_{1}\binom{1}{1} e^{-2 t}+c_{2}\binom{1}{-2} e^{-5 t}+\binom{\frac{6}{5} t-\frac{27}{50}+\frac{1}{4} e^{-t}}{\frac{3}{5} t-\frac{21}{50}+\frac{1}{2} e^{-t}}
\end{aligned}
$$

or
